- *2417 LANDS AND FORESTRY—YASMAR RESERVE—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
 - (1) Has a Memorandum of Understanding been finalised with Property NSW over the future management of Yasmar Reserve (R 1011588)?
 - (2) Has the Yasmar Reserve been transferred to Property NSW?
 - (a) If so, when was the transfer finalised?
 - (3) Was any transfer subject to community consultation?
 - (a) If not, why not?
 - (4) Is there any approval in place to transfer Yasmar Reserve to Property NSW?
 - (a) If so, when will that occur?
 - (5) Will any future transfer be subject to community consultation?
 - (a) If not, why not?
 - (6) Can the Minister rule out the transfer of Yasmar Reserve to Property NSW?
 - (7) Will the Minister place any restriction on any future transfer to prevent the sale of the Reserve?
 - (a) If not, why not?
 - (8) Can the Minister rule out the sale of Yasmar Reserve?
 - (9) Can the Minister rule out the future use of Yamsar Reserve for residential purposes?

Answer—

There is no Memorandum of Understanding with Property NSW. The land has not been transferred to Property NSW, nor is it in the process of being transferred to Property NSW. Proposed changes in management arrangements for any Crown land is subject to the Community Engagement Strategy under the Crown Lands Management Act which came into effect on 1 July 2018. The remaining matters have not been presented for consideration and are therefore hypothetical.

- *2418 REGIONAL NEW SOUTH WALES—REGIONAL RELOCATION OF BUSINESSES—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
 - (1) How many inquiries by businesses wishing to relocate to regional New South Wales (excluding Newcastle, Central Coast, Wollongong and Sydney regions) were made to the Department of Industry or its equivalent each financial year since 2011-12?
 - (2) How many of these inquiries were passed on to the relevant organisation each financial year since 2011-12?
 - (3) How many actual relocations of businesses to regional New South Wales (excluding Newcastle, Central Coast, Wollongong and Sydney regions) were achieved for each financial year since 2011-12?

Answer-

(1) The number of inquiries made to the Department of Industry, or its equivalent, by businesses wishing to relocate to regional New South Wales (excluding Newcastle, Central Coast, Wollongong and Sydney reg ions) total:

- (2) My understanding, based on departmental advice, is that all enquiries were passed on to relevant agencies.
- (3) Business conditions in regional NSW remain strong. I am pleased to report that the NSW regional economy is powering ahead, off the back of record jobs growth and infrastructure investment. More jobs have been created in the regions in the past three years (99,500) than were created in all of Labor's last eight years in office (68,600). The confidence of small and medium sized businesses in regional NSW is soaring with the latest Sensis Business Index survey revealing a 20 point jump in confidence to +51. Between June 2015 and June 2017, regional NSW (as per the question, exciuding Illawarra, Newcastle, Lake Macquarie and Sydney) added an additional 6,449 businesses. Not every business that relocates interacts with the NSW Government. The number of known business relocations is as follows:

The NSW Government has also recently introduced a number of new initiatives and programs aimed at making regional NSW a great place to work and do business, including:

- Announcing the first special activation precinct in Parkes, to leverage existing opportunities and incentivise investment while improving planning;
- The Regional Investment Attraction Package, which will encourage businesses to establish themselves in regional NSW;
- The provision of Regional Economic Development Strategies, which set out clear, tailored development plans for the regions;
- The 20 year Economic Vision for Regional NSW, which is our long term plan to secure lasting economic success in the regions; and
- The commitment of 100 per cent of the proceeds of the State's share in Snowy Hydro Limited to regional NSW, unlocking \$4.154 billion for transformative, visionary infrastructure projects.
- *2419 PREMIER—SOCIAL MEDIA PLATFORMS—Revd Mr Nile asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Premier—

Can the Premier:

- (1) Confirm whether or not the Government or any of its ministries or departments has used any internet based social media platforms as part of its public relations and education initiatives?
- (2) Inform the House which social media platforms the Government has relied upon and what benefit this has obtained?
- (3) Outline the costs associated with the use or reliance upon internet based social media platforms?

Answer-

NSW Government departments and ministries use social media, including Facebook, Twitter and Instagram, where appropriate, alongside other forms of advertising as a cost effective medium of communication.

- *2420 INNOVATION AND BETTER REGULATION—SOCIAL MEDIA BULLYING AND HARASSMENT TERMS AND CONDITIONS—Revd Mr Nile asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education representing the Minister for Innovation and Better Regulation—
 - (1) Is the Minister aware of the vague and subjective nature of various social media platforms' "terms and conditions", particularly relating to bullying and harassment, which may leave significant room for misinterpretation, misunderstanding and potential abuse?
 - (2) Can the Minister appreciate that this can undermine the integrity of online social and communications media, and in particular, that this has already had an impact on the quality and manner of political communication online?
 - (3) Has the Minister conducted any planning regarding this issue and future regulation aimed at mitigating the potential for abuse?

Answer-

- (1) Yes, the Government is aware that terms and conditions are often designed to obfuscate rather than inform. That is why the Government has introduced reforms which will increase transparency by requiring traders to provide notice of significant terms, in an upfront and explicit way.
- (2) People can make informed decisions when they have access to all the relevant information before they undertake any type of transaction. This is good for consumers and business, reducing complaints and improving outcomes.

Answer—

I am advised:

176 additional police were deployed, all officers were on rostered shifts and there was no NSW Police Force user pays agreement in place.

Answer—

I am advised:

In addition to user pays policing, 194 additional police attended the event over 2,100.5 policing hours.

For policing provided at the event the promoter reimbursed the NSW Police Force \$89,802.

No searches were undertaken based solely on a drug dog indication. 355 searches undertaken at Defqon 1 were based upon police establishing reasonable grounds following drug dog indications, observations made by police, the demeanour of the person searched, further investigations and questioning by police. A number of persons searched admitted to of having been in possession of or in contact with illicit drugs within the previous 48 hours.

Searches resulted in illicit drugs being located on 70 occasions and 9 of those were for supply.

10 people were denied entry for reasons including intoxication and aggressive behaviour.

Police at the event were not provided with any specific directions in relation to the stall referred to in the question.

Answer-

I am advised:

The Commonwealth has legislative power in relation to the internet in accordance with section 51 (v) of the Australian Constitution. In Australian Capital Television Pty Ltd v The Commonwealth (1992) 177 CLR 106 the High Court recognised the existence of an implied freedom of political communication in the Australian Constitution.

The NSW Government has provided 671 of the most disadvantaged and lowest performing schools across NSW with instructional leadership support K-2 (531 government, 99 Catholic and 41 independent schools).

The Government has also appointed 50 Literacy and Numeracy Advisors who are delivering state wide literacy and numeracy professional learning and support to NSW public schools.

\$85 million is available in each calendar year of the program, which remains within budget.
