- *1044 WATER, PROPERTY AND HOUSING—FLOODPLAIN HARVESTING—Mr Field asked the Minister for Mental Health, Regional Youth and Women representing the Minister for Water, Property and Housing—
 - (1) What is the status of the audit of floodplain harvesting in NSW?
 - (a) Will this audit be made public? If so, when?
 - (2) For each of the state's Water Sharing Plan areas for which floodplain harvesting is possible, how many floodplain harvesting works are estimated to be in operation in NSW?
 - (3) For each of the state's Water Sharing Plan areas for which floodplain harvesting is possible, what is the volume of water estimated to be able to be stored as a result of floodplain harvesting in NSW?

Answer-

- (1) 1. The Department of Planning, Industry & Environment completed an independent peer review of floodplain harvesting implementation in 2019.
 - (a) The report and also the Governments response were published on the Department website in July 2019.
- (2) Please see table below. Note, the NSW Government has committed to implementing the Floodplain Harvesting Policy in the five northern NSW valleys as the priority due to risk regarding Sustainable Diversion Limits. Equivalent information for other areas of NSW is not available. This table does not look at whether some storages in existing irrigation areas in the Southern Basin have been set up in a way to be capable of floodplain harvesting.

- *1045 WATER, PROPERTY AND HOUSING—EXEMPTIONS FOR FLOODPLAIN HARVESTING—Mr Field asked the Minister for Mental Health, Regional Youth and Women representing the Minister for Water, Property and Housing—

Regarding the Water Management (General) Amendment (Exemptions for Floodplain Harvesting) Regulation 2020 ('the Regulation') gazetted on 7 February 2020 which exempted certain floodplain harvesting works from the requirement for approval to construct a water supply work as contained in section 91B(1) of the Water Management Act 2000:

- (1) How many floodplain harvesting works were affected by the Regulation?
 - (a) What is the volume of water that is able to be stored as a result of these works?
- (2) How is the Regulation consistent with NSW Floodplain Harvesting Policy that sets a clear intention to create a licencing scheme for all floodplain harvesting in NSW?
 - (a) Will these exempt works fall under a licencing arrangement in the future? If so, are they all expected to be approved?
- (3) What consultation, if any, occurred regarding the decision to introduce the Regulation?

- (4) For how long will the Regulation remain in place?
- (5) Is there a trigger for its revocation?
- (6) What was the legal basis for having to introduce both the the Regulation and the Temporary Water Restriction (Northern Basin) (Floodplain Harvesting) Order 2020 concurrently?
- (7) Prior to the introduction of the Regulation, what was the legal status of floodplain harvesting works in NSW?

Answer-

- (1) The Water Management (General) Amendment (Exemptions for Floodplain Harvesting) Regulation 2020 relates to the ability of floodplain works to take water but does not provide approval for those physical infrastructure works.
- (2) The need for this Regulation was clearly articulated as part of the Floodplain Harvesting Policy first published in 2013.
 - (a) Licensing of floodplain harvesting is planned to be completed by 1 July 2021 as published in the NSW Government Floodplain Harvesting Action Plan.
- (3) State-wide public consultation on the Independent Peer Review and also the NSW Government Floodplain Harvesting Action Plan occurred in September 2019. The intention to introduce this Regulation was included in that consultation.
- (4) The regulation is intended to cease when licensing is complete (1 July 2021 for the northern basin valleys) as per the NSW Government Floodplain Harvesting Action Plan.
- (5) The regulation is intended to cease when licensing is complete (1 July 2021 for the northern basin valleys) as per the NSW Government Floodplain Harvesting Action Plan.
- (6) The legal basis for the introduction of both the Water Management (General) Amendment (Exemptions for Floodplain Harvesting) Regulation 2020 and the Temporary Water Restriction (Northern Basin) (Floodplain Harvesting) Order 2020 was the Water Management Act 2000.
- (7) Approvals for flood works are required under the Water Management Act 2000 this regulation does not relate to flood works. Prior to this regulation, all floodplain harvesting in NSW sat outside the licensing framework of the Water Management Act 2000, meaning that no licences or approvals were required. This exemption represents a restriction to current practice as a transitional arrangement to full regulation thro.ugh licensing and measurement.

*1047 WATER, PROPERTY AND HOUSING—TEMPORARY APPROVAL TO TAKE FOR THE PURPOSE OF FLOODPLAIN HARVESTING—Mr Field asked the Minister for Mental Health, Regional Youth and Women representing the Minister for Water, Property and Housing—

Regarding the approval to take from Namoi, Gwydir and Barwon under the Temporary Water Restriction (Northern Basin) (Floodplain Harvesting) Order 2020 made on 10 February 2020:

- (1) How many floodplain harvesting works were affected by this Order?
- (a) What is the volume of water that is able to be stored as a result of these works?
- (2) Which stakeholder groups requested that this order be made?
- (3) Given the public statements of the Minister that only a few properties were affected by the order, how many properties were affected?
- (4) What specific floodplain infrastructure on these properties were threatened by flooding in the six catchments identified in the approval to take order?

Answer—

- (1) Works not properties.
- (2) Northern NSW community members and landholders.
- (3) Following the initial advice I received, I have subsequently been advised approximately 200 properties were in the area where the order was lifted.
- (4) Various types of irrigation infrastructure, private property as well as public infrastructure was reported to be at risk by landholders. There was also reported to be a significant risk to public safety.
- (5) Between 7-9 February.
- (6) NRAR staff were asked to assist in an aerial investigation which included reported infrastructure damage and ongoing risk that was allegedly being exacerbated because of the pumping restrictions. This was not part of NRAR's normal duties.
 - (a) Monday 10 February.
 - (b) The purpose of this investigation was to inform future decision making around these restrictions.

The NSW Government is funding more health services every year.

In 2019-20, \$2.7 billion will be invested in capital on top of \$24 billion in recurrent spending, taking the total health budget this year to \$26.7 billion. This represents \$1 billion, or 4.5 per cent, more for NSW Health's recurrent spending budget than in 2018-19.

Local health districts are responsible for providing the range of health services for residents in their areas. Health service delivery changes over time, which may involve realignment of existing services to improve the overall level of services available to local populations.
