

- (g) acknowledges that this global initiative consists of locally based organisations that conduct events and education outreach programs to benefit their community with the aim of increasing community awareness about the value of bringing good, clean, local food from the farm directly to market, and
- (h) commends the slow food ethos of urging people to eat locally produced and seasonal food, and supporting local small-scale farms which helps reduce the

carbon emissions attributable to the transportation of goods around the country and the globe.






