NOTICE OF MOTION

The Honorable Daniel Mookhey MLC says -

Mister President:

I give notice that on the next sitting day I will move that this House notes that:

- 1) On 22 November 2017 Streets Ice Cream and members of the Australian Manufacturing Workers' Union reached an in-principle agreement to settle their industrial dispute, by agreeing to maintain both their existing enterprise agreement, and other long-standing workplace conditions.
- 2) This agreement followed a community boycott, and social media campaign, in which tens of thousands of Australians abstained from the purchase of Streets products to protest management's attempts to cut workers' pay by 46%, by unilaterally terminating the company's enterprise agreement.
- 3) That this House congratulates:
 - a) Streets Ice Cream workers for their solidarity and workplace activism, which sustained the long campaign that led to victory; and
 - b) The Australian Manufacturing Workers' Union and Australian Council of Trade Unions for supporting the Street Workers, and for leading the community boycott; and
 - c) The NSW Young Liberals for their unsolicited endorsement of Streets Management's actions, which was crucial in building public support for the boycott and Streets Workers.
 - d) All Australians who, heretofore in solidarity, boycotted Streets products pending the Streets Management's withdrawing their application to terminate their enterprise agreement.

Notice of Motion Justin Field MLC 23 November 2017

1) That this House notes that:

- a) The December 2016 decision of the NSW Land and Environment Court in favour of Liverpool City Council to reject a proposal by the De Angelis DHI group to build a late-night trading hotel with poker machines in Casula at the site of the Fontainebleau Motor Inn.
- b) The rejection was based on social impact grounds and followed a community campaign led by the Casula Community Group for Responsible Planning.
- c) The hotel if constructed would have been within 140metres of a primary school, an aged care facility and a women's refuge.
- d) Recent changes liquor licencing laws and planning laws have restricted or eroded the rights of impacted communities to object to certain proposals, including on social impact grounds.
- e) There are community concerns that the De Angelis DHI group may bring a new proposal to try to take advantage of the weaker laws, despite the unequivocal judgement of the court regarding the proposals social impacts on the Casula community.
- f) The decision of the NSW Legislative Council to support a motion by Dr Joh-Kaye of 18 June 2014 that called on the Liverpool City Council to reject the original application by the De Angelis DHI Group.
- 2) That this house calls on the De Angelis DHI group to respect the decision of the court and the objection of the community and to permanently abandon plans for a hotel with poker machines on the site.
- 3) That this house calls on Liverpool City Council to take steps it can to ensure the site is not used for unsuitable hotel and gaming related businesses in the future.

Pollution and fertility

Mr President, I give notice that on the next sitting day I will move:

That this House;

- 1. Notes that a recent study from the Chinese University of Hong Kong has found that high levels of air pollution are associated with poor sperm quality and could be partly responsible for a sharp drop in male fertility. Sperm counts among men have more than halved in the last 40 years.
- 2. Notes that this shows a link between our environment's health and our physical health. Although in this study, the effect is "relatively small in clinical terms", the study concluded that it might still lead to infertility for a "significant number of couples" given the extent of air pollution in cities around the world and this poses a public health challenge for our communities.
- 3. Calls on the Government to ensure health is considered in all public planning decisions.
