  - (a) New South Wales' GambleAware Week commences on 21 October 2024;
  - (b) On 17 October 2019, a motion was agreed to in this House, calling on the Government to change the name of the week from Responsible Gambling Awareness Week to Gambling Harm Awareness Week;
  - (c) Instead of honouring this agreement, the name of the week was changed to GambleAware Week; and
  - (d) South Australia, Queensland, Victoria, and the Australian Capital Territory have all chosen to name the week Gambling Harm Awareness Week to better reflect the considerable harm gambling causes to individuals, families and communities.
- (2) That this House also notes that:
  - (a) Research conducted in 2022 found that almost half of Australians aged 18 and over who gambled would be classified as being at-risk of, or already experiencing, gambling harm; and
  - (b) In 2023, people in NSW lost a record \$8.1 billion on poker machines alone, an increase of \$29 million from the year before and an equivalent of \$1000 for every adult and child in NSW;
  - (3) That this House reiterates its calls on the Government to name the week dedicated to promoting awareness about gambling harm and to reducing that harm to Gambling Harm Awareness Week.

#### Mr PRESIDENT:

- (1) That this House notes that:
  - (a) Recent analysis undertaken by the Superpower Institute shows that Australia's coal mines and gas fields are producing more than twice the amount of methane currently reported;
  - (b) The Open Methane tool, based on satellite imaging and ground-based verification, has identified Australia's top twenty methane hotspots all located near sites of significant coal or gas extraction;
  - (c) In New South Wales, these include:
    - i. Boggabri in the Gunnedah Basin, where three coal mines are operated by Idemitsu and Whitehaven;
    - ii. Muswellbrook in the Hunter Valley, where five coal mines are operated by New Hope, Glencore, BHP, MACH Energy and Idemitsu;
    - iii. Narrabri in the Gunnedah Basin, where one coal mine is operated by Whitehaven;
    - iv. Springvale in the Sydney Basin, where two coal mines are operated by Centennial Coal;
    - v. Appin in the Sydney Basin, where one coal mine is operated by Illawarra Coal; and
    - vi. Helensburgh in the Sydney Basin, where one coal mine is operated by Peabody.
  - (d) Methane is more than 28 times as potent a greenhouse gas as carbon dioxide;

- (e) Australia's existing greenhouse gas reporting scheme relies on self-reported data from major emitters, who base their estimates on factors like the amount of coal mined;
- (f) The lack of accurate and consistent emissions data has long hindered efforts across the world to rapidly reduce emissions;
- (g) Experts say that the self-reporting approach creates a significant risk of inaccuracy, as compared to satellite based measurements, which offer independent, objective data collection; and
- (h) The findings suggest that Australia is undercounting its annual total emissions by about 6%.
- (2) That this House calls on the Government to request the Chief Scientist to urgently undertake an investigation into the reporting of methane emissions from the state's existing coal mines so as to make recommendations that will ensure accurate and transparent reporting by all coal and gas mine operations in this state..

Mr PRESIDENT:

- (1) That this House notes that:
  - (a) on 26 September 2024, the Audit Office of NSW published a performance audit report of the NSW Department of Education entitled "Supporting students with disability" which found that:
    - the Department has not been adequately implementing its own inclusive education policies and procedures or rectifying longstanding and well-known issues in a timely way, despite being aware of these issues for almost two decades across multiple public reviews and audits, parliamentary inquiries and the recent national Disability Royal Commission;
    - (ii) the Department is not even aware of how effectively it is meeting the needs of students with disability because it has not consistently monitored outcomes for students with disability and schools' compliance with legal obligations and inclusive education practices;
    - (iii) the Department's criteria for accessing targeted supports for disability has not been updated in over 20 years since 2003, which is continuing to result in the exclusion of students with undiagnosed disability or with diagnosed disabilities that fall outside the outdated criteria including ADHD and dyslexia;
    - (iv) the Department's expectations for schools to provide inclusive education are not consistently being realised 'on the ground', with the Department having no centralised visibility of school performance in supporting students with disability and complying with the Disability Standards for Education;

- (v) the Department does not regularly use input sought from students, parents/guardians and teachers to understand the experiences of students with disability;
- (vi) there are gaps in the Department's complaints management process, which could be enhanced by providing parents/guardians with independent advice and disability expertise, supporting schools to analyse complaints data and ensuring school complaint handling and other policies are student-centric, accessible, efficient, safe, trauma-informed, and culturally appropriate;
- (vii) Aboriginal students with disability are worse off than their non-Aboriginal peers with disability in relation to suspension, expulsion, individual student growth and reported experiences of bullying; and
- (viii) students with disability were disproportionately suspended in each year of the audit review period, from 2018 to 2023. Of all the suspensions (385,382) issued over this six-year period (to either primary or secondary students), 58% were issued to a student with disability (223,706); and
- (b) the Auditor-General recommended that by January 2026 the Department of Education should:
  - (i) monitor the experiences and outcomes of students with disability at least annually;
  - (ii) expand the use of NCCD data to support funding allocation in accordance with the needs of students with disability;
  - (iii) ensure NSW public schools are adequately funded to support students with disability;
  - (iv) work with stakeholders to enhance guidance and practical support to public schools and families on reasonable adjustments for students with disability; and
  - (v) improve the planning and delivery of targeted supports.
- (2) That this House expresses its concern at the findings of the Auditor-General, and calls on the NSW Government to take urgent action to address them.

  - (b) Rosemary Kayess, Australia's Disability Discrimination Commissioner, was the event's keynote speaker and spoke about the Australian and NSW Governments' obligations and compliance under the UNCRPD and a pathway forward for dismantling ableism and building an inclusive society with inclusive education and employment.   - (i) that the NSW Department of Education adopt a definition of inclusive education that is consistent with the CRPD, in alignment with Finding 6 of the NSW Legislative Council Portfolio Committee No.3 - Education Inquiry Report 52 (August 2024),
  - (ii) that the NSW Government fully "Accept" Disability Royal Commission Recommendation 7.5 'Careers guidance and transition support services' and Recommendation 27 of the Legislative Council Portfolio Committee No.3 - Education Inquiry Report 52 (August 2024) in relation to improving career guidance and transition support services,
  - (iii) that the NSW Government establish an independent complaints system, and fully "Accept" Disability Royal Commission Recommendation 7.10 "Complaint Management" and Recommendation 23 of the Legislative Council Portfolio Committee No.3 - Education Inquiry Report no. 52 (August 2024) in relation to this,
  - (iv) that the NSW Government annually monitor the experiences and outcomes of students with disability to take effective steps to improve longer-term student outcomes, and
  - (v) that the NSW Public Service increase the percentage of people with disability in their employment in line with Disability Royal Commission Recommendation 7.18, including by increasing the disability representation of the teacher workforce and adopting a Customised Employment approach model within the NSW Public Service.
- (2) That this House congratulates the efforts of all those involved in organising a successful event, and commends the ongoing work and advocacy of Family Advocacy and PWDA in fighting for an inclusive and accessible society free from ableism where all people with disability are able to live with dignity and thrive.
