 - (a) on Thursday 20 November 2025, the annual Elimination of Violence Against Women event will be held in the NSW Parliament Dining Room to raise money for the new Core and Cluster Women's Safe House in Lightning Ridge and the Lokahi Foundation that provides domestic and family abuse support services,
 - (b) the event was founded in 2007 by then member of the Legislative Council, Marie Ficarra OAM and Vincent De Luca OAM, has been held every year since and has raised over \$1 million over the last 19 years for the White Ribbon Foundation, women's refuges, safe houses, shelters, emergency centres and domestic and family violence support services,

 - (iii) an on-site Hub building, that offers a safe environment and access to counselling, legal assistance, education, employment support and child friendly spaces and allows families to receive support while maintaining independence, personal space and routines,
 - (d) the Lokahi Foundation, founded in 2016 by Rachel Lloyd, provides a wide range of support services for women who have been victims of domestic and family abuse and its experienced caseworkers deliver ongoing support that is

designed to help survivors regain their freedom and independence, with support continuing for as long as each individual needs it, focusing solely on case management to ensure that domestic abuse survivors are offered ongoing support without time limit to regain their independence and freedom,

- (b) all documents relating to the design, methodology, criteria, data sources, assessment, publication, or review of Native Vegetation Regulatory Map or all related mapping, commonly referred to as the "pink map" identifying "Category 2 sensitive regulated land", including its initial application from 25 August 2017 or all subsequent iterations or revisions in the South Western Slopes Bioregion,
- (c) all documents relating to communications with or notifications to landholders, including the treatment for compliance purposes of coppicing of Melaleuca uncinata (broombush) or Eucalyptus polybractea (blue mallee) under the Biodiversity Conservation Act 2016 or the Local Land Services Act 2013,
- (d) all documents relating to all consultants or contractors engaged, and

(e) any legal or other advice regarding the scope or validity of this order of the House created as a result of this order of the House.

NOTICE OF MOTION

Mr Banasiak says—

Mr PRESIDENT:

That this House notes with serious concern:

- 1. The recent social-media post published by the Coalition for the Protection of Greyhounds (CPG) on or about 18 November 2025 that falsely claimed a retired racing greyhound known as "My Crabby" (formerly racing under the name "Crabby") had been drugged, seriously injured, "disappeared" from the Greyhounds As Pets Western Sydney facility, and implied that the dog was dead or had been killed.
- 2. That on 19 November 2025, Greyhounds As Pets (GAP) and the operator of the facility publicly confirmed, with contemporaneous photographs taken on 18 November 2025, that "My Crabby" is alive, happy, in good health, receiving ongoing veterinary treatment for a minor injury sustained in retirement, and is progressing well toward adoption as a pet.

That this house condemns

- 1. The Coalition for the Protection of Greyhounds for deliberately publishing and disseminating demonstrably false and inflammatory claims about the welfare and whereabouts of "My Crabby" without any evidence and in the face of clear information to the contrary.
- 2. engaging in a pattern of spreading mistruths, reckless allegations, and malicious innuendo that
 - a) unjustly damages the reputation of Greyhounds As Pets and the dedicated staff and volunteers who rehome retired racing greyhounds.
 - b) causes unnecessary distress to the public, adopters, and the wider greyhound community; and
 - c) undermines legitimate animal-welfare advocacy by resorting to bald-faced lies rather than facts.

That this house

- 1. Calls on the Coalition for the Protection of Greyhounds to:
 - (a) immediately and unreservedly withdraw the false claims concerning "My Crabby";
 - (b) issue a full public apology to Greyhounds As Pets, its staff, volunteers, and the greyhound racing and adoption community; and

- (c) commit to ceasing the publication of unsubstantiated allegations in the future.
- 2. Puts the Coalition for the Protection of Greyhounds on notice that this House considers any organisation that continues to base its public advocacy on proven falsehoods and deliberate misrepresentation to have grossly diminished its credibility as a responsible participant in animal-welfare debate in New South Wales.
- 3. Calls on all animal-welfare organisations operating in this State to adhere to basic standards of truthfulness and evidence in their public statements, so that genuine welfare concerns are not drowned out by sensationalist misinformation.

Mr PRESIDENT:

I move

That this House notes:

- a) The Draft Orana Bush Fire Risk Management Plan (BFRMP) now on public exhibition specifically omits any meaningful assessment of bushfire risk arising from the rapid expansion of large-scale renewable energy infrastructure in the Orana region, including utility-scale solar farms, wind farms, transmission assets and Battery Energy Storage Systems (BESS).
- b) The BFRMP relies heavily on vegetation-driven modelling tools but does not incorporate electrical, mechanical or thermal-runaway failure modes associated with renewable energy projects, despite these being known ignition sources and high-consequence risks.
- c) The Plan's asset listings and treatment strategies do not provide site-specific risk assessments, fuel management conditions, access requirements or pre-incident response plans for major renewable energy developments such as Wellington North Solar Farm, Suntop Solar Farm, associated substations, or proposed Orana renewable energy precincts.
- d) Communities and emergency services in the Orana region will be increasingly exposed to new and complex fire hazards without clear, enforceable emergency access arrangements, shutdown/isolation protocols, hazard information, or operator coordination obligations being embedded in regional fire planning.
- e) Local brigades and incident controllers require clarity, training and guidance on safe firefighting practices for BESS events, solar-array fires, transformer failures and wind-turbine fires, none of which currently appear in the Plan.

This house calls on the Government to:

- (a) Direct the NSW Rural Fire Service and the Bush Fire Coordinating Committee to incorporate explicit, site-specific risk assessments for all existing and proposed large-scale renewable energy projects within the Orana region into the final BFRMP;
- (b) Require operators of solar, wind, transmission and BESS facilities to provide the BFMC and local Fire Control Centres with:
- (i) a site-specific Fire Safety and Emergency Management Plan;
- (ii) electrical isolation and shutdown procedures;
- (iii) 24/7 emergency contact arrangements;
- (iv) detailed mapping of access/egress routes and internal layouts;
- (c) Ensure that the Fuel Management Register and Asset Protection Zone requirements are updated to clearly address on-site and perimeter fuel loads associated with solar farms, substations and turbine footprints;
- (d) Develop NSW-wide renewable-infrastructure firefighting protocols for distribution to all BFMCs, including guidance on BESS thermal-runaway behaviour, electrical hazards, suppression limitations, and crew safety;
- (e) Require the inclusion of renewable-infrastructure mapping layers in all future publicly-exhibited BFRMPs to ensure transparency and community awareness; and
- (f) Report back to the House within three months on the Government's actions to address the identified gaps.

General Notice - Murwillumbah High School staff allegations

Mr PRESIDENT: I give notice that on the next sitting day I will move:

- (1) That this House notes with disgust:
 - (a) the detailed 30-page sworn statement of a former teacher at Murwillumbah High School, which outlines a series of grave allegations involving senior staff at Murwillumbah High School, including allegations against a deputy principal that a past student, who completed Year 12 in 2020, had been in an ongoing sexual relationship with the then-head teacher of mathematics, later the relieving deputy principal, beginning during or before a 2019 school excursion to Japan when she was still a student,
 - (b) that this relationship allegedly continued through 2021, and escalated to the point where the former student returned to her family home for safety, expressing fears of controlling behaviour and potential domestic violence,
 - (c) that a current student disclosed these matters to a teacher on 4 February 2022, expressing distress and a fear that the school executive would "cover it up", and fear for their own education if they were identified as the informant, and
 - (d) that the teacher, fulfilling their legal obligations, reported the matter to police and then to the Department of Education's Professional and Ethical Standards (PES) unit and the Incident Hotline, explicitly requesting anonymity.
- (2) That this House further notes with disgust:
 - (a) allegations against a head teacher including that in late 2022, multiple former students alleged that said head teacher engaged in sexual activity with a group of former students and possible current students after drinking with them socially,
 - (b) that these acts were allegedly performed in the house of a teacher of Murwillumbah Primary School and witnessed by the year 11 son of that teacher,

- (c) it is alleged the teacher's eldest son participated in this activity while also being a paid student learning support officer at Murwillumbah Primary School, and
- (d) that said teacher who failed to report the incident is known in the community as having a close association with the local member through previous advocacy work on the de-merger from 2020 to 2024.
- (3) That this House notes with concern the systemic failures of the PES unit as described in the statement, including that:
 - (a) despite the PES unit and the Incident Hotline explicitly assuring the reporting teacher that they would remain anonymous, the relieving principal telephoned him that same evening, agitated, demanding to know what complaint he had lodged, and that this breach occurred within hours, exposing the teacher to direct reprisal from senior staff with close personal ties to the accused,
 - (b) following the breach, the reporting teacher describes sustained negative treatment from members of the school executive, including hostile comments, intimidation, deliberate obstruction of duties, and aggressive behaviour, which ultimately contributed to his decision to leave the teaching profession,
 - (c) PES investigators acknowleded the breach should not have occurred, yet took no corrective action, offered no explanation, and provided no protection for the whistleblower contrary to the Public Interest Disclosure Act 2022,
 - (d) despite multiple follow-up attempts between February 2022 and July 2023, PES provided no information, no confirmation that allegations were investigated, and ultimately informed him he had "no right to know the outcome", even though he was the mandatory reporter and the allegations involved multiple children, and
 - (e) PES failed to contact the reporting teacher for months after the second set of allegations, failed to act on new information about potential underage involvement, and failed to provide any assurance that staff remained stood down during investigations.
- (4) That this House condemns the Department of Education as a whole, including Secretary, Murat Dizdar and Darryl Currie for:
 - (a) referring extremely serious allegations, including sexual activity with minors and inappropriate relationships involving school executives, back to "local management", despite clear conflicts of interest and documented patterns of previous mishandling by the same executives,
 - (b) decision making that directly contravenes the principles of impartiality, conflict management, and protective governance,
 - (c) allowing individuals accused of serious sexual misconduct to continue teaching or working within the district office, despite community awareness

- of the allegations and concerns raised repeatedly by parents, students, and staff,
- (d) failing to guarantee any transparent, accountable, or timely investigation, even when multiple elected representatives, including the state and federal local members, were notified of the concerns, and
- (e) creating a governance environment in which complaints about child safety can be ignored, buried, or indefinitely stalled, thereby exposing children to ongoing risk.
- (5) This House calls on the Minister to
 - (a) dismiss Murat Dizdar and Darryl Currie for repeated poor leadership that has directly impacted both students, teachers and community,
 - (b) order an independent external investigation into the handling of all allegations outlined in the statement,
 - (c) strengthen whistleblower protections immediately,
 - (d) require that any credible child safety complaint be automatically escalated beyond local management,
 - (e) ensure that staff subject to serious allegations are removed from contact with students pending independent review, and
 - (f) provide assurance to the public that no child is placed at risk due to departmental inaction or internal conflicts of interest.
- (6) That this House affirms that the safety of children, the integrity of mandatory reporting, and the protection of whistleblowers must be paramount within New South Wales public education, and that any system which punishes those who report while shielding those accused of harm is fundamentally unfit for purpose.

 - (a) Matthew Briggs, now deceased, was a former youth group leader at Maitland Evangelical Church and was an identified paedophile with at least three victims between seven and fourteen years of age,
 - (b) Mr Briggs:
 - (i) was also a children's netball coach and a volunteer at a local cinema with access to unsupervised children,
 - (ii) often had children from the church attend sleepovers at his home,
 - (c) the victims and their families, as well as the wider community, have been failed by a lack of transparency from the leadership of Maitland Evangelical Church,
 - (d) serious concerns have been raised about the response of church leadership to disclosures about Mr Briggs' offences, including that:
 - (i) Pastor Roger Burgess, senior minister of Maitland Evangelical Church, received a disclosure regarding Mr Briggs' crimes immediately after his death,
 - (ii) Pastor Burgess refused to inform the church congregation, which comprised more than 500 people,
 - (iii) Pastor Burgess publicly demonised Mr Phil Bear, a trusted and prominent church member who raised concerns about the handling of information about Mr Briggs,
 - (iv) when Pastor Burgess eventually made public comment, at a poorly attended church finance meeting, he described Mr Briggs' actions as "extreme domestic violence" rather than "child sex offences.",
 - (e) Pastor Burgess is also alleged, along with Pastor Steven Doust, to have covered up the sexual abuse of a year 8-aged girl,

- (f) in late 2023, Mr Phil Bear became aware that Pastor Burgess would be leaving the church to become National President of the Fellowship of Independent Evangelical Churches, and
- (g) despite a formal complaint to Andrew Heard, Chair of the Fellowship of Independent Evangelical Churches, the national body has not satisfactorily investigated matters of child sexual abuse at Maitland Evangelical Church.
- (2) That this House further notes that:
 - (a) concerns regarding reporting and oversight have been raised with authorities,
 - (b) after receiving no action from church leadership, Mr Bear engaged a solicitor who wrote to the Office of the Children's Guardian detailing matters involving child sexual abuse,
 - (c) the Office of the Children's Guardian:
 - (i) advised that the issues raised were outside its jurisdiction and powers,
 - (ii) did not contact Mr Bear directly, despite his contact details being provided in the complaint,
 - (iii) had a potential undeclared conflict of interest, with the Senior Investigator at the Office of the Children's Guardian allegedly being a former child protection officer for the Sydney Anglican Diocese, a diocese with close connection to the Fellowship of Independent Evangelical Churches, and this conflict was not declared,
 - (d) under the Reportable Conduct Scheme of the Children's Guardian Act 2019, religious bodies are relevant entities with an obligation to report allegations of abuse, and
 - (e) section 316A of the Crimes Act 1900 makes it an offence for an adult to conceal child abuse offences and not report such offences to the NSW Police Force,
- (3) That this House calls on the Government to work with the Office of the Children's Guardian to:
 - (a) revoke the working with children checks accreditation of:
 - (i) Roger Burgess,
 - (ii) Steven Doust, and
 - (b) ensure a full investigation of reportable allegations of child sex abuse and review the conduct of the Maitland Evangelical Church and the Fellowship of Independent Evangelical Churches.

 - (a) ANZ bank has, in chaotic fashion, announced sweeping mass redundancies across its workforce, aiming to slash the jobs of 3,500 employees and 1,000 contractors by September 2026, with most of the 3,500 employee positions projected to go by the end of March,
 - (b) As of 31 October, more than 30 percent of the targeted 3,500 employees have already left the bank, with a further 1,000 contractors also having had their employment ended,
 - (c) ANZ bank has received a \$240 million fine from the Australian Securities and Investments Commission (ASIC) for widespread misconduct, relating to incorrectly reporting bond trading data, ignoring hundreds of customer hardship notices and failing to refund fees to thousands of dead customers, and
 - (d) Despite the penalties imposed by ASIC, and the redundancy payments associated with the banks sweeping job cuts, ANZ has recently reported a full-year profit of \$5.7 billion.
- (2) That this House further notes that:
 - (a) The Finance Sector Union (FSU) has commenced a dispute in the Fair Work Commission against ANZ bank over significant work health and safety concerns stemming from ANZ's mass redundancy plans,
 - (b) The FSU conducted an interim survey of ANZ employees, which found that the uncertainty surrounding ANZ's disastrous job cutting program is so severe

that it is making workers sick, with workers experiencing psychosomatic symptoms such as stomach pain, headaches and muscle tensions with employees reporting anxiety that is spreading negatively into their family lives,

- (c) 81% of surveyed workers say communication from executives had not been transparent or timely and 49% say they do not feel safe to raise concerns, fearing negative consequences,
- (d) One worker is quoted as saying "Everything is chaos roles are changing weekly, workloads are huge, and no one knows who will still have a job next month", and
- (e) A second workers is quoted as saying "No worker should have to choose between their mental health and their job and yet that's exactly what ANZ's staff are facing."
- (3) That this House expresses its solidarity with the FSU and ANZ workers across the country facing this unreasonable management action by multi-millionaire bank executives, and calls on ANZ to cease perpetuating widespread harm to its employees in pursuit of unjustifiable job cuts in the context of multi-billion dollar profits.

 - (a) Domestic Violence NSW (DVNSW), the peak body for specialist domestic and family violence services in NSW with approximately 200 member organisations across the state and diverse lived expertise advisory groups, launched their pre-budget submission on Wednesday 12 November 2025 for the 2026-27 NSW Budget;
 - (b) DVNSW's key ask ahead of next year's budget is for the NSW government to "prioritise a 50 percent core funding increase for all specialist domestic and family violence services, so that frontline services have sufficient resourcing to meet demand (\$177.4 million increase from 2024-25)";
 - (c) every year for over five years, the number one ask of the sector has been for the NSW government to prioritise a 50 percent increase in core baseline funding for frontline services;
 - (d) demand for the services delivered by the expert specialist domestic and family violence sector continues to grow rapidly; despite this, investment from the NSW government in the sector's core funding has not increased in line with demand;
 - (e) DVNSW has also called for targeted investment in various areas including specific programs, services and strategies ahead of each state budget, however the peak body has repeatedly emphasised that an uplift in core funding is the most crucial thing the NSW government can and must do to help frontline services meet demand; and

- (f) after the 2025-26 NSW Budget was released, DVNSW CEO Delia Donovan said in the media "we are deeply concerned about the future of domestic violence services in NSW. For too long, our sector has been carrying the weight of a growing crisis. We are historically overlooked, chronically underfunded, and expected to do more with less. Today's announcement falls millions of dollars short of the funding we put forward to respond to the scale, and urgency, of the domestic and family violence crisis in NSW. It's time for reasonable and sustained investment in existing services. It's time to fund the baseline".
- (2) That this House thanks Domestic Violence NSW for relentlessly advocating on behalf of victim-survivors and the entire domestic and family violence sector for government investment in what we know will turn the domestic and family crisis around and keep women and children safe.
- (3) That this House calls on the NSW government to finally meet the calls of the expert domestic and family violence sector, and commit to providing a permanent and significant increase in core baseline funding for existing frontline services in the 2026-27 NSW Budget.

- (1) That this House notes that:
 - (a) the week from Friday 7 November to Sunday 16 November 2025 was FrogID Week, Australia's biggest frog count that anyone with a smartphone can participate in;
 - (b) Frog ID Week is hosted annually by the Australian Museum and aims to monitor frog populations and distributions over time to help us better understand frogs and how Australia's ecosystems are responding to a changing planet;
 - (c) using the acoustic monitoring tool in the FrogID app, anyone in Australia can record the many unique sounds and calls that frogs make, including their different ribbits, croaks, barks, whistles and bleats, to help count frogs around the country;
 - (d) in 2024, over 18,000 FrogID recordings were submitted by over 4,000 individuals, which helped record over 34,000 frogs and identify 112 species;
 - (e) in 2023, frog researchers were able to name a new frog species, the otway smooth frog, by analysing the subtle differences in the calls of closely related species using recordings submitted through FrogID;
 - (f) frogs, like other amphibians, are sentient beings capable of a range of emotions and feelings including happiness, pain, anxiety and even altruism; they have opioid receptors and nociceptors, can identify humans who bring them food as non-threatening, and can demonstrate pain avoidance learning;

- (g) some frogs are named after the sounds they make, like the ticking frog, the quacking frog, the growling grass frog and the shoemaker frog (whose call sounds like a shoemaker's hammer tapping into the sole of a shoe);
- (h) frogs are known as 'bioindicators'; they are highly sensitive to environmental changes and pollution, which has helped humans realise that healthy frog populations are an indicator of a balanced, healthy and thriving ecosystem and environment, while a decline can warn of environmental degradation;
- (i) Australia has one of the world's most diverse frog populations, with over 250 different unique species living in various habitats from deserts and arid inland areas to rainforests and mountains;
- (j) frogs play an important role within ecosystems, as both crucial predators of insects and a food source for many other animals;
- (k) frog populations in Australia are declining every year because of threats including habitat loss from land clearing, wetland drainage, the broader impacts of climate change, diseases and the use of pesticides; and
- (1) one in five frog species are currently threatened in Australia.

(2) That this House recognises the unique and important existence of frogs within Australia's ecosystems and environment, and encourages everyone to learn more about frogs and get involved in counting and protecting frog populations.

Mr PRESIDENT: I give notice that on the next sitting day I will move:

- 1. That this House notes the inspiring initiative by Maitland City Council, led by Mayor Philip Penfold, to provide free Australian-made flags to residents for proud display outside their homes.
 - a) That this is the second year of the program, with Council allocating \$10,000 to meet overwhelming demand after last year's budget was exceeded.
 - b) That Mayor Penfold, drawing from his time living in the United States, emphasised that the Australian flag represents nothing more than pride in our country, stating it is "okay to be proud" and a shame that such patriotism is seen as controversial.
 - c) That Council has also erected the Hunter region's largest Australian flag in Queen Elizabeth II Park, delighting residents who commend its proud flutter as they drive past.
 - d) That this House commends Maitland City Council for defying divisive trends and fostering genuine community spirit through this small but meaningful gesture.
- 2. That this House recognises that one flag—the Australian National Flag—represents all Australians equally, and is the path to the unity our country so desperately needs.

Mr PRESIDENT:

- (1) That this House notes that:
 - (a) non-disclosure agreements (NDAs) operate to prevent parties to a dispute from disclosing information following a settlement agreement through confidentiality or non-disparagement terms;
 - (b) in the context of workplace sexual harassment, NDAs often require victim-survivors to keep their experiences confidential as a condition of receiving compensation, effectively contracting victims into silence;
 - (c) in almost all workplace sexual harassment settlements, NDAs are sought by the employer or perpetrator, not the victim-survivor, thereby exploiting power imbalances to sheild employers from reputational harm and reduce accountability;
 - (d) contributors to the Australian Human Rights Commission's (AHRC) 2025 Speaking from Experience report described NDAs as barriers to healing, closure and systemic change, noting that victims often feel pressured to sign due to fears of job loss, retaliation or reputational harm;
 - (e) according to the AHRC in the *Speaking from Experience* report, NDAs used in sexual harassment cases are frequently weaponised by perpetrators and can:
 - (i) exacerbate isolation and grief arising from enforced silence of victim-survivors;
 - (ii) prevent victim-survivors' access to counselling, connection and advocacy; and

- (iii) undermine transparency, which is essential for accountability; and
- (f) human rights experts Jennifer Robinson and Dr Keina Yoshida have:
 - (i) stated that "[p]lacing survivors in silos of silence under NDAs creates a culture of impunity that enables further abuse"; and
 - (ii) questioned "how can we as a society tackle gender-based violence and workplace harassment if those affected by it can't talk about it?".

(2) That this House recognises that:

- (a) in 2022 the AHRC and Respect@Work Council developed Guidelines on the Use of Confidentiality Clauses in the Resolution of Workplace Sexual Harassment Complaints, which set out best-practice victim-centred alternatives to blanket confidentiality;
- (b) despite the guidelines, NDAs remain common in sexual harassment settlements, with a 2024 Human Rights Law Centre and Redfern Legal Centre study finding NDAs were "standard practice", with 75% of legal practitioners never having resolved a sexual harassment matter without one;
- (c) the AHRC's most recent 2025 Speaking from Experience report recommended that governments act to restrict the use of confidentiality and non-disclosure agreements in workplace sexual harassment cases, to enhance transparency and properly protect victim-survivors, yet NSW has not proposed any legislative reform seeking to do so;
- (d) there are different models emerging internationally to regulate the use of NDAs in sexual harassment cases, including in Ireland, Canada, the US and the UK; and
- (e) in late October 2025, the Victorian Government introduced the Restricting Non-disclosure Agreements (Sexual Harassment at Work) Bill 2025 which:
 - (i) is the first bill in Australia to seek to restrict NDAs used in workplace sexual harassment cases within both the private and public sectors;
 - (ii) models the existing Irish legislation which prohibits NDAs in sexual harassment and discrimination cases unless such an NDA is expressly requested by the victim-survivor;
 - (iii) covers both explicit prohibitions on communicating facts about harassment and indirect restrictions embedded in non-disparagement or confidentiality provisions;
 - (iv) allows a worker who has entered into a workplace NDA to talk to certain people and bodies such as Victoria Police and medical and legal professionals;
 - (v) mandates the provision of information statements and a review period of at least 21 days before a worker signs a workplace NDA; and

- (vi) grants a worker an unconditional right to terminate a workplace NDA after giving 12 months of notice to the other party.
- (3) That this House affirms that:
 - (a) survivors of workplace sexual harassment should never be compelled into silence as a condition of settlement;
 - (b) transparency and accountability are essential to preventing workplace sexual harassment before it occurs and ensuring safe, respectful workplaces across NSW; and
 - (c) addressing and eliminating gender-based violence requires fostering a culture where all victim-survivors can speak out without fear of retaliation, professional harm or reputational damage.
- (4) That this House calls on the NSW government to:
 - (a) commit to aligning NSW with emerging national and international best practice, by introducing legislative reform to restrict the use of NDAs in workplace sexual harassment and discrimination cases;
 - (b) properly resource the specialist community organisations who provide accessible and culturally appropriate education on workplace sexual harassment;
 - (c) embed workplace sexual harassment education into respectful relationships and consent education in schools; and
 - (d) ensure victim-survivors of workplace sexual harassment and discrimination can safely access trauma-informed support to navigate justice, healing and recovery pathways.

Mr PRESIDENT:

- (1) That this House notes:
 - (a) the Country Women's Association of NSW (CWA) representing over 8,000 members in regional, rural, and remote communities continue to highlight chronic under-investment in rural road infrastructure, limited signage, poor road maintenance, long travel distances, wildlife hazards, and delayed emergency response times as key contributors to road trauma in country NSW,
 - (b) in this regard, debate around bullbars in New South Wales has been reignited following evidence to the NSW road-safety inquiry, with concern growing in regional areas that calls to ban or heavily restrict bullbars risks ignoring the lived experience and unique hazards of country driving,
 - (c) the CWA's submission to the Joint Standing Committee on Road Safety underscored that risks associated with unintended animal interaction on rural roads remains a pervasive and under-addressed human safety risk, and
 - (d) the debate on bullbar restrictions must therefore be situated within a broader context: the regulation of vehicle features and long-term investment in infrastructure, signage, and community-tailored safety programs.
- (2) That this House acknowledges:
 - (a) that any proposal to ban or heavily restrict bullbars without considering regional realities may be perceived as a one-size-fits-all, city-centric policy that fails to reflect rural road conditions, and

- (b) that regulatory compliance, targeted enforcement against non-compliant bullbars, and stronger community engagement are more proportionate, equitable, and effective than a blanket prohibition.
- (3) That this House further acknowledges:
 - (a) the evidence and advocacy contributed by the Country Women's Association of NSW in the inquiry, calling for greater infrastructure investment, better road signage (especially for wildlife), community-based road safety education, and tailored interventions for regional road trauma, and
 - (b) the parallel concerns raised by NSW Farmers, who, in their submission to the same inquiry, emphasise that rural communities face elevated risk due to poor road maintenance, underfunded local roads, inadequate overtaking lanes, aging bridges, and insufficient rest stops.
- (4) That this House calls on the Government to address concerns raised including comprehensively analysing the protective value of bullbars for regional/rural drivers, taking into account the safety of such motorists will not be improved by blanket bans or city-centric approaches but by factoring in the informed position of organisations such as the CWA and NSW Farmers whose clear and consistent message of that lives will only be saved through safer roads, better signage, targeted education, and practical, evidence-based solutions that reflect the realities of country driving.
