NOTICE OF MOTION

Ms Mitchell says—

Mr PRESIDENT:

- (1) That this House recognises the outstanding leadership and contributions of Ms Zoë Robinson, the NSW Advocate for Children and Young People, as she concludes her tenure in January 2026 after serving the children and young people of New South Wales for six years.
- (2) That this House acknowledges Ms Robinson's tireless work to ensure that every child and young person in NSW be heard, listened to and placed at the centre of decision-making across government, business and community.
- (3) That this House notes Ms Robinson's extensive achievements during her tenure, including:
 - (a) Consulting with more than 35,000 children and young people since 2020 and releasing 23 reports amplifying their voices,
 - (b) Conducting major research during the COVID-19 pandemic to ensure children and young people were supported to stay connected, return to school safely, and maintain wellbeing,
 - (c) Supporting young people's participation in decision-making through the creation of a Mental Health Reference Group, representation on government boards, and support for the establishment of the Australian Government's Youth Advisory Groups,
 - (d) Leading youth-informed responses on vaping, cost-of-living pressures, disaster recovery and inclusion,
 - (e) Creating the ACYP Child Rights online training program to support government, business and community organisations to embed children's rights in practice,
 - (f) Establishing the first Special Inquiry under the Advocate for Children and Young People Act into young people in alternative care arrangements (ACAs),

- (g) Contributing to the development of the landmark \$1.2 billion Child Protection Package,
- (h) Advocating for the establishment of Recovery Support Officers following the February 2022 Northern Rivers floods, securing a dedicated team working solely with children and young people and supporting more than 2,900 children and young people in the Northern Rivers through targeted recovery engagement,
- (i) Launching the Strategic Plan for Children and Young People 2022–2024 to monitor NSW Government commitments,
- (j) Establishing the first Memorandum of Understanding between ACYP and the NSW Department of Education to strengthen outcomes for students,
- (k) Supporting the Cultural Institutions Amendment Bill 2025, ensuring each of the six state cultural institutions now include a board member aged 18–28,
- (l) Funding governance training for young board members through the Australian Institute of Company Directors Foundation of Directorship Course,
- (m) Launching the "One to Watch" Women's Award recognising outstanding girls aged 7–15,
- (n) Funding a First Nations scholarship through the Jilya Institute for a young woman from the Northern Rivers studying psychology,
- (o) Reforming "packages on exit" so young people are no longer handed clearly identifiable bags when leaving custody, improving dignity and safety,
- (p) Funding vocational and skills-based programs—including Plate it Forward, MyStrengths, and trade-focused initiatives—to support pathways to training and employment,
- (q) Launching a book club for young women in youth justice centres with Her Excellency the Hon Margaret Beazley AC KC; and
- (r) Establishing the first Lived Experience Advisor role within ACYP, providing critical expertise to youth justice policy work and government decision-making.
- (4) That this House expresses its sincere gratitude to Ms Robinson for her dedicated service, her tireless efforts to advocate for children and young people, and her extraordinary commitment to elevating their voices across New South Wales.

Ms Higginson says-

Mr PRESIDENT:

- (1) That this House notes that negotiations between the Australian Labor party and the Australian Greens on federal nature laws have secured agreement that:
 - (a) exemptions from federal nature laws for regional forest agreements will be sunset in the legislation after 18 months,
 - (b) there will be a \$300 million transition package for the logging industry,
 - (c) existing use rights for native vegetation land clearing will be removed,
 - (d) there will be a prohibition on land clearing in the Great Barrier Reef Catchment,
 - (e) coal and gas projects will not be eligible for fast tracking by the Federal Government, and
 - (f) the federal water trigger will remain in place.
- (2) That this House notes that the NSW Labor Government must acknowledge that:
 - (a) the public native forest logging industry is coming to an end,
 - (b) an immediate moratorium on public native forest logging is the best opportunity to begin the regeneration of our degraded public native forests.
- That this House calls on the Government to place a moratorium on all current and future public native forest logging and immediately commences a transition for the public native forest logging industry.
- That this House thanks the Australian Greens for securing better and stronger outcomes for the natural environment that we all rely on.

Mrs Overall says—

Mr PRESIDENT:

- (1) That this House notes
 - (a) the ambitious plan to deliver 377,000 new homes by 2029 for NSW including 55,000 homes committed to for regional NSW will be unachievable if pre-existing infrastructure issues across New South Wales are not addressed.
- (2) That this House further notes that:
 - (a) as recently reported in the media, aging water and sewerage infrastructure issues in local government areas across the Riverina Murray are resulting in locals facing ever-increasing costs for maintenance and utility bills,
 - (b) Local Governments are scrambling to find ways to afford the associated cost blowouts including through the increasing of rates though special rate variations, water and wastewater charges, and borrowing, all of which directly impact the already burdened ratepayers across the region, and
 - (c) without urgent repairs and upgrades, Riverina Murray councillors have publicly expressed that the housing targets imposed by government cannot be achieved.

- (3) That this House acknowledges:
 - (a) Greater Hume Shire Mayor Councillor Lea Parker has publicly stated that housing development in her area will stop unless urgent funding is received to upgrade infrastructure and that while Councils are reluctant to charge ratepayers more, the region is facing a water and rate crisis and are in critical need of urgent State and Federal Government financial support, and
 - (b) Albury Mayor Councillor Kevin Mack has stated that while more people are choosing to call the regions home, with expectations that city's population will double over the next 50 years, it is essential for the NSW Government to work with councils to ensure infrastructure keeps pace and supports the delivery of much-needed homes, and that strong investment in water and wastewater infrastructure is critical to unlocking housing supply in regional centres,
- (4) That this House calls on the Government
- (a) to release a full, detailed reform roadmap for the proposed funding model and the regulatory framework, including the timeline, definition of standards to be met, performance reporting and progress of the proposed reforms of the overhaul of local water utilities and the delivery of new water infrastructure in achieving the commitments for the housing supply across the state, including regional housing.
