- (3) That this House establish a special select committee comprising three government, three opposition and three crossbench members to inquire into the Office of the Director of Public Prosecutions with the following terms of reference:
 - a) To inquire into the decisions to prosecute by the ODPP where adverse comments have been made by judges concerning the credibility and reliability of evidence in sexual assault matters in the last 24 months.
 - b) To inquire into the adequacy and application of the NSW ODPP Guidelines including how prosecution decisions, including the decision to prosecute, are taken and recorded, the independence of prosecutors who have carriage of sexual assault matters and the interplay between the Legal Profession Uniform Conduct (Barristers) Rules 2015 and the independence of salaried prosecutors.
 - c) The incidence of sexual assault prosecutions that have been discontinued by the ODPP prior to committal, following committal and during trial.
 - d) The adequacy and outcomes of the self-audit/ review announced following budget estimates by the Director of the ODPP of sexual assault briefs before the courts.
 - e) The appropriateness of public comments by the Director of Public Prosecutions with respect to the two public statements made in response to recent judicial comments of Whitford J and Newlinds J in relation to sexual assault cases.
 - f) This inquiry will not investigate current matters before the court where a verdict is yet to be returned.
 - g) The scope of the inquiry is to remain narrow with respect to the aforementioned matters that are already in the public realm.

 - a. Earlier this month, Virgin Australia announced its plans to become the first airline in the country to allow dogs and cats to travel in-cabin on their flights
 - b. This is an important step forward to making Australia more animal friendly, and it is hoped that more airlines will soon follow suit
 - c. NSW is continuing to lag behind other jurisdictions when it comes to animalfriendly transport, and still does not allow companion animals on trains, buses, the metro or ferries, except in very limited circumstances
 - d. This remains a major barrier to those with animals it prevents those without a car from easily transporting their animal, including to the vet, the dog park and other important appointments, and has a disproportionate affect the most vulnerable, including those who cannot afford to own a vehicle or older people who no longer drive
 - e. Allowing animals on public transport will also get cars off the road, reducing both traffic congestion and pollution
 - f. Public transport is there to share, and there are easy ways to ensure animal carriages are maintained and separated from other areas to ensure everyone can travel safely and comfortably
- 2. That this House congratulates Virgin Airlines for making the first move to ensure air transport is more animal friendly and calls on the Minns Government to do their part in making public transport animal friendly

General Notice – World Day for the End of Fishing

 - b. Approximately 396 million fishes and 3.8 billion shellfishes are killed in Australia each year, through a combination of fishing, wild-catch, commercial fishing and intensive aquaculture
 - c. The number of fishes killed each year can only be estimated, because the industry measures their deaths by tonnage, rather than recognising the billions of individual animals affected,
 - d. There is a large body of scientific evidence which proves fish feel pain and suffer in a similar way to humans, which is deeply concerning given the cruel ways in which fish are killed by sharp fishing hooks, crushing caused by trawler nets and suffocation,
 - e. If fishes could scream, we would not disregard their pain and suffering the way we do now
- 2. That this House notes there is much that needs to be done to protect fishes and other aquatic animals from the cruelty and suffering associated with fishing

Mr PRESIDENT:

- (1) That this House notes Mr Christopher Hugh Pratten's significant lifetime contribution to the preservation and conservation of the natural, historical, and built environment in New South Wales.
- (2) That this House notes that:
 - (a) On Thursday the 7th of March 2024 Mr Christopher Pratten died in Royal Prince Alfred Hospital, he was eighty-nine years old.
 - (b) Mr Pratten made a significant contribution to the preservation and conservation of New South Wales' cultural, social, built, and environmental heritage over a period of seventy years.
 - (c) Mr Pratten was born at St Luke's Hospital in Darlinghurst in September 1934, the youngest of three Pratten boys.
 - (d) He loved his holiday trips on the train to "Amaroo" the family property near Orange.
 - (e) He graduated from University of NSW with a Bachelor of Science in wool and pastoral science in the mid-1950's.
 - (f) After leaving university the family property Amaroo was split with his brother Geoff and Chris took on ownership and management of his part of the property "Koolewong". Mr Pratten was an owner-occupier farmer of this property for thirty years as a mixed grazing and cropping farm.
 - (g) From early on, Mr Pratten was enthusiastic about conservation, be it conservation of native plants, animals, birds, soil, buildings, antiques etc. He fenced off hundreds of acres of Koolewong from stock in the 1960's to form his arboretum, he built dams for ducks and planted trees for native birds and wildlife.
 - (h) In 1974, Mr Pratten and several other people established the Orange Field Naturalists and Conservation Society due to growing concerns over impacts

of development on the natural environment on the Central Tablelands. He was the initial President and held that position for ten years.

- (i) While living in Orange he taught at Orange TAFE getting a wildflower course established. He also presented a TV program in Orange, "Lament of the Rural Gum" with the late Peter Andren. During this time, he also joined the Ashfield and District Historical Society.
- (j) In 1984 Mr Patten accepted a position with the National Trust and moved to Sydney, where he oversaw the environmental section of the Trust. He found and purchased a historical house to restore in Summer Hill and joined the Summer Hill Action Group that year and was a very active member campaigning and lobbying for conservation and preservation of the local cultural, historical, and natural environment.
- (k) In 1990 he commenced working as a heritage consultant and over the next 10 years working mainly out in the south-west of Sydney on significant historical industrial and mine sites as well as the large north Sydney gasworks site.
- (1) During his time in Sydney he worked for the Nature Conservation Council, the National Trust, and Australian Conservation Foundation. He would join Jack Mundey to stop developers demolishing significant buildings around Sydney.
- (m) He was a member of the Ashfield and District Historical Society for half his life and in 1993 became President of the Ashfield Hand District Historical Society. It was whilst he was a member of the ADHS that they managed in 1972, to have a preservation order placed on the Villa named "Northridge" in Victoria St., Ashfield. The order saved the 1885 property, that I subsequently purchased in 1991, in a very poor and dilapidated state of repair.
- (n) Over the next thirty years Mr Pratten wrote numerous journal articles as well as several historical books on the Ashfield and Summer Hill areas (including an historical journal on Northridge in Ashfield) including books about his grandfather, his family's brickworks/cordial works, about Ashfield and his beloved Amaroo.
- (o) In 2005 Mr Pratten was awarded an OAM for service to the environment and to the conservation of natural and built heritage areas as a grazier, educator, and administrator.
- (p) In October 2023, Mr Pratten took his last trip to Orange, to launch the book, Orchids of Central Western NSW, and his speech at the launch at the age of eighty-nine was nothing short of brilliant.
- (3) That this House acknowledges:
- (a) Mr Christopher Pratten made a significant life-long contribution to the preservation and conservation of the cultural and historical environment of NSW and did not shy away from controversy in his pursuit of this in an age when development and demolition of important sites and historical buildings

was an everyday occurrence, for which all citizens of New South Wales are in his debt.

(b) This house extends condolences for the significant loss to Mr Pratten's and loved ones, from his passing on the 7th of March 2024. May he rest in peace.

 - (a) in the two years to June 2023, at least 115 young people aged from 12 to 17 were strip searched by the NSW Police,
 - (b) the Minns government committed to review the policies underpinning the practice and directed NSW Police to do likewise,
 - (c) between 18 October 2023 and 14 February 2024, 26 young people were strip searched by the NSW Police, a rate that is consistent with the 2 years prior to June 2023 and:
 - (i) included seven First Nations young people,
 - (ii) included a 12 year old child and a 13 year old child,
 - (ii) only discovered objects in 3 instances,
 - (d) the Minister for Police has declined to give a timeframe for the review, and
 - (e) the NSW Police have provided no comment on the review.

 - (a) strip searching is a terribly degrading exercise and a genuine violation of somebody's dignity,
 - (b) the threshold for a police officer to have the power to conduct a strip search is very low,
 - (c) stripsearching children is draconian and totally heavy-handed and causes long-term harm, and
 - (d) strip searches of First Nations young people is disproportionately high and is five times higher than for non-First Nations children.

(4) That this House calls on the Government to end the practice of strip searching children.

NOTICE OF MOTION

Ms Higginson says-

Mr PRESIDENT:

- (1) That this House notes that the findings of the Special Commission of Inquiry into offending by former Corrections Officer Wayne Astill at Dillwynia Correctional Centre is a damning indictment of our correctional system and centres.
- (2) That this House notes the report outlines:
 - (a) that Wayne Astill should never have been employed by Corrective Services NSW and was under employment either as the result of "corruption" or "incompetence",
 - (b) before Astill started working for Corrective Services he was a police officer and for a time was a detective. His police employment file shows complaints of serious criminal and other misconduct,
 - (c) Astill was transferred to Dillwynia Correctional Centre which is an all female facility in February 2009. Until his arrest on 20 February 2019 he served as a senior correctional officer and at times he acted as Chief Correctional Officer,
 - (d) on 25 August 2022 a jury convicted Astill of 27 criminal offences, comprising:
 - (i) incidents of foul language toward inmates,
 - (ii) 5 counts of aggravated sexual assault without consent,
 - (iii) 14 counts of aggravated indecent assault,
 - (iv) 3 counts of aggravated indecent assault,
 - (\mathbf{N}) 5 counts of misconduct in public office,
 - (e) Astill pleaded guilty to 7 counts of misconduct in public office all concerning inappropriate personal or sexual relationships with inmates and the sentencing judge further found a charge of intimidation had been proved beyond reasonable doubt. All up 35 criminal offences over 5 years, that we

know of, against women inmates, many of whom had significant histories of abuse and trauma,

- (f) the seriously toxic culture of Dillwynia Correctional Centre, described by one senior officer as a "viper pit" and a place of fear and retribution, alongside numerous issues with the management including:
 - (i) incidents of foul language toward inmates,

(ii) no system of report, complaint, investigation and accountability, and,
 (ii) a culture of impunity,

- (g) given the seriousness of the findings the inquirer found it would be "wrong to assume that there are not problems elsewhere", and,
- (h) it is apparent that problems in the management structure of Corrective Services NSW and the incapacity of some managers have undermined public confidence in Corrective Services NSW facilities ... and it will be important that a process of review of the entire institution is undertaken, and appropriate changes implemented. This should not be left to a process internal to Corrective Services NSW.
- (3) That this House calls on the Government to:
 - (a) acknowledge the courage of all of the inmates who gave gave evidence at the inquiry,
 - (b) apologise to the survivors of Astill's crimes,
 - (c) immediately establish an independent task-force to audit and reform all procedures and systems of integrity and accountability within Corrective Services NSW,
 - (d) implement each of the Inquiry's 31 recommendations as a matter of urgency, including:
 - (i) timely access to confidential, external, independent specialised sexual assault trauma counselling is provided in an ongoing manner to the survivors of Astill's criminal offending and other female inmate survivors of sexual assault by Corrective Services NSW staff via the Uralla Cottage service provider, for so long as it is required in the view of the specialist counsellors,
 - (ii) a Women's Strategy to oversee strategic and operational issues for female inmates,
 - (iii) access to private and confidential phone calls, and
 - (c) immediately begin full and thorough reform of each of the State's correctional centres so that they can begin to be places of rehabilitation and recovery for inmates and all of us.
