#### **QUESTION**

The Hon. TANIA MIHAILUK: My supplementary question for written answer is directed to the acting Minister for Education and Early Learning. Will the acting Minister advise whether the Department of Education was consulted by Canterbury-Bankstown Council on its Punchbowl and Wiley Park Precinct Plan submission and alternative scheme to the Transport Oriented Development Program and, if yes, on which dates? On which date did the Department of Education become aware of the fact that its land at Wiley Park Public School and Lakemba Public School was going to be rezoned by Canterbury-Bankstown Council?

ANSWER

I am advised :

The Department of Education is aware that Canterbury Bankstown Council has been working on a draft Precinct Plan, which was exhibited in May 2025 for the Punchbowl and Wiley Park Village Centres, and has been engaging with the council on the draft plan.

Under the State Environmental Planning Policy (Transport and Infrastructure) 2021, education establishments are a prescribed development in a variety of residential zones. The proposed change in the zoning of existing school sites would not impact the operation of those schools.
