**The Hon. Mark Latham: My supplementary question for written answer is directed to the Leader of the Government, representing the Premier.**

Having taken on notice my question regarding Minister Ron Hoenig, will the Leader of the Government and the Premier now review the transcript of the Local Government budget estimates hearing conducted by Portfolio Committee No. 8 - Customer Service on 28 February 2025 and subsequent answers on notice where three matters of ministerial interference are evident and substantiated? What does the review show regarding breaches of the ministerial code of conduct? As part of that review, will the Leader of the Government and the Premier now seek from Brett Whitworth, who has refused to answer three times, his knowledge of Minister Hoenig wanting the Saravinovski matter expedited to suit Labor's Bayside election timetable?

**ANSWER**

I am advised;

The NSW Ministerial Code of Conduct (Ministerial Code) sets out the standards of ethical behaviour required of Ministers, to ensure public confidence in the integrity of Government.

All Ministers are required to comply with their obligations under the Ministerial Code and are expected to do so.

I note that the ICAC has confirmed, in correspondence to the Clerk of the Parliaments dated 21 May 2025, that it is undertaking ongoing work concerning Mr Saravinovski and related matters.
