### **Overview**

The first sitting week of 2016 saw the House pass two Government bills, agree to an order for papers and pass several resolutions to vary times of meeting, the time for the adjournment and the precedence of business. The sitting day on Tuesday was unexpectedly interrupted by a power outage which required the President to leave the Chair and adjourn proceedings. The House resumed at 10.20 am the following day and, following several brief formalities, adjourned at 10.56 am. The House then commenced the scheduled Wednesday sitting at 11.00 am.

This edition signals the commencement of some changes to the format of the *House in Review*, including a more concise discussion on items of business and a move to a full screen format for the bulk of commentary. In the coming months, we will move to a format that is more readily accessible for online readers together with the inclusion of more hyperlinks to information on the activities of the House. These changes are designed to enhance readability and ensure that the *House in Review* is compatible with new digital reading platforms. We welcome your feedback on the new format over the coming weeks and months.

### **Committee of the whole proceedings now captured in the Minutes**

This week the President informed the House that from Tuesday 25 February 2016, proceedings in committee of the whole will be published in the Minutes of Proceedings, in keeping with the practice of the Senate and the NSW Legislative Assembly.

### **Variation to sessional orders**

On Wednesday 24 February 2016, the House agreed to a series of resolutions that varied the sessional orders for the days and times of meeting of the House, the time for the adjournment and the precedence of business. The effect is:

- The House will meet at 10.00 am Thursdays, instead of 9.30 am.
- Business will be interrupted to allow a minister to move the adjournment, if desired, at 10.00 pm on Tuesday, 7.00 pm on Wednesdays and at the conclusion of Questions, approximately 4.00 pm, on Thursdays.
- General business will take precedence until half an hour after the conclusion of Questions on Thursdays.

## **Retirement of Manager, Parliamentary Research Service**

On Tuesday 23 February 2016, the President made a statement concerning the retirement of Dr Gareth Griffith, Manager, Parliamentary Research Service, Parliamentary Library after 23 years of service, including five as the Manager of the Research Service. Dr Griffith is well known for his authoritative briefing papers, particularly those on areas of law and government, and as the co-author of the book *Decision and Deliberation: The Parliament of New South Wales 1856-2003*.

## **Government business**

**Note:** Government business includes Government bills introduced or carried by ministers in the Council.

### **Associations Incorporation Amendment (Review) Bill 2016**

House of origin: Legislative Assembly

The bill gives effect to recommendations arising from the statutory review of the Associations Incorporation Act 2009. The bill seeks to clarify the rights, liabilities and obligations of members of an association, the grounds for refusing registration applications, and the effect of amendments to model constitutions. The bill also makes provision for electronic voting, new processes for the winding up of associations and various administrative provisions. The bill was supported by the Opposition, The Greens and the Christian Democratic Party (CDP), however the CDP flagged that they would move amendments to further clarify the rules in response to feedback from community organisations.

During consideration in committee of the whole, the committee agreed to two Christian Democratic Party amendments requiring that where a Secretary intends to wind up an association, they must first give notice to the association stating the grounds that exist under new section 61A (1). The association must also be provided 28 days in which to make submissions.

The bill was reported to the House with amendments, read a third time and returned to the Assembly.

### **Government Sector Employment Legislation Amendment Bill 2016**

House of origin: Legislative Assembly

The bill seeks to apply the provisions of the Government Sector Employment Act 2013 (the GSE Act) to employment arrangements for senior executive officers in the NSW Health Service, the NSW Police Force and the Transport Service of NSW. The bill also extends the misconduct provisions of the GSE Act, and makes amendments of a minor or consequential nature to certain other legislation. The Opposition did not oppose the bill but noted that it remained committed to a rewrite of the GSE Act, arguing that the framework and concepts underpinning it are flawed. The CDP supported the bill, stating that the amendments would bring greater efficiency to the public sector. However, both the Opposition and CDP flagged that they would move amendments in committee to address areas of particular concern. The Greens opposed the bill, in keeping with their previous opposition to the new GSE Act, which they argued has led to a less independent public service. The second reading was agreed to on the voices.

During consideration of the bill in committee of the whole, the committee agreed to 19 CDP amendments. The amendments sought to maintain current provisions in the Police Act that allow the Governor declare a Commissioner of Police who has been removed from office to be an unattached officer, clarify superannuation arrangements for the Commissioner of Police and Police Force senior executives on termination of employment and while unattached, and provide for current executive eligibility lists to continue. The CDP amendments also provided that model contracts of employment prescribed under the amended Act would not have retrospective effect, and made provisions regarding the compensation to apply on the termination of employment.

The Opposition moved five amendments regarding disallowance provisions for Government Sector Employment Rules, protections for employees terminated in reprisal for making a public interest disclosure

and the removal of above band remuneration of police senior executives. The amendments were supported by The Greens but disagreed to.

The bill was reported to the House with amendments, read a third time and returned to the Assembly for concurrence.

### **Private members' business**

**Note:** Private members' business is business introduced by members of the House other than Government ministers. There are two types of private members' business: private members' bills and private members' motions.

#### *Motions*

#### **Hemp food products (Mr Buckingham, The Greens)**

Debate on the motion commenced on Thursday 25 February 2016. The motion noted that Australia and New Zealand are the only countries in the world where the sale of hemp food is illegal, impacting negatively on farmers who would otherwise stand to benefit from participation in the billion dollar hemp food industry, and called on the Government to lift the ban. During debate Mr Buckingham identified the many benefits of hemp food products, including their environmental sustainability and the significant health benefits produced by cannabinoids. Mr Buckingham also noted that the consumption of hemp food products will not produce a positive result in a drug test, as hemp contains no, or very low levels of THC (delta 9-tetrahydrocannabinol), the chemical associated with the psychoactive properties of marijuana.

The Government opposed the motion on the basis that the Government is already working proactively with the Federal and other State and Territory Governments to lift the ban on hemp food products. The Opposition supported the motion, stating that other jurisdictions had already done the work to ensure that hemp food products are safe for human consumption and that adequate controls are in place.

The motion was agreed to (Division 17:16).

#### **Health and hospital system (Mr Secord, Australian Labor Party)**

The motion calls on the House to express concern over the Government's failure to properly resource and fund the health and hospital system, that this is having a detrimental impact on emergency departments and increasing patient waiting times, and notes the impact this has on the community and health workers.

Debate on the motion resumed on 25 February 2016 from 29 October 2015 (see the previous editions of *House in Review* for earlier debates). A member from the Opposition spoke in support of the motion, citing the need to improve outcomes for sick and suffering people in NSW. A member of the Government spoke against the motion, arguing that the Coalition Government's management of the health system has led to better outcomes and more innovation in health and hospitals.

The motion was negated (Division 16:19).
