## Introduction

### Establishment of the General Purpose Standing Committees

The five General Purpose Standing Committees were first constituted by resolution of the Legislative Council on 7 May 1997, during the 51<sup>st</sup> Parliament.<sup>1</sup> On 13 May 1999, shortly after the commencement of the 52<sup>nd</sup> Parliament, the five committees were reconstituted.<sup>2</sup>

The General Purpose Standing Committees may inquire and report on:

- (a) any matters referred to them by the House;
- (b) the expenditure, performance or effectiveness of any department of government, statutory body or corporation;
- (c) any matter in any annual report of a department of government, statutory body or corporation.<sup>3</sup>

### Portfolios

The five committees reflect the Government Minister's portfolios as follows:

- Treasury, State Development

- Education and Training

### **Powers of the General Purpose Standing Committees**

The General Purpose Standing Committees have power:

- (a) to send for and examine persons, papers, records and things;
- (b) to adjourn from place to place;
- (c) to make visits of inspection within the State;
- (d) to request the attendance of and examine Members of the House;
- (e) to publish, before presentation to the House, submissions received and evidence taken in public; and
- (f) to report from time to time their proceedings, evidence taken in public and recommendations.<sup>4</sup>

## **Referral of the 1999-2000 Budget Estimates**

On 29 June 1999, the Legislative Council resolved that the Budget Estimates and related documents presenting the amounts to be appropriated from the Consolidated Funds be referred to the General Purpose Standing Committees for inquiry and report.<sup>5</sup> Each Committee is to examine the Budget Estimates for their relevant portfolios and report to the House by the first sitting day in November 1999.<sup>6</sup>

Unlike previous years, the Committees' consideration of the Budget Estimates did not form part of the passage of the Appropriation Bills (which were passed on 2 July 1999). This separation of consideration of the Budget Estimates from the passage of the Appropriation Bills allows a more relaxed timeframe for their consideration. The reference is modelled on that used by the Commonwealth Senate and is particularly appropriate for the Legislative Council which, while having a scrutiny function concerning Government expenditure, is not able to prevent the passage of the ordinary annual services of the Government.

### **Premier, the Arts, Citizenship**

The Committee heard evidence from the Hon Bob Carr MP, Premier, Minister for the Arts and Minister for Citizenship, together with officers of relevant departments, at a public hearing held on 7 September 1999.

A brief summary of issues discussed at the hearing is provided below.

### **Premier**

#### ***Funding for the operations of the Council on the Cost of Government***

Mr Carr was questioned about the ongoing funding that has been provided for the operations of the Council on the Cost of Government since the statute under which the Council operated expired on 1 May 1999.

#### ***Remuneration of Professor Bob Walker***

Mr Carr undertook to provide information about the salary paid to Professor Bob Walker, both in his capacity as Chair of the Council on the Cost of Government and as Chair of the Superannuation Administration Corporation.

#### ***Bligh House***

Mr Carr answered questions about the intentions of the Government to move the Council on the Cost of Government from Governor Macquarie Tower to the currently vacant Bligh House.

#### ***Staffing structure of the Council on the Cost of Government***

Mr Carr undertook to provide the Committee with information about the staffing structure of the Council on the Cost of Government.

***Release of the Sixth Report of the Council on the Cost of Government***

The timing of the release of the Sixth Report of the Council on the Cost of Government in December 1998 was discussed.

***Content of the Sixth Report of the Council on the Cost of Government***

Mr Carr was questioned about the content of the Sixth Report of the Council on the Cost of Government.

***Staffing strategy for the Commission for Children and Young People***

Mr Carr provided information about the staffing strategy for the Commission for Children and Young people.

***Role of the Commission for Children and Young People in screening of government and non-government employees***

Mr Carr undertook to provide information about the role of the Commission for Children and Young People in screening of government and non-government employees.

***Independence of the Commissioner for Children and Young People***

Concerns were raised about the independence of the newly appointed Commissioner for Children and Young People, Ms Gillian Calvett, as she has previously worked in the Cabinet Office and as a Ministerial Advisor. Mr Carr informed the Committee that Ms Calvett had been selected by a panel comprising the former Chief Executive of the Children's Hospital, the New South Wales Ombudsman, the Director-General of the Premier's Department and the Deputy Director-General of the Cabinet Office.

***Increase in miscellaneous grants from State Administration Services***

The Committee was provided with information about the increase in the revised 1998/99 budget for miscellaneous grants from the State Administration Services program.

***Drug Summit***

Mr Carr advised that issues associated with possible United Nations or High Court challenges that might arise from moves by the government to allow legal injecting rooms to operate in New South Wales would be addressed in the Government's second reading speech on proposed legislation to be introduced into Parliament shortly.

***Investigation of fraudulently registered parties by the State Electoral Office***

Mr Carr advised the Committee that rather than engage officers to investigate fraudulently registered parties, the Government would prefer to address the issue by amending the Electoral Act.

***Investigation of internet fraud and corruption by the Independent Commission Against Corruption (ICAC)***

Mr Carr undertook to provide the Committee with the public sector guidelines aimed at preventing the misuse of the internet and e-mail within government departments and agencies.

## **Citizenship**

### ***Funding for the Community Relations Commission***

Mr Carr advised that the current allocation for the Ethnic Affairs Commission would be transferred to the new Community Relations Commission, but that no additional funding would be provided for the expanded role of the new entity.

### ***Interpreter and translation services***

The Committee was advised that the 5.8 per cent cut in funding for interpreter and translation services was due to a decreasing demand for government services, arising from an increasing tendency for private sector services to be used.

### ***Role of the Ethnic Affairs Commission / Community Relations Commission***

In response to questions about the role of the Ethnic Affairs Commission and its replacement by the new Community Relations Commission, Mr Carr advised that the primary role of the new Community Relations Commission was the provision of services.

### ***Upgrading of the Ethnic Affairs Commission's leased premises at Ashfield***

Mr Carr undertook to provide information about costs associated with upgrading the Ethnic Affairs Commission's leased premises at Ashfield to meet occupational health and safety and fire safety standards.

### ***Change of name of the Ethnic Affairs Commission***

Concern was expressed by Committee Members about the lack of consultation with ethnic communities about the proposed change of name of the Ethnic Affairs Commission to the Community Relations Commission.

## **Arts**

### ***State Library equity reserves***

The Director-General of the Premier's Department undertook to provide an explanation about why the State Library's equity reserves had decreased from \$2 million in 1998/99 to zero in 1999/2000.

### ***Increase in Art Gallery grants and contributions***

Mr Carr undertook to provide details of gifts and sponsorships provided to the Art Gallery in 1998/99.

### ***Purchase of Greek cup by the Powerhouse Museum***

Mr Carr undertook to provide the Committee with details about the acquisition of a fifth century Greek Cup by the Powerhouse Museum.

## **Treasury, State Development**

The Committee heard evidence from the Hon Michael Egan MLC, Treasurer and Minister for State Development, together with officers of relevant departments and agencies at a public hearing held on 8 September 1999.

A brief summary of issues discussed at the hearing is provided below.

### ***Treasury***

#### ***Increasing State Government revenue***

Mr Egan stated despite decreasing taxes, it was expected that revenue would increase in coming years due to ongoing economic growth.

#### ***Tendering out of Group Homes***

Mr Egan confirmed that Treasury had advised the Minister for Community Services to tender out Group Homes.

#### ***Payroll tax rate reduction***

When questioned about the payroll tax rate, Mr Egan stated that the payroll tax rate was currently set at 6.4 per cent and would be reduced to 6 per cent.

#### ***Cost of public sector redundancies policy***

Mr Egan reaffirmed the government's commitment to a no forced redundancies policy.

#### ***Projected electricity revenue***

Mr Egan indicated that the introduction of a competitive electricity market is expected to draw on the surplus electricity capacity in NSW, which will lead to an increase in revenue.

#### ***Financial position of WorkCover***

Mr Egan indicated that an additional package of reforms is due to be introduced in the current Parliament to address concerns about the financial position of WorkCover.

#### ***Requests by government agencies for additional funding***

While Mr Egan and the Secretary to the Treasury stated they had not received any requests for additional funds, the Treasurer undertook to review whether any requests had been made to Treasury officials.

#### ***Treasury response to the Auditor-General's criticisms***

Mr Egan and the Secretary to the Treasury provided information about changes to accounting procedures.

#### ***Impact of the GST on the State Budget***

Mr Egan indicated that the introduction of the Commonwealth goods and services tax (GST) would impact on the State Budget in a number of ways, with the implementation of various measures staggered up until 2005. Mr Egan advised that states and territories have been assured

by the Commonwealth that 'top up' payments will be provided until full implementation of the GST package in 2004/2005. A number of taxes will be abolished, including the Commonwealth wholesale sales tax, the bed tax in New South Wales and the Northern Territory, financial institutions duty, share transfer duty and debits tax.

***Bad debt collection and debtor management***

Mr Egan advised that he was yet to consider the issue of outsourcing bad debt collection and that he would be "happy to look at" outsourcing debtor management.

***Remuneration and workload of the Chair of the Superannuation Administration Corporation***

The Committee was advised that Professor Bob Walker, Chairman of the Superannuation Administration Corporation, is paid \$52,000 for his work for the Corporation.

***Council on the Cost of Government***

The Council on the Cost of Government was discussed in some detail. Mr Egan indicated that significant effort was made to ensure that Treasury did not duplicate the work of the Council on the Cost of Government and that reference is made to the Council's recommendations when formulating the state budget. The issue of corporate services reform was also discussed.

***Impact of a cap on the number of poker machines on gambling taxes***

The Secretary to the Treasury indicated that a restriction on the number of poker machines would not be expected to change greatly the amount of gambling revenue, as it would merely increase the intensity of use of existing machines.

***Funding for new women's prison***

Mr Egan confirmed that construction of a new women's prison at Windsor is due to commence in 1999 and should be completed in 2002, at a total cost \$42 million.

***NSW fiscal position***

Mr Egan provided the Committee with four pages of written information about the fiscal position in New South Wales, reductions to government taxes, and job increases in New South Wales since 1995. The information provided included details of initiatives to reduce government debt, information about budget surpluses during the period from 1995/96 to 1998/99, and highlighted the State's triple A credit rating.

***State Development***

***Construction of Grahame Park stadium on the Central Coast***

Mr Egan was questioned about the financial assistance provided by the Government through the State and Regional Development Fund for the construction of Grahame Park stadium on the Central Coast.

***Specialist investment and trade advisor for Hong Kong and China***

Mr Egan advised that \$100,000 had been provided in the 1999/2000 budget for an initiative to appoint a specialist investment and trade advisor responsible for sourcing trade and investment opportunities and identifying potential business partners in Hong Kong and China.

***Regional headquarters tax concession program***

The benefits of the regional headquarters tax concession program were discussed.

***Funding for the Federation of Gay Games***

Mr Egan advised that to the best of his knowledge the Government had not provided financial assistance to the winning bid for the Federation of Gay games, to have them held in Sydney.

**The Legislature**

The Committee heard evidence from the Hon Meredith Burgmann MLC, President of the Legislative Council, together with officers of the Parliament at a public hearing held on 14 September 1999.

A brief summary of issues discussed at the hearing is provided below.

***Increase in retained revenue***

Ms Burgmann advised that the \$20,000 increase in the Legislative Council's 1998/99 original and revised budget estimates figures for retained revenue was associated with the trade-in of computers and the sale of old photocopiers.

***Introduction of rental charges for Ministerial offices***

Ms Burgmann advised the Parliament has decided to charge all Ministers rent for their Ministerial offices.

***Consideration of rental charges for media offices***

While stating that there was no current proposal to charge the media rent for the use of office space on level 6 of Parliament House, Ms Burgmann advised the matter was "always under

***Increase in maintenance costs***

Ms Burgmann advised that the increase in the Legislative Council maintenance costs in 1998/99 was associated with changes to accommodation for committee staff on level 8.

***Formal opening of Parliament on 7 September 1999***

Ms Burgmann was asked a number of questions about the formal opening of Parliament on 7 September 1999. Ms Burgmann advised that the preliminary estimate for the cost of the opening was \$15,830, and this was approximately half that of the net cost of the last formal openings. Ms Burgmann also provided information about the number of guests attending the opening and various decisions about the arrangements on the day.

***Occupational health and safety issues and Parliament House office accommodation***

The adequacy of certain office accommodation in Parliament House, including that of staff in the President's office and of the media, was discussed.

***Transfer of Legislative Council Members from level 12 to level 11***

Ms Burgmann indicated that the transfer of Legislative Council Members from level 12 to level 11 of Parliament House in 1998/99 was for both occupational health and safety and practical reasons, with the total cost of the transfer amounting to \$662,039.

***Conversion of offices after the 1999 State Election***

Ms Burgmann advised that the total cost of converting existing Legislative Council offices for use by staff of cross bench and independent Members after the 1999 State Election was \$139,989. Ms Burgmann undertook to provide additional information about how much of this work actually undid some of the previous work associated with the transfer of Members from level 12 to level 11.

***Legal costs relating to Egan v Willis and Egan v Chadwick and others***

The Committee was advised that the cost of legal advice and representation to the President and Officers of the Legislative Council for the matters of *Egan v Willis* and *Egan v Chadwick and others*, Ms Burgmann in 1998/99 was \$100,076.

***Installation of listening devices (bugs) in Parliamentarians' offices***

Ms Burgmann advised she had never given, and would never give, approval for any listening device to be installed in Parliament.

***Cost and adequacy of Parliament House security***

Ms Burgmann advised that the Legislature employees 12 security staff, and has an additional 3.5 contract staff, at a cost of approximately \$1 million per annum. Ms Burgmann indicated she is involved in ongoing discussions about the adequacy of security with the Speaker of the Legislative Assembly.

***Study assistance for Legislative Council employees***

In response to questioning, Ms Burgmann assured the Committee that study assistance continued to be available to employees of the Legislative Council.

***Resources for the General Purpose Standing Committees***

Ms Burgmann provided information about levels of resources, particularly staff resources, for the Legislative Council's General Purpose Standing Committees.

***Public entry to Parliament House***

Concerns were raised about the perceived accessibility of Parliament House to the general public and tourists.

***Advertisement of Legislative Council sitting times***

An explanation was provided as to why the Legislative Council sitting times no longer appear in the *Daily Telegraph*.

***Changes to sitting hours***

The Legislature's intentions in relation to changes of current sitting patterns were discussed, specifically whether sitting hours might be brought into line with normal business hours, resulting in family-friendly hours and budget savings.

***Impact of possible reduction in the number of Members of the Legislative Council***

Ms Burgmann expressed concern that a reduction in the number of Members of the Legislative Council would limit the ability of the Upper House to undertake committee work.

***Impact of revaluation of Parliament House building on 1998/99 budget result***

Ms Burgmann advised that revaluation of the Parliament House building to an amount \$26 million less than the previous valuation was the primary reason why the Legislature's 1998/99 budget was exceeded by \$27.8 million.

***Impact of budget cuts on the Parliamentary Library***

The Committee was advised that the \$90,000 cut to the Parliamentary Library's budget would be achieved by efficiencies resulting from information technology initiatives and staff salary savings.

***Value of Parliamentary Library heritage items***

When asked about the value of the Parliamentary Library's heritage items, Ms Burgmann advised that these items had been recently valued at \$11.1 million.

***Disposal of publications not required by the Parliamentary Library***

The Parliamentary Librarian provided an account of the Library's use of Bibliocity, an Internet network, to advertise and sell surplus publications.

***Availability of storage in the Parliamentary Library***

The Parliamentary Librarian provided information about a number of measures that were being undertaken to ensure adequate space was provided for required publications.

***Access to ethnic newspapers***

While the Parliamentary Library was praised for its initiative in recent years to provide parliamentarians access to ethnic newspapers, a concern was raised about the delays associated with flattening of the newspapers prior to their being made available.

***ICAC investigation relating to Parliamentarians' travel***

Ms Burgmann advised that ICAC had completed certain aspects of its investigation relating to travel of Members of the Legislature but that these investigations were continuing.

***Damage to antique chairs located in the President's dining room***

A number of questions were asked about damage sustained by antique chairs that are ordinarily located in the President's dining room. Ms Burgmann advised damage was solely due to normal wear and tear and the style of construction of the chairs.

***Impact of overdue House Committee Accounts on the Legislature's cash flow***

Ms Burgmann advised that there were no concerns about overdue House Committee accounts impacting on the cash flow of the Legislature, and advised that a 24 per cent interest rate was charged on outstanding accounts.

***Decrease in costs associated with Members' salaries***

Ms Burgmann advised that while provision had been made in the original 1998/99 budget for a salary increase for Members, the salary increase had not occurred.

***Legislative Assembly expenditure***

Some Members of the Committee expressed concern that, given that the Speaker and Officers of the Legislative Assembly were not in attendance at the hearing, they were unable to ask questions about the operations of the Legislative Assembly.

The Committee notes that Members and Officers of the Legislative Assembly can not be compelled to appear before a Legislative Council Committee.<sup>7</sup> While the Speaker and Officers of the Legislative Assembly were not specifically invited to attend the hearing, the Committee is aware of the Speaker's past reluctance to allow the Financial Controller to give evidence before an Estimates Committee.<sup>8</sup> This would suggest it is unlikely that the Speaker would have attended the hearing, or allowed any officer of the Legislative Assembly to attend, if invited.

The Committee highlights this issue to ensure that it is understood that its ability to scrutinise the Legislature's Budget Estimates was constrained by its inability to ask questions about expenditure by the Legislative Assembly. The House as a whole may wish to further consider how the Legislative Assembly's Budget Estimates might be scrutinised in the future.

## **Education and Training**

The Committee heard evidence from the Hon John Aquilina MP, Minister for Education and Training, together with officers of the relevant department at a public hearing held on 15 September 1999.

A brief summary of issues discussed at the hearing is provided below.

### ***Introduction of the new Higher School Certificate***

Concerns were raised with Mr Aquilina about the cost to schools of the new Higher School Certificate (HSC).

### ***Disposal of surplus school and TAFE sites***

Mr Aquilina was questioned about departmental policy relating to the disposal of surplus school and TAFE sites, with particular reference to the St Ives Chase Public School site at Warrimoo Avenue.

### ***School security***

Mr Aquilina was asked a number of questions relating to school security, with a particular emphasis on accountability mechanisms for security firms who are contracted to provide security services to schools. A concern was raised about the possibility that a former government employee involved in the tender process had subsequently taken up employment with a security firm that had secured a tender.

### ***Screening mechanisms for employees at non-government schools***

Mr Aquilina advised that the Department of Education and Training would have responsibility for screening employees only at government schools, and the Children's Services Commission would undertake this responsibility for non-government schools.

### ***Operation of TAFE Colleges***

The Committee asked a series of questions about the operation of TAFE colleges, including the impact of staff cuts. Mr Aquilina indicated that individual colleges were responsible for determining appropriate class sizes, and for determining what courses are offered, based on local demands.

### ***Decrease in staffing for secondary schools***

Mr Aquilina indicated a decrease in staffing by 66 FTEs did not relate specifically to teaching positions, but reflected a combination of teaching, school support and non-teaching administrative staff.

### ***Matters associated with a call for salary increases for teachers***

In response to questions about the call by the New South Wales Teachers' Federation for salary increases for teachers, Mr Aquilina stated that negotiations are continuing in relation to mechanisms for the removal of inefficient and incompetent teachers.

***Commonwealth Enrolment Benchmark Adjustment (EBA) policy***

Concerns were raised with Mr Aquilina about the impact of the Commonwealth Government's Enrolment Benchmark Adjustment (EBA) policy on funding for non-government schools.

***Attendance of politicians at school openings***

Mr Aquilina acknowledged that while he had been concerned about the appropriateness of State back benchers representing the Commonwealth Minister at school openings, this matter had now been resolved.

***Casual teacher shortages***

Concerns were raised about the difficulties some schools have in obtaining casual teachers to cover short-term staff absences.

***Community language schools***

The issue of funding for community language schools in New South Wales was discussed.

***Funding for ESL (English as a second language) teachers***

Mr Aquilina advised the Committee that funding for non-English speaking background programs will be reduced from \$85.760 million to \$80.860 million, primarily due to Commonwealth funding cuts.

***Adult Migrant English Service***

Mr Aquilina advised that changes to the composition of the migration humanitarian programs in 1997/98 had reduced the levels of need for adult migrant English service and consequently over 360 redundancies have been offered to staff in this area.

***St George campus***

Mr Aquilina was asked a number of questions about the use of the St George campus site and the Trinity Grammar School lease.

***Special Minister of State***

The Committee heard evidence from the Hon John Della Bosca MLC, Special Minister of State, together with officers of relevant departments and agencies at a public hearing held on 16 September 1999.

A brief summary of issues discussed at the hearing is provided below.

***Role of the Special Minister of State***

Given the unique nature of the position of Special Minister of State, Mr Della Bosca was asked a number of questions about his role.

***Review of the Motor Accidents Authority (MAA)***

Mr Della Bosca provided information about the cost and outcomes of the review of the MAA.

### ***Green Slips***

The Government's initiative to reduce the cost of Green Slips in New South Wales was discussed, with Mr Della Bosca providing information about the measures that have been put in place to achieve savings.

### ***Road safety and the MAA***

In response to questioning about the road safety role of the MAA, Mr Della Bosca provided information about the MAA's Road Safety Strategy.

### ***Upper House reform***

Mr Della Bosca indicated that the legislation relating to Upper House reform would be introduced in the current session of Parliament, and that he hoped to include a mechanism to improve the transparency of preference allocations for voters.

### ***Drug Summit***

Mr Della Bosca advised the Committee that he is Chair of the Cabinet Committee responsible for formulating the Government's response to the recommendations of the Drug Summit, and the Parliament would be advised of that response shortly.

## **Olympics**

The Committee heard evidence from the Hon Michael Knight MP, Minister for the Olympics, together with officers of relevant departments and agencies at a public hearing held on 15 October 1999.

A brief summary of issues discussed at the hearing is provided below.

### ***Olympic-related expenditure by other departments***

The Committee questioned the Minister about Olympic-related expenditure by other departments. The Minister indicated the issue was complicated by a number of factors, including historical anomalies and the status of venues after the Olympics.

### ***Premium packaging of Olympic tickets***

The Minister was asked a series of questions relating to arrangements for the sale of premium tickets at prices above those paid by participants in the ballot process.

The Minister confirmed that ticket packages had been sold to the Tattersalls Club for prices considerably above face value, and that similar arrangements had been, and continue to be, negotiated with various other organisations and individuals. In response to a request for the names of companies other than Tattersalls who have been offered premium ticket packages, the Minister stated:

... I would be reticent to say that we will publicly name everyone who buys a premium ticket  
... because that may have a negative impact on the selling process.

The Chief Executive of the Sydney Organising Committee for the Olympic Games (SOCOG), Mr Sandy Hollway, was asked to confirm that approximately 250,000 tickets (or around five per cent of the approximately five million tickets available) had been set aside for premium sales. In response, Mr Hollway stated:

Yes, subject to my checking and correcting if that is wrong ...

The Committee was told that sales of premium tickets were an essential part of the ticketing strategy for the Olympic games, and helped to cross-subsidise initiatives such as the Olympic Opportunity program.

#### ***On-selling of Olympics tickets by international organisations***

In response to questioning, the Minister confirmed there was an obligation to provide a certain number of Olympic tickets to the various national Olympic Committees throughout the world, and while there were suspicions that some countries on-sold these tickets, it was impossible to stop this from occurring.

#### ***Allocation of Olympic tickets through the ballot process, and subsequent allocation rounds***

The Committee asked a number of questions about the allocation of Olympic tickets through the first-round ballot process, and proposed mechanisms for further allocation of tickets. The Committee was provided with a considerable amount of information about the mechanisms that were used to allocate tickets during the first round. The Minister indicated that the SOCOG board was likely to make a decision about mechanisms for subsequent rounds of ticket allocations no later than Thursday 21 October 1999.

#### ***Olympic Opportunity tickets***

In response to questioning about tickets set aside for low-income earners, the Minister advised that 1½ million tickets, priced between \$10 and \$19, had been set aside for the Olympic Opportunity initiative and that these tickets will be distributed through school and community organisations. The Committee was advised that Olympic Opportunity tickets will not be available for the opening and closing ceremonies, and was provided with information about sporting events for which it is proposed that these tickets be available. The Chief Executive of SOCOG confirmed that 30,000 of the tickets set aside for the Olympic Opportunity initiative had been inadvertently allocated through the first-round ballot process.

#### ***Contingency arrangements for power-black outs during the Olympics***

The Committee was advised that contingency plans have been put in place in case of power black-outs, including the provision of back-up generator facilities at the Olympic Park site. In addition, the power substation, which has been especially built for the Olympics, has been upgraded to provide reserve capacity in case it is required.

#### ***Surplus Funds***

The Minister was questioned about the level of surplus funds that may be generated by the Sydney Olympics. The Minister provided detail about the contract with the International Olympic Committee and the Australian Olympic Committee for payment of funds to these organisations, and indicated that it was expected that the remaining surplus funds, which are to be paid to the New South Wales Government, would total around \$30 million.

---

***Radio handsets***

In response to questioning about the purchase of 10,000 radio handsets for the Olympics, the Minister advised that these handsets will be used after the Olympics in the upgrade of the government radio network.

***Ryde pool***

The Committee was provided with information about construction progress of the new swimming pool facilities at Ryde, which are to be used during the Olympics. The Minister indicated that the project would be completed by April 2000.

***Ceremonial planting of olive trees***

The Minister undertook to provide the Committee with information about a recent ceremonial planting of olive trees.

***Ministerial travel***

The Minister was questioned about overseas travel he undertook in July 1998, with particular reference to a visit to Lake Powell, near Salt Lake City. The Minister advised that the Olympic Coordinating Committee paid for the cost of his accommodation during a weekend visit to Lake Powell, but the cost of this accommodation was less than the cost of accommodation in Salt Lake City.

***Olympic construction budget***

The Minister provided information about the cost of construction venues in the Olympic Coordination Authority budget.

***Environmental aspects of Olympic sites construction***

In response to a question about the environmental aspects of the Homebush Bay site, the Minister indicated that considerable work had been undertaken to rehabilitate the site.

***Bondi Beach volleyball site***

The Committee was advised of changes that have been made to the design of the Olympic beach volleyball stadium, which will be located at Bondi Beach, to accommodate local community concerns.

***Impact of sponsorship arrangements on media access to Olympic news***

The Minister provided information about the impact of sponsorship arrangements with specific media outlets on the release of Olympic-related news to the general media.

***Status of Olympic Coordination Authority after the Olympics***

In response to a question about the future of the Olympics Coordination Authority after the Olympic games, the Minister advised that decisions still needed to be taken about the future management of some public venues.

### ***Bus 2000***

The Committee was provided with information about the Bus 2000 initiative, which is aimed at coordinating the services of professional bus operators to provide transport during the Olympics.

### ***Accommodation tariffs for visitors during the Olympics***

The Minister indicated that while there was an agreement in place with the peak hotel and motel associations to regulated accommodation tariffs during the Olympics period, the government was unable to enforce this agreement.

### **General issue**

A notable change from past Budget Estimates hearings was the decision of Government Members to refrain from asking questions during the Budget Estimates hearings this year. While it is understood this decision was made to expedite the hearings process, it is noted that in the past, even where questions from Government Members were anticipated by the relevant Minister, these questions provided valuable information about the budget. It is hoped that the involvement of Government Members in the questioning process is restored in future Estimate Committee hearings, where possible.

### **Questions on notice**

The Committee received responses to a number of questions placed on notice prior to the Budget Estimates hearings. Copies of these responses are to be tabled in the Legislative Council in a separate volume.

The Committee has set Tuesday, 26 October 1999 as the date by which all Ministers, except the Minister for the Olympics, should respond to questions placed on notice at, or after, the hearing. Responses to these questions will be tabled in the Legislative Council once they are received. The deadline set for the Minister for the Olympics is 12 noon on Friday, 29 October 1999

### **Supplementary hearings**

The Committee has not set a date for supplementary hearings at this stage.

9. A daily Hansard record of the hearings of a Committee on the Budget Estimates is to be published as soon as practicable after each day's proceedings.
10. The Committees have leave to sit during the sittings or any adjournment of the House.
11. After a Committee has considered proposed expenditure referred to it by the House and agreed to its report to the House, the Committee must fix:
  - (a) a day for the submission to the Committee of any written answers or additional information relating to the proposed expenditure, and
  - (b) a day for the commencement of supplementary meetings of the Committee to consider matters relating to the proposed expenditure, which day must be not less than 10 days after the day fixed under subparagraph (a).
12.
  - (1) A Member may lodge with a Committee, not less than 3 working days before the day fixed under subparagraph (11) (b), notice of matters relating to the written answers or additional information, or otherwise relating to the proposed expenditure referred to the committee, which the Member wishes to raise at the supplementary meetings of the Committee.
  - (2) Any notice lodged with a Committee must be forwarded by the Committee to the Minister in the House responsible for the matters to which the notice relates.
13. A Committee may determine at any time the number and duration of any supplementary meetings.
