A four car Millennium train (M2) was retained out of service for investigation of a Train Operating System fault on 5 August 2003.

Following wiring testing, software upgrades and track trials, this was rectified and the train returned to service on 2 September 2003.

The StateRail website has been updated to reflect this information.

Why have so many key areas within the Millennium train web site not been updated since August (Hansard page 13)?

Airport Link was originally proposed as a private sector no cost to government initiative by the Coalition Government. The Carr Government contributed around \$700 million to the project after the private sector proposal was unable to be sustained.
