The Selection of Bills Committee met on Tuesday 16 June 2020 at 1.18 pm to consider whether the following bills be referred to a standing committee for inquiry and report.

- Constitution Amendment (Water Accountability and Transparency) Bill 2020
- (Crimes Amendment (Special Care Offences) Bill 2020
- Mental Health and Cognitive Impairment Forensic Provisions Bill 2020
- Personal Injury Commission Bill 2020
- Transport Administration Amendment (International Students Travel Concessions) Bill 2020
- Building Amendment (Mechanical Services and Medical Gas Work) Bill 2020
- Rural Fires Amendment (NSW RFS and Brigades Donations Fund) Bill 2020
- Water Management Amendment (Transparency of Water Rights) Bill 2020
- Water Management Amendment (Water Allocations—Drought Information) Bill 2020
- Law Enforcement Conduct Commission Amendment Bill 2020.

The committee makes the following recommendations:

- (1) That:

  - (b) the Constitution Amendment (Water Accountability and Transparency) Bill 2020 be referred to the committee upon receipt of the message from the Legislative Assembly,
  - (c) the provisions of the Water Management Amendment (Transparency of Water Rights) Bill 2020 be referred to Portfolio Committee No. 4 – Industry for inquiry and report,
  - (d) the resumption of the second reading debate on the Water Management Amendment (Transparency of Water Rights) Bill 2020 not proceed until the tabling of the committee report,
  - (e) the committee report by Friday 31 July 2020, and
  - (f) on the report being tabled a motion may be moved immediately for the first reading and printing of the Constitution Amendment (Water Accountability and Transparency) Bill 2020.
- (2) That:
  - (a) the provisions of the Rural Fires Amendment (NSW RFS and Brigades Donations Fund) Bill 2020 be referred to Portfolio Committee No. 5 – Legal Affairs for inquiry and report,
  - (b) the resumption of the second reading debate on the Rural Fires Amendment (NSW RFS and Brigades Donations Fund) Bill 2020 not proceed until the tabling of the committee report,
  - (c) the committee report by Friday 31 July 2020.

- (3) That the following bills not be referred to a standing committee for inquiry and report, this day:
- (a) Crimes Amendment (Special Care Offences) Bill 2020
  - (b) Mental Health and Cognitive Impairment Forensic Provisions Bill 2020
  - (c) Personal Injury Commission Bill 2020
  - (d) Transport Administration Amendment (International Students Travel Concessions) Bill 2020
  - (e) Building Amendment (Mechanical Services and Medical Gas Work) Bill 2020
  - (f) Water Management Amendment (Water Allocations - Drought Information) Bill 2020
  - (g) Law Enforcement Conduct Commission Amendment Bill 2020.
