Terms of reference

- 1. That a select committee be established to inquire into and report on the conduct of elections under COVID-19 conditions by the NSW Electoral Commissioner, including the local government elections held on 4 December 2021 and the four New South Wales by-elections held on 12 February 2022, with particular reference to the appropriateness of similar settings in a general election, including:
 - (a) the COVID-19 restrictions that were in place for the conduct of these elections and any implications that had for the conduct of the elections,
 - (b) the issuing of postal votes in both elections to all registered voters in the four New South Wales by-elections and the rationale for doing so, the administrative arrangements and processes employed to support this, and any implications for the conduct of the elections,
 - (c) the adequacy or otherwise of material alerting voters to the upcoming by-elections and explanatory information provided in languages other than English,
 - (d) the use of the iVote system in the local government elections, the performance of that system and its implications, and future arrangements for use of the iVote system, including the possibility of a replacement software system, and
 - (e) any other related matter.

The terms of reference were referred to the committee by the Legislative Council on 11 May 2022.¹

Inquiry into the conduct of elections in New South Wales

Chair's foreword

This report provides a brief summary of the commencement of the inquiry into the conduct of elections in New South Wales, before the inquiry was discontinued in late September 2022. The evidence received during the Budget Estimates hearing of Portfolio Committee No. 1 – Premier touched on many aspects of the inquiry, particularly how future state and local government elections will be conducted by the NSW Electoral Commission, obviating the need for this inquiry.

On behalf of the committee, I would like to thank the stakeholders who made submissions to the inquiry, as well as my fellow committee members and the secretariat staff for their work throughout the inquiry process.

Conduct of inquiry

The terms of reference for the inquiry were referred to the committee by the Legislative Council on 11 May 2022.

The committee received 22 submissions.

These submissions are available on the committee's website.

Chapter 1 Background

This chapter provides an overview of the inquiry into the conduct of elections in New South Wales, including issues raised by the terms of reference and evidence received from the NSW Electoral Commissioner during the Budget Estimates hearings in September 2022.

Conduct of the inquiry

- 1.1 On 11 May 2022 the Legislative Council established a select committee to inquire into and report on the conduct of elections under COVID-19 conditions by the NSW Electoral Commissioner, including the local government elections held on 4 December 2021 and the four New South Wales by-elections held on 12 February 2022, with particular reference to the appropriateness of similar settings in a general election, including:
 - a. the COVID-19 restrictions that were in place for the conduct of these elections and any implications that had for the conduct of the elections,
 - b. the issuing of postal votes in both elections to all registered voters in the four New South Wales by-elections and the rationale for doing so, the administrative arrangements and processes employed to support this, and any implications for the conduct of the elections,
 - c. the adequacy or otherwise of material alerting voters to the upcoming by-elections and explanatory information provided in languages other than English,
 - d. the use of the iVote system in the local government elections, the performance of that system and its implications, and future arrangements for use of the iVote system, including the possibility of a replacement software system, and
 - e. any other related matter.²
- 1.2 Submissions to the inquiry closed on 15 July 2022, with 22 stakeholders providing submissions.
- 1.3 The terms of reference cited above raised various issues, including:
 - legislative changes to local and State electoral laws throughout 2021 and 2022, in response to the COVID-19 pandemic
 - the expansion of postal vote eligibility in local government elections in 2021 to include electors who were self-isolating or electors who believed that attending a venue on election day would pose a risk to health and safety
 - the use of iVote in local government elections for the first time and the disruption to the system on election day
 - the subsequent proceedings brought by the NSW Electoral Commissioner in NSW Electoral Commissioner v Kempsey Shire Council (No 2)³

- the decision to issue postal vote packs to all electors in the electorates of Bega, Monaro, Strathfield and Willoughby for the State by-elections held on 4 February 2022
- the adequacy of advertising and awareness campaigns held to inform electors of these by-elections.
- 1.4 The committee notes that these issues were ventilated, at least in part, during the Budget Estimate hearing of Portfolio Committee No. 1 Premier on Monday 7 September 2022. Issues addressed in the evidence of the NSW Electoral Commissioner during this hearing included:
 - funding received by the NSW Electoral Commission in the 2022-23 State Budget for the conduct of future elections
 - the challenges posed by some of the aging electoral systems used by the Electoral Commission
 - the likelihood of future State elections being conducted entirely by postal vote
 - the discontinuation of iVote
 - voting options for blind and low-vision voters
 - an upcoming review of technology assisted voting in New South Wales
 - the effect of the decision of the NSW Supreme Court in NSW Electoral Commissioner v Kempsey Shire Council (No 2).
- 1.5 In light of the evidence received in Budget Estimates in September 2022, the committee resolved not to proceed with the inquiry.
- 1.6 The committee thanks those stakeholders who made a submission to this inquiry.

The committee noted the following resolution of the House establishing the committee, which reads as follows:

- That a select committee be established to inquire into and report on the conduct of elections under COVID-19 conditions by the NSW Electoral Commissioner, including the local government elections held on 4 December 2021 and the four New South Wales by-elections held on 12 February 2022, with particular reference to the appropriateness of similar settings in a general election, including:
 - (a) the COVID-19 restrictions that were in place for the conduct of these elections and any implications that had for the conduct of the elections,
 - (b) the issuing of postal votes in both elections to all registered voters in the four New South Wales by-elections and the rationale for doing so, the administrative arrangements and processes employed to support this, and any implications for the conduct of the elections,
 - (c) the adequacy or otherwise of material alerting voters to the upcoming by-elections and explanatory information provided in languages other than English,
 - (d) the use of the iVote system in the local government elections, the performance of that system and its implications, and future arrangements for use of the iVote system, including the possibility of a replacement software system, and
 - (e) any other related matter.
- (2) That, notwithstanding anything to the contrary in the standing orders, the committee consist of six members comprising:
 - (a) two government members,
 - (b) two opposition members, and
 - (c) two crossbench members, one being Mr Borsak.
- (3) That the Chair of the committee be Mr Borsak.
- (4) That, unless the committee decides otherwise:
 - (a) submissions to the inquiry are to be published, subject to the Committee Clerk checking for confidentiality and adverse mention and, where those issues arise, bringing them to the attention of the committee for consideration,
 - (b) the Chair's proposed witness list is to be circulated to provide members with an opportunity to amend the list, with the witness list agreed to by email, unless a member requests the Chair to convene a meeting to resolve any disagreement,

- (c) the sequence of questions to be asked at hearings is to alternate between government, opposition and crossbench members, in order determined by the committee, with equal time allocated to each,
- (d) transcripts of evidence taken at public hearings are to be published,
- (e) supplementary questions are to be lodged with the Committee Clerk within two days, excluding Saturday and Sunday, following the receipt of the hearing transcript, with witnesses requested to return answers to questions on notice and supplementary questions within 21 calendar days of the date on which questions are forwarded to the witness, and
- (f) answers to questions on notice and supplementary questions are to be published, subject to the Committee Clerk checking for confidentiality and adverse mention and, where those issues arise, bringing them to the attention of the committee for consideration.
