- (3) That for the purposes of the 2022-2023 initial budget estimates hearings:
 - (a) each portfolio, except The Legislature, be examined concurrently by Opposition and Crossbench members only, from 9.30 am to 11.00 am, and from 11.15 am to 12.45 pm, then from 2.00 pm to 3.30 pm, and from 3.45 pm to 5.15 pm, with 15 minutes reserved for Government questions at the end of the morning and afternoon session, if required,
 - (b) the portfolio of The Legislature be examined concurrently by Opposition, Crossbench and Government members from 9.30 am until 12.30 pm.
- (4) That, further to the resolution of the House of 16 November 2021 adopting the 2022 sitting calendar, the 2022-2023 supplementary budget estimates hearings be held over five days from 24 October to 28 October 2022.
- (5) That for the purposes of the 2022-2023 initial and supplementary budget estimates hearings:
 - (a) the committees must hear evidence in public,
 - (b) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure,
 - (c) ministers be invited to appear for the morning sessions only unless requested by committees to appear also for the afternoon session,
 - (d) witnesses, including ministers, may not make an opening statement before a committee commences questions,
 - (e) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following a hearing, and
 - (f) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.
- (6) That the committees present a final report to the House by 23 December 2022.

On 21 September 2022, the Budget Estimates resolution and schedule, as it relates to the Corrections hearing, was varied by the House as follows²:

- (1) That this House notes that:
 - (a) on Wednesday 22 June 2022, the House adopted a schedule of initial budget estimates hearings for 2022-2023 over 13 working days from Monday 22 August to Wednesday 7 September 2022, and
 - (b) the following hearing was unable to be conducted as scheduled by Portfolio Committee No. 5 Regional NSW and Stronger Communities due to the unavailability of the Minister:

Day Six: Monday 29 August 2022 PC 5 Corrections

(2) That in view of the inability of Portfolio Committee No. 5 – Regional NSW and Stronger Communities to conduct this hearing, the committee be authorised to undertake the hearing on a date of its choosing under the same arrangements as originally agreed to by the House on Wednesday 22 June 2022.

The key evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2022-2023

- 1.1 On 16 November 2021 and 22 June 2022, the Legislative Council resolved that hearings for Budget Estimates 2022-2023 be held over 13 days from 22 August to 7 September 2022, and supplementary hearings be scheduled over five days from 24 to 28 October 2022.³
- 1.2 The Budget Estimates resolution and schedule was subsequently agreed to by the House on 22 June 2022, referring the Budget Estimates and related papers for the 2022-2023 financial year to the Portfolio Committees for inquiry and report by Friday 23 December 2022.⁴
- 1.3 Following changes to the administration of the government, the hearing schedule was amended by the House on 10 August 2022 to reflect the changed ministerial responsibilities.⁵
- On 21 September 2022, the Budget Estimates resolution and schedule was further varied by the House to facilitate the postponement of the initial hearing of Portfolio Committee No. 5 Regional NSW and Stronger Communities into the Corrections portfolio, due to the unavailability of the Minister.⁶
- 1.5 The budget estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Attorney General

- A hearing examining the portfolio of Attorney General was held on Monday 22 August 2022. The following issues were raised during the committee's examination of this portfolio:
 - Response to Operation Tusket
 - Bail law reforms
 - Coercive control laws
 - Age of criminal responsibility
 - Response to Special Commission of Inquiry into the drug 'Ice'
 - Backlog of cases before the courts.

Families and Communities, Disability Services

- A hearing examining the portfolios of Families and Communities, Disability Services was held on Tuesday 30 August 2022. The following issues were raised during the committee's examination of these portfolios:
 - Child protection matters, including:
 - intervening in Family Court orders
 - at-risk reports
 - Provision of out-of-home care, including from non-government organisations
 - Family Is Culture' report recommendation implementation update
 - response to the 'Voices of Children and Young People in Out-of-Home Care 2021' report
 - Social housing, including accessibility, wait lists, evictions and transitioning out of social housing, leasing subsidies and programs, homelessness services and programs
 - The increase in youth crime, the increase in the representation of First Nations children in detention, and the increase in the number of children held on remand
 - Youth justice programs, including 'A Place to Go', 'Youth on Track', youth detention centres' practices and safety measures
 - Data collection by the Department and transparency of that data to the public and Parliament
 - Response to the Northern New South Wales floods in 2022, including evacuation centres, temporary accommodation, and housing solutions

 NSW Ageing and Disability Commission, including funding of the Commission and its Official Community Visitor program, disability services and facilities at Tomaree Lodge and Stockton Centre.

Deputy Premier, Regional New South Wales, Police

- 2.3 A hearing examining the portfolios of Deputy Premier, Regional New South Wales, Police was held on Wednesday 31 August 2022. The following issues were raised during the committee's examination of these portfolios:
 - Operation of the Future of Coal framework
 - Cybersecurity issues in regional New South Wales and the NSW Government response
 - Use of drone technology in regional New South Wales
 - Review of customer service at the Firearms Registry
 - NSW Police implementation of protest laws at various protest events
 - Role of the Firearms Registry regarding the inquest into the deaths of John, Jack and Jennifer Edwards
 - Issues relating to the operation of the Child Offenders Register
 - Recommendations made by the Law Enforcement Conduct Commission regarding strip searches, and the status of the implementation of these recommendations
 - Implementation of recommendations made by the Special Commission of Inquiry into the drug 'Ice'
 - Money laundering in New South Wales casinos
 - Critical minerals strategy and exploration in New South Wales
 - Functions of the Northern Rivers Reconstruction Corporation
 - Instances of needle and drink spiking in Newcastle, and any relevant NSW Police response
 - Potential legislation regarding encrypted devices.

Multiculturalism, Seniors

- A hearing examining the portfolios of Multiculturalism, Seniors was held on Thursday 1 September 2022. The following issues were raised during the committee's examination of these portfolios:
 - Funding arrangements for the NSW Ageing and Disability Commission
 - Aged Crime Prevention Officers
 - NSW Growing Regions of Welcome (GROW) pilot program
 - NSW Religious Communities Advisory Council

- Anti-racism strategies
- Diversity of NSW Government workforce.

Emergency Services and Resilience, Flood Recovery

- A hearing examining the portfolios of the Emergency Services and Resilience, Flood Recovery was held on Friday 2 September 2022. The following issues were raised during the committee's examination of these portfolios:
 - Recommendations of the Australian Transport Safety Bureau report into the large air tanker crash that killed three Americans on 23 January 2020 during Black Summer fire operations
 - Implementation of recommendations from reports into the 2022 NSW Floods and the readiness of the emergency services for large scale floods
 - Data on bullying complaints and complaints handling in the emergency services
 - Workers compensation injuries and mental health in the emergency services
 - Placement and planning of fire and rescue services in response to demographic changes
 - Future of Resilience NSW, including the role of Mr Shane Fitzsimmons.

Corrections

- 2.6 A postponed hearing examining the portfolio of Corrections was held on Monday 24 October 2022. The following issues were raised during the committee's examination of this portfolio:
 - Operation and conditions of correctional facilities, including impact of current flooding events, contraband in prisons, Goulburn Correctional Centre, and impacts of and response to COVID-19
 - Inspection of New South Wales prisons by United Nations OPCAT inspectors
 - Infrastructure strategy and projects, and minimum standards in prisons
 - Corrections employees, including staffing and recruitment, workplace complaints of sexual harassment and bullying, workers compensation claims, violence in prisons, and People Matter survey results
 - Aboriginal people in custody, including Closing the Gap supports and policy responses, prevention and support programs, and rates of incarceration
 - Deaths in custody
 - Safety and welfare issues relating to inmates, including violence in prisons, access to medical services and support, prisoners with disability or additional medical needs, and Emu Plains Mother and Babies Unit
 - Rehabilitation programs, recidivism, orders and parole.
