

Chair's foreword

On 24 November 2022, the Minister for Local Government, the Hon Wendy Tuckerman MP, wrote to me in my capacity as Chair of the Standing Committee on State Development to request an inquiry into allegations of impropriety made against agents of the City of Canterbury Bankstown Council and the previous City of Bankstown Council. The Minister referred terms of reference which were adopted by the committee on 29 November 2022.

This inquiry has been integral to unearthing numerous issues with the administration and leadership of the Canterbury Bankstown Council. The committee found that the close relationships between Councillors and property developers in the Canterbury Bankstown area may have influenced planning instruments and the positioning of infrastructure across the Council area. The committee regards this as a highly concerning and serious matter and has therefore recommended in this report that the committee refer these concerns to the Independent Commission Against Corruption.

Evidence to the inquiry also uncovered that property developers may be using shell companies to obfuscate their political donations to candidates for local government elections in order to sidestep the ban on political donations from property developers. The committee recommends that the NSW Government review the potential for candidates in local government elections to receive funds from property developers through shell companies, as well as from third party lobbying firms.

Another key issue which came to light during the inquiry was Councillors' entitlements. This was a result of the Council providing, in response to requests from the committee, thousands of pages of Councillors' expenses claims over many years. The Council's reimbursements of the Mayors' expenses for designer suits, a spa treatment on an overseas Council-funded trip, and his attainment of a Master of Business Administration are out of step with the community's expectations. The committee recommends that the Office of Local Government review the Guidelines for the payment of expenses and provision of facilities to Mayors and Councillors in New South Wales to ensure that they align with community expectations.

A separate issue which came to light through the committee's examination of documents requested from the Council is need for a requirement to disclose pecuniary interests relating to overseas and interstate property. The committee therefore recommends that the Office of Local Government review the Model Code of Conduct for Local Councils in New South Wales to ensure that the obligation to disclose pecuniary interests extends to overseas and interstate property interests.

In addition, the committee was troubled to discover that the Council misused Council resources to assist a NSW Labor candidate by releasing a media statement regarding Councillor Asfour's withdrawal as a candidate for election to the NSW Legislative Council in 2023. Councils should and must remain independent from supporting the political aspirations of any Councillor.

As I have noted already, the Council provided thousands of documents over several months on a voluntary basis. However, the timeframe in which documents were provided delayed the committee's capacity to examine them. In addition, key officers of the Council's executive leadership team appeared in mid-February 2023, despite having been first invited to appear at hearings as early as mid-December 2022.

The committee's examination of the issues has not been able to be as effective as it could have been if we had earlier access to information and evidence from key inquiry participants. The committee's capacity to investigate alleged impropriety has consequently been hindered, with the looming suspension of Legislative Council business from 3 March 2023 in the lead up to the State election. It follows that the

committee recommends that the inquiry be re-established in the next Parliament to continue the examination commenced by this committee.

On behalf of the committee, I would like to thank all those who participated in the inquiry. I also thank my committee colleagues for their contributions, and the secretariat and Hansard for their assistance.

I commend this report to the House.

Findings

Finding 1 9

There is evidence that Councillors of the City of Canterbury Bankstown Council have close relationships with property developers in the area. Furthermore, this has a strong potential to have influenced planning instruments and the positioning of infrastructure across the Canterbury Bankstown Council area.

Finding 2

Councillor Khal Asfour's expenses claims were outside the community's expectations.

Finding 3

The City of Canterbury Bankstown Council misused Council resources to assist a NSW Labor candidate.

Finding 4

The timeframe for the provision of documents delayed the committee's capacity to hold hearings and review documents. This has in turn affected the capacity of the inquiry to appropriately investigate allegations made by the member for Bankstown Tania Mihailuk MP.

Recommendations

Recommendation 1

That the Standing Committee on State Development refer the influence of property developers in the creation of planning instruments and the positioning of infrastructure in the City of Canterbury Bankstown Council to the Independent Commission Against Corruption, along with this report and committee transcripts of evidence, for investigation.

Recommendation 2

That the NSW Government review the potential for candidates in local government elections to receive funds from property developers through shell companies, including third party lobbying firms, contrary to the ban on political donations from property developers.

Recommendation 3

That the Office of Local Government review the:

- Guidelines for the payment of expenses and provision of facilities to Mayors and Councillors in New South Wales to ensure that they align with community expectations
- Model Code of Conduct for Local Councils in New South Wales to ensure that the obligation to disclose pecuniary interests extends to overseas and interstate property interests.

Recommendation 4

That the Legislative Council re-establish the *inquiry into allegations of impropriety against agents of the City of Canterbury Bankstown Council* in the 58th Parliament to enable the Standing Committee on State Development to further pursue current lines of inquiry.

Conduct of inquiry

The terms of reference for the inquiry were referred to the committee by the Hon Wendy Tuckerman MP, Minister for Local Government, on 29 November 2022.

The committee did not call for submissions and resolved to accept and publish submissions on an as received basis. The committee received and published one submission.

The committee held four public hearings at the State Library of New South Wales on 21 December 2022, 6 February 2023, 13 February 2023 and 17 February 2023.

Inquiry related documents are available on the committee's website, including submissions, hearing transcripts, correspondence, answers to questions on notice and other documents.

Procedural issues

A number of noteworthy procedural matters arose during this inquiry which are summarised below.

Requests for documents

The committee made two requests for documents from the City of Canterbury Bankstown Council. These requests, along with other correspondence, can be accessed on the inquiry webpage. Following a lengthy exchange of correspondence regarding the provision of the documents, the Council provided seven tranches of documents between 14 December 2022 and 21 February 2023, compromising approximately 20,000 pages. The documents fall into the following categories:

- Councillors' Claim Form for Reimbursement of Expenses and associated receipts and invoices, from 2004 to 2022
- pecuniary Interest Return Forms made by Councillors to City of Canterbury Bankstown Council and Bankston City Council between 2004 and 2022
- minutes from the Development Committee of the Council and ordinary meetings of the Council
- a copy of all Council reports related to overseas trips dating back to 2004
- a copy of the gift disclosure register for all Councillors dating back to 2004.

The committee also made requests to eight private companies to provide documents on a voluntary basis.

Request for the committee to cover the costs associated with the Council voluntarily complying with a request for documents

In a letter from the Council's legal representatives on 25 January 2023, the Council sought confirmation that the committee reimburse the Council for the reasonable costs in complying with the committee's requests for documents. In line with standard practice, the committee did not agree to cover any cost associated with the Council's fulfillment with the committee's requests.

Clerk's advice on committees' power to order state papers

As part of its initial request for documents, the committee requested the Council provide 'All disclosures under the Public Interest Disclosure Act by Councillors to City of Canterbury Bankstown Council and Bankstown City Council'.

The Council's position in response to this request was that it could not produce the documents 'given the prohibition on the disclosure of identifying information' contained in section 64 of the *Public Interest Disclosure Act 2022* (NSW)'. It further asserted that the 'exceptions contained in section 64(2) of the PID Act do not cover the present circumstances such as to permit the Council providing disclosures made under the PID Act to the Standing Committee'.

The Chair sought the Clerk's advice on this matter. The Clerk's advice, dated 13 December 2022 (accessed on the inquiry webpage), indicated his belief that Legislative Council committees are on solid legal grounds to order the production of State papers, and that it is more likely than not that if tested in court, it would be found that local councils do hold State papers amenable to production by order of the Legislative Council and its committees. With respect to the *Public Interest Disclosures Act 1994*, the Clerk advised that it cannot be conceded that its provisions affect the common law powers of the Legislative Council and its committees, including the common law power to order the production of State papers. However, committees should give due and proper consideration to protecting the privacy of those making public interest disclosures.

These issues were not pursued further by the committee as part of this inquiry as the Council advised on 14 December 2022 that a search of its records revealed that there were no documents to provide that fall within this category.

Summonses witnesses for a public hearing

Mr Matthew Stewart, Chief Executive Officer at the City of Canterbury Bankstown Council, and Mr Ken Manoski, Director Corporate at the City of Canterbury Bankstown Council, were summoned to attend and give evidence at a public hearing held on 13 February 2023.

Mr Matthew Stewart and Mr Ken Manoski were represented by Sparke Helmore Lawyers during the inquiry. A letter dated 7 February 2023 from Sparke Helmore advised that it had been instructed to accept service of the summonses. The committee advised that under section 4 of the *Parliamentary Evidence Act* 1901 a summons must be served personally on the subject of the summons.

LEGISLATIVE COUNCIL Allegations of impropriety against agents of the City of Canterbury Bankstown Council

Chapter 1 Key issues

This report sets out the background to the inquiry into allegations of impropriety against agents of the City of Canterbury Bankstown Council and the key findings of the committee in relation to the inquiry.

Background to the inquiry

- 1.1 On 24 November 2022 the Hon Wendy Tuckerman MP, Minister for Local Government, wrote to the Standing Committee on State Development to consider terms of reference for an inquiry into allegations of impropriety against agents of the City of Canterbury Bankstown Council.
- 1.2 On 29 November 2022 the committee resolved to adopt the following terms of reference:

That the Standing Committee on State Development inquire into and report on matters in regard to the City of Canterbury Bankstown and the previous city of Bankstown council, including:

- a. any matters relating to integrity, processes of council, employees and elected officials of council; and
- b. any other related matter.²

City of Canterbury Bankstown Council

- 1.3 The City of Canterbury Bankstown Council is constituted under the *Local Government Act 1993*. It was formed in May 2016 as a result of an amalgamation between City of Canterbury Council and the City of Bankstown Council.³
- A key figure in this inquiry was the Mayor of the Council, Councillor Khal Asfour. Councillor Asfour was first elected to the former City of Bankstown Council in 2004 and held the role of Deputy Mayor from 2008 to 2011, and Mayor from 2011 to 2014 and again in 2015.⁴
- 1.5 In May 2017, Councillor Asfour was elected as the inaugural Mayor of the newly merged City of Canterbury Bankstown Council and remains in the position as of 27 February 2023.⁵

Allegations raised in NSW Parliament concerning planning matters at City of Canterbury Bankstown Council

1.6 On 20 September 2022, Ms Tania Mihailuk MP, member for Bankstown, made a number of allegations in the NSW Parliament concerning planning matters at the Canterbury Bankstown

Council, as well as Councillor Khal Asfour's 'character and his unprincipled actions in furthering the interests of developers and identities'. The planning matters in question included:

- the proposal that the West Terrace car park be redeveloped
- discrepancies in planning controls between sites, including the redevelopment of the Bellevue function center
- the West Terrace car park's reclassification from V2 zoning to 'open space'.
- 1.7 On 21 September 2022, Ms Wendy Lindsay MP, Member for East Hills, also made allegations in the Parliament with respect to planning matters at Canterbury Bankstown Council. In particular, Ms Lindsay alleged that the Council had improperly engaged with developers⁸ in relation to:
 - the rezoning of Segars Avenue, Padstow
 - the drafting of the Local Environmental Plan as it relates to East Hills
 - discrepancies in Local Environment Plans.⁹
- 1.8 Ms Lindsay also claimed that Council had been less than transparent with local residents regarding development matters. 10

Councillor Khal Asfour as a candidate for the NSW Legislative Council

1.9 Councillor Asfour was selected as a candidate on the Legislative Council ticket for the Labor Party for the 2023 NSW State Election. Following media attention regarding the allegations aired in NSW Parliament, Councillor Asfour stepped down as a candidate for the NSW Legislative Council on 20 January 2023.¹¹

Media coverage

- 1.10 Since the statements made in Parliament in September 2022, a number of media reports were published making further allegations regarding alleged impropriety at the City of Canterbury Bankstown Council. These include allegations that:
 - Councillor Asfour used Council funds to pay his professional development costs, including a Masters of Business Administration (MBA) degree ¹² said to cost \$48,000¹³
 - Councillor Asfour misused council expense claims and charged the costs of a health spa treatment, alcohol and luxury clothes to Council¹⁴
 - Councillor Asfour was reimbursed for parking costs to attend a Christmas party, a Health Services Union conference and the NSW Trades and Labour Council dinner¹⁵
 - Councillor Asfour failed to disclose his directorship of a company as required under council policy¹⁶
 - Canterbury Bankstown councillors and council staff travelled to North America in 2019 at a cost to ratepayers of almost \$146,000¹⁷
 - a multibillion-dollar redevelopment plan for Bankstown's CBD, including 12,5000 apartments and new businesses, would improperly benefit developers such as the owner of the Bellevue function center Mr Walhan Wehbe. Mr Wehbe was said to have originally acquired the function center for \$1 from Mr Hassam Achie, the financial controller of the Obeid family¹⁸
 - Councillor Asfour accepted donations through a company owned by a property developer during local government elections.¹⁹

Investigative processes

- 1.11 In addition to this inquiry conducted by the State Development Committee, there have been a number of other investigations and reviews into the allegations made against Councillor Asfour and the City of Canterbury Bankstown Council. These investigations, reviews and referrals have been conducted by the Independent Commission Against Corruption (ICAC), SINC Solutions, Arthur Moses SC and the NSW Electoral Commission.
- 1.12 There was also an investigation by the committee of an unauthorised leak of information from the committee.

Independent Commission Against Corruption

- 1.13 Between 2013 and 2022 a number of allegations regarding potential impropriety at Canterbury Bankstown Council were referred to ICAC. These are detailed below.
 - On 25 November 2013, a report was made to ICAC by the General Manager of Bankstown Council regarding alleged inappropriate conduct by a Council official in relation to the West Terrace Car Park tender process. On 13 December 2013, ICAC wrote to Council advising that it would not investigate the matter.
 - On 2 January 2014, a report was made to ICAC by the General Manager regarding alleged inappropriate conduct by a Council official and requesting that ICAC interview the person making the allegations. On 20 January 2014, ICAC wrote to Council advising that it would not investigate the matter.
 - On 22 April 2021, another report was made to ICAC by the General Manager. On 22 June 2021, ICAC wrote to Council advising that they would not investigate the matter.
 - On 14 May 2021, Ms Mihailuk made a public submission on the Bankstown City Centre Masterplan. The submission identified concerns regarding the Masterplan process and peculiarities in the building height limits, and criticised Councillor Asfour for declaring a conflict of interest but continuing to support the masterplan. On 5 July 2021, the General Manager wrote to ICAC providing a copy of Ms Mihailuk's submission. On 20 August 2021, ICAC wrote to the Council advising that it would not investigate the matter.
 - On 10 December 2021, the General Manager wrote to ICAC regarding alleged inappropriate conduct. On 25 February 2022, ICAC wrote to Council advising that it would not investigate the matter.
 - In December 2022, Councillor Asfour wrote to ICAC regarding statements made by Ms Mihailuk and Ms Lindsay under parliamentary privilege.²⁰

SINC Solutions

1.14 Following the allegations made by Ms Mihailuk and Ms Lindsay in the Parliament concerning Councillor Asfour, Canterbury Bankstown Council and Council staff, the Council engaged consulting firm SINC Solutions to conduct an independent investigation.

- 1.15 On 20 December 2022, SINC Solutions released a report addressing the following matters:
 - whether Ms Mihailuk or Ms Lindsay raised these allegations or complaints directly with the Council
 - the appropriateness of the steps taken by the Council when it became aware of the allegations
 - any steps taken by the Council to deal with matters relating to probity and corporate governance arising from the allegations
 - what steps or otherwise the Council should take in relation to the allegations. ²¹
- 1.16 The SINC Solutions Report concluded that 'there is no governance, probity or conduct issues relating to Council Officials'. ²²

Review by Arthur Moses SC

- 1.17 In September 2022, the City of Canterbury Bankstown Council engaged barrister Mr Arthur Moses SC to review the SINC Solutions independent investigation into allegations concerning Councillor Asfour, the Council and Council staff.²³ On 10 January 2023, Mr Moses released his review. A copy of the report was provided to ICAC and the Minister for Local Government.²⁴
- 1.18 Mr Moses reviewed SINC Solutions' investigation to ascertain whether there was any evidence of any unlawful or corrupt conduct by elected officials or Council employees. In his conclusion, Mr Moses found the evidence showed that Councillor Asfour had 'diligently' fulfilled his obligations under the Code of Conduct.²⁵

NSW Electoral Commission

1.19 In February 2023, the Hon Alister Henskens MP, Minister for Investment and Trade, wrote to the NSW Electoral Commissioner calling for an investigation into a \$6,600 donation from a Bankstown business owner and property developer to Councillor Asfour's 2021 local government campaign, which the Minister claimed could be a violation of NSW electoral laws. ²⁶ The outcome of this referral is unknown.

Key issues raised during evidence

- 1.20 At the public hearings conducted by this committee, the evidence focused mostly on allegations of impropriety against Councillor Asfour. The allegations related to the matters reported in the media in late 2022 and early 2023,²⁷ as well as the allegations made under parliamentary privilege by Ms Mihailuk, member for Bankstown, and Ms Lindsay, member for East Hills.²⁸
- 1.21 The allegations centre around three key issues. The first related to councillors' reimbursement for allowable expenses. In relation to Councillor Asfour in particular, the most troubling concerns were that Councillor Asfour:
 - used Council funds to pay for his Master of Business Administration degree on the grounds it was deemed to be professional development activity eligible to be reimbursed by Council²⁹

- made numerous international visits in his capacity as a Council representative and claimed reimbursement of allowable expenses during those trips, such as a float tank spa treatment in Tokyo, Japan³⁰
- used Council funds to reimburse his clothing expenses such as designer suits.³¹
- 1.22 The second key issue was the potential influence of property developers and agents of impropriety in Canterbury Bankstown Council's planning processes and decisions, such as in relation to the rezoning of the West Terrace Carpark and the Bellevue Venue and the windfall gains of property developers.³²
- 1.23 The third key issue related to donations from property developers to local government election campaigns, contrary to the ban on political donations from property developers. Namely, at the second hearing with Councillor Asfour, the committee examined allegations relating to Councillor Afour's acceptance of donations to his local government election campaign from property developer Mr David Fam through retailers in a complex owned by Mr Fam. 33
- 1.24 At the hearing on 6 February 2023, Councillor Asfour stated the following in response to questions about this matter:

The Hon. CHRIS RATH: I assume you've read that article. I think you alluded to it in your opening statement. The illegal donations from David Fam via Mr Bingsoo—the trading name now called Snow Blossom— what's your response to the article and those allegations?

KHAL ASFOUR: I have not accepted a donation from Mr David Fam. I accepted a donation from Bingsoo Pty Ltd, which is a dessert store in Bankstown.

The Hon. CHRIS RATH: Owned by David Fam?

KHAL ASFOUR: Not that I'm aware of.

The Hon. CHRIS RATH: What's your relationship with David Fam?

KHAL ASFOUR: I know David Fam. I don't have a relationship with David Fam. I have not seen David Fam for—I don't know—three or four years. I don't have a relationship with David.

The Hon. CHRIS RATH: You would not classify him as a friend?

KHAL ASFOUR: No. The Hon.

CHRIS RATH: Has he helped on your campaigns?

KHAL ASFOUR: No.

The Hon. CHRIS RATH: So you weren't aware at the time that David Fam had part ownership of Mr Bingsoo?

KHAL ASFOUR: And I'm still not aware that he does. I haven't seen anything to tell me that he did or had.³⁴

1.25 In addition, at the public hearing on 6 February 2023, Councillor Asfour stated the following in response to questions about using Council resources to issue a media release relating to his candidacy for the March 2023 election to the NSW Legislative Council:

The Hon. TAYLOR MARTIN: Mr Asfour, when you resigned from Labor's upper House ticket it was inappropriately put on Canterbury Bankstown council letterhead—that media release. Why were council facilities and staff used to assist you in managing your candidacy for Labor's upper House ticket at the upcoming State election?

KHAL ASFOUR: Can you show me that? I wasn't in the country at the time and I don't know what was presented to the media, or to anyone, for that matter.

The Hon. TAYLOR MARTIN: There is a media release on council letterhead which solely discusses your resignation from Labor's upper House ticket.

KHAL ASFOUR: If you say so.

The Hon. TAYLOR MARTIN: It was circulated. It was from your office.

KHAL ASFOUR: I am not saying no. I am saying I haven't seen it and I wasn't in the country at the time.

The Hon. TAYLOR MARTIN: Who did you liaise with in the mayor's office or council's communications team about putting that statement out?

KHAL ASFOUR: I wrote the statement and I sent it to council's communications team because, as an upper House candidate at the time and as the mayor of the city, I thought it was appropriate for the ratepayers to know that.

The Hon. TAYLOR MARTIN: For them to know that? Yes, it is true that it should be communicated from you, but did anyone in that communications team flag with you that this is a personal issue for you and not for the council to assist your candidacy?

KHAL ASFOUR: No, it wasn't assisting my candidacy; it was ending my candidacy.

The Hon. TAYLOR MARTIN: Nonetheless, should ratepayers really pay staff to assist in your personal candidacy? Do you think that's appropriate?

KHAL ASFOUR: No, I don't.

The Hon. TAYLOR MARTIN: Why didn't you release it personally on your own social media or through a private email address or something, rather than get the council team to assist in your affairs?

KHAL ASFOUR: I was overseas at the time and had limited internet and it was done that way. Again, I didn't—

The Hon. TAYLOR MARTIN: An oversight?

KHAL ASFOUR: I didn't know or see anything on letterhead.³⁵

1.26 These issues were explored across the committee's four hearings on 21 December 2022, 6 February 2023, 13 February 2023 and 17 February 2023, transcripts of which are available on the inquiry webpage.³⁶

Committee comment

- 1.27 This inquiry was held in the interests of transparency. Serious allegations were made under parliamentary privilege and aired in the media which had the potential to erode public trust in local government. The aim of this inquiry was to use the committee's powers to get to the bottom of these serious allegations as they relate to the City of Canterbury Bankstown Council.
- 1.28 The inquiry considered the influence of property developers in relation to planning approvals by the Canterbury Bankstown Council. Developers have a responsibility to act lawfully and be transparent in all their dealings together with respecting the community. Councillors should not progress the Council's plans and strategies based upon their personal relationships with developers as this ultimately erodes any confidence in the Council and the planning system.
- 1.29 The committee has found that councillors of the Canterbury Bankstown Council, and in particular Councillor Khal Asfour, have close relationships with property developers. This may have influenced planning instruments and the positioning of infrastructure across the Canterbury Bankstown Council area, and we recommend that the Independent Commission Against Corruption investigate the matter.

Finding 1

There is evidence that Councillors of the City of Canterbury Bankstown Council have close relationships with property developers in the area. Furthermore, this has a strong potential to have influenced planning instruments and the positioning of infrastructure across the Canterbury Bankstown Council area.

Recommendation 1

That the Standing Committee on State Development refer the influence of property developers in the creation of planning instruments and the positioning of infrastructure in the City of Canterbury Bankstown Council to the Independent Commission Against Corruption, along with this report and committee transcripts of evidence, for investigation.

1.30 In addition, we heard evidence that local government election campaigns may be receiving funds from property developers, in particular through shell companies, contrary to the ban on political donations from property developers. This ban was introduced to prevent property developers having undue influence on planning decisions which favour developers' interests. We recommend that the NSW Government review this issue.

Recommendation 2

That the NSW Government review the potential for candidates in local government elections to receive funds from property developers through shell companies, including third party lobbying firms, contrary to the ban on political donations from property developers.

1.31 Through the committee's requests for documents, the spending habits of Councillor Asfour came to light. The committee was troubled to discover that he had used Council funds to pay for expenses including a float tank spa treatment while on a Council funded trip to Tokyo, Japan and designer suits, as well as to cover the cost of his Masters of Business Administration degree. Councillor Asfour said in his defence that all expenses were within Council's policy and guidelines. However, this application of the policy is not in line with community expectations.

Finding 2

Councillor Khal Asfour's expenses claims were outside the community's expectations.

1.32 The committee is concerned that this loose spending of ratepayer funds may not be isolated to the City of Canterbury Bankstown Council. There may also be gaps in the requirements to disclose pecuniary interests relating to overseas and interstate property. We recommend the Office of Local Government review governing polices in relation to these matters.

Recommendation 3

That the Office of Local Government review the:

- Guidelines for the payment of expenses and provision of facilities to Mayors and Councillors in New South Wales to ensure that they align with community expectations
- Model Code of Conduct for Local Councils in New South Wales to ensure that the obligation to disclose pecuniary interests extends to overseas and interstate property interests.

1.33 Not only was there evidence about the influence of property developers in relation to planning approvals by the Canterbury Bankstown Council, but we were also troubled to learn about the links between the Council and the NSW Labor Party. It came to light that Council resources had been expended to release a media statement regarding Councillor Asfour's withdrawal as a candidate for election to the NSW Legislative Council in 2023. We find that the Council misused Council resources to assist a NSW Labor candidate.

Finding 3

The City of Canterbury Bankstown Council misused Council resources to assist a NSW Labor candidate.

As summarised at the start of this report, the committee made several requests for documents from the Council. These documents were in the thousands and spanned many years. We acknowledge the Council administrative staff who worked to provide the documents. In addition, the committee sought to hold a hearing with executive officers from the Council in December 2022. Ultimately, the Council provided some but not all documents at a frustratingly slow pace and executive officers from the Council finally appeared before the committee to give evidence under summons in February 2023. Unfortunately, this left us little time to pursue these matters due to the suspension of Legislative Council business from 3 March 2023 in the lead up to the State election. This affected the committee's capacity to fully investigate allegations made by the member for Bankstown Tania Mihailuk MP and we recommend that this inquiry be reestablished in the next Parliament to pursue these matters.

Finding 4

The timeframe for the provision of documents delayed the committee's capacity to hold hearings and review documents. This has in turn affected the capacity of the inquiry to appropriately investigate allegations made by the member for Bankstown Tania Mihailuk MP.

Recommendation 4

That the Legislative Council re-establish the *inquiry into allegations of impropriety against agents of the City of Canterbury Bankstown Council* in the 58th Parliament to enable the Standing Committee on State Development to further pursue current lines of inquiry.

KHAL ASFOUR: No.

The Hon. CHRIS RATH: Has he helped on your campaigns?

KHAL ASFOUR: No.

The Hon. CHRIS RATH: So you weren't aware at the time that David Fam had part ownership of Mr Bingsoo?

KHAL ASFOUR: And I'm still not aware that he does. I haven't seen anything to tell me that he did or had.'

Ms Sharpe moved in globo: That:

Why were council facilities and staff used to assist you in managing your candidacy for Labor's upper House ticket at the upcoming State election?

KHAL ASFOUR: Can you show me that? I wasn't in the country at the time and I don't know what was presented to the media, or to anyone, for that matter.

The Hon. TAYLOR MARTIN: There is a media release on council letterhead which solely discusses your resignation from Labor's upper House ticket. KHAL ASFOUR: If you say so.

The Hon. TAYLOR MARTIN: It was circulated. It was from your office.

KHAL ASFOUR: I am not saying no. I am saying I haven't seen it and I wasn't in the country at the time.

The Hon. TAYLOR MARTIN: Who did you liaise with in the mayor's office or council's communications team about putting that statement out?

KHAL ASFOUR: I wrote the statement and I sent it to council's communications team because, as an upper House candidate at the time and as the mayor of the city, I thought it was appropriate for the ratepayers to know that.

The Hon. TAYLOR MARTIN: For them to know that? Yes, it is true that it should be communicated from you, but did anyone in that communications team flag with you that this is a personal issue for you and not for the council to assist your candidacy?

KHAL ASFOUR: No, it wasn't assisting my candidacy; it was ending my candidacy.

The Hon. TAYLOR MARTIN: Nonetheless, should ratepayers really pay staff to assist in your personal candidacy? Do you think that's appropriate?

KHAL ASFOUR: No, I don't.

The Hon. TAYLOR MARTIN: Why didn't you release it personally on your own social media or through a private email address or something, rather than get the council team to assist in your affairs?

KHAL ASFOUR: I was overseas at the time and had limited internet and it was done that way. Again, I didn't—

The Hon. TAYLOR MARTIN: An oversight?

KHAL ASFOUR: I didn't know or see anything on letterhead.'

Ms Sharpe moved in globo: That:

• paragraph 1.30 be amended by omitting: 'We find that the Council misused Council resources to assist the NSW Labor Party, after 'election to the NSW Legislative Council in 2023.'

• Finding 3 be omitted: 'The City of Canterbury Bankstown Council misused Council resources to assist the NSW Labor Party'.

Question put.

The committee divided.

Question resolved in the negative.

Resolved, on the motion of Mr Farlow: That paragraph 1.30 and Finding 3 be amended by omitting 'the NSW Labor Party' and inserting instead 'a NSW Labor candidate'.

Resolved, on the motion of Ms Sharpe: That paragraph 1.31 be amended by inserting 'These documents were in the thousands and spanned many years. We acknowledge the Council administrative staff who worked to provide the documents' after 'made several requests for documents from the Council.'.

Resolved, on the motion of Ms Sharpe: That paragraph 1.31 by amended by omitting 'previous Labor Shadow Minister' and inserting instead 'the member for Bankstown'.

Ms Sharpe moved: That paragraph 1.31 be amended by omitting: 'Ultimately, the Council provided some but not all documents at a frustratingly slow pace and executive officers from the Council finally appeared before the committee to give evidence under summons in February 2023. Unfortunately, this left us little time to pursue these matters due to the suspension of Legislative Council business from 3 March 2023 in the lead up to the State election.'

Question put.

Appendix 4 Dissenting statement

Hon Penny Sharpe MLC, Australian Labor Party Hon John Graham MLC, Australian Labor Party

This report was always a tale of two inquiries.

The first inquiry follows in this report. It is the inquiry into allegations made in the Legislative Assembly chamber relating to Canterbury Council. The report makes for brief reading.

The second inquiry is now being dealt with by Portfolio Committee 7. That is the inquiry into allegations made in the Legislative Assembly chamber relating to the Hills Shire Council. That second inquiry should have also been dealt with by this Committee in the view of the Opposition.

As the committee minutes show a resolution to examine the two matters together was proposed by the Opposition and opposed by the Government. Had that resolution succeeded the Hills Shire Council inquiry would have been dealt with in the Government controlled committee on terms, tempo and timing determined by the Government. That has proven not to be case.

Opposition members of the committee supported the Canterbury Council inquiry using its powers widely in the search for evidence of wrongdoing. Despite this the evidence unearthed was scant.

Mayor Asfour was also co-operative and appeared in front of the inquiry on two occasions to give evidence.

The key finding of the inquiry about the close relationships between councillors and property developers was particularly flimsy. It is not clear when reading the report what evidence this finding is based on.

The findings of the inquiry are particularly odd given that the report goes on to say in relation to the Review conducted by Arthur Moses SC: "In his conclusion, Mr Moses found the evidence showed that Councillor Asfour had 'diligently' fulfilled his obligations under the Code of Conduct." The findings of the report do not reflect this.

The evidence which was requested from Canterbury Council by the committee majority was substantial and stretched back over decades. A significant amount of material was provided by the Council in response.

The minutes show committee concerns about the leaking of confidential committee considerations. It now appears that the report itself has also been leaked prior to its completion. We place on the record our objection to such behaviour.

An important recommendation of this inquiry was that developer donation laws may need tightening, including in relation to payments by third party lobbying firms. The Opposition is developing grave concerns in regard to this and it was pleasing to see that Government members themselves supported action in this regard.

In the end the inquiry's work was incomplete. Should the House take up the suggestion that the committee reconvene, the Opposition intends to take the opportunity of re-calling the former councillors it proposed as witnesses during the hearing.
