

Terms of reference

The Budget Estimates resolution and schedule was agreed to by the House on 12 September 2023, referring the Budget Estimates and related papers for 2023-2024 to the Portfolio Committees for inquiry and report and is reproduced, as amended on 11 October 2023 and 30 November 2023, as follows:

Initial hearings

- 1. That, upon tabling, the Budget Estimates and related papers for the financial year 2023-2024 presenting the amounts to be appropriated from the Consolidated Fund be referred to the Portfolio Committees for inquiry and report.

 - (a) each portfolio, except The Legislature, be examined concurrently by Opposition and Crossbench members only, from 9.15 am to 10.45 am, 11.15 am to 12.45 pm, 2.00 pm to 3.30 pm and 3.45 pm to 5.15 pm, and, if required, by Government members only from 10.45 am to 11.00 am, 12.45 pm to 1.00 pm, and 5.15 pm to 5.30 pm
 - (b) the portfolio of The Legislature be examined by Opposition, Crossbench and Government members from 2.00 pm until 5.30 pm.
- 5. That for the purposes of the 2023-2024 initial budget estimates hearings:
 - (a) the committees must hear evidence in public
 - (b) the committees may ask for explanations from ministers, parliamentary secretaries or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure
 - (c) ministers be invited to appear for the morning sessions only unless requested by committees to appear also for the afternoon session
 - (d) witnesses, including ministers, may not make an opening statement before a committee commences questions

- (e) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following the receipt of the hearing transcript
- (f) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.
- 6. That the committees report by 28 June 2024.²

Supplementary hearing

 - (d) the minister be invited to appear for the morning session only unless requested by the committee to appear also for the afternoon session
 - (e) witnesses, including the minister, may not make an opening statement before a committee commences questions
 - (f) members may lodge supplementary questions with the committee clerk by 5.00 pm within two business days following the receipt of the hearing transcript
 - (g) answers to questions on notice and supplementary questions are to be published, except those answers for which confidentiality is requested, after they have been circulated to committee members.³

Portfolio Committee No. 2 – Health is responsible for the scrutiny of the following portfolio areas:

- Health, Regional Health, the Illawarra and the South Coast
- Water, Housing, Homelessness, Mental Health, Youth, the North Coast.

The primary evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

On behalf of the committee, I would like to thank the ministers and their officers who assisted the committee during this important inquiry, as well as committee members and the secretariat staff for their contributions to the inquiry process.

Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for Parliament to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2023-2024

- **1.1** On 12 September 2023, the Legislative Council referred the Budget Estimates for the 2023-2024 financial year to the portfolio committees for inquiry and report.⁶
- **1.2** On 10 May 2023, the Legislative Council resolved that initial hearings for Budget Estimates 2023-2024 be held over 12 days from 24 October to 26 October and 31 October to 10 November 2023.⁷ The hearing schedule was amended by the House on 12 September 2023 to provide that initial hearings for Budget Estimates 2023-2024 be held over 11 days from 24 October to 26 October, 31 October to 3 November, and 7 November to 10 November 2023.⁸ The hearing schedule was further amended by the House on 11 October 2023 to add an additional hearing and make consequential amendments.⁹
- **1.3** On 22 November 2023, the Legislative Council resolved to hold a supplementary hearing for the portfolios of Agriculture, Regional New South Wales, and Western New South Wales in 2023.¹⁰
- **1.4** On 30 November 2023, the Legislative Council resolved that additional hearings for Budget Estimates 2023-2024 be held over 12 days from 20 February to 23 February, 27 February to 1 March, and 4 March to 7 March 2024.¹¹
- **1.5** The Budget Estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv-viii.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Health, Regional Health, the Illawarra and the South Coast

- 2.1 A hearing examining the portfolios of Health, Regional Health, the Illawarra and the South Coast was held on Thursday 26 October 2023. The following issues were raised during the committee's examination of these portfolios:
 - palliative care funding
 - safe nurse staffing levels
 - regional and rural paramedics
 - hospital redevelopments including Bankstown Hospital, Albury Hospital and Tweed Valley Hospital
 - pill testing services
 - treatment and prevention of silicosis
 - COVID-19 transmission in hospitals.
- **2.2** An additional hearing examining the portfolios of Health, Regional Health, the Illawarra and the South Coast was held on Thursday 22 February 2024. The following issues were raised during the committee's examination of these portfolios:
 - palliative care funding
 - remuneration for nurses and midwives
 - redevelopment of Manning Base Hospital
 - safe access to abortion services
 - safe staffing levels
 - transmission of COVID-19 in New South Wales healthcare facilities
 - pill testing in New South Wales
 - use of consultants.

Water, Housing, Homelessness, Mental Health, Youth, the North Coast

- **2.3** A hearing examining the portfolios of Water, Housing, Homelessness, Mental Health, Youth, the North Coast was held on Wednesday 1 November 2023. The following issues were raised during the committee's examination of these portfolios:
 - ministerial travel disclosures and office staffing

- social, community and affordable housing, including supply, construction, waitlists, and specific projects such as Waterloo South and Argyle Housing
- water management and security, including impact of mining on rivers and catchment areas, drought preparedness, water sharing plans, cultural water rights, and water harvesting
- homelessness, including street counts for rough sleepers, support and accommodation services, and homelessness across vulnerable communities
- access to mental health services, including suicide prevention training, outpatient mental health services, and data collection across a range of mental health diagnoses
- children and young people, including the Youth Advisory Council, vaping, mental health and suicide prevention, and the NSW Strategic Plan for Children and Young People.
- 2.4 An additional hearing examining the portfolios of Water, Housing, Homelessness, Mental Health, Youth, the North Coast was held on Wednesday 28 February 2024. The following issues were raised during the committee's examination of these portfolios:
 - water management and security, including buybacks, water sharing plans, water quality, floodplain harvesting and regional water infrastructure projects
 - social, community and affordable housing, including supply, construction, waitlists and Aboriginal housing
 - mental health workforce and facilities, including the availability of trauma-informed care, peer workers, and workplace culture at Cumberland Hospital
 - flood recovery and mitigation, and temporary accommodation in the North Coast
 - issues facing young people, including access to mental health services, vaping, forums for regional youth and the creation of a central youth agency
 - recommissioning specialised homelessness services.
