The primary evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2023-2024

- 1.1 On 12 September 2023, the Legislative Council referred the Budget Estimates for the 2023-2024 financial year to the portfolio committees for inquiry and report.⁶
- On 10 May 2023, the Legislative Council resolved that initial hearings for Budget Estimates 2023-2024 be held over 12 days from 24 October to 26 October and 31 October to 10 November 2023. The hearing schedule was amended by the House on 12 September 2023 to provide that initial hearings for Budget Estimates 2023-2024 be held over 11 days from 24 October to 26 October, 31 October to 3 November, and 7 November to 10 November 2023. The hearing schedule was further amended by the House on 11 October 2023 to add an additional hearing and make consequential amendments.
- 1.3 On 22 November 2023, the Legislative Council resolved to hold a supplementary hearing for the portfolios of Agriculture, Regional New South Wales, and Western New South Wales in 2023.¹⁰
- On 30 November 2023, the Legislative Council resolved that additional hearings for Budget Estimates 2023-2024 be held over 12 days from 20 February to 23 February, 27 February to 1 March, and 4 March to 7 March 2024.¹¹
- 1.5 The Budget Estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv-viii.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Education and Early Learning, Western Sydney

- A hearing examining the portfolios of Education and Early Learning, Western Sydney was held on Tuesday 24 October 2023. The following issues were raised during the committee's examination of these portfolios:
 - universal pre-kindergarten
 - consent education
 - mobile phone ban in schools
 - Department of Education organisational chart
 - Northern Rivers floods and impacts on school infrastructure and attendance
 - First Nations languages
 - expenditure on consulting services
 - number of school counsellors and school psychologists
 - AI in schools, including use of ChatGTP for reporting.
- 2.2 An additional hearing examining the portfolios of Education and Early Learning, Western Sydney was held on Tuesday 20 February 2024. The following issues were raised during the committee's examination of these portfolios:
 - asbestos in schools
 - implementation of the teachers code of conduct to ensure impartiality in classrooms
 - recruitment, resignation, retirement and vacancy data of teachers
 - canteen sales in a cost of living crisis
 - salary increase for school psychologists and counsellors
 - building public preschools
 - increase in the number of schools due to housing density
 - Schooling Resource Standard negotiations with the federal government
 - funding of teacher roles from temporary to permanency
 - rural and remote teaching programs
 - vaping in schools
 - teacher workload reductions.

Skills, TAFE and Tertiary Education

- 2.3 A hearing examining the portfolios of Skills, TAFE and Tertiary Education was held on Wednesday 1 November 2023. The following issues were raised during the committee's examination of these portfolios:
 - Oracle program replacement project
 - early childhood education training programs
 - expenditure on consulting services
 - Bungendore school site
 - country university centres
 - Smart and Skilled program
 - funding for Manufacturing Centres of Excellence
 - Vocational Education and Training review
 - land audit of TAFE sites
 - TAFE fee-free initiative.
- 2.4 An additional hearing examining the portfolios of Skills, TAFE and Tertiary Education was held on Tuesday 5 March 2024. The following issues were raised during the committee's examination of these portfolios:
 - TAFE infrastructure
 - net zero targets, climate-resilient campus, and sustainable design principles
 - TAFE enrolment figures, course availability, fee-free places, and completion rates, including a focus on rural and regional areas
 - TAFE teacher shortages, casualisation, retention and Teachers Award
 - Housing Accord targets, skills shortage, and related programs
 - apprenticeship and traineeships, including availability in rural and regional communities
 - Vocational Education and Training review
 - sexual assault and harassment policy
 - consultation and engagement with stakeholders and community.
