- Agriculture, Regional New South Wales, Western New South Wales
- Small Business, Lands and Property, Multiculturalism, Sport.

The primary evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

# Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

# **Budget Estimates 2023-2024**

- 1.1 On 12 September 2023, the Legislative Council referred the Budget Estimates for the 2023-2024 financial year to the portfolio committees for inquiry and report.<sup>7</sup>
- On 10 May 2023, the Legislative Council resolved that initial hearings for Budget Estimates 2023-2024 be held over 12 days from 24 October to 26 October and 31 October to 10 November 2023.8 The hearing schedule was amended by the House on 12 September 2023 to provide that initial hearings for Budget Estimates 2023-2024 be held over 11 days from 24 October to 26 October, 31 October to 3 November, and 7 November to 10 November 2023.9 The hearing schedule was further amended by the House on 11 October 2023 to add an additional hearing and make consequential amendments.10
- 1.3 On 22 November 2023, the Legislative Council resolved to hold a supplementary hearing for the portfolios of Agriculture, Regional New South Wales, and Western New South Wales in 2023.<sup>11</sup>
- On 30 November 2023, the Legislative Council resolved that additional hearings for Budget Estimates 2023-2024 be held over 12 days from 20 February to 23 February, 27 February to 1 March, and 4 March to 7 March 2024. 12
- 1.5 The Budget Estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv-viii.

# Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

# Small Business, Lands and Property, Multiculturalism, Sport

- A hearing examining the portfolios of Small Business, Lands and Property, Multiculturalism, Sport was held on Tuesday 24 October 2023. The following issues were raised during the committee's examination of these portfolios:
  - sale of golf courses across Sydney and New South Wales, including the proposed repurposing of Moore Park Golf Course
  - grants and programs conducted in the last year by Multicultural NSW
  - appointment process of Venues NSW executive staff and board members
  - property sales information that Valuations NSW sells to authorised information resellers
  - the use of synthetic turf in New South Wales sports fields
  - upgrades to various stadiums and clubs in New South Wales, including Penrith Stadium,
     WIN Stadium and Bondi Bowling Club.
- 2.2 An additional hearing examining the portfolios of Small Business, Lands and Property, Multiculturalism, Sport was held on Tuesday 20 February 2024. The following issues were raised during the committee's examination of these portfolios:
  - progress of land audit identifying available sites for housing development, integrity of the audit questioned due to previous corruption allegations
  - use of Crown land, including redevelopment of Sydney Fish Markets, greyhound racing lease at Wentworth Park and recreational fishing on Cooper Island
  - multicultural investment, including Safe Places for Faith and Community program, community language schools, GROW program and funding for multicultural media
  - the Catholic Metropolitan Cemeteries Trust audit, raising questions about transparency and accountability, and uncertainty about the Catholic Metropolitan Cemeteries Trust status as a State-owned entity
  - review of the 'hate speech' provision of the *Crimes Act 1900* (section 93Z) to reform anti-discrimination laws
  - Sydney Speedway, Sydney International Dragway and Wollongong Kart raceway, operational status, licensing, and application progress
  - sports facilities, including stadium and sporting precinct development and upgrades, asbestos contamination in facilities and health and environmental impacts of synthetic turf

- equity in sport, including gender equality, inclusion of LGBTIQ+ individuals in sport,
   'Level the Playing Field' program, defibrillator program eligibility and 'Her Sport Her Way' program
- Sydney International Equestrian Centre at Horsley Park.

# Agriculture, Regional New South Wales, Western New South Wales

- 2.3 A hearing examining the portfolios of Agriculture, Regional New South Wales, Western New South Wales was held on Wednesday 25 October 2023. The following issues were raised during the committee's examination of these portfolios:
  - site of Bungendore High School
  - government support for farmers and drought affected regions
  - staffing levels in the NSW Department of Primary Industries and Department of Regional NSW
  - shark nets and other deterrence measures at Garie Beach
  - fisheries management and sustainability and Recreational Fishing Trusts
  - funding for regional airstrips
  - koala hubs in the Great Koala National Park
  - flood recovery assistance for local government areas.
- A supplementary hearing examining the portfolios of Agriculture, Regional New South Wales, Western New South Wales was held on Wednesday 13 December 2023. The following issues were raised during the committee's examination of these portfolios:
  - appearance of Minister and departmental officials before committee
  - funding for Local Land Services
  - animal cruelty offences in the *Crimes Act 1900*
  - forestry operations in Tallaganda State Forest
  - Dolphin Marine Conservation Park
  - proposed Great Koala National Park
  - appointment of Cross-Border Commissioner
  - Marine Park Advisory Committees
  - management of fire ants
  - forced swim and smoking tower experiments in medical research
  - management of white spot disease
  - pest control programs facilitated by Local Land Services

- management and prevention of regional crime.
- 2.5 An additional hearing examining the portfolios of Agriculture, Regional New South Wales, Western New South Wales was held on Wednesday 21 February 2024. The following issues were raised during the committee's examination of these portfolios:
  - the termination of Mr Scott Hansen, former Director General of the NSW Department of Primary Industries
  - the status and potential outcomes of the functional review of the NSW Department of Primary Industries
  - the various impacts of budget cuts on the NSW Department of Primary Industries, such as the ability of staff to travel to regional areas for meetings, and the intention to maintain research stations
  - the 12-month trial ban on all forms of fishing blue groper in New South Wales
  - the Country Mayors Association of New South Wales's concerns regarding crime in rural and regional areas
  - progress on a trial of alternatives to shark nets
  - concerns regarding the use of Recreational Fishing Trust funds and status of funded projects
  - animal welfare matters such as the review of the *Prevention of Cruelty to Animals Act* and Regulation and the Rodeo Code of Practice; aerial culling of feral pigs; and how audits of animal facilities are prioritised
  - extension of the proposed assessment area for the Great Koala National Park
  - priorities and timelines for the Orange Sport Stadium and Precinct.
