

- The Hunter
- Families and Communities, Disability Inclusion
- Women, Seniors, Prevention of Domestic Violence and Sexual Assault.

The primary evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2023-2024

- 1.1 On 12 September 2023, the Legislative Council referred the Budget Estimates for the 2023-2024 financial year to the portfolio committees for inquiry and report.⁶
- On 10 May 2023, the Legislative Council resolved that initial hearings for Budget Estimates 2023-2024 be held over 12 days from 24 October to 26 October and 31 October to 10 November 2023. The hearing schedule was amended by the House on 12 September 2023 to provide that initial hearings for Budget Estimates 2023-2024 be held over 11 days from 24 October to 26 October, 31 October to 3 November, and 7 November to 10 November 2023. The hearing schedule was further amended by the House on 11 October 2023 to add an additional hearing and make consequential amendments.
- 1.3 On 22 November 2023, the Legislative Council resolved to hold a supplementary hearing for the portfolios of Agriculture, Regional New South Wales, and Western New South Wales in 2023.¹⁰
- On 30 November 2023, the Legislative Council resolved that additional hearings for Budget Estimates 2023-2024 be held over 12 days from 20 February to 23 February, 27 February to 1 March, and 4 March to 7 March 2024.¹¹
- 1.5 The Budget Estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on pages iv-viii.

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Women, Seniors, Prevention of Domestic Violence and Sexual Assault

- A hearing examining the portfolios of Women, Seniors, Prevention of Domestic Violence and Sexual Assault was held on Friday 3 November 2023. The following issues were raised during the committee's examination of these portfolios:
 - elder abuse
 - coercive control legislation implementation
 - the Core and Cluster Program
 - Shared Equity scheme expansion to victims of domestic and family violence
 - volunteering and carers portfolio
 - domestic violence support for Aboriginal and Torres Strait Islander persons
 - Regional Woman of the Year Award
 - the domestic violence death review recommendations
 - the Staying Home Leaving Violence program.
- 2.2 An additional hearing examining the portfolios Women, Seniors, Prevention of Domestic Violence and Sexual Assault was held on Tuesday 27 February 2024. The following issues were raised during the committee's examination of these portfolios:
 - palliative care funding and demand
 - targeted investment and funding in domestic violence services
 - cost of living crisis in relation to women and children
 - domestic violence within the LGBTQIA+ community
 - education of judiciary and police relating to domestic violence training
 - government handling of complaints of sexual assault
 - regulation and access of harmful pornography/NSW Sexual Violence Plan
 - women and children in regional and rural areas
 - domestic violence programs in rural and regional areas
 - Aboriginal and Torres Strait Island organisations and funding
 - gender pay gap
 - implementation of legislation relating to coercive control

- the increase in reports of elder abuse and the abuse of those with a disability to the Ageing and Disability Commission
- the role of the Women's Safety Commissioner and her office, and the lived experience advisory group.

Police and Counter-terrorism, the Hunter

- A hearing examining the portfolios of Police and Counter-terrorism, the Hunter was held on Tuesday 7 November 2023. The following issues were raised during the committee's examination of these portfolios:
 - police actions and advice relating to recent protests in Sydney
 - circumstances surrounding the death of Mrs Clare Nowland after being tasered by police in May 2023
 - police response to domestic and family violence, and readiness to implement new coercive control legislation

 - crime rates in rural and regional areas.
- 2.4 An additional hearing examining the portfolios Police and Counter-terrorism, the Hunter was held on Friday 23 February 2024. The following issues were raised during the committee's examination of these portfolios:
 - number of police officers, vacancies and retention issues
 - police pay, overtime and other employment conditions, including use of firearms
 - police stations and operating hours
 - regional and youth crime, recidivism rates and bail laws
 - operation of the PACER (Police, Ambulance, Clinical, Early Response) program and PULSE program
 - outcomes of the Special Commission of Inquiry into LGBTIQ hate crimes
 - policing of protests, including potential use of s 93Z of the *Crimes Act 1900*, police actions and prosecutions relating to recent protests in Sydney
 - firearms registration, licensing and standards, and shooting range management
 - implementation of the Youth Strategy
 - raising the age of criminal responsibility
 - consorting laws
 - improvements to body worn cameras
 - status of IPOS system

- crime prevention messaging
- training for coercive control legislation
- Firearm Prevention Orders
- misidentification of domestic violence perpetrators
- use of biometric assessments, including facial recognition technology.

Families and Communities, Disability Inclusion

- A hearing examining the portfolios of Families and Communities, Disability Inclusion was held on Thursday 9 November 2023. The following issues were raised during the committee's examination of these portfolios:
 - children missing from out-of-home care
 - accessibility and disability inclusion in New South Wales
 - caseworker vacancy rate
 - First Nations children in out-of-home care
 - consultation with First Nations people in policy reform
 - Permanency District Action Plans

- 2.6 An additional hearing examining the portfolios Families and Communities, Disability Inclusion was held on Monday 4 March 2024. The following issues were raised during the committee's examination of these portfolios:

 - high-cost emergency accommodation/arrangements
 - First Nations children in out-of-home care, including the Family is Culture report
 - Aboriginal Community-Controlled Organisations
 - non-government organisations and alternative care providers
 - accessibility and disability inclusion, including temporary accommodation and children with disability
 - Ageing and Disability Commission
 - National Disability Insurance Scheme review.

Attorney-General

- 2.7 A hearing examining the portfolio of Attorney-General was held on Friday 10 November 2023. The following issues were raised during the committee's examination of this portfolio:

 - court programs, including pre-court drug diversion scheme, merit program and related legislative reform
 - responses to issues arising from certain legal cases
