

- Customer Service and Digital Government, Emergency Services, Youth Justice
- Better Regulation and Fair Trading, Industry and Trade, Innovation, Science and Technology, Building, Corrections
- Local Government.

The primary evidence gathering mechanism of this inquiry is through the conduct of public hearings. This report lists the key issues raised during the hearings. Transcripts, tabled documents and additional answers provided after the hearings are published on the <u>inquiry's webpage</u>.

On behalf of the committee, I would like to thank the ministers and their officers who assisted the committee during this important inquiry. I am grateful to my fellow committee members and the secretariat staff for their contributions to the inquiry process.

## Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence taking process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

#### **Budget Estimates 2023-2024**

- 1.1 On 12 September 2023, the Legislative Council referred the Budget Estimates for the 2023-2024 financial year to the portfolio committees for inquiry and report.<sup>6</sup>
- On 10 May 2023, the Legislative Council resolved that initial hearings for Budget Estimates 2023-2024 be held over 12 days from 24 October to 26 October and 31 October to 10 November 2023. The hearing schedule was amended by the House on 12 September 2023 to provide that initial hearings for Budget Estimates 2023-2024 be held over 11 days from 24 October to 26 October, 31 October to 3 November, and 7 November to 10 November 2023. The hearing schedule was further amended by the House on 11 October 2023 to add an additional hearing and make consequential amendments.
- 1.3 On 22 November 2023, the Legislative Council resolved to hold a supplementary hearing for the portfolios of Agriculture, Regional New South Wales, and Western New South Wales in 2023.<sup>10</sup>
- On 30 November 2023, the Legislative Council resolved that additional hearings for Budget Estimates 2023-2024 be held over 12 days from 20 February to 23 February, 27 February to 1 March, and 4 March to 7 March 2024.<sup>11</sup>
- 1.5 The Budget Estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on pages iv-viii.

### Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

#### Customer Service and Digital Government, Emergency Services, Youth Justice

- A hearing examining the portfolios of Customer Service and Digital Government, Emergency Services, Youth Justice was held on Tuesday 31 October 2023. The following issues were raised during the committee's examination of these portfolios:
  - the process for allocating funds under the Local Small Commitments program
  - what cuts were made in the 2023 budget to fund pay increases for essential workers
  - preparations for the upcoming fire season, including early detection and response, equipment availability and volunteer training
  - financial management of Fire and Rescue NSW
  - flood recovery programs in western New South Wales and the Northern Rivers region
  - support for raising the age of criminal responsibility in New South Wales
  - education and welfare programs for young people in juvenile detention.
- An additional hearing examining the portfolios of Customer Service and Digital Government, Emergency Services, Youth Justice was held on Wednesday 28 February 2024. The following issues were raised during the committee's examination of these portfolios:
  - NSW Government support for Fire and Rescue NSW and the NSW Rural Fire Services in regard to agency budgets, fuel vouchers and maintenance of fire appliances
  - government response to allegations of historical child sexual abuse at youth justice centres
  - youth justice conferencing, recidivism rates and the provision of electronic tablets to young offenders
  - the number of children and young people in custody
  - raising the age of criminal responsibility
  - status of community leaders' consultation and buyback and accommodation arrangements for people displaced by floods in Northern Rivers and Central West
  - actions taken by Cybersecurity NSW regarding audits, cyber-preparedness and tracking cybersecurity breaches
  - the use of artificial intelligence within NSW Government agencies, and the impacts of its adoption for the public sector workforce
  - definitions and numbers of active volunteers in the NSW Rural Fire Service
  - engagement of NSW emergency services with wildlife rescue protection groups in developing plans and providing briefings.

# Better Regulation and Fair Trading, Industry and Trade, Innovation, Science and Technology, Building, Corrections

- A hearing examining the portfolios of Better Regulation and Fair Trading, Industry and Trade, Innovation, Science and Technology, Building, Corrections was held on Wednesday 8 November 2023. The following issues were raised during the committee's examination of these portfolios:
  - Department Liaison Officer roles and secondments in the Minister's office
  - the de-privatisation of correctional facilities in New South Wales
  - GEO contract expiration and renewal
  - the operations, upkeep and staffing at Junee correctional facility
  - the Junee facility de-privatisation and safety of inmates during transition
  - inmate welfare, services, assistance and support programs
  - Closing the Gap First Nations inmates and offenders including death rate of First Nations people in correctional facilities
  - rehabilitation animals in correctional facilities (greyhounds and thoroughbreds)
  - companion animals in rental properties and conditions on renters having animals in the property
  - no grounds eviction legislation and policy
  - Spark Festival funding
  - Sydney start up hub budget for this financial year
  - Ignite Spark program in Queensland and other interstate programs
  - Innovation Blueprint and timeframes for program
  - role and responsibilities of Rental Commissioner.
- An additional hearing examining the portfolios of Better Regulation and Fair Trading, Industry and Trade, Innovation, Science and Technology, Building, Corrections was held on Friday 1 March 2024. The following issues were raised during the committee's examination of these portfolios:
  - political history and affiliations of Department Liaison Officer appointments to the Minister's office
  - location of New South Wales Trade offices, the state's trade relationships/competitiveness relative to other jurisdictions
  - status and timeline of the government's implementation of its proposed rental policy reforms, specifically in relation to no grounds evictions and companion animals in rentals
  - the government's approach to lithium battery regulation
  - research into cell-based meat

- accessibility and cost for inmates to communicate with friends and family
- safety and condition of New South Wales correctional facilities, cost of living pressures on prisoners, and the expansion of closed circuit television and body-worn cameras in prisons
- Innovation Blueprint, engagement with ASEAN partners, promotion and viability of advanced manufacturing in New South Wales,
- Closing the Gap Indigenous incarceration and offending rates, deaths in custody, and funding of programs to reduce recidivism
- funding and promotion of the defence industry in New South Wales, manufacturing, and exportation of armaments, specifically to Israel
- funding of the Quantum Technology Industry in New South Wales, Sydney Quantum Academy, retention of talented scientists in New South Wales and competitiveness in relation to other states
- interaction with and treatment of animals within correctional facility programs
- expansion of the NSW Building Commission and budgetary allocations for staffing.

#### **Local Government**

- A hearing examining the portfolio of Local Government was held on Friday 10 November 2023. The following issues were raised during the committee's examination of this portfolio:
  - reforming local government to restore public trust and increase transparency of local government
  - Canada Bay Council investigation and corruption
  - puppy and kitten farming
  - de-amalgamation/de-merging Cootamundra Gundagai Regional Council and Inner West Council
  - diversity in local government and representation on councils
  - financial viability of NSW local councils.
- An additional hearing examining the portfolio of Local Government was held on Wednesday 6 March 2024. The following issues were raised during the committee's examination of this portfolio:
  - 2024 local government elections, including funding, disqualification of certain individuals to stand for local government elections, and matters relating to certain councils
  - council governance, including operation and review of the code of conduct for local government, and matters relating to the conduct of meetings, investigations, and asset management
  - local councillors and council officials and staff, including diverse representation, remuneration, and employment

- policies and costs regarding de-amalgamation/de-merging of local councils, including Cootamundra Gundagai Regional Council
- council rates and finances, including reviews into the financial model of local government by the Independent Pricing and Regulatory Tribunal and a Legislative Council committee
- companion animals, including the pet registry, pounds and shelters, and reviews of animal breeding practices and the *Prevention of Cruelty to Animals Act 1979*
- funding to animal welfare organisations, facilities and programs, including enforcement agencies, RSPCA, Animal Welfare League and Sydney Dogs and Cats Home
- changes to the Local Government (General) Regulation 2021, including tendering, employee retention, remuneration and entitlements
- issues before councils in the provision of services, including cancellation of LGBTIQA+ events, safety at events, asbestos contamination, childcare services, disaster response
- Office of Local Government, including the establishment of Strategic Policy Unit.
