

Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence gathering process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

Budget Estimates 2024-2025

- **1.1** On 20 June 2024, the Legislative Council referred the Budget Estimates for the 2024-2025 financial year to the portfolio committees for inquiry and report.⁴
- **1.2** The Legislative Council resolved that initial hearings for Budget Estimates 2024-2025 be held over 11 days from 27 August to 30 August 2024, 3 September to 6 September 2024 and 9 September to 11 September 2024 and that supplementary hearings be scheduled from 2 December to 6 December 2024.⁵
- **1.3** On 21 November 2024, the Legislative Council resolved that additional hearings for Budget Estimates 2024-2025 be held over 12 days from 25 February 2025 to 28 February 2025, 3 March 2025 to 7 March 2025, and 10 March 2025 to 12 March 2025.⁶
- **1.4** Three additional hearings were rescheduled due to the impact of Cyclone Alfred and the unavailability of ministers and other witnesses.⁷
- **1.5** The Budget Estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv-xiii.

Hearings

 - 27 August 2024, 2 December 2024 and 25 February 2025: Education and Early Learning, Western Sydney

Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

Education and Early Learning, Western Sydney

- **2.1** A hearing examining the portfolios of Education and Early Learning, Western Sydney was held on Tuesday 27 August 2024. The following issues were raised during the committee's examination of these portfolios:
 - school funding negotiations with the Australian Government
 - codes of conduct for teachers and students regarding conflict in the Middle East
 - the Department of Education review into executive teaching time
 - restructures within the Department of Education
 - processes within the Department of Education to respond to Standing Order 52 and *Government Information (Public Access) Act* requests
 - expenditure on consultants by the Department of Education
 - support for students with disability
 - planning for future early childhood education and care services around housing growth areas
 - implications of the proposed wage increase for early childhood educators employed by local councils
 - rollout and delivery of consent, respectful relationships and domestic and family violence education
 - changes to professional development requirements of teachers
 - problematic and harmful behaviours in schools
 - NAPLAN targets, numeracy checks and support for reading instruction.
- **2.2** A supplementary hearing was held on Monday 2 December 2024 and the following issues were raised:
 - restructures within the Department of Education
 - staffing matters within the Department of Education, such as resignation, retirement and vacancy numbers
 - discrimination in education settings, including departmental support material and alleged breaches of the Department of Education Code of Conduct
 - regulation of early childhood education and care (ECEC) services
 - the role and processes of the Professional and Ethical Standards (PES) unit of the Department of Education

- the mobile phone ban in New South Wales high schools
- procedures for small schools closures
- suspensions and bullying in schools
- review of the Department of Education's Legal Issues Bulletin 55: Transgender students in schools – legal rights and responsibilities.
- **2.3** An additional hearing was held on Tuesday 25 February 2025 and the following issues were raised:
 - building new schools and infrastructure upgrades to existing schools
 - workforce issues including teacher vacancies and measures to address them, and supporting staff to stay in the workforce
 - regulation of early childhood education and care services and response to complaints
 - setting of NAPLAN targets
 - supporting schools given global conflicts and heightened anti-semitism
 - embedding explicit teaching practices in schools
 - NSW curriculum and changes to syllabuses
 - projects in Western Sydney.

Skills, TAFE and Tertiary Education

- 2.4 A hearing examining the portfolio of Skills, TAFE and Tertiary Education was held on Wednesday 4 September 2024. The following issues were raised during the committee's examination of this portfolio:
 - TAFE capital projects such as the asset renewal program
 - the outcome of the NSW vocational education and training (VET) review 2023-2024
 - TAFE responsiveness in teaching skills required by industry including offerings for workers to upskill and develop micro skills
 - the development of courses relevant to emerging markets, such as the renewable energy sector
 - the retention of students with disability including adjustments provided for students
 - the availability of short/micro courses
 - the temporary relocation of Bankstown TAFE campus
 - Gosford TAFE redevelopment project
 - the status of various TAFE contracts with external organisations
 - governance of TAFE and accountability regarding performance

- the welfare of University of Sydney students during on-campus protests related to conflict taking place in the Middle East
- overseas travel by TAFE staff
- the availability and funding of fee-free TAFE places
- support offered to students travelling to, and requiring accommodation to participate in, TAFE courses.
- **2.5** An additional hearing was held on Monday 10 March 2025 and the following issues were raised:
 - budgeting decisions of universities
 - delay in the temporary accommodation delivery for Bankstown TAFE
 - work with the Commonwealth to prevent gendered violence on university campuses
 - meetings with University of Wollongong discussing budgeting constraints in relation to international students
 - Northern Rivers TAFE campuses affected by Cyclone Alfred and support provided to students
 - departure of Mr Stephen Brady, Managing Director from TAFE NSW
 - redundancies from TAFE NSW and process for electing permanent staffing
 - TAFE Charter consultation process
 - Bankstown TAFE student and community consultation for relocation, course availability and floor space at new site, enrolments, and traffic flow during construction
 - NSW achievements working with the Commonwealth on the Australian Universities Accord
 - TAFE student completion rates
 - NSW Skills Plan data
 - competition between TAFE and independent RTOs in the contestable market
 - mandatory student learning modules at Macquarie University
 - housing affordability around, and access for rural and regional students to, university.
