

## Chapter 1 Introduction

The inquiry into Budget Estimates is one of the key mechanisms for parliamentary committees to scrutinise government expenditure, performance and effectiveness. It holds ministers and government officials to account and provides a greater level of transparency to the public.

The inquiry is conducted annually by the Legislative Council's Portfolio Committees. Each committee examines the budget estimates of its responsible portfolios, with ministers and senior public servants as the primary witnesses. The evidence gathering process of the inquiry consists of answers provided during public hearings, including answers to questions on notice, and answers to post-hearing written questions (known as supplementary questions). There is no provision for written submissions.

### Budget Estimates 2024-2025

- **1.1** On 20 June 2024, the Legislative Council referred the Budget Estimates for the 2024-2025 financial year to the portfolio committees for inquiry and report.<sup>5</sup>
- **1.2** The Legislative Council resolved that initial hearings for Budget Estimates 2024-2025 be held over 11 days from 27 August to 30 August 2024, 3 September to 6 September 2024 and 9 September to 11 September 2024 and that supplementary hearings be scheduled from 2 December to 6 December 2024.<sup>6</sup>
- **1.3** On 21 November 2024, the Legislative Council resolved that additional hearings for Budget Estimates 2024-2025 be held over 12 days from 25 February 2025 to 28 February 2025, 3 March 2025 to 7 March 2025, and 10 March 2025 to 12 March 2025.<sup>7</sup>
- **1.4** Three additional hearings were rescheduled due to the impact of Cyclone Alfred and the unavailability of ministers and other witnesses.<sup>8</sup>
- **1.5** The Budget Estimates resolution establishing the inquiry, which sets out the rules for the inquiry, is reproduced on page iv-xiii.

- **1.6** The committee held public hearings as follows:
  - 27 August 2024 and 25 February 2025: Agriculture, Regional New South Wales, Western New South Wales

## Chapter 2 Issues raised during hearings

This chapter provides a brief summary of key issues raised during the hearings.

### Agriculture, Regional New South Wales, Western New South Wales

- 2.1 A hearing examining the portfolios of Agriculture, Regional New South Wales, Western New South Wales was held on Tuesday 27 August 2024. The following issues were raised during the committee's examination of these portfolios:
  - the role of the Agricultural Commissioner
  - the recruitment process and subsequent appointment of the Biosecurity Commissioner
  - the Forestry Industry Action Plan and long-term sustainability of the forestry industry
  - the use of animals in research and experimentation
  - cultural fishing and over-harvesting of abalone on the South Coast, marine conservation and threatened species management
  - appointments and promotions of staff within the Department of Primary Industries and Regional Development.
- **2.2** An additional hearing was held on Tuesday 25 February 2025 and the following issues were raised:
  - the decision to discontinue the development of the Dubbo Sports Hub project
  - the operation of Fisheries NSW, including staff vacancies, allocated funding and the exercise of its compliance functions
  - staffing issues across the Department of Primary Industries and Regional Development, including vacancies and People Matter Employee Survey results
  - the NSW Shark Management Strategy, including shark net policies
  - cattle tick management programs
  - the funding of regional media
  - the operations of Forestry Corporation NSW, including its reporting on biomaterials, its clear felling operations, and its management of pressures on the timber industry.

### Small Business, Lands and Property, Multiculturalism, Sport

- **2.3** A hearing examining the portfolios of Small Business, Lands and Property, Multiculturalism, Sport was held on Wednesday 28 August 2024. The following issues were raised during the committee's examination of these portfolios:
  - the operation and performance of the Office of Sport and leasing of shooting facilities

- the decline of volunteers for local sporting events and attracting more community groups to participate
- the use of land which is subject to Aboriginal land claims and progress of the Department of Planning, Housing and Infrastructure land acquisition review
- status and completion of the land audit process (the government's property audit for housing) including the development of government land and affordable housing
- Aboriginal land claims on NSW Crown Land, including the number of claims and measures taken to resolve claims
- Cemeteries and Crematoria NSW revenue from interment levies and expenditure
- the status of various sporting facility projects and upgrades across Sydney
- the government's pursuit of potential NFL games held in Sydney
- the status of ongoing Service NSW Business Bureau operations
- the Multicultural NSW Advisory Board appointments process
- Active Kids vouchers
- the status of Coffs Harbour Jetty Precinct Revitalisation project
- the Small Business Commissioner's role and operations including assistance to small business and initiatives to address the skills shortage
- the impact of property rezonings on property valuations
- Multicultural NSW operations budgeting and various initiatives including the Countering Violent Extremism Program, Remove Hate from the Debate, and the NSW Settlement Strategy.
- **2.4** An additional hearing was held on Wednesday 26 February 2025 and the following issues were raised:
  - the status of decisions concerning Crown land management, Racing NSW, Wentworth Park and Queanbeyan Racing Club criteria for appointment and conflicts of interests
  - the impact on public access to Tilligerry Creek, following decision to return 10.6-hectare plot of land to the Aboriginal community in Port Stephens
  - repurposing Moore Park Golf Course, including consultation and proposal from Golf NSW and Moore Park Golf Club
  - Cemeteries and Crematoria NSW staffing, revenue, and sites under consideration as potential cemetery spaces, including Carnarvon Golf Course
  - update on Dubbo Sports Hub, including impact of tripartisan funding and responsibility, and the variation request from Police Citizen Youth Club
  - political donations from local football clubs and allocation of government grants
  - the impact of rezoning Parramatta North

- the status of Coffs Harbour Jetty Precinct Revitalisation project
- privacy concerns and recommendations from the Joint Standing Committee on the Office of the Valuer General
- challenges faced by small businesses, including insolvencies, impact of red tape and regulations, and the availability of toll relief and energy relief
- the status of the Sydney Fish Markets, including completion date, variations and total cost of variations
- the free multicultural water safety day in Wollongong
- the Multilingual NSW Academy
