## RE: Transcript and questions on notice

Below, please find our answers to the Questions taken on notice during proceedings of the Standing Committee on Law and Justice on Friday, 17 June 2016.

## **Current situation on Recreational Registration in NSW**

- Minister Gay made an announcement on 16/7/14 that he would send a paper to cabinet for review of Recreational Registration.
- Roads and Maritime Services had their Registration manager working on it for some time and it was mostly ignored for about 12 months until the Motorcycle Council had further discussions with the Roads and Ports Minister's office and advisers in mid-2015.
- Discussions between the MCC of NSW and Centre for Road Safety late 2015 and early 2016 saw CRS take on the Project and we have been working with Scott Kidd on a draft proposal which is currently under review.
- Early indications are it looks promising.
- The main roadblocks could be:
  - the State Insurance Regulatory Authority (MAA), again
  - Forests NSW and National Parks as they feel that this will create a situation where riders have open slather to ride in their areas and all over their areas.
    - O This is far from being the case as dirt bikes like other vehicles are limited to using formed roads and must be registered in order to do so.
    - This proposal is just another style of registration that is less expensive in line with the time limited, lower usage of the vehicle.
  - Dept of Finance are worried about a loss of revenue from Registrations
    - o Given that we estimate 80,000 unregistered trail bikes in NSW this will in fact be revenue positive
    - o Any shrinkage will be countered by overall increase in registrations

The NSW Recreational Registration scheme was proposed as a Third Party Scheme only. Yes, the Victorian Scheme is "No Fault" and because of that it is subsidised.

## Recreation motorcycle registration

### Introduction

Recreation motorcycle registration provides a low cost option for motorcycle riders who wish to only operate their motorcycles on country roads with light traffic. Minimum construction standards apply to motorcycles eligible for recreation registration.

Note: The vehicle register records the identification details of each vehicle and the name and address of the registered operator of the vehicle. The register is not a register of vehicle ownership (title).

## Conditions that apply to recreation motorcycles

- Recreation motorcycles are not permitted on roads declared as freeways or arterial roads under the Road Management Act 2004.
- Recreation motorcycles may only operate on:
  - roads that are not declared as freeways or arterial roads and are outside built up areas (which are defined by speed zones of less than 100 km/h)
  - those areas that are not a road and are solely for the training and assessment of a holder of a motor cycle learner permit by an organisation approved by VicRoads for that purpose.
- The vehicle must not carry a load or a person other than the rider.
- The operator must wear a protective helmet of the type approved for normal road use.



## Eligibility

A person operating a recreation molorcycle must be at least 18 years of age and hold an appropriate motorcycle learner permit or licence.

# Recreation motorcycle minimum construction standards

#### General construction

A recreation motorcycle must have two wheels, and its general construction must not cause, or be likely to cause, a danger to its operator or any other person.

#### Rear vision mirror

An effective rear vision mirror must be fitted to the right side.

#### Brakes

A recreation motorcycle must have a braking system comprising of brakes fitted to both wheels of the vehicle, capable of working independently should one of the brakes fail in its operation.

### Lighting

Recreation motorcycles must have:

- one head lamp
- one rear red lamp
- one rear red brake lamp
- one rear white number plate lamp.

The power source for the lighting must not be a "total loss system" (eg. batteries). The power source must have its own re-generation for the continued operation of the lights.

## Exhaust/noise requirements

Internal combustion engines must be permanently fitted with a silencing device capable of restricting the engine noise level to 94 dBA or less (the on-road motorcycle noise level standard).

### General safety requirements

The following safety items must also be fitted to all registered recreation motorcycles:

- an appropriate horn or warning device wired into the motorcycle's electrical system
- a chainguard that protects the rider from the front chain sprocket.

## Road classification

The following table shows the road classification and code numbers of roads on which recreation motorcycles may and may not be operated. Classification and codes are shown in the RACV VicRoads Country Street Directory.
