- 2. Who initiated the discussions? Why?

- 6. Was the Premier's Office aware that:

ANSWER:

The Premier's Office has not discussed this issue with the Administrator of Queanbeyan-Palerang Regional Council.

ANSWER:

DPC staff numbers are included in the Annual Report.

QUESTION – Greyhounds

10. Please outline the process that the Government will undertake in converting crown land currently used for greyhound racing for community use? How will the community have a say during this process?

ANSWER:

All greyhound tracks on Crown land will be converted for community use. The Government will undertake a detailed planning process to determine how each site will be used. This will include public consultation on each site to understand the needs of each local community.

ANSWER:

QUESTION - Western Sydney Heat Island

17. Western Sydney is particularly vulnerable to heat increases from climate change and heat island effects. Will you commit that the proposed State Environmental Planning Policy (Protection of Trees in Urban Areas) 2016 will not lead to an increasing loss of trees across Sydney including in Western Sydney?

ANSWER:

The proposed regulatory framework for biodiversity reforms will include a new State Environmental Planning Policy (SEPP) that will change the way councils manage biodiversity in urban areas. The new SEPP will not relax existing clearing controls.

QUESTION - Western Sydney Parklands

The Western Sydney Parklands Trust manages land almost fifteen times the size of the land managed by Centennial Parklands and Moore Park Trust but has a budget almost four times less.

- 18. Are there any plans to increase funding to the Western Sydney Parklands Trust?
- (a) If yes, when will the budget be increased and by how much?

(b) If No, why not?

ANSWER:

The Western Sydney Parklands Trust is not budget dependant. The Trust is self-funded through revenue generated by leasing, business hubs, shelter hire and events at the Western Sydney Parklands. The revenue generated by the Western Sydney Parklands is increasing.

The Western Sydney Parklands is also not yet fully developed for long term public use, so costs are lower than established parks like Centennial Park and Moore Park. The Parklands will continue to be developed.

QUESTION – Western Sydney Transport

- 19. There are plans to convert the Bankstown Line to a metro line to be then run by a private operator. Will you rule out privatising other Western Sydney train lines?
- 20. Average loads on the Sydney Trains Western Line the city's busiest surged by 21 percentage points to 134 per cent between September 2014 and September 2015. Are there plans to increase the frequency of trains on this line?
- (a) If yes, what are these plans?
- (b) If no, why not?

ANSWER:

- 19. Aside from conversion of the Bankstown Line to Metro operation, there is currently no plan to change the operator of train lines in Western Sydney.
- 20. The Government is implementing network enhancements to increase the frequency of train services across the rail network, including on the Western Line. These enhancements will help to ease congestion for Western Sydney commuters by introducing additional AM peak express services from Parramatta to the City and improving the reliability of the 20 trains per hour (a train every 3 minutes) that travel on the Western Line.

WestConnex

- 21. When did the Premier become aware of the May 2013 Report of the Joint Standing Committee on the Office of the Valuer General, chaired by Liberal MP Matt Kean?
- 22. When did the Premier first see the Review from David Russell SC commissioned by the NSW Government?
- 23. Why did the government refuse to implement the recommendations of this review knowing that the compulsory acquisition process was deeply flawed?
- 24. The Premier expressed concern in June this year that "There are personal individual cases where people's homes have been acquired and I think the way we've gone about it hasn't been as careful as it should have been". Did you ever consider implementing the Russell review might avoid these issues?

ANSWER:

- 21. The Government responded to the Joint Standing Committee's report in November 2013.
- 22. The Russell Review into the compulsory acquisition of land process was delivered to Government in February 2014.
- 23 24. Since receiving the report, the Government has implemented recommendations to improve the process, including:
 - A plain English guide to land acquisition
 - Requiring a face-to-face meeting with land owners

The Government has committed to improving the compulsory acquisition process from a resident's perspective. The Government has requested the Customer Service Commissioner, Mike Pratt, examine the existing process and the recommendations of the Russell Review, and make recommendations to improve the way Government compulsorily acquires land.

The Government's response is expected to be released in the coming weeks.

Further to this, I am advised that the Valuer General has also implemented several measures for compulsory acquisition, including:

- Assigning a case coordinator to provide a central point of contact for the land owner
- Sharing all information held by the Valuer General that is relevant to the determination with the land owner.

QUESTION – Western Sydney Light Rail

- 25. The prospect of light rail around Parramatta has been on the agenda for some time now. In fact it's been three years since Parramatta Council commissioned the feasibility study for light rail in the area. Now, three years later, the Transport website currently states: "Later in 2016, Transport for NSW will consult on a detailed route with the wider community, ahead of formal consultation on an Environmental Impact Statement in 2017." Construction is only scheduled to start in late 2018. Why is this Western Sydney initiative so delayed?
- 26. Is the government planning on building a metro train line from Maroubra to Parramatta?
- 27. If yes, will this further delay the delivery of the Western Sydney light rail network?

ANSWER:

25. There is no delay to the Parramatta Light Rail project. During these early stages of planning, the Government has been consulting with stakeholders, considering route options, progressing the project's business case and determining the optimal route. More information is available at the project website: http://www.parramattalightrail.nsw.gov.au

I note Labor failed to include Parramatta Light Rail in their infrastructure plan and, when criticised, found \$1 billion for the project overnight.

- 26. While there are a number of potential solutions to the rail needs of Western Sydney, the Government has not made a decision on a new metro line from Parramatta. The NSW Government has committed to refreshing its long term transport master plan, which is planned for release in 2017. The NSW Government has also released, jointly with the Commonwealth, a Western Sydney Rail Needs Study which identifies a number of potential options, including a metro-style line from Parramatta.
- 27. No decision has been taken on a metro line from Parramatta.

QUESTION - Westconnex

28. Will any additional funding from government be required to complete stage 1, 2 or 3 of the WestConnex?

ANSWER:

The Government's investment in WestConnex is detailed in the Budget papers.

QUESTION – Public Relations

- 29. Has your Department undertaken or commissioned any opinion surveys, polling or market research?
- (a) If so, on what subjects?
- (b) If so, how much was spent?
- 30. Have any departmental or agency funds been used to sponsor posts on your Facebook page?

ANSWER:

- 29. DPC undertakes limited customer research as and when required to obtain information about the likely impact of policy changes, in accordance with the Procurement Policy Framework and NSW Procurement Board directions. The Department's Annual Report includes all consultancies valued more than \$50,000.
- 30. No

QUESTION – Parliamentary Secretaries

- 31. Are additional staff provided to parliamentary secretaries?
- (a) If so, how many additional staff are provided to each parliamentary secretary?
- (b) If so, what are the costs of this staffing?

ANSWER:

The NSW Ministers' Office Handbook provides that Parliamentary Secretaries may be provided with a full-time Secretary/Stenographer, Research Officer or Project Officer at the discretion of the Minister(s) they are assisting and that such staff assistance will be provided from the Minister's office budget. No staff have been provided in 2015-16.

QUESTION - Lock Out Laws

32. Why were The Star and Barrangaroo exempted from the lock-out laws?

ANSWER:

The lock-out restrictions sit under the *Liquor Act 2007*. Liquor licensing of casinos is administered under the *Casino Control Act 1992* and *Casino Control Regulation 2009*.

- 33. What are the roles and responsibilities of the State Crisis Committee?
- 34. What is the composition of the Committee?
- 35. Who is responsible for keeping records of its decisions?

ANSWER:

33 – 37. In the event of a significant threat to NSW, such as a terrorist incident or a major natural disaster, the Crisis Policy Committee may be convened by the Premier on the advice of the NSW Commissioner of Police. Membership of Ministers and Executives is dependent on the nature of the incident.

QUESTION – Severance Payments

- 38. Last financial year, were any severance payments made to the staff of your personal office?
- (a) If so, how many staff received a severance payment?
- (b) If so, how much was paid in severance payments in total?
- (c) If so, how much was paid to each staff member?
- (d) If so, what were the three highest amounts paid?
- 39. So far this financial year, have any severance payments been made to the staff of your personal office?
- (a) If so, how many staff received a severance payment?
- (b) If so, how much was paid in severance payments in total?

ANSWER:

38 – 39: In 2015-16 severance payments to Ministers' staff (less refunds received) totalled \$102,541. This compares with \$6.2 million paid to staff of the former government in 2010/11.

QUESTION – Western Sydney Offices

- 40. Has the office of Multicultural NSW moved from the Sydney CBD to Liverpool?
- 41. Have the State Headquarters of the Ambulance Service moved from Rozelle to North Parramatta?
- 42. Is the Head Office of Service NSW located in the Sydney CBD or Parramatta?

- 43. Is the Head Office of the Environment Protection Agency in the Sydney CBD or Parramatta?
- 44. Is the main administration office of the Office of Environment and Heritage at Parramatta?

ANSWER:

- 40. Consistent with the Government's public commitment, Multicultural NSW will be moving to Parramatta in December 2016.
- 41. Consistent with the Government's public commitment, the State Headquarters of the Ambulance Service will be relocated to Western Sydney.
- 42. Sydney CBD.
- 43 44. Property NSW has commenced a leasing market search to secure new premises in Western Sydney for Planning and Environment which includes EPA, to relocate to Western Sydney by mid-2019.

QUESTION - Ports

- 45. What is the Government's response to concerns expressed by Rod Sims of the ACCC about the privatisation of the ports of Botany, Kembla and Newcastle and his comments that "the higher price received for the sale of an unregulated asset can effectively be a tax on users or consumers, now and into the future. And it can be a poorly targeted tax on consumers."
- 46. What is the Government's response to the comments by Rod Sims of the ACCC who said of the privatisation of the port of Newcastle: "The owners factored in very large price rises because there's no regulation on how they set the price of a monopoly. How dopey is that?"
- 47. Does NSW support recommendation 24 of the Harper Review to apply competition law to further activities of the states?

ANSWFR-

45 – 46. Port Botany, Port Kembla and the Port of Newcastle are bound by the *Ports and Maritime Administration Act 1995* which enables port operators to apply statutory charges in order to earn an appropriate return on capital, with oversight by the State designed to provide transparency and reasonableness of pricing outcomes.

Under the NSW Government's oversight, all port operators must give advance notice of any proposed changes to service charges and must provide details of the charge to the Minister for Roads, Maritime and Freight. Additionally, port operators must report annually on prices, and if these are unsatisfactory, the Premier has the power to refer them to IPART for review.

47. Recommendation 24 of the Harper Review aims to ensure that governments do not harm competition when they participate in markets. NSW is open to considering the best way to achieve this objective.

It should be noted that the Harper recommendations to strengthen competitive neutrality principles (recommendations 15-17) and review policies governing government commercial arrangements with the private and non-government sectors (Recommendation 18) would also support this objective.

The Commonwealth has indicated that it will consult further with the states and territories on the implications of recommendation 24 and we look forward to engaging in this process.

Financial statements, including expenditure on consultants, are available in agency annual reports.

QUESTION - GST

- 49. Prime Minister Malcolm Turnbull has ruled out a GST because it; '...does not give you the economic dividend, the growth dividend, that would justify doing it.' Do you still support raising the GST to 15%?
- 50. Did you commission any consultants reports, external modelling or such on the impacts of increasing the GST?
- (a) (a) If so, how many?
- (b) (b) If so, how much was spent on which consultants?

ANSWER:

49. I have previously talked about the medium-term fiscal challenge facing all governments, driven primarily by increases in the costs of providing healthcare.

Of course, we will always strive to deliver these critical services more efficiently. However efficiencies alone will not fix this problem, and on current projections by 2029 the national shortfall is estimated to be over \$45 billion annually.

This significant challenge remains unresolved, and all governments have a duty to continue to investigate options for revenue reform.

On this basis, I support considering all feasible options to address this challenge. In considering options to address this challenge it is important to ensure that any changes to the tax system are fair, widely consulted and allow for sustainable long term growth.

50. No consultant reports or external modelling on the impacts of increasing the GST were commissioned by DPC or Treasury during this term of Government.

- 51. Will you name the secret political donor who paid \$2,000 to have dinner with you on 10 February 2015 and whose identity is still redacted on the Liberal Party's disclosure?

51 – 53. I refer the Honourable Member to responses provided on this issue during the course of the Estimates hearing.

QUESTION - Electoral Commission

- 54. Which parliamentarians or former Liberal Party parliamentarians have been issued a demand from the Electoral Commission to repay the illegal donations they received?
- (a) How much has each of these parliamentarians or former Liberal Party parliamentarians been asked to repay?
- (b) How long do they have to repay the illegal Liberal Party donations?
- (c) What action will be taken against those who fail to repay the illegal donations that were made to the Liberal Party?

ANSWER:

The NSW Electoral Commission advises that:

- a) it has completed its investigation and formed the view that sufficient evidence is available to justify recovery action against some of the persons who have received or benefited from unlawful donations, loans or indirect campaign contributions,
- b) those persons have been issued with demands for payment,
- c) it reserves its right to pursue recovery action in the event of non-payment; and
- d) it will release further information when it is in a position to do so.

QUESTION - Community Building Partnerships Grants

- 55. Can you explain how your department processed five separate applications for the on organisation, Lu'a Samoa, and paid them \$51,600 for \$22,600 worth of equipment?
- 56. Have the grants to Lu'a Samoa been audited grants?
- 57. Have the grants to Lu'a Samoa been acquitted?
- 58. Has the \$10,000 grant you approved to the AMCS (Australian Multicultural Christian Society), an organisation headed by Carl Trad, a convicted money launderer and person involved in stealing \$340,000, now been acquitted?
- 59. Did you approve the change of purpose for the \$10,000 grant to Carl Trad's AMCS from buying a van to feed the homeless, to buying a bus to provide free transport for Christian charities?
- 60. Which Christian charities have used the bus purchased by the \$10,000 grant you gave to Carl Trad's AMCS?
- 61. Has the East Hills Public School received the \$18,000 for a covered learning area that was awarded to the Australian Multicultural Christian Society through the 2014 Community Building Partnership program?
- 62. Has the St Christopher's Primary School received the \$20,000 for a shade cloth that was

awarded to the La'u Samoa Council through the 2015 Community Building Partnership?

63. What is your response to the statement by Father Maurice Thompson of St Christopher's Parish in Panania, who said:

"It is beyond me how a group that is not even catholic could apply for a grant on behalf of our Parish and School Community, our Catholic Samoan Community, without any of us having any knowledge of it or receiving any of the funds."

ANSWER:

55 – 63. The Community Building Partnership (CBP) program began in 2009 and provides funding to support local community infrastructure projects that benefit local communities.

In early 2016, the CBP program probity advisors Hill Rogers Assurance Partners undertook an independent review of the program's payment and acquittal processes. The report is available on the Department of Premier and Cabinet's website.

The review found the controls within the CBP program administration 'were suitably designed to achieve the control objectives identified; and the controls were implemented as designed'. The review report included 14 recommendations to improve the payment and acquittal processes in the future. The Department of Premier and Cabinet has committed to implementing all 14 recommendations.

In respect of having landholder consent, all organisations are responsible for obtaining approval for the proposed project from the appropriate land or property owner/s. Organisations are required to indicate whether they have secured approval from the land or property owner as part of their application.

If a project is successful, the release of grant funds will depend on evidence of the land or property owner's consent if applicable for the approved project.

In respect of specific projects:

- Approval was recently granted for transfer of the 2014 CBP funding of \$18,000 for a
 covered outdoor learning area at East Hills Public School into the School's Parents and
 Citizens Association (from the Australian Multicultural Christian Society). Discussions are
 continuing with the P&C to ensure the project can proceed at the School as originally
 intended.
- Approval was recently granted for transfer of the 2015 CBP funding of \$20,000 for a shade cloth at St Christopher's Primary School, Panania into the School's Parents and Friends Committee (from the La'u Samoa Council) to allow for the fit out of a covered outdoor learning area at the School. Discussions are continuing with the P&C to deliver the project.
- Funding of \$10,000 was paid to the Australian Multicultural Christian Society for the purchase and fitout of a multipurpose food van. To date, the project has not been acquitted. The findings of an audit process are under consideration by the Department of Premier and Cabinet.
- In the 2015 CBP round the La'u Samoa Council were awarded four (4) separate grants for mobile barbecues and cool rooms in the electorates of East Hills (\$15,000), Campbelltown (\$22,000), Cabramatta (\$10,000) and Lakemba (\$4,600). These were confirmed as separate projects for four individual barbecues, to be based at different church locations. La'u Samoa also made a fifth application for funding for a barbeque and cool room in the electorate of Bankstown but it was not awarded funding.

Funding for all four of the 2015 mobile barbecue projects (and one other 2015 La'u Samoa project for renovations to a community Hall in the Lakemba electorate) has not been paid. Funding is being withheld until the La'u Samoa Council properly acquits a project from the

2014 CBP round. To date, the project has not been acquitted.

QUESTION - Waste Service NSW

- 64. In 2009 did you have any discussions or communications with Paul Nicolau of the Millenium Foundation concerning Global Renewables' legal dispute with Waste Service NSW?
- 65. Are you aware that Global Renewables' Roderic David made a request of Paul Nicolau in October 2009 that you ask a parliamentary question about the legal dispute between Global Renewables and Waste Services NSW?
- 66. In November 2009 you asked the Minister representing the Treasurer about details of the contingent liabilities that could accrue because of Waste Services NSW's outstanding legal cases. Did you ask this question after a discussion with Paul Nicoloau and/or a representative of Global Renewables?

ANSWER:

In my role as Shadow Treasurer, I asked many questions of Ministers right across Government about NSW-based industries. In 2009 alone I asked Ministers over 145 Questions on Notice.

NSW Liberal and Nationals Ministers are required to disclose scheduled meetings held with stakeholders, external organisations and individuals. Under this policy, the Government has disclosed 7,034 meetings since the policy commenced in July 2014. The Opposition Leader has disclosed just 155 meetings.

I note the Opposition frontbench is yet to join the Opposition Leader in disclosing any scheduled meetings held.

QUESTION - Operation Prospect

- 67. What is the total cost to date of the Ombudsman's handling of Operation Prospect?

- 67, 70 71. Expenses incurred by the Office of the Ombudsman in the conduct of Operation Prospect will be included in the Ombudsman's report on Operation Prospect which will be tabled in the NSW Parliament before the end of 2016.
- 68 69. I refer the Honourable Member to the Ombudsman's website:

"It has recently been suggested that the Ombudsman has transferred some or all of Operation Prospect to the NSW Police, or another investigative body. This is incorrect. Professor McMillan has undertaken to complete Operation Prospect and table his report of the investigation in the NSW Parliament before the end of 2016. Once tabled, the

investigation report will be published on the Ombudsman's website."

ANSWER:

- 76. As has been previously stated, the cost of the 14-month Special Commission of Inquiry was \$4.2 million. This includes legal, employment and operating expenses.
- 77. Data related to domesticated dogs and cats are publicly available via the Office of Local Government and RSPCA. Data on the production of poultry, cattle and lambs are publicly available via the Australian Bureau of Statistics.

- 86. The staff who work the bar and food outlets at the dog tracks, they are all going to lose their iobs.
- (a) What specific assistance do you envisage the NSW Government will provide to these people?
- 87. There will be other people losing their jobs people who maintain the tracks, do the event staging, and others. Will these people be compensated?
- (a) What specific assistance will the Government be providing?
- 88. As a result of the closure of the greyhound industry, will the NSW Government need to pay any money to Tabcorp or other betting firms or bookmakers?
- 89. Will firms based outside of NSW be eligible for assistance?

ANSWER:

- 79. The Commission found that NSW greyhound clubs provided 600 individuals with paid work (full-time, part-time or casual); and that there were 4,414 participants in the form of licensed trainers, owner-trainers and attendants, according to Greyhound Racing NSW. Broader impacts are being assessed as part of the work by Dr John Keniry AM as the head of the Greyhounds Transition Taskforce.
- 80 87. Industry assistance arrangements are being developed on the advice of Dr John Keniry AM as head of the Greyhounds Transition Taskforce. Advice and support services for small businesses are being provided thought the Small Biz Connect program. Staff at affected businesses also have access to subsidised training through the Smart and Skilled program (Training Services NSW).
- 88. The Government is considering the implications for Tabcorp and other betting firms as part of the transition plan.

ANSWER:

91 – 92. Industry assistance arrangements are being developed on the advice of Dr John Keniry AM as head of the Greyhounds Transition Taskforce. Advice and support services for small businesses are being provided thought the Small Biz Connect program. Staff at affected businesses also have access to subsidised training through the Smart and Skilled program (Training Services NSW).

QUESTION - Crown Land

93. What are the issues you expect the Government will have to deal with associated with tenure arrangements relating to the greyhound industry on Crown Land?

ANSWER:

Most greyhound track sites on Crown land already accommodate a range of community uses. Most of these sites are managed by reserve trust managers, who are generally local councils or community groups. The Government will work with reserve trust managers to develop transitional arrangements following the cessation of greyhound racing. This will include a public consultation process and consideration of how existing infrastructure can best be used for community use on each site.

QUESTION - Cessation of Training

94. In the Minister's second reading speech, he said that the issue of how long trainers can continue their business after the cessation of racing will be decided by regulation. Do you have any information that you can give to these people who are trying to negotiate with financial institutions and sort out their lives now that you have pushed your law through the Parliament?

ANSWER:

Dr John Keniry AM, who is leading the Greyhounds Transition Taskforce, has been consulting

PREMIER, MINISTER FOR WESTERN SYDNEY

with industry about the appropriate time when training of greyhounds for racing should be phased out. Dr Keniry will be making recommendations to the Government.

ANSWER:

Dr John Keniry AM is leading the Greyhounds Transition Taskforce and is leading work on a detailed industry assistance package. He has been consulting with industry to ensure that a suitable range of assistance and support services are available for industry participants and other supply change businesses affected by the shutdown. He will be making recommendations to the Government.

QUESTION - Relocation

- 96. What measures are you putting in place now to avoid the mass euthanasia of greyhounds?
- 97. Following the recent meetings of various state agencies organised by Greyhounds Australia, how many greyhounds of racing age and those still approaching racing age do you expect will be relocated interstate up to 1 July 2017?

96. The Taskforce is working with RSPCA NSW and other animal welfare organisations to rehome

as many greyhounds as possible.

- 104 105. Floral arrangements purchased by the Ministry are managed within the office's budget.
- 106. The Premier's Office subscribes to a modest number of publications, the cost of which is managed within the Office's budget.
- 107. Gifts are presented to dignitaries during overseas missions and to dignitaries visiting NSW.
