

Supplementary questions from Monday 19 December 2016

1. Does the Department have estimates for how many businesses may leave the industry as a result of these reforms?

No. To date 131 applications for fishing business buyouts have been received. The vast majority of these are transactions between related businesses, i.e. amalgamations of businesses with a common owner.

2. Does the Department have estimates for how many businesses may leave the industry in each region as a result of these reforms?

No. The closest information the department has access to is the number of inactive shares and inactive fishers. This may provide an indication of the number of businesses that wish to exit the industry.

3. What modelling has the Department conducted to estimate this?

See answer to Question 2.

4. When the Department put together its package for the industry, what was the number of exit buyouts assumed in the budget process?

121 fishing businesses are completely inactive and might be expected to change hands or exit. It is also expected that additional holders of fishing businesses would opt to exit the industry, or consolidate their fishing businesses.

5. Why was a Social Impact Assessment for this reform not completed?

Deliberations made by the Structural Adjustment Review Committee (SARC) included high-level discussions of social, economic and environmental impacts of management options.

6. Given the calls for a Social Impact Assessment to still be completed, is the Department open to doing so?

The government is considering the feasibility of conducting a social impact assessment and the scope of such an assessment.

7. Of the 138 staff who previously worked at the Cronulla Fisheries research facility, how many remain working for Fisheries?

Of the 138 staff who worked at Cronulla Fisheries Research Centre, 117 worked for DPI Fisheries. This included scientists, technical staff, admin support, licensing staff and fisheries managers.

Approximately 50% of these DPI staff relocated to new locations following the closure of the Cronulla Fisheries Research Centre.

8. How many scientists worked at the Cronulla Fisheries research facility immediately prior to its closure?

18 scientists worked at the Cronulla Fisheries research facility. These scientists worked on issues such as stock assessments, shark research, by catch reduction, gear modifications and marine eco-systems research.

9. How many of those scientists still remain working for Fisheries?

9 of the 18 scientists currently work for DPI Fisheries.

10. How many scientists worked in stock assessment at the Cronulla Fisheries research facility immediately prior to its closure?

13 – note that not all of the 18 scientists that worked at the Cronulla Fisheries facility directly provided input into resource assessments.

11. How many of those scientists still remain working for Fisheries?

6 scientists working in resource assessments at the Cronulla Fisheries research facility continue to work for DPI Fisheries.

A number of the staff working at Cronulla Fisheries were over the age of 55 and took up other offers such as retirement and positions at universities.

12. How many scientists worked in the Wild Fisheries team at the Cronulla Fisheries research facility immediately prior to its closure?

16 – this comprises the 13 scientists that were directly involved in resource assessments, and other staff that:

- may have had involvement in areas outside the resource assessment process, or
- didn't have a direct contribution to the resource assessment process due to their seniority in the organisation

13. How many of those scientists still remain working for Fisheries?

8 scientists from the former Wild Fisheries team continue to work for DPI Fisheries. Additional staff were recruited after the closure of the Cronulla office. A short term reduction in the group's capacity was resolved and improved through the recruitment of staff with broad experience in the field of fisheries resource assessment.

14. Who is the population modeller for resource assessment purposes within Fisheries?

Several of the species experts within the Fisheries Resource Assessment group have extensive experience in population modelling for specific species.

15. What is the population modelling experience now held in within Fisheries?

See answer to Question 14.

16. Confidence in the stock assessments has been described as being at an "all time low". What is the Department planning to do to address this?

The Department has full confidence in the resource assessment process. Metrics regarding the performance of the resource assessment group since the relocation from Cronulla are all improving with increases in peer reviewed outputs, increases in funding and a proven track record in meeting all project related milestones.

In addition, to continue improving the assessment program, DPI proactively commissioned a review of the resource assessment framework by fishery scientists John McKoy and Kevin Stokes. The recommendations of this report will be implemented including:

- developing a Harvest Strategy policy and framework to achieve environmental, economic and social objectives
- undertaking a review of collection and quality of commercial catch information
- revising and updating the Fisheries Management Strategies
- increasing stakeholder engagement, including as part of the Total Allowable Fishing assessment and review process.

NSW will also be transitioning to the Commonwealth Status of Australian Fish Stocks (SAFS) reporting framework by 1 July 2017, which will help ensure there is consistent reporting of fish stocks nationally.

17. The committee heard evidence that previous resource assessments contained more information than the most recent assessments that have been issued. Is this the case?

No. Resource assessments are conducted and published annually and are available at <http://www.dpi.nsw.gov.au/content/research/fishing-aquaculture>

On a regular basis, a comprehensive report is published, known as the status of fisheries report. The most recent status of fisheries report was published for 2013-14. In other years a summary document is produced. The 2014-15 summary will be published in the coming weeks.

In addition to this, NSW has committed to transition to the Commonwealth Status of Australian Fish Stocks (SAFS) reporting framework. The Commonwealth report will be supported by domestic assessments that will adopt the SAFS framework. This will provide additional information on species that are of particular importance to NSW.

18. What are the Department's plans to address this?

See answers to questions 16 and 17.

19. The proportion of the assessment that falls in the uncertain or undefined categories seems to have increased over the last five years. Is this the case?

Yes, however there are shifts up and down over this period.

20. Why is this the case?

The process seeks to carry out assessments on around 117 species. The stock assessments look at the impact on fish stocks due to commercial or recreational harvest. Many of the species that are classified as undefined do not have significant levels of commercial or recreational harvest associated with them.

21. Is it regarded by the Department as a problem?

No.

22. What is being done to address this?

Transition to the Status of Australian Fish Stocks framework will facilitate a more effective focus on assessment of priority species and will provide a consistent approach to reporting nationally.

23. Did the closure of the Cronulla Fisheries research facility impact on this?

No.

24. Wouldn't this reform process have been easier without the closure of the Cronulla Fisheries research facility?

No. The closure of the Cronulla Fisheries Research Centre did not impact on the capabilities of the fisheries research group. Since the closure, staff with broad experience in the field of fisheries resource assessment have been recruited.

The recruitment process provided further opportunities to align resources with future needs, resulting in greater capacity in areas in which key commercial and recreational fisheries occur and in co-location with universities.

Since the relocation of staff from Cronulla, there have been:

- No defaults in completion of projects.
- Similar FTEs (scientists plus technicians).
- More scientific outputs.
- Greater external funding.
- Better assessments - especially for recreational catch but also increased observer coverage.
- Improved strategic planning and better alignment to management and industry needs.

In addition:

- co-location with industry has improved understanding of commercial and recreational fishing priorities
- co-location with universities has improved links with students and increased innovation.

25. Does the Department accept the evidence put to the committee that these reforms will result in the closure of a number of Co-ops?

The department recognises that some Co-ops may be impacted by a number of factors including generational change in the industry and the reforms. The Government has put in place a range of assistance measures to help Co-ops manage the expected change.

26. What additional assistance is proposed to deal with this?

The following assistance is being provided to Co-ops:

- payments of \$30,000 to for obtaining specialist business advice on how Co-ops may adjust their businesses depending on what their members choose to do through the program
- short term rent subsidies for fishing Co-ops on Crown Land.
- standardised long terms leases for fishing Co-ops on Crown Land.

27. What are the Department's plans to strengthen Country of Origin labelling?

The department is looking into strengthening country of origin labelling so that benefits can be extended into the cooked seafood market. The program would aim to provide consumers with knowledge on where the cooked seafood they purchase comes from. However, this needs to be developed in consultation with industry. The NSW Government will work closely with the fishing, catering industries and retailers on how a source of origin labelling scheme could operate in NSW.

28. What is the current status of the Aboriginal Commercial Fishing Trust?

The Aboriginal Fishing Trust has been established under section 233(1)(d1) of the *Fisheries Management Act 1994*. Operational arrangements for the Trust are currently being developed in consultation with the Aboriginal Cultural Fishing Advisory Council (AFAC) and with input from other key organisations and stakeholders. Initial funding options are being pursued and potential contributors have been approached to assist in building a strong foundation to be able to commence operations.

29. What is the timeline for establishing the governing body and governance arrangements?

It is anticipated that governance arrangements will be in place so that calls for applications for expenditure from the trust can commence during the 2017/18 financial year.

30. When does the Government anticipate the Aboriginal Commercial Fishing Trust will be fully operational?

It is anticipated that calls for applications for expenditure from the trust will commence during the 2017/18 financial year. The Trust will be open to funding applications that:

- take measures to enhance, maintain or protect Aboriginal cultural fishing or provide economic development opportunities for Aboriginal communities in relation to fishing or fishing-related activities.

31. What engagement has there been with Aboriginal representative bodies in regards to the establishment of the Trust?

The Aboriginal Cultural Fishing Advisory Council (AFAC) has been consulted on the Trust implementation arrangements and will have an on-going role in governing the Trust.

AFAC has fourteen members which include:

- ten Aboriginal people providing regional perspectives from across the State,
- the NSW Aboriginal Land Council (NSWALC),
- NTSCORP,
- an Aboriginal person with relevant expertise, and
- a non-voting senior officer from the department.

In addition to the engagement with the NSWALC and NTSCORP through their membership on AFAC, DPI – Fisheries has also been directly engaging with these organisations.

32. What would need to happen before the Aboriginal Commercial Fishing Trust would be in a position to purchase commercial fishing shares.

Operational arrangements and establishing a funds base need to be resolved before expenditure from the Trust can occur. Once these matters are resolved the next steps involve calling for applications for expenditure in line with formal criteria, and assessing applications before decisions about investments can be made.

33. Can the Government confirm that if the Trust was to purchase a fishing business or shares before the BAP started, it would then be considered an active fisher in that fishery and would then be eligible for subsidy through the BAP?

The Trust is not operational yet and the Trust timeline does not align with the BAP timeline.

Furthermore, the Trust will operate on the basis of calls for expressions of interest which would not align with the planned framework for the Business Adjustment Programme (BAP). The proposed market has been constructed to allow for minimal involvement from Government. Inclusion of the Trust in this process could distort the market and threaten the integrity of the BAP.

34. Would the Government consider entering the market to secure a number of shares that can be allocated or purchased by the trust when it is in that position?

Fishers are encouraged to participate in the first instance. The government is prepared to consider other options if fishers are unsuccessful in the subsidised trading market. It would be difficult to justify providing assistance to fishers who have not adequately engaged with the Business Adjustment Programme.

35. Is the department aware of concerns about potential pollution in the Manning river impacting prawns (See testimony from Mr Saunders)?

a. If yes, has there been any investigation of these concerns? Has there been any referral to the EPA?

b. If there had been any investigation, what was the outcome?

Questions regarding pollution are best directed to the EPA.

Supplementary question relating to Ms Danielle Adams, Clarence River Fishermen's Co-operative

36. We have been doing a lot of work with our shareholders to see where they need to be, what they need for the future and just to make sure that they recognise the viability. The share register was released in October. There were 379,800 shares in the share register. The share register that was just released in December had over 407,000 shares. There are 27,000-something shares extra from one month to another. We would like to know where those shares came from and why they have appeared and are not in their previous answer.

There were 407 121 shares in both the 6 October 2016 register and the 6 December 2016 register. See the attached share registers.

Supplementary questions contained in Mr Paul Heron's submission

37. Why are there no DPI representatives at the preview of the share trading sessions? Why are they not there to listen and answer concerns from the fishing industry about the reform process?

The preview market training sessions were run by Rural Training Initiatives, a professional training company with more than twenty years' experience delivering capacity building and industry leadership programs for the primary industries sector, including for the seafood industry.

The training sessions had a specific purpose, which was to demonstrate the share trading market software and teach fishers how to place bids and offers for shares, to help prepare them for the preview market. The training sessions were run by an experienced professional trainer, not the department.

38. As I attended the preview session on the 12th of September, I asked 14 questions to do with my personal concerns about the industry and 13 replies were answered with I don't know and one with a no. I left this meeting after wasting 2 hours of my night with no answer to any of my questions. How do you think this satisfactory information for fishers?

The government regrets the frustration experienced but made it clear from the outset that the training sessions were limited to market training and were not general information nights.

The training sessions were not intended to discuss other elements of the reform. Ongoing support for fishers with concerns or questions about the business adjustment process is provided by the business adjustment program hotline which has received more than 1500 calls to date.

39. If I own a share in any other company, you would know what the dollar value is when you buy or sell these shares. Why has DPI never given a value to each share unit within the commercial fishing industry?

Share prices are determined in and by the market and change over time.

40. Why didn't DPI free up shares by offering a buyback scheme to free up shares, this way the share market could commence on time by a barter system with fishers willing to leave the industry at the right price not forced out.

The approach to the buyback and subsidised share trading market was informed by a number of reviews and advice from independent experts over a period of nearly 10 years. These include advice from:

- The independent report on structural adjustment in commercial fisheries in NSW, Stevens 2007
- The independent review into NSW Commercial Fisheries policy, management and administration commissioned by the NSW Government in 2012.
- The Structural Adjustment Review Committee (SARC)'s report, *NSW commercial fisheries reform final recommendations on share linkages*

41. If the R.A.A is only offering loans of up to \$80,000 how can I buy the shares I need to fish. I need approximately a cost of around \$250, 000+ on current share prices to fish as I do now. I have spoken to R.A.A about loans and they require a 3-year cash flow forecast and a 3-year business plan, which is impossible to forecast as I have not worked an example of the reform to estimate cash flow return. There is no information on how it will affect my business as yet. The only other way is to hand over my house deeds and business as collateral which is also impossible as it is all already tied up in an existing home loan by which I am only 2 years into. So how am I expected to get this?

The government is providing grants of:

- up to \$1,000 for fishers to access independent financial advice through an accountant or financial adviser to inform future business planning.
- up to \$1,000 for fishers to seek assistance relating to the share trading market including legal advice and/or to appoint a professional to place bids and/or offers on the behalf of them in the subsidised share trading market.

When making any calculations on potential expenditure to purchase shares, it is important to bear in mind:

- the actual number of days a fisher needs to catch the level they have been fishing at - not necessarily 365 days
- the share prices that are currently advertised on the market are typically not the final prices
- the NSW Government will subsidise the share purchases for active fishers.

We have confirmed with the Rural Assistance Authority that Mr Heron has not made an application for a low interest rate loan.

We suggest Mr Heron takes advantage of the grants on offer and obtains some free financial advice.

42. Why have you stated in your past media releases that 75 fishing businesses have sold when you know these are empty business numbers with no shares attached?

The government has received 131 applications for fishing business buyouts to date and encourages the sale of inactive or unwanted shares to fishers who needed them.

43. Why have you also stated that there was 4 million dollars applied for in R.A.A loans but in media release on 12th September 2016 it has changed to around 2 million, was your first statement a lie just like this whole reform is?

Over 100 applications for low interest loans have been received, the value of these loans can vary depending on how they are reported.

44. If over 40,000 shares have been traded by fishers as you say, why is there still no shares available to the fishers on a share market and only a preview is available? Or as we all suspect are the only shares being traded are from john smith back to john smith to link his/her own shares together.

Shares can still be traded on the private market – both prior to and after the subsidised process. The subsidised share market will occur in 2017. The preview share trading market was designed for fishers to practice placing bids to buy and offers to sell shares so they are prepared for the subsidised share trading market next year.

45. Why does the minister only listen to the P.F.A and not the WCFC? The WCFC has more members than the P.F.A and is clearly the peak body for the commercial fishing industry.

The NSW Government seeks to consult with all stakeholders but in turn relies on stakeholders engaging productively. Significant consultation has occurred with industry and the community during the reform process including the WCFC. Each step in the process of implementing the reforms involved public calls for submissions, regional meetings, stakeholder reference groups and responding to issues raised.

46. Why does the minister and D.P.I. only listen to groups that are appointed by the minister and not properly elected by fishers by a voting system from all fishers? This has been happening since 1995.

See answer to Question 45.

47. The reform is unjust and unfair to fishers who bought their business before 2000 as they bought their right to fish as an RFO complete with access to all endorsement's. These businesses were issued with a business number and ABN number and were deemed viable, so why now has that changed and I need to buy 3 more businesses worth of shares to fish as I do now?

Under the current fisheries management arrangements, in most cases the value of fishing rights (shares) is not proportional to catch or effort. As recommended by a number of independent reports, experts and the Commonwealth Productivity Commission, the Government will change this by linking shares with catch or fishing effort to create greater certainty for fishers, greater viability for the industry and more sustainable fisheries.

48. For 20+ years I have owned and operated my business never asking for government assistance. So why now do you want to force me into debt and work less days to repay monies owing on top of existing debt and only able to work 92 days a year based on my current shares.

See answers to Questions 41 and 47.

49. Fishers need to know DPIs end game, what they want to achieve from this reform and where the constant rise of shares to fish will end?

The primary aim of the Business Adjustment Program is to support the ongoing economic viability of NSW commercial fishers. A viable and sustainable commercial fishing industry is also fundamental to:

- delivering value and security to the industry
- delivering sustainability outcomes for the state
- effectively managing the marine estate
- providing for Aboriginal fishing rights and interests
- providing flow on benefits for the recreational fishing sector

50. This reform is causing stress, depression and anxiety on most fishers, I myself have a 3- year-old son and a baby due in February 2017. So, imagine this, I tell you as of tomorrow you can only work 75 days of the year based on your current wage and if you want to work more days you need to get a loan for \$80,000+ to work more days. So, including your expenses you currently have you also need to pay back the \$80,000+ on less days that you work now. Would you be able to survive and support your family?

The government understands that reforms of this type can create uncertainty for people and can be a stressful time for those involved.

The Fisher Care Line has been set up to provide counselling sessions that will support fishers experiencing stress, and we have made available free support services including financial counselling, legal advice and other help lines.

The NSW Government is working to quickly and clearly communicate to reduce as much as possible any uncertainty fishers may have about the reform process and its impact on them.

51. This reform is forcing fishers out of the industry. Most fishers have no experience in other fields as most are 2nd and 3rd generation fishers, others are at retirement age and fear they will not be employed due to their age. How is this fair?

The NSW Government recognises the various independent reports identifying that there has been a significant over-allocation of shares that needs to be addressed for the industry to remain viable.

The aim of the reform is to provide an economically viable industry into the future. Some fishers may choose to exit the industry. It is not the intention of the reforms to force out a particular number of commercial fishers from the industry.

The government is providing \$10 000 towards retraining expenses for those exiting the industry.

52. The treasurer has stated the “liberal government” is focused on small business, growth, jobs and wealth which has helped the economy over the last 25 years. How does destroying many small fishing businesses which have operated through this growth period help our economy? Or is this also another lie from the liberals?

The primary aim of the Business Adjustment Program is to support the ongoing economic viability of NSW commercial fishers.

53. As many industries, have been destroyed over the past year+ such as taxis, greyhounds, steel, electricity, famers, timber, transport, council merges and now the fishing industry. With recent polls and local council voting results how do you think this will help liberals at the next election when you are putting more people out of work?

The primary aim of the Business Adjustment Program is to support the ongoing economic viability of NSW commercial fishers.

54. The minister is saying he is consulting with the entire fishing industry and listening to all concerns from fishers, then why hasn't the minister visited any fishers from region 6 at any time since this reform started?

Minister Blair met with Commercial fishers from Region 6 in Nowra on 1 February 2016. The Minister has met with more than 200 commercial fishers up and down the coast throughout the reform process.

55. I have sent many letters addressed to the minister outlining my concerns and yet all these letters and consultation papers never being answered by you or your colleagues. Will you have a lie as to why you have not answered? Apparently, it is against the law for you not to respond but you still don't respond.

The department seeks to respond to all correspondence. Mr Heron's letter of September 2016 was responded to in December 2016.

56. We in region 6 would like Minister Niall Blair to attend a meeting with us personally to discuss issues raised within our region and the reform.
