- Ferrybridge FM1 (in operation, brochure attached) and FM2 (in construction, FM1 & FM2 Overview attached) processes the following wastes MultiFuel:
 - Solid Recovered Fuel (SRF), municipal solid waste, commercial /industrial waste, waste wood
- Riverside (built, brochure attached) processes the following wastes:
 - o Domestic Solid Waste
- Mallorca (brochure attached) processes the following wastes:
 - Municipal solid waste and commercial waste
 - Specific waste fractions Hospital waste (<10%), sewage sludge (<10%), tyres (<2.5%)
- File HZIA corrections (2 minor amendments; attached)
- Press release by VIC Premier Daniel Andrews demonstrating what other States are ready to facilitate with regards to protected cropping and renewable energy

We encourage you to consider:

- Fulfil our societal obligations under the Paris Agreement to move towards a sustainable society
- Ban all untreated waste going to landfill in line with European Community and replace the NSW EfW Police with the European EfW standard (WID/IED)
- Ramp the NSW landfill levy to the same level as in the UK for all of NSW as well as a lower rate for ash material (also applicable for ash from coal and biomass power stations unless recycled); encourage all other States to do same.



- Hypothecate all levies raised back to industry (composting, recycling, Energy from Waste, landfill remediation) to make (nearly) zero waste to landfill happening
- Introduction of Standard Rules SR2012 No13 from England and Wales as a proven standard for millions of tons of bottom ash recycling every year (attached)
- EfW plant visits in Europe

The last point being the most important point, we would be happy to facilitate a program to visit some EfW plants and facilitate discussions with respective local and state regulators, politicians and community groups. We suggest to visit:

- Ferrybridge FM1 (in operation) and FM2 (in construction), near Leeds UK
- Riverside in London UK
- Mallorca Spain

If requested, I would be pleased to provide further evidence or information to the inquiry.
