QUESTION – Campbelltown Koalas

1. The Campbelltown area contains the only healthy, chlamydia free population of koalas listed in NSW as actually growing. Their long term survival is now under threat from proposed urbanisation projects in the Campbelltown and Greater Macarthur area. What actions is the Minister for Western Sydney taking to protect these koalas?

ANSWER:

Koala habitat will be protected through a range of measures. The government has acted on the recommendation of the NSW Chief Scientist and Engineer that a whole-of-government NSW Koala Strategy be developed and has committed funding to:

- deliver a state-wide map of potential koala habitat and updated map of koala occurrence to support planning and decision making.
- \$800,000 for on-ground koala conservation activities in 2017-18 through the Saving our Species program, which is aimed at securing NSW's threatened species in the wild for the next 100 years. This is part of the \$100 million committed over the next five years to protect of all threatened species in NSW. This includes \$50,000 to help implement and support the actions in the draft Campbelltown koala plan of management such as restoring habitat connectivity, community engagement and identification of hotspots for dog attack.

54 – 56. All NSW Government agencies are required to impose surcharges to recoup their merchant interchange fees, pursuant to Treasury Circular TC12/13.

Agency staff only use their Pcards for the purchase of goods and services for official business purposes. If particular vendors elect to impose a merchant fee on card transactions, that is an unavoidable cost of doing business. It would not be possible to determine fees charges to Departmental cards, as these would either be embedded in the individual transaction cost, or if separately disclosed would require each monthly card statement for each user to be reviewed.

- 89. The original WestConnex Business Case was prepared in "Real" 2012 dollars and did not take into account inflationary impacts for future years. The original Business Case estimate of \$11.5 billion was converted to "Nominal" dollars that is "Real" dollars after allowing for inflationary impacts resulting in an estimate in "Nominal" dollars of \$14.9 billion. All WestConnex Business Cases and budgets are now shown in "Nominal" dollars.
- 90. The increase from \$14.9 billion to \$15.4 billion was due to approved scope changes, which enhanced the effectiveness and benefits of the project and increases in land acquisition costs.
- 91. The increase from \$15.4 billion to \$16.8 billion was due to scope changes which enhanced the effectiveness and benefits of the project.
- 92. The WestConnex budget remains \$16.8 billion with the WestConnex project making the already budgeted \$800m contribution towards the motorway component of the Sydney Gateway project.

- (a) If so, where can it be found?
- 133. Will the Sydney Motorway Corporation pay the builders of the Sydney Motorway Corporation \$800 million as an allocation or will this be an additional payment made by NSW Taxpayers?
- 134. On page 4-11 of the NSW Budget's Infrastructure Statement the "Estimated Total Cost" of the Sydney Gateway is stated as \$800 million. Is this an error or a lie?

179 – 184. I am advised that the majority of the M4-M5 Link's tunnels will be located at depths of greater than 35 metres in Hawkesbury sandstone, which provides ideal tunnelling conditions. Similar to other tunnelling projects in Sydney such as NorthConnex, Sydney Metro and the New M4 and New M5, work on the M4-M5 Link would be regularly monitored and assessed to ensure tunnels are strengthened appropriately for minimal impact at ground level.

The Environmental Impact Statement for the M4-M5 Link is on public exhibition until 16 October 2017. It discusses potential impacts on buildings and open space and recommends further assessment during detailed design and construction planning to be carried out once a contractor is appointed to the project.

All properties on the surface within 50 metres from the outer edge of the tunnels will be offered a property condition survey before and after construction. This will ensure a clear record of property conditions before construction starts.
