'Ceased to Trade & Recommence Trade' figures are indicative only. Liquor & Gaming NSW can only quote instances where it has been advised that a venue has ceased (or recommenced) trade.

Some venues have multiple entertainment-related conditions, so have been included once only to avoid double-counting.

Most on-premises restaurants are also catering services, accommodation, vessels, karaoke etc. so have multiple business classes. Most public entertainment venues are also restaurants.

**Question 4:** 'Of the liquor on premises licences, could you divide these into the following categories - how many of them are restaurants and how many are entertainment venues?' (Based on table supplied for Q44)

**Answer:** Restaurants - 171 of 213 total on-premises venues with entertainment conditions total; Entertainment venues: 1 of 213 total on-premises venues with entertainment conditions total.

**Notes:** The number of 'cancelled' licences reflects a shift from a perpetual to an annual liquor licence scheme in 2015. Many licences were not being utilised (often for many years) but had never lapsed. In effect, the introduction of an annual fee resulted in an accurate picture of the actual number of operating licences being established.

'Ceased to Trade & Recommence Trade' figures are indicative only. Liquor & Gaming NSW can only quote instances where it has been advised that a venue has ceased (or recommenced) trade.

Some venues have multiple entertainment-related conditions, so have been included once only to avoid double-counting.

Most on-premises restaurants are also catering services, accommodation, vessels, karaoke etc. so have multiple business classes. Most public entertainment venues are also restaurants.

**Question 5:** 'Could you also indicate the numbers in each of the following categories - cancelled, surrendered, ceased to trade, recommenced trade?' (Based on table supplied for question on notice 39.)

**Answer:** As per table below.

**Notes:** The number of 'cancelled' licences reflects a shift from a perpetual to an annual liquor licence scheme in 2015. Many licences were not being utilised (often for many years) but had never lapsed. In effect, the introduction of an annual fee resulted in an accurate picture of the actual number of operating licences being established.

'Ceased to Trade & Recommence Trade' figures are indicative only. Liquor & Gaming NSW can only quote instances where it has been advised that a venue has ceased (or recommenced) trade.

Some venues have multiple entertainment-related conditions, so have been included once only to avoid double-counting.

Most on-premises restaurants are also catering services, accommodation, vessels, karaoke etc. so have multiple business classes. Most public entertainment venues are also restaurants.
