# 1 Apologies Dr Geoff Allan, Deputy Director General, NSW DPI Fisheries.

# 2 Day 1 10:30 - Meeting with The Hon. Niall Blair (Parliament House).

Members met and were welcomed by The Hon. Niall Blair MLC Minister for Primary Industries at Parliament House. The Minister welcomed all members, acknowledged the local traditional owners and member John Luke as the Aboriginal Commercial Fishers representative. The Minister thanked all members for their participation in the newly formed Commercial Fishing Advisory Council (CommFish NSW AC) and indicated that he was looking forward to receiving advice from the Council on NSW Commercial Fishing Industry issues



All members introduced themselves and summarised their experience in the fishing industry. The Chair discussed a range of issues including transparency, working groups, agenda items and the Business Adjustment Program (BAP).

#### 3 12:30 - Chair's introduction.

The Chair initiated discussion on their membership roles, conflict of interest disclosure, recording of minutes, pecuniary interests, the overall objectives of the Council to make recommendations as a whole and the public/media interaction of members.

#### 4 CommFish NSW AC Induction

Carolyn Raine (NSW DPI) presented the induction presentation, with a focus on the CommFish NSW AC 'Draft Charter'. The Council considered the 'Draft' CommFish NSW AC Charter that had been previously circulated to members, with some of the main points discussed including terms of reference. Following clarification of a number of sections in the Charter, the Council endorsed it as the basis for its operation.

DECISION: Adopt CommFish NSW AC Charter.

RESULTING ACTION: Release adopted CommFish NSW AC Charter to NSW DPI intranet.

RESULTING ACTION: All CommFish NSW AC members to contact the executive officer if pecuniary interests submitted to the department change.

DECISION: All CommFish NSW AC papers to be made available on the NSW DPI Website, including the Chair statement.

RESULTING ACTION: Release Chair Statement to NSW DPI Internet.

DECISION: Improve industry's understanding of the process of working group involvements initiated by members.

RESULTING ACTION: Draft a media release that includes how decisions are made, with members and other NSW stakeholders can have input into recommendations and also promote working groups.

# 5 CommFish NSW AC Strategic Agenda & Meeting Dates

The Council agreed to the following dates and locations for future CommFish NSW AC meetings, with strategic agenda to include:-

### 5.1 Strategic Agenda

The following terms for future meetings this year were agreed:

- all will be 2 day meetings
- meetings to start at 1200 on day 1, finish by 1400 on day 2
- Sydney to be the location at least for next two meetings with future meetings considered for regional areas. To be researched further and members to formulate a potential list of invites.

DECISION: All CommFish NSW AC Members to formulate a list of potential invites to member events, with particular focus on including some young stakeholders to informal get together or as observers.

RESULTING ACTION: All CommFish NSW AC members to contact the executive officer if they wish to nominate an invite to member events.

The Chair referred to Charter as Terms of reference, indicating important that we conduct meetings in a professional manner and that the Council is required to make majority recommendations even if not all members support specific recommendation. The Chair also indicated for members to contact either the Chair or executive officer in regard to additional agenda items. Attendance by proxy members is not permitted but written comments on agenda items may be accepted if the member is



unable to attend the meeting. The Chair indicated that his contact details can be distributed all members of the Council and that a list of all members contact details should be distributed to members of the Council. All members agreed to the release of their contact details to other Commfish NSW AC members.

ACTION: Executive Officer to distribute the contact details of the Chair and all members, including their division represented to all members of Council.

The following dates, locations and topics were confirmed, with unanimous decision to switch topics of meetings 2 and 3, moving the Catch and Effort Online Reporting & Culture of adoption within the Industry to meeting date 2.

DECISION: MFAC Resource sharing document to be distributed to members prior to meeting 3 (Investment Plan for the Commercial Fishing Trust).

RESULTING ACTION: Distribute MFAC Resource sharing document to CommFish NSW AC members prior to meeting 3.

DECISION: Members to contact Chair/other members in regard to any other items to add to agenda, with ongoing agenda prioritisation, with members also to develop strategies of engagement with local fisherman at either the meeting or informal gatherings.

ACTION: Draft agenda for next meeting, including potential to add resource sharing within the department and SFT to agenda for meeting 3.

# 6 Working groups & MISC Meeting 1 discussion (Cost Recovery)

The Council discussed the importance and different types of working groups, with the Chair indicating that several working groups may be required for the Council around the topics of the investment Plan, Fisheries Research Development Council (FRDC) consultation with public and the cost recovery framework. These groups may require specialist advice, with NSW DPI indicating that there is funding potentially available if required for specialist working groups or advice (e.g. Economist).



A short discussion ensued on different forms of cost recovery that could be discussed in a working group including those used in other States and the Commonwealth cost recovery frameworks. Any cost recovery should take into consideration the public good component that should not be recoverable.

The Chair requested if there were any proposals from members for any specific working groups at this stage, with none indicated by any members.

DECISION: Unanimous decision that working groups would be formed only on an as needs basis.

The Chair discussed conflict of interest with the observation that all members have some form of interest because of their involvement and expertise in different fisheries but that is not a bad thing as long as it is recognised and on the table for all members to be aware of. When a member has an interest where the member could be disproportionately impacted, compared to others in that fishery, either in a positive or negative way, that member would be asked to leave the room while a decision was being made.

The Chair requested that a register of interests be completed, indicating that won't be done before tomorrow's meeting, so each member will verbally declare all pecuniary interests first thing tomorrow to all other members for clarity and transparency.

ACTION: Executive officer to develop a register of pecuniary interests of all members and forward this to the Chair.

Chair adjourned the meeting at 3:45pm and thanked all members and invitees for their attendance.

## 7 Day 2 9:00 - Chair's welcome and introduction

The Chair acknowledged the traditional owners of the land past and present. The Chair introduced Darren Reynolds, Senior Fisheries Manager NSW DPI, as an invitee to present NSW DPI's proposals on each of the NSW DPI BAP consultation papers.

#### 7.1 Conflict of Interests Declarations

Each member verbally declared their current interests (pecuniary) for transparency, including a pecuniary interest declaration of NSW DPI members and guests.

ACTION: Add to agenda item of next meeting that member's to update pecuniary interest declarations if required.

## 7.2 Strategic Agenda Items

#### 7.2.1 BAP Consultation Papers

The Chair reiterated that it is important for members to consider the interests of NSW fisheries as a whole and the consequence of complex management arrangements on cost recovery when considering their views. With Darren Reynolds introducing each topic, including industry feedback submission results, background required and existing NSW DPI proposals.



#### 7.2.1.1 1. Regulations to support redefinition proposals

NSW DPI clarified that share management fisheries are defined in the *Fisheries Management Act 1994* (the Act), and some fishery changes require a redefinition (e.g. expanding the waters of the spanner crab component of the Ocean Trap and Line fishery).

#### 7.2.1.1.1 Issue 1 Defining 'majority support'

The Council discussed the pros and cons of various ways to determine majority support.

OUTCOME: Unanimous support for recommendation that a 50%+1 vote, or greater than 50% of eligible votes, as 'majority support' determination be incorporated.

#### 7.2.1.1.2 Issue 2 – Shareholders who fail to vote

The Council discussed shareholders who fail to vote.

OUTCOME: Unanimous decision to recommend that shareholders who fail to vote are to be disregarded when determining if a redefinition proposal has majority support.

#### 7.2.1.1.3 Issue 3 Weighing votes based on shareholdings

The Council discussed the pros and cons of weighting votes based on fishing businesses and shareholdings. NSW DPI clarified that the proposal was to be one shareholder equals one vote irrespective of the number of fishing businesses or shares owned.

The Council discussed the proposal in terms of future cost recovery, shareholders with multiple fishing businesses and the variances of polls held by the business community and society in general.

OUTCOME: Majority support a recommendation that votes should be weighted on shareholding (i.e. the number of shares held by a shareholder), with one member wanting to record concerns relating to the possible impact on smaller shareholders.

#### 7.2.1.1.4 Issue 4- Conduct of Polls

The Council discussed the need for any poll to be cost effective, efficient and be accompanied with clear instructions and support. The Chair summarised that majority support seemed to be for hard copy and electronic, but have the choice to do by paper (two options).

OUTCOME: Unanimous support recommending that polls be conducted in writing by either hard copy or email, noting that the Council recommends that electronic reporting polling be considered, in order to aid in cost reductions for industry and include appropriate education/support.

#### 7.2.1.2 2. Transfer rules for new species shares

The Council discussed both options for the transfer rules that will apply for the new species (quota) shares. The discussion included the ultimate flexibility of Option 1, harvest strategies, the benefits of investment in the industry and the need to be able to maximise return on investment.

OUTCOME: Unanimous support for the recommendation for maximum flexibility (Option 1) in regard to the transfer of new species shares.



#### 7.2.1.3 3. Transfer rules for new catch and effort quotas

The Council discussed NSW DPI's proposal, including advantages of ongoing entitlement rights of shares and instant trading of shares electronically.

OUTCOME: Unanimous recommendation to accept NSW DPI proposal as it is, with only holders of the relevant new species shares or a share class that is subject to quota be allowed to hold the relevant quota.

**7.2.1.4 4.** Criteria for the allocation of new effort shares in the Ocean Prawn Trawl fishery NSW DPI presented proposals regarding the allocation of new effort shares in the Ocean Prawn Trawl fishery.

#### 7.2.1.4.1 Issue 1: Determining the 'snapshot date'

The Council discussed the proposal and the importance of providing people with certainty and clarity.

OUTCOME: Unanimous recommendation to accept NSW DPI proposal to have a snap shot date around mid-2018.

#### 7.2.1.4.2 Issue 2: Identifying the licensed fishing boat owned and used

The Council discussed for a short time, with no objections to the NSW DPI proposal.

OUTCOME: Unanimous recommendation to accept NSW DPI proposal to apply all three criteria.

#### 7.2.1.4.3 Issue 3: Determining the hull units to use to allocate 'effort shares'

The Council discussed the three scenarios that required their consideration in depth. The Ocean Trawl member indicated that he has pecuniary interests in regard to this issue and was excused from the room to have no further part in the discussion. A detailed discussion followed that included costs associated with bigger boats and disadvantage to some individuals if others are able to use surrendered shares.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in regard to the allocation of new effort shares in the Ocean Prawn Trawl fishery.

#### 7.2.1.5 5. Additional dillies - Spanner crab north

The Council discussed the proposed increase to the maximum number of dillies permitted in the spanner crab north 40 and the results of submissions received.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in regard to additional dillies in the spanner crab north fishery.

#### 7.2.1.6 6. Crew in the Estuary General fishery

NSW DPI introduced this item in relation to the requirement for crew to hold a commercial fishing licence when employed in the Estuary General fishery.



# 7.2.1.6.1 Unendorsed crew – category one and two hauling, meshing and prawning & trapping share classes

The Council discussed various issues including the risk of increased pressure and social conflict. It was noted that catch and effort quotas will be used to manage this fishery into the future and unendorsed crew provide for business flexibility and assists to minimise the safety risks associated with operating alone.

#### 7.2.1.6.2 Unendorsed crew requiring a commercial fishing licence

The Council discussed the cost of crew having to hold a commercial fishing license, and supported the concept of developing some sort of industry accreditation in the future.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposals with no changes, noting safety aspects and cost issues.

# 7.2.1.7 7. Net length for general purpose hauling nets in the Ocean Hauling fishery The Council discussed this issue briefly.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal to apply a maximum net length of 400 metres to general purpose hauling nets used in the Ocean Hauling Fishery from 1 August to 28 February the following year, meaning a 400 metre maximum net length would apply all year.

#### 7.2.1.8 8. Deterring unlawful participation in prawn ballots

The Council had a short discussion on prawn ballots and the implications of industry run ballots and cost recovery.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in regard to deterring unlawful participation in prawn ballots, with no changes.

#### 7.2.1.9 9. Crew in the Ocean Hauling fishery

The Council discussed the proposed share linkage arrangements for Ocean Hauling net and general shares and the requirement of to hold a commercial fishing licence. The Ocean Hauling member indicating that he fully supported the proposal but declared a potential pecuniary interest and asked if he should be excluded, members indicated should remain. Potential benefits to Aboriginal commercial fishers were also discussed.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposals in regard to crew in the Ocean Hauling fishery.

#### 7.2.1.10 10. Managing catches of quota species in non-quota fisheries

The Council discussed the costs and benefits of trip limits in general and the daily and possession limits proposed by NSW DPI to assist to protect the integrity of the new catch quota management arrangements. There was considerable discussion on the Wallis Lake blue swimmer crab fishery and the taking of this species in the Ocean Trawl and Ocean Trap and Line fisheries. Options discussed included the requirement for anybody that wanted to retain catch quota managed species to hold quota and to report the proposed daily and possession limits electronically in real time.



OUTCOME: Unanimous recommendation that the arrangements be implemented as proposed, noting it is also recommended that more research be done to determine the impact of trawling activities on the spawning biomass of BSC in waters adjacent to Wallis Lake as well as the cumulative take of BSC from all fishing activities with a possible view to spatial or temporal closures. It was also recommended that any take of quota species by trip limit should be reported in the same manner as quota holders.

#### 7.2.1.11 11. Marking requirements for commercial fishing boats

There was a short discussion on boat licensing and marking requirements.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposals in regard to marking requirements for commercial fishing boats and removing the NSW DPI boat licensing requirements in the additional Estuary General and Ocean Hauling share classes.

#### 7.2.1.12 12. Marking requirements for commercial set fishing gear

The Council discussed the various different marking requirements of set gear in certain fisheries. Noting that Council recommends for consistency that all to minimum 100mm irrespective of area and some kind of grace period for changeover to implementation.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal with one exception – to have a consistent minimum buoy diameter in all fisheries of 10 cm in all areas.

### 7.2.1.13 13. Minimum crew numbers Estuary General and Ocean Hauling fisheries

There was a short discussion of the Council in regard to the minimum number of endorsement holders to operate nets and hold priority, including submission discrepancies and enacting government's previous announcement in relation to unauthorised crew. The Chair then summarised and indicated unanimous support to NSW DPI, noting submission discrepancies and recommending. NSW DPI committed to further industry consultation to prawn ballots.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal regarding the minimum crew numbers in the Estuary General and Ocean Haul fisheries.

#### 7.2.1.14 14. Real time quota reporting - Estuary General

The Council discussed this issue, including submission responses received, procedures on other situations where unable to report, cost recovery impacts and other working examples that already have been implemented. The MFAC representative declared a pecuniary interest for the Estuary General prawning share class but was not required to leave the room. Also discussed were additional reporting requirements, with NSW DPI committed to investigating the cost / benefit of tagging mud crabs and further extension and training.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in principle in regard to real time quota reporting arrangements in the Estuary General fishery. Noting that NSW DPI is committed to further investigating tagging of mud crabs.

DECISION: Next meeting to include presentation on online reporting options/procedures.

RESULTING ACTION: NSW DPI to present in regard to online reporting options/procedures.



#### 7.2.1.15 15. Real time quota reporting - Ocean Hauling garfish

The Council discussed the submission discrepancies and the proposal to increase the distance to 50 metres from point of landing as a reporting requirement.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in principle in regard to real time quota reporting arrangements for the sea garfish component of the Ocean Hauling fishery, noting that there will be an increase to 50 metres from point of landing requirement.

#### 7.2.1.16 16. Real time quota reporting - Spanner crab

The Council discussed the requirement discrepancies to other fisheries and the proposal to change when the pre-land requirement has to be made.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in principle in regard to real time quota reporting arrangements for the Spanner Crab component of the Ocean Trap and Line fishery, noting support of change to pre-land requirement as proposed.

#### 7.2.1.17 17. Consultation real time quota reporting- Lobster

The Council discussed the issues raised at the recent Lobster Working Group meeting, with the Council recommending that additional reporting parameters be included in the real time reporting in order to improve reporting accuracy of the data collected for the fishery.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in principle in regard to real time quota reporting arrangements for the Lobster fishery, noting that further details to be considered and potentially included in real time reporting requirements.

#### 7.2.1.18 18. Consultation real time quota reporting - Abalone

The Council discussed standardised bin weights and the receiver to get electronic copy in order to retain chain of custody. The Council also discussed the landing of Abalone catches in different states, the corresponding consequences of limited compliance jurisdiction for those states involved and the additional biosecurity issues of these actions.

OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in principle in regard to real time quota reporting arrangements for the Abalone fishery. Noting that further details to be considered, including secure bin tags, landing out of jurisdiction and receivers retaining chain of custody.

#### 7.2.1.19 19. Consultation real time quota reporting-Red Urchin

The Abalone member indicated a possible conflict of interest in regard to the Abalone and SUTS fishery. The member was not required to leave the room for the discussion.

The Council discussed the current requirements where catches of red urchins are to be validated when landed while purple urchin has no quota, are generally taken in large quantities with quality losses if extended periods of time are taken in getting the product to market. Also discussed was the issue of existing outstanding SUTS fees for some shareholders.



OUTCOME: Unanimous recommendation to accept the NSW DPI proposal in principle in regard to real time quota reporting arrangements for the SUTS fishery. Noting that further details are to be considered and NSW DPI investigates any outstanding SUTS fees and attempt to recover fees or cancel those licences that don't comply.

#### 7.3 General Businesses

The Chair opened up discussion to members for general businesses, with the following topics included in the discussion:-

- Recommend looking at switching Abalone season back to a financial year, referring to the biology of species that in summer has a smaller weight average and potential peak take due to season timing. If occurred would increase financial accountability (Economics) and reduce burden on industry.
- The Minister to determine time frame of decision on Council recommendations and implementations of meeting outcomes.
- Trip limits north of Barrenjoey, logbooks and 5" rubber footlines in the trawl fishery
- Importance for transparency of Council and short turnaround of actions to give industry/public assurances that CommFish NSW AC is getting outcomes achieved.
- Poaching of Pipi's in Zone 4
- Concerns around fisheries compliance issues, particularly around theft. The Council discussing
  more extensive penalties, particularly for repeat offenders, with a suggestion that a
  proportion of fines should be going back to managing the fishery as per other examples
  worldwide.
- A future meeting to include a discussion on a peak industry body and possible funding sources.
- Current inland fishery issues (eg. Catch and effort reporting discrepancies, Carp fishery and the impending release of the carp virus, drying lakes policy and the issue of access to waterways in the west of the state).
- Agenda item for future meeting to get a briefing on Marine Sustainable Aquaculture Strategy that includes Kingfish.

The Chair thanked all members for their remarks, with the following resulting from these discussions:-

DECISION: Future meeting to incorporate discussion on compliance issues, with a recommendation that a senior compliance representative attend to give an overview.

RESULTING ACTION: NSW DPI to present in regard to compliance issues at a future meeting.

ACTION: Add item to agenda for next meeting, briefing on the Marine Sustainable Aquaculture Strategy that includes Kingfish.

DECISION: Members to form register of regulations that potentially require amending and to nominate specific issues to address.

RESULTING ACTION: Form a register of regulations that is nominated by CommFish NSW AC members.



### 7.4 Next Meeting - Confirm Date and Location

Chair confirmed that next meeting will be 11/12<sup>th</sup> of July 2017 commencing at 12am in Sydney with venue to be confirmed. The NSW DPI member advised that the Minister had announced members of CommFish NSW AC in Parliament yesterday. The Chair closed the meeting at 16:00 and thanked members for their contribution and professionalism.

# 1 Member Welcome & Introductions, Housekeeping

The Chair opened the meeting at 12:40am acknowledging the traditional owners of the land past and present and welcoming Council members and invitee Dr Geoff Allan (DDG DPI Fisheries). The Chair also discussed the benefits of new meeting schedule, other housekeeping details and invited DDG DPI Fisheries to say a few words. With remarks including, thanking the Chair and Council members for their recommendations resulting from CommFish NSW meeting 1 and indicating that the Department is interested in helping all of industry on adjusting to new requirements in the Business Adjustment Program (BAP).

## 2 Review of Agenda

The Chair expressed interest to the Council to indicate any additional agenda items. The Estuary General Council member indicated that he would like to discuss several additional issues in the general business section.

## 3 Apologies -

Steve Everson, Estuary Prawn Trawl Share Managed Fisheries member.

# 4 Review and update Register of Interests

The Chair asked all Council members to indicate if individual pecuniary interests had changed significantly from register of interests distributed, noting that any recent changes in shareholdings to be indicated to the Executive Officer.

DECISION: Council members to update any changes to shareholdings through Executive Officer.

#### 4.1 Declarations of Interest

The Chair and Council members indicated any significant amendments as required.

- Ministerial Fisheries Advisory Council (MFAC) Council member tabled new interest recording for company and also noted requirements for interest declaration is different between CommFish NSW and MFAC.
- DDG DPI Fisheries indicated support for individual interests as this Council is not a decision making body.
- Inland Council member advised he is now authorised to target different species due to fishing business change.

ACTION: The Executive Officer to amend the register of interests as required and redistribute to Council members.

# 5 Confirmation of the Minutes of Meeting 1

The Council accepted the draft minutes without change as a true and accurate record of discussions from the first meeting held on 25/26 May 2017.

# 6 Actions Arising from Meeting 1

The Chair and Council members reviewed the action items list agreeing that all actions had been substantially completed noting the following:-

- Action item 1.3 'All CommFish NSW papers to be made available on the NSW DPI Website, including the Chair statement.' Council discussed that the Minutes from CommFish NSW meeting 1 had not been uploaded and approvals incomplete, noting that the Chair statement had been uploaded and indicates that the minutes will be available on the NSW DPI website once they have been approved and the Minister has received advice on the recommendations.
- Action item 1.4 'Draft a media release that includes how decisions are made, that members and other NSW stakeholders have input into recommendations and promote working groups.' – The Chair indicated that the Council Executive Officer had advised that this action had not been

completed, noting that this action is in contrast to a previous decision that working groups would be formed only on a needs basis. The Council noted the requirement to engage industry and table correspondence received and not to undertake the media release previously proposed.

DECISION: Make time at CommFish NSW meetings to table and consider correspondence received.

The Council discussed the mechanisms possible to facilitate engagement with industry. Noting that correspondence received should clearly identify topic or issue, provide background, a solution or recommendation and not be limited to emails.

DECISION: Create pro forma to structure correspondence received from Council members or external parties and email address for CommFish NSW to facilitate contact.

RESULTING ACTION: NSW DPI to create pro forma and email address for CommFish NSW and include section on NSW DPI website to facilitate contact with CommFish NSW.

Outcome Items 1.1 to 1.19 – 'NSW DPI BAP consultation papers recommendations.' – DDG DPI
Fisheries indicated that all recommendations were accepted and that a letter from Minister is to
be received in regard to CommFish NSW meeting 1 outcome items.

DECISION: Once received publish the letter from the Minister in regard to CommFish NSW meeting 1 outcome items, while decisions to reject any recommendations made from CommFish NSW should still be published.

RESULTING ACTION: Once letter from Minister received in regard to meeting 1, progress upload to NSW DPI website.

# 7 Correspondence

Correspondence was provided from Ocean Haul Council member that was received from an industry stakeholder and to be discussed in general business section.

# 8 Strategic Agenda Item 1 - Compliance Overview Presentation

The Chair introduced Patrick Tully, NSW DPI Director of Fisheries Compliance, who provided a compliance overview presentation.

Several Council members also indicated concerns over increased illegal activity and lack of compliance resources. The Chair indicated that could recommend to Minister that CommFish NSW concerned about increased illegal fishing related to introduction of BAP.

The Chair thanked both Director of Fisheries Compliance and Supervising Fisheries Officer for their participation and indicated benefits of compliance attendance to future CommFish NSW meetings.

DECISION: NSW DPI compliance to be invited to future CommFish NSW meetings, including strategic agenda items of cost recovery.

RESULTING ACTION: Invite compliance to attend CommFish NSW meeting 4 with agenda item of cost recovery.

# 9 Results from Share Trading Market (Moved forward 15:20)

The Chair introduced NSW DPI Director of Analysis Doug Ferrell who provided a brief update on BAP Share Trading Market results. Several Council members questioned the tax implications of the share market. NSW DPI representative member indicated each individual case may be different, that the Department are investigating this issue further and that fishers should seek advice from their financial advisors, particularly in relation to CGT implications.

## 10 Review last meeting General Business Items

The Chair, Council members and DDG DPI Fisheries briefly discussed further in regard to increased compliance funding required initiated in section 8, as a result of BAP regulations to be implemented. Discussion included:-

- Risks to other shareholders, support for demerit points, current measures not hard enough to
  deter illegal activity, licence suspension and that compliance are to re-attend future meetings to
  discuss further.
- NSW DPI Council nominee and DDG DPI Fisheries indicated that understand message coming across and will raise compliance issues with the Minister.

#### 10.1 Abalone season & Compliance Enforcement

The Chair introduced the topic, as raised and background provided by Abalone Council member, indicating that the Council can't make recommendation of season timing, but can recommend what needs to be investigated further to achieve results.

DECISION: No action on Abalone season timing until further correspondence to Abalone industry has occurred in regard to any proposed changes.

## 10.2 Trip limits, logbooks & Foot lines in Trawl Fishery

The Chair introduced SFT Council member to present on the issue and background material provided. The Council discussion included:-

- Trip limits introduced when no VMS on Commonwealth, but still in place with little research to support.
- DDG DPI Fisheries provided overview history, including OCS agreement for the trip limits.
- Need to discuss further with Commonwealth and recreational sectors.
- DDG DPI Fisheries indicated that more data required on discards.
- Current foot line arrangements and 6/7 inch foot lines recommended by SFT Council member.

ACTION: Recommend trip limits, logbooks and foot lines in the Trawl Fishery further investigated by NSW DPI as part of the Offshore Constitutional Settlement discussions with the Commonwealth.

Estuary General Council member raised concern at direction of agenda items not being high level topics. The Chair indicated that results have been achieved in addressing the above two topics.

# 11 Mulloway Paper – Monitoring and assessment of the impact of management changes under the Mulloway recovery program

The Chair introduced NSW DPI Council nominee who indicated that the Department is seeking CommFish NSW position on this topic and how the commercial sector can improve Mulloway recovery. Council discussion included:-

- Correspondence received from stakeholder, indicated in the correspondence section was provided to all Council members.
- Concern of understanding the data with mixed views on increase/decrease of stocks.
- Potential for working group to investigate further issues.

DECISION: CommFish NSW should discuss the Mulloway Recovery Program further in tomorrow's session, including potential to form a small working group.

# 12 Quota regime discussion (Port visit tour)

Chair discussion deferred to next meeting.

ACTION: Include quota regime of different jurisdictions (Port visit tour) in meeting 3 agenda.

# 13 Meeting close (Day 1 at 5:30pm)

The Chair thanked DDG DPI Fisheries, clarified dinner arrangements and that day 2 will commence at 8:30 in contrast to agenda.

# 14 Welcome and Agenda Review (Day 2commence 8:30am)

The Chair opened the meeting at 8:30pm and welcomed all Council members, the invitees Mika Malkki, Director of Fisheries Operations and Heath Calder, Senior Business Analyst of the NSW DPI.

# 15 Housekeeping

NSW DPI Council nominee indicated topics on agenda have been prioritised structured around meetings strategic agendas, with background to Council members prior to discussion.

The topic of the Mulloway recovery program was discussed further by the Council members. The Council discussed for the need for NSW DPI to establish a working group, the structure of this working group, terms of reference and need to include industry in working group.

#### DECISION: CommFish to:

- Form a small working group of 3 fishers, 1 scientist and 2 CommFish members (Estuary General and Ocean Haul Council members) to assess and develop industry position on its contributions to improving mulloway recovery.
- 2. Develop Terms of Reference for Working Group.
- 3. Invite expressions of interest from industry for 3 positions on the Working Group.
- 4. Report back to CommFish with recommendations after assessing all options and their benefits and risks.

#### ACTION:

CommFish to release EoI for positions on Working Group.

 NSW DPI to compile catch reports for commercial fishers to understand primary beneficiaries of change and impacts of changes.

RESULTING ACTION: NSW DPI to identify and provide list of key industry stakeholders to CommFish NSW for selection and develop terms of reference through email out of session.

#### 16 Conflict of Interest Declarations

Previously addressed, no further information provided.

# 17 Strategic Agenda Items 2a - Fishing Activity Reporting & Digital Authority

The Chair invited Senior Business Analyst to provide a live demonstration of FisherMobile, a secure link that allows real time reporting. The presentation included:-

- Viewing available quota, including negative balance if evident, in future real time transfers in FisherDirect.
- Completion pre/post land reported in the Spanner Crab Fishery (Day/kg linkages to complete real time reports).
- Digital authorities (Commercial Fishing licence and FB Cards, replaces cards, has security features to avoid fraud and has endorsement requirements for each share class).
- NSW DPI sought comment from the Council on its ease of use, with the Council suggesting need to keep it simple and future additions to its functionality, including a review page prior to confirming real time report.
- The Council also discussed cost recovery advantages of online quota transfers and more flexible business operations through instant trading in real time.
- Commonwealth fees comparison, with significant reduction for online reporting.

# 18 Strategic Agenda Item 2b - Engage Fishers, Training & Online Products

NSW DPI Council nominee indicated that NSW DPI is seeking initial view and how best to approach industry and transition to new BAP online reporting requirements as at 1 Dec 2017. Discussion included:-

- Requirement for targeted training in small specific training sessions (Cost recovery benefits).
- Current support available to Spanner Crab FisherMobile users (e.g. Online demonstrations, individual user support and trips to locations to address individual issues).
- Benefits of third providing training support, similar to BAP share trading.
- Need to talk to individual managers about share class specific reporting requirements.
- Targeted demonstration/tutorial videos for each share class requirements once specific requirements decided for each share class.
- NSW DPI representative member indicated that can look into a recommendation to Minister in regard to cost recovery and reduction of fees for those that transition and report FisherDirect system as an incentive.

# 19 Fish Receivers (General Business item)

The Chair introduced MFAC Council member to introduce the issue brought forward and background paper provided on Fish Receiver registration.

- Two issues Cost & Existence of mechanism (is it required red tape).
- Places NSW fisherman at a disadvantage, excluding inland areas, Commonwealth registration has no cost, done online and received on day.
- As per IPART review and questions raised at recent parliamentary inquiry.

Recommendations - Fees brought into line & Consideration if this licencing mechanism remains (existence to be reviewed).

ACTION: Support department reviewing Fish Receivers as a matter of priority in accordance with recommendations of IPART and Palmer reports, as a boost to industry and consider immediate waiving the fee in line with other jurisdictions.

#### 20 Minister attendance

The Chair welcomed and thanked the Minister for Primary Industries Niall Blair and Policy Advisor Miranda Pade for their attendance. The Minister reciprocated thanks and discussed a number of issues relating to the development of a pathway to a profitable and sustainable NSW fishing industry. Minister comments included:-

- Appreciated significant outcome regarding the recommendations from last meeting. Noting he
  accepted all recommendations except one deviation in regard to the proposal that the new
  species shares can be held by anyone. Minister proposes a change to stage it so that existing
  Fishing Business owners get the first chance to acquire species shares before they are available to
  anyone.
- Acknowledged significant compliance resources required to protect value in shares generated from reforms and asked for CommFish NSW recommendations to assist.
- Commitment to BAP, including working with all to industry to meet minimum shareholding and taxation advice.

The Chair then provided comment to the Minister on several current issues that have been discussed at the Council, including:-

- Chair indicated the Council supports targeted education to new FisherMobile reporting requirements and benefits of third party trainer.
- Minister confirmed support for additional resources to further assist to make sure shareholders understand responsibility, entitlements and need to identify any misunderstandings.
- Chair indicated the Council concerned about increased illegal fishing related to introduction of BAP and current OCS arrangements in Ocean Trawl Fisheries.
- Chair indicated that Mulloway issue appears to be a problem and Council started process to form a working group, with potential recommendations resulting.
- The Chair indicated that a list of regulations to be reviewed is to be collated that will include the current Fish receiver registration requirements.
- Minister indicated that Fish Receivers and recognises importance to traceability of sale to catch.
- MFAC Council member indicated Fish Receivers fees and disadvantages to industry.

- Minister indicated cooperative issues need to be looked at further.
- Chair indicated other regulations likely to be recommended for review, as industry moves to new Output controls.
- Minister indicated support for investment through species shares.
- The Chair indicated need to protect the bank's asset so they can invest and suggested large fines instead of share forfeiture. Minister indicated need advice on compliance systems and implications.
- Estuary General Council member brought up prohibition of trusts holding licence issue and advantages in investment, with the Minister indicating need further advice on this topic before comment.
- Ocean Haul Council member indicated TACC not until 2024 and there is a risk of increasing minimum shareholding in certain share classes, such as estuary prawning.
- Minister indicated need to look at further and any other share classes to be impacted. Council indicated Ocean Trap and Line.
- MFAC Council member indicated unconfirmed tax implications of the BAP share market trading, with the Minister indicating high priority and noting importance to individuals to get their own advice.
- Minister confirmed support for committee's importance.

The Chair and Council members thanked the Minister for his attendance and reciprocated by the Minister.

# 21 Draft NSW Marine Waters Sustainable Aquaculture Strategy (WWSAS)

Chair introduced Ian Lyall, NSW DPI Manager of Aquaculture, to provide a briefing on the Draft NSW Waters Sustainable Aquaculture Strategy. Manager of Aquaculture thanked for opportunity and indicated after feedback and comments on the strategy.

The Chair thanked Manager of Aquaculture for the comprehensive presentation and indicated that will re-attend and provide additional correspondence once the draft is completed.

DECISION: NSW Marine Waters Sustainable Aquaculture Strategy to be included in agenda of a future CommFish NSW meeting.

#### 22 General Business Items

NSW DPI Council nominee indicated benefits of clear strategy, is there a need to have a similar strategy for Commercial Fisheries, such as the Draft Aquaculture Strategy, that is linked to the investment plan.

DECISION: DPI to bring forward a paper on a future strategic plan for commercial fisheries in NSW.

# 22.1 Investment Plan Workshop (Facilitated workshop)

The Chair introduced NSW DPI Council nominee who indicated the Minister wants us to develop Investment Plan for Commercial Fishing Trust, including investment priorities. It is a legislative requirement that the Minister consults with relevant committees.

DECISION: NSW DPI to develop a workshop for next meeting on the Investment Plan for Commercial Fishing Trust, allowing half a day in agenda of this meeting.

RESULTING ACTION: NSW DPI to develop and provide further information to CommFish NSW members for a workshop on the Investment Plan for Commercial Fishing Trust, prior to meeting 3.

## 22.2 Nominate list of Regulations that require Amending

The Chair opened the table for Council members to nominate any regulations that require amending, noting that the Council had already discussed several (e.g. Fish Receivers). Further Council discussion included:-

- NSW DPI Council nominee indicated that NSW DPI has a list of approximately 100 regulations and will disperse list to Council members.
- Inland Council member nominated *Fisheries Management (General) Regulation 2010* clause 183 that restricts inland commercial fisher's ability to hold multiple different endorsements in the inland fishery at the same time.
- Ocean Haul Council member identified issue of unlicensed crew and assistance with prawn running nets.
- Chair indicated need to identify criteria, usefulness, any restrictions on trade and compliance.

DECISION: CommFish NSW to review list of regulations identified by NSW DPI and include further identified.

RESULTING ACTION: NSW DPI to provide list of regulations identified for review prior to next CommFish NSW meeting and include as an item on next meeting agenda.
