Unsolved - 477

Homicide or any other matter deemed Homicide have been referred to the Homicide Squad

## Unresolved - 116

Unresolved: Homicide where judicial proceeding have commenced and either; withdrawn, suspect/s acquitted at trial (except for self defence of mental illness), suspect/s convicted and conviction is overturned by Higher Court

### **Undetermined - 65**

Undetermined: A death where the cause and manner of death are unknown or cannot be judged, ie; apparent suicide with some doubt, death by misadventure where there is some doubt, coronial referred MP where foul play, any other deaths referred by Coroner that do not fall under unsolved or unresolved

# Solved - 100

Solved: suspect has been charged and convicted and appeal finalised, suspect acquitted on the grounds of self-defence or mental illness, an arrest warrant for a homicide offence is in existence and suspect is outstanding, matter finalised POI deceased.

Of the total 759 cases on our files there is further on ongoing classifications to remove duplicates, suicides, now not homicides etc. The figures fluctuate as they are constantly reviewed and re-categorised.
