Re: Medical Doctor's opposition to Reproductive Health Care Reform Bill 2019

I am writing to air my grave concerns about the recent passage in the lower house of the above bill. It concerns me greatly that the NSW State Government has sanctioned by this Act the killing and dismembering of the living children within the womb by the Abortion industry after 5 months of pregnancy and right up until the birth of that child.

This bill is ideologically addled, it is unspeakably abhorrent and it is an utterly abysmal reflection on our society and civilisation in this State in the way that it sanctions the appalling treatment of our weakest and most vulnerable members. One of the stated aims of the law is to prevent women from being prosecuted if they were to procure an unlawful abortion. This could be simply achieved by deleting the line pertaining to women in section 83 of this Act. This bill goes further than that. What this Bill ignores, that these same laws were used in 2006 in R vs Sood to prosecute an unregistered person who held herself out to be a doctor for performing an unlawful abortion, to the detriment of the woman.

The focus of my protest, however, is primarily on the Leglislatures decision to co-opt doctors to their rotten cause. As it is, doctors <u>must</u> either perform the abortion, prescribe the abortifacient or make an effective referral for one. There has been an interpretation (and in my view an incorrect one) applied to various codes governing the right behaviour of doctors acting under the auspices of a conscientious objection such that referrals are to be arranged by doctors if the patient is seeking one. This is one step too far. It deems that the outcome of a consultation must go exactly the way a patient wants it. This is deeply flawed. Doctors are not ATM machines, we are professionals and need to be free to apply our best judgement for the care of our patients. In the case of pregancy, it is the case that there are *two* patients.

Please understand that the therapeutic relationship between a doctor and their patient is unique. It is underlined by trust, advocacy and care following a correct formulation of the precise problem afflicting the patient. Just imagine for a second if a patient were sent along to a gastroenterologist to investigate iron deficiency and I stated that the patient <u>must</u> have this procedure, because the law says so. If there is any compulsion on the doctor's part by law to investigate / manage in a very particular way, this removes the necessary process a doctor ought to go through to first arrive at a correct diagnosis. The law is simply not sophisticated enough to account for every single aspect of the patient journey through the many interactions with their doctor. To return to my example, many times patients are knocked back from colonscopies, as the gastroenterologist has applied their skill to the situation and deems that the complaint arises from their diet rather than bleeding. This is even against the backdrop where the specialist in question is financially incentivised to operate / investigate via procedure. Hence, the cure is different to the one proposed. The law has no oversight in this interaction, the only thing that matters is the truth of the matter at hand.

Now to turn to the issue at hand. How it stands currently, imagine a woman finds herself before

her doctor requesting the end of her pregnancy at 18 weeks. A caring doctor, applying his or her skill to the situation will take a history to understand how it is that the patient arrived at this decision. Compassionate probing instills confidence and trust in the patient and she discloses that she is actually the victim of domestic violence and the father of the child is pressuring her to do this. The patient is really conflicted about this line of action. She can already feel the child kicking. Neurophysiological changes are already setting in and are facilitating bonding with her child, as is natural. Pregnancy necessarily makes her vulnerable, open to exploitation and coercion, and yet she is troubled by the thought of ending the life of her child, who she sees in her dreams. The doctor emphasises with the woman's situation, contacts the domestic violence line with the patient there and arranges a shelter for the woman where she can retreat from the violence. Pregnancy counselling is also arranged. This example is an accurate portrayal of the precise mechanism by which doctors care for their patients, stemming from a correct formulation.

Imagine the situation, now where the doctor is approached by this same patient, but this time, the above Bill is in place. The doctor now feels intimidated by the patient, fearing professionl or legal repercussions unless he / she do exactly as the patient wants. The doctor reluctantly writes and puts their signature on the referral to a known provider. The woman is assessed and abortion is recommended. This comes as little surprise given that Abortion is in fact an industry, and not health care in the traditional sense as it often mendaciously labelled. The woman is offered counselling which may or may not be required by ans employee of the industry and is inherently conflicted in his / her ability to give frank and fearless advice. The referring doctor feels constrained in their practice to ask questions and resents the whole process.

As you can see, this plunges a knife right into the heart of the patient-doctor relationship. Furthermore, it pays disrespect to medical practitioners; politicians this week have been able to apply their conscience to this Act in ordered to either vote For or Against it. They can decide not to have their signatures next to this ugly law as it troubles their consciences. But a doctor, can they decide to withold their name? No, they cannot. It is unconscienable. It violates Article 18 of the 1948 Universal Declaration of Human Rights, it violates the correct interpretation and intention of the Australian Medical Board's stance on the rights of the doctors to have a conscientious objection and it utterly tears asunder the very principles upon which medicine is founded, that is, the duty to do no harm and to seek to do good.

This bill will do nothing for women's health and it will lead to more abortions. The great lie of abortion is that things can go back to how they were, when in fact, a mother is always a mother. I am aware of the increased risk of suicide in those mothers procuring abortion as well as substance abuse and a PTSD-like syndrome known as Post Abortion Stress. I hold grave concerns for the mental health of the women, men and families connection with abortion already, but I can only see this crisis deepening. I am further appaled to think about how this will further brutalise relationships between women and men. Currently, men deal themselves out of the equation. It is entirely sexist. This bill provides no real reproductive rights (let's be clear, these are child-killing rights) and neither does it encourage reproductive responsibility. Is this the type of society leglislators really want? Is this what the people of NSW were consulted on? The answer is obvious. The Legislature is divided, NSW is divided. Doctors are now forced to either break the law or violate foundational principles of medicine. In a word, this Act is unjust.

I urge you to reconsider your position. I am making this letter widely available to my local member and politicans generally.

As a Catholic, I am against abortion and there the bill for abortion.

The consequences and the door opened in this Bill will be an opening for much more complication for the mothers and the scope of reasons to abort a baby..Please protect our children yet to be born..

Not supporting the murder of the most vulnerable members of our society.

Thankfully, our parliamentary system has safeguards in place to prevent legislation that is flawed and/or not in public interest. You are one such safeguard and your roll has never been more important than now. A bill on a topic as critical as abortion should never be rushed through parliament without extensive public consultation. It beggars belief that a bill legislates for babies born alive to be denied medical care and left to die has suddenly been rushed through parliament, shortly after an election, where this was never mentioned. I have never been ashamed of my country, until this week. I find it both heartbreaking and disgusting to see elected officials clapping and cheering as legislation is passed to kill babies. I stand against abortion

I would like to voice my serious concerns about the Reproduction Bill being considered in the upper house. There are some women, who in pregancy, find themselves in a difficult situation. For reasons such as pressure from a boyfriend, being of a young age, cultural reasons, financial reasons and many others, they feel obliged to end their pregnancy. Dear all, I strongly oppose this bill on behalf of women and children. Abortion is a decision women make when they feel they have no choice. It is therefore NOT pro-choice. Women need REAL options. Turn every abortion clinic into a crisis pregnancy centre! If women have a legitimate health concern, they can go to hospital to address it. Women facing financial concerns, abusive relationships etc. should be HELPED. An abortion only offers a very temporary relief and does nothing to fix their real problems. 1 in 4 women are coerced into having an abortion against their will. This bill only perpetuates violence to women and children and restriction of their rights. Remove this bill immediately. Instead, focus on bettering the adoption and fostering systems, funding for crisis pregnancy centres, support for pregnant women and mothers at university, funding organisations like the Culture Project to talk to young men about loving and respecting women, informing women of how they should be treated in and out of a relationship. All these are real solutions, abortion is merely a violent way of perpetuating a culture of hurt and destruction.

Against Abortion I am writing in the strongest possible terms to protect human life in the womb. One of the great tests of a society is how it treats those who are most vulnerable. In Australia, it is commonly estimated that 75,000 lives are terminated in the womb annually. In the USA, the figure is closer to a million (note, however, that abortion has been declining since the mid-1990s). It is true of the millennial generation that, as Jessica Resuta says, "One-third of my generation is gone. One-third of my peers will never experience life in the outside world as I have." Tragically, in many parts of the Western world, Down Syndrome children are becoming less and less common (in August 2017, CBS reported that termination rates for Down Syndrome were 98% in Denmark for 2015). Sadly too, groups such as White Ribbon (against domestic violence) also support abortion. In the womb, billions of letters of coded DNA are there to "knit together" a person. Within the first trimester a child's organs are formed and functioning – brain, heart, nervous system. A baby may suck their thumb and even has a thumbprint. Recent research has brought to light the fascinating way in which children learn language in the womb (see New York Times, 21/2/17). A child in the womb is not a potential human, but an actual human. Any attempts to place a start date on life, e.g. 12 weeks, are subjective and morally weak. In the end, arguments in favour of abortion, also work for infanticide (the killing of child after birth). It is not surprising then, that Peter Singer (who was made a Companion of the Order of Australia in 2012) supports both abortion and selective infanticide until one month after birth (see Peter Singer, Practical Ethics). Biologist Jerry Coyne agrees: "If you are allowed to abort a foetus that has a severe genetic defect, microcephaly, spina bifida, or so on, then why aren't you able to euthanize that same foetus just after it's born?" When sanctity of life is rejected, such a conclusion is logical to many. The Hippocratic Oath included a statement about not taking life in the womb. Intuitively, we know that this must be true. Norma McCorvey (1947-2017), famous for being the plaintiff, "Jane Roe," in Roe vs. Wade, which led to the legalization of abortion in the USA in 1973, later turned to oppose abortion. In late 2017, Eminem has released a song (featuring Ed Sheeran) that seems to speak about his regret at an abortion. It includes the line, "I really woulda' loved your smile." Let our society provide every possible support to both a mother and child. Even when pregnancy is the result of the most horrific situation, we must support the life of both mother and child in every way. I write with great shame that this week the NSW Lower House even voted against providing life-saving treatment to babies born alive after an abortion. In addition, medical practitioners may be required to go against their consciences and refer patients to someone who will perform abortions. Never would I give up my freedoms in that way.

I am making this brief submission to express my opposition to the Reproductive Health Care Reform Bill 2019, for the following reasons: 1. Although we may debate when it is that life begins in the womb, there is no denying that a 22 week old foetus is a living human being. This Bill proposes that this unborn child potentially has no human rights simply because it may not be wanted. A child that is born prematurely at the same age will receive medical intervention with the hopes of saving its life. This Bill allows our society and medical practitioners to save the life of one child, whilst ending the life of another, for no reason other than a mother's choice. This Bills strips the unborn completely of any intrinsic value or human dignity. 2. The Bill does not allow for babies that survive a late term abortion to receive medical care. They are left to die. Statistics show that in Victoria, about 10% of late term abortions (that is, abortions after 20wks) are unsuccessful and the baby is delivered alive. Approximately 370 babies have been born this way, and have been left to die. How can we call ourselves a civilised society and allow this to happen? 3. The Bill does not allow doctors true professional freedom and a genuine conscientious objection to abortion. Doctors are bound by the Bill to refer patients to other doctors with no objection. 4. The Bill ignores the psychological and mental trauma that many mothers suffer post abortion. Thank you for your time and consideration.

Becoming a grandfather on the day the abortion bill passed became a poignant day for me. As I stared into his eyes and his tiny fingers I thought of how , if this bill would become law , that just one day before his birth little humans like him could be legally killed . This is a travesty of justice for mankind .

Objection lodged to entire Bill, with special consideration to section 9 (3) Conscientious Objection, regarding mandatory referral to another practitioner. It appears this section is included to nullify any objections to an abortion, whether valid or not, by forcing practioners to nominate another practioner immediately, who may have less than ethical practices, to ensure the abortion takes place regardless of the possibility that the abortion may not meet legal criteria. Submitted for consideration.

Life is precious. There are so many who would love to bear, or adopt a child. They spend so much money for this privilege. Having an abortion due to an unwanted pregnancy doesn't make the problem 'go away'. The vast major women will report the fact that they grieve their choice for the rest of their lives. Life is not a commodity, nor an inconvenience. We should instead insist on better support women who fall pregnant unexpectedly. It simply does not belong in a compassionate country. The only possible exception should be for women whose life is physically at risk from proceeding with a pregnancy. I beifly considered abortion with my first son - an unplanned pregnancy. He is now 21 and has autism. Not for one moment do I regret my choice to give him life. Despite the challenges (both he and I experience issues with anxiety and depression) he has blessed us beyond measure, is gainfully employed and making a valuable contribtion to his workplace and his church.

This is something that is a watershed. Nothing you decide will please all within our society. Though, where are we as a society when dispensing with a life is so laissez-faire! We are in an extremely dark place condoning, let alone making legal the destruction of life. What apalls me (& so many others in society that many of you seem to think don't exist or have zero contribution to make to this debate - evidenced by ignoring us or believing we don't count) is how disposable people are. There is nil protection for human life in utero, none at all. What a sick society we are. Please use your vote to reverse the Lower House decision

Dear Members of the Upper House, Just because everyone else is doing it does not mean NSW has to. I am writing to ask for you to reject the bill that is before you confusingly called reproductive health care. I would like to make a few points: Firstly, as a working parent, I wish to challenge the notion that abortion gives women rights or choice or that extending abortion gives women more rights and choice. A colleague of mine, a talented HR manager, once made the following point a few months before quitting her job: once she had paid tax, childcare, transport and lunch, she essentially worked for free. She went back to caring for her family full time, but I was left wondering, what if she had been a single parent? what if she had been pregnant and had needed that extra income? Women should never be forced to choose an abortion and this new law, creates the idea that motherhood is some kind of optional lifestyle choice that can always be planned. rather than an investment in raising the next generation of Australians, and that frequently life does not go to plan. With true rights, there should be duty bearers that can be called on or even punished if they fail to fulfil their duty. Who is punished with abortion? Clearly the unborn child Surely the duty bearers with respect to the mother are the father, the employer and the state but abortion lets them all off the hook. How is a society just, when the weak are punished for the irresponsibility of the strong? Parents need real rights, such as equal pay for equal work, proper maternity and parental leave, affordable childcare that doesn't double tax the mother and affordable housing. This law does not provide for proper pre-abortion counselling to help a woman explore her options and will make it a great deal easier for women to be coerced, directly or indirectly into killing a child that they wished to keep. All these factors fundamentally undermine women's rights. . Secondly, the law does not properly protect the rights of children, particularly unborn children. I personally believe that a human life begins at conception and that the law should protect every human life. This is not a controversial idea for example WebMD explains that a baby is at 1 month an embryo, at 2 months a fetus and at 3 months a fully formed baby (https://www.webmd.com/baby/1to3-months), this is how we talk and think. After 3 months, killing a wanted child in the womb would be considered killing a baby It would seem that this new law is creating a precedent that a human that is loved and wanted has rights, but that a human that is not loved and wanted does not. The law would not prevent sex selective abortions (the killing of unwanted girls), the killing of people with disabilities, and even allows late term abortion when the child could survive outside the womb. When humans loose rights, how is Australia any different from China or even ancient Rome where the father was allowed to expose an unwanted infant? By allowing abortion of a child that could survive outside the womb and not requiring medical care to be given to a child born alive, the law essentially legalises infanticide. Thirdly the law does not protect the rights of doctors and nurses to conscientiously object on religious grounds. Nor does it protect the rights of parents to know what is happening to their daughter under 16. This continues to fray at the already strained bonds of trust in our society.

Please do not legalise the murder of unborn children. It goes against everything God and our nation should stand for.

I respectfully ask that the members reject the Bill to legalize abortion. I consider tat the Bill to leafs Lise abortion. Terminations are currently very easily accessible and the implication that these are 'backyard' and unsafe procedures is mis-information. The Bill in question will shift the procedure from being one of necessity to one of convenience. It will further allow individuals to prey on the most vulnerable. The suggestion that late term abortions should be allowed is clearly a violation of the rights of a life. Many babies born after 22 weeks are able to be saved and recognized as a life to be fought for. Surely life is a physical reality, not a product of thought or will. I am vehemently opposed to the Bill in its entirety, but do see a number of additional points that have inadequate provision. - this Bill will allow abortion on the basis of gender selection (quite ironic given that current thought surrounding gender fluidity!) - there is no mandatory requirement for counseling prior to abortion or after. I have seen first hand a number of cases of young women (and men) living with trauma following a termination - there is no provision for medical care to be given to a baby who is born alive as a result of an abortion. This will lead to those barbaric practices employed in previous times regarding babies born with a disability. -Doctors and Nurses who strongly believe their role is to give life and healing, have no provision to refuse to perform an abortion when they believe this procedure is contrary to the beliefs for ethical or religious reasons. Regard for their personal well being, is not only not considered but completely disregarded. - there is also no requirement that any report is to be made to the Secretary if the Dept. of Communities and Justice when an abortion is performed on a young girl 16 or under. What follow up care will be provided for these very young and vulnerable children? It seems that this Bill has been prepared in a 'rush' and without adequate time for meaningful consideration and I request that the process be halted before a decision is made that has dire consequences.

To the Honourable the President and Members of the Legislative Council of New South Wales As a resident of New South Wales I would like to brings to the attention of the House my strong concerns about the Reproductive Health Care Reform Bill 2019: 1. I am concerned about legalisation of the termination of a life. Picture, in one room a life will be terminated whilst in the next room a couple are going through IVF in hope of a new life. 2. I am concerned about the coercion of women to have abortions over due consideration of other alternatives. 3. I am concerned about the sex selection of children, and terminations motivated by disability and fashionable traits. 4. I am concerned about the mental health of women who have abortions. I am concerned about increasing the number of women who battle with guilt and regret, even years later. 5. I am concerned about doctors being placed in an ethical and legal bind between their concience and governmental obligations. Thank you for addressing my concerns.

I oppose the bill currently before the NSW Parliament to de-criminalise abortion in its current form. Without entering into discussion about abortion per se, the bill has the following failings: 1. It allows for late term abortion. The foetus at such stage is commonly and rightly regarded not as a thing but as an unborn child, a fully human life. This is readily perceived in grief at tragic pre-birth losses and in the medical funds expended to keep alive pre-term unborn children. The bill, then, is hypocritical. 2. It does not require sufficient controls to access late term abortion. Two doctors who may work together and share pro-abortion ideology is insufficient. There is no requirement for counselling or the consideration of other options. 3. It does not protect medical professionals who oppose abortion to act in accordance with their professional perspective and conscience but requires they cooperate in the process by referring requests for abortion on to pro-abortion doctors. 4. It does not set sufficient boundaries nor require sufficient recording of reasons for late term abortions. 5. It has not had sufficient informed public debate. The bill has come before parliament as a surprise to the community. It has disingenuously been present as a non-controversial decriminalisation of abortion without acknowledgement of the highly contested permission for the late term abortion of unborn children. 6. It does not provide safeguards against various possible abuses, e.g., gender based abortion choices. More broadly, abortion is not just about the life, body and choice of the mother but also about the life, body and future choices for and of the unborn child, and ultimately about the attitude and values of our whole community to life. The bill further undermines the value we as a community places on life and the protection of the vulnerable.

While I understand the desire of some to remove criminality from the process of abortion, the logic is flawed. Any abortion conducted in contravention to agreed and very specific criteria shoul remain a criminal offence. The crime should include both the woman having the procedure and the practitioner conducting the procedure. The act of terminating a life should have the same consequences for those performing it as apply to any other form of murder as it is the identical act of taking a life or assisting in the taking of a life. The proposed legislation amounts to murder on demand. Politicians should listen to the medical profession as to what term of pregnancy achieves a viable human life. I understand it is perhaps as short as 16 weeks but a foetus of 22 weeks is a viable human life - so terminations of embryos older than 16 weeks is murder. The debate places almost all the emphasis on the wishes of the mother and virtually none on the life and rights of the foetus. This is clearly inequitable as no foetus has an audible voice and it requires society as a whole to speak up for the rights of the foetus. Why can't politicians see themselves as defenders of the defenceless? Why are the rights of the mother prioritised over those of the foetus. This legislation should not be allowed to pass and I urge all politicians to man up and make a stand for the unborne children of tomorrow. To support this bill is to weaken our civilisation and take us a step closer to the jungle of survival of the fittest. As a Christian - this bill is an offense against my God and the teachings of the bible. Your failure to block this. Bill will require some considerable explaining on Judgement Day because the way you vote will be on your conscience forever. Be wise and reject this bill.

This bill defies scientific and biological fact that demonstrates conclusively that the foetus is a full human being. Abortion takes the life of this human and is therefore an act of infanticide. This bill would legalise abortion on the basis of sex-selection. Meaning healthy baby girls or boys could be aborted simply because the parents want a boy or girl. The bill would force doctors and nurses to participate in an abortion, even if they object to abortion on ethical or religious grounds. The bill allows open-slather abortion, including late term after 22 weeks. There is no mandatory requirement for counselling in the bill, which might provide women with an opportunity to discuss more options. There is no requirement that neonatal care be given to a child born alive as a consequence of undergoing an abortion procedure. There is currently no requirement that medical practitioners report abortion procedures performed on girls under 16 years to the Secretary of the Department of Communities and Justice. From a Christian perspective, this bill would legalise the breaking of the Law of God, specifally the sixth commandment of God's Ten Commandments, viz, "Thou shalt not murder". Other religions have similar laws. These laws underpin our society and culture. In contrast to other parts of Government legislation protecting such things as flora and fauna for example, this bill if enacted would elevate such phenomena above that of the life of an unborn child. We have laws in place to enforce and punish those who are found guilty of manslaughter or murder. But the murder of innocent children before birth is to be condoned and made legal by the state. This bill does nothing to protect the rights of the unborn child as a human being in contrast to the rights of the mother. While the mother has rights over her own body, she does not have the right to murder her own unborn child. To take the life of a child one day before birth would be admissible, but taking it one day after birth would, in the letter of the law would be murder. The paradox is clear.

I would like to submit my strong criticism of the proposed abortion bill. Why must the unborn innocents pay the ultimate price for the promiscuity of adults because that's what will increase with this bill. I'm not talking about the medical necessity to protect a woman's life in the case of a serious medical episode in pregnancy. When something is legalised it is authenticated, this bill intentionally or unintentionally will authenticate infanticide. It is further moral decline which has seen taking place and will directly affect our society adversely.

Please stop what is simply and clearly murder. This should never have been passed.

Decriminalizing abortion will not stop this suffering. It will increase the number of women who will try to not feel the negative emotions connected with choosing to abort their baby. I have studied depression and anger issue in a pastoral care course and it is evident that these mental health issues can be caused by pushing down issues and not dealing with them. Women struggle with guilt often and there would be many women who would carry guilt after a chosen pregnancy termination. I don't believe this bill will be caring for women's rights at all. I think we will see an increase in mental illness in women over the next 30 years in women. If a women feels a baby kicking for some time then chooses to terminate the pregnancy it is extremely unlikely that this will not haunt the woman for years to come. Human beings are not robots and issues in life inevitably cause distress and removes joy. Mental illness is currently on the rise and I can only see this bill increasing the amount of money the government will need to funnel into mental illness in the future. I care about Australia being a healthy nation of women and men who contribute to our nation being the most wonderful country to live in.

I will protect the environment which sustains us, in the knowledge that the continuing health of ourselves and our societies is dependent on a healthy planet. I will remember that I remain a member of society, with special obligations to all my fellow human beings, those sound of mind and body as well as the infirm. If I do not violate this oath, may I enjoy life and art, respected while I live and remembered with affection thereafter. May I always act so as to preserve the finest traditions of my calling and may I long experience the joy of healing those who seek my help. Thank you.

I am a human being, I do not need a panel of judges, a royal commission or even a group of learned individuals, whom I have come to believe in, to know that society has come full circle enough to understand the difference between morality and injustice. Please consider this late submission as we weren't given enough time to do so within an appropriate timeframe. This submission is in rejection of the amendments to the Reproduction Bill of 2019

I make this submission to the inquiry into the Reproductive Healthcare Reform Bill 2019 ("bill"). I am grateful for the opportunity to contribute to this inquiry on this very important matter. I am opposed to the bill in its entirety. However, I would like to make two brief points which may be constructive on considering possible amendments.

My first point is that the right to conscientious objection is not satisfyingly being recognised in the bill in its current form. Doctors who have conscientious objections should not be obliged to refer and should not have any obligations whatsoever to facilitate or participate in the process of providing an abortion. If a foetus is indeed human life, as would be the view of some doctors, perhaps based on natural law or religious belief, why should they be legally obliged to be an accessory to what they consider to be murder? My point is that the extent to which the bill is proposing facilitation of abortion does not respect the gravity of the objection in the conscience of those being bound.

My second point is that I consider that neonatal care for live babies born of abortions is not only warranted but reasonable.

I make this point in a tentative way. It appears to me that the operative definition of human personhood behind the bill is that it begins at birth. If this is not the case, the conditions (or stage of human development) to be satisfied so that personhood applies should be clarified within the context of this inquiry. Furthermore, if personhood does not begin at birth from the womb then what is the rationale for not obliging provision of neonatal care for live babies born of failed abortions? Would this not be discriminating against a class of human persons? The current provisions (without the bill in place) that would apply to live babies born of failed abortions should be clarified in this inquiry. This should cover any care that is currently obligated under policy or legislation.

This would ensure that at least there is a transparent and rational consistency to legislation, but also for this to be clear for the public the view of parliamentarians.

If the operative definition of human personhood behind the bill is not that it begins at birth, then the alternative definition for personhood should be made clear in the inquiry. I trust that my submission is well received in good faith and a considered manner.

I would like to join with many others in expression of strong opposition to the Reproductive Health Care Reform Bill, as it now stands, on the basis of the value of human life. Every human regards life as sacred, special, which is why every human grieves when it ends. I know it sounds cliched, but it is cliched because it is so fundamental to this issue. Life is life, whether it is fully formed, or still growing. On the basis of valuing human life, we need to consider and explore EVERY other avenue for mothers over the abortion of a life, and therefore the amendment to this Bill should be revised. As it currently stands, it will open the door to further abortions (even on the basis of gender), which is going backward in our progression of human rights. Giving pregnant mothers the ability to abort late-term does not progress their rights more than it totally eradicates the rights of the person inside them; their right to life. As representatives for our country, I request that you please act in our most basic and fundamental interest - our lives. Thank you in advance for your consideration.

This submission is short because we are appraising a deadline...this is a result of the hate with which this bill is being pushed through. I believe this bill is a matter for significant public consultation and the haste is an effort to circumvent that process. I do not support this bill or the manner in which it is being pushed through star government.

Dear Sir,

Abortion is not mentioned in the title of the bill however it is the central proposal of the bill. I have long supported 'Open Doors' a counselling service for women seeking abortion. I support adoption of children.

The Australian philosopher, Peter Singer advocates for post-birth abortion. The governors of New York (Andrew Cuomo) and Virginia (Ralph Northam), also advocate abortion to term (the former), and post birth (the latter). Post birth abortion is murder under our law and if life begins at conception (I believe it does) pre-birth abortion is also murder.

It is not hard to see that the dis-memberment of a human being in the womb and post-birth killing undermine the dignity of human beings and therefore the health of civilisation. The classical Greek philosopher Hippocrates forbade abortion and our medical students on graduation swore to his oath.

To the Hon Shayne Mallard MLC, Chair of the Reproductive Health care Bill 2019, First and foremost the name of the Bill, Reproductive Health Care Reform Bill 2019, is an absolute

misnomer. Abortion is abortion and absolutely nothing to do with women's health care in the vast

majority of case. Is does not improve the health care of women and it can be argued that it will impact

them mentally and physically immediately after the procedure, requiring follow up consultations further

burdening the New South Wales (NSW) Health Care system.

The proposed Bill fails to provide women with adequate health care because there are no alternatives

provided to termination. In most medical procedures health professionals will detail all possible solutions and side effects yet this bill does not provide any of this but rather shuts out counselling,

cooling off period, ultra-sounds, etc. The result is that women are not told of the possible side effects

and no alternatives meaning they are given no choice but to terminate.

The 2017 NSW Parliament Research Paper into abortion highlighted that the top reasons for aborting

were, in order:

Does not want children now - 23.2% Already enough children - 18.1% Too young - 11.2% Not the right time - 10.8% Has young baby - 8.7% Financial reasons - 6.3% New or unstable relationship - 3.4%

These top seven reasons which account for almost 82% of all abortions in NSW could be solved by

providing adoption as a solution. As you may be aware we have a huge problem and difficulty in Australia for parents who would like to adopt a child and a huge shortage and in many instances have to

go overseas to access adoption service. Why is this not a consideration?

There are no protection for live births during abortion and we have evidence from all over the world to

suggest this does occur.

No mention of organ trade as was uncovered in the United States of America.

No mention of how the baby body is disposed of. Is there any dignity for the featus?

Cigarette packets suggest smoking will harm your unborn baby with a picture of an unborn baby on the

smoking packet yet there is debate among many that the 'clump of cells' is not a baby.

Why the hypocrisy in the law where the rights of a baby are recognised in the area of smoking cigarettes

yet ignored in this abortion bill. Is it sometimes a baby and sometimes not?

A 16 year old child must gain permission from her parents to go onto a school excursion, yet does not

rates the babies are living beings developing and nurtured within the womb until such time they

survive on their own. And with better technology and medical advancement the rate of survival will

increase and reduce in gestation rate periods. The Bill effectively placed before the Legislative Assembly

is effectively supporting infanticide.

Are there clear guidelines to how and what type of abortions can take place? Please let us, the public

know the method of abortion/s which is being proposed. This needs to be detailed and made public for

all health care professionals and their peers to review. Why the secrecy when other 'medical practices'

are made so very public and explained to the patient in detail prior to each procedure.

As a lifelong resident of NSW I strongly suggest that this bill be REJECTED and for it never ever to see the

light of day. This bill is not about health care and it's not about decriminalisation. This bill does nothing

- 1. The baby's heart beat is audible 4 weeks after conception. If passed, this Bill amounts to murder of a human being. What other forms of murder will then be approved?
- 2. Healthcare professionals should be guaranteed protection from being complicit in the process of abortion. Receptionists, nurses and doctors are affected, not just the woman.
- 3. Who is responsible to care for the child if the abortion is botched and the child survives even if it is mutilated in the process?

I implore you to not vote in favour of this bill but to choose life and freedom for the most vulnerable in our society.

To whom it may concern,

I write to express my disgust regarding the reproductive reform in NSW.

I have seen my own baby's heartbeat on ultrasound just 4 weeks after conception. Babies are living human beings and allowing them to be killed is MURDER. They are the most vulnerable in our society and we should be doing everything possible to protect them.

Science has proven unborn babies feel pain by 16 weeks gestation, and must be anaesthetised to perform surgery. Abortion is a totally cruel practice on these poor helpless little babies. Just because we can't hear them crying doesn't mean they aren't in pain.

If a baby is born alive during an abortion procedure there is no requirement in this bill for care to be given to that baby. Considering parents are required to provide certain care for their older children I feel this is very heartless.

I urge you to please not allow this reform to be passed.

I am writing as an interested citizen, who is very concerned about the amendments proposed under the Reproductive Health Care Reform Bill 2019.

In particular, I am very concerned about the provisions enabling terminations after 22 weeks (section 6), the provisions by passing conscientious objectors (section 9), and the lack of any provision relating to the treatment of babies born after a failed abortion.

My concerns are as follows:

1. A foetus at 22 weeks to term may be viable

We know that an extremely pre term baby may be viable outside the womb. A 2015 paper published in the New England Journal of

Medicinehttps://www.nejm.org/doi/full/10.1056/NEJMoa1410689 shows that "Overall rates of active treatment ranged from 22.1% (interquartile range [IQR], 7.7 to 100) among infants born at 22 weeks of gestation to 99.8% (IQR, 100 to 100) among those born at 26 weeks of gestation. Overall rates of survival and survival without severe impairment ranged from 5.1% (IQR, 0 to 10.6) and 3.4% (IQR, 0 to 6.9), respectively, among children born at 22 weeks of gestation to 81.4% (IQR, 78.2 to 84.0) and 75.6% (IQR, 69.5 to 80.0), respectively, among those born at 26 weeks of gestation". I find it extremely upsetting, and morally repugnant, that we could consider killing a baby who (if born) has significant chances of survival. Instead we should be doing everything we can to support the mother, and the baby, fighting for the health of both. Because of the reasonable prospects of viability of a pre term baby born after 22 weeks if treated, we cannot consider abortion as an issue affecting only a mother's body. It is a construct, and a sham. The baby is an independent life, supported by the mother's womb, but (from 22 weeks onward) not dependant on it, if high care treatment is available. We cannot let these babies be killed through termination, or through lack of treatment after a failed termination. This bill is out of step with the personal views of the community, and is a great mistake.

There is no moral, economic or medical justification for section 6 as currently drafted, and it contradicts the personal views of Australians.

2. Babies born due to failed terminations must be treated

Likewise, there is no moral, economic or medical justification for a lack of provisions requiring compulsory treatment for babies born alive due to failed terminations (at any gestation). The likelihood of failed termination at late term is significant, and it is morally and ethically repulsive to leave these babies to die. They must be treated. They must be given every chance to recover from their near death experience.

3. We have an issue with adoption in Australia - inducement may be a better alternative to termination

Adoption wait lists are long, and the supply is short, leading to arbitrary "cut offs" (such as by age) and often disappointment. Loving future parents often turn to overseas adoption agencies at very significant cost to adopt a baby. The cost of abortion is not only to the families who lose a child, and to those that miss a chance at adopting, it is also economic as a future generation is robbed of a valuable contribution each time we allow a termination.

Once a mother, or a medical practitioner, decides that a baby should be terminated, perhaps we could induce the birth instead, treating the baby, and provide that baby with a loving home in which to thrive and prosper. As a person who has suffered multiple miscarriages, I for one would love to expand my family and my heart with one of these little ones who would otherwise be lost to us.

4. Conscientious objectors should not be bypassed

Section 9 is shocking in that it enables one pro-termination practitioner to steam-roll his or her fellow medical practitioners who do not support the termination. No only are they professionally "bypassed" under section 9(3) but they are forced to refer the first medical practitioner to another person who does not have an objection to the proposed termination. In essence, the dissenting medical voice is silenced!

This makes a sham of the operation of section 6(1)(a) under which two medical practitioners must agree on the termination where it occurs after 22 weeks. If the dissenting voice is silenced (as it will be under the current wording of section 9), then the termination becomes a certainty, regardless of the grounds of the objection to the termination, and regardless of the number of dissenters! For example, a first medical practitioner may get no agreement from 5, or 10 colleagues, but finds it in the 11th and so the termination is endorsed under s6(1)(a) because of the operation of section 9(3). This is problematic, and flies in the face of good medical practice.

5. Serious lack of adequate community consultation

I am also extremely concerned about the way this has been rushed through the House of Representatives without adequate community consultation. For those who have been away or ill or perhaps not just following current events as they should, this bill has been read and passed through the Lower House. We need time for the community to catch up, and consider the changes properly, and have time to work out what they think, and meaningfully contribute to the debate. The issues are considerable (moral, ethical, and economic) and people need time to think this through. The MPs need time to think this through too! Let's not be hasty to rush through a bill with such significance without proper consideration on all aspects of it.

We as a community are relying on the Senate to slow this bill down, arrange an enquiry, allow the community to consider this carefully, and for them to have a say. There is no immediacy to the bill, and we owe these unborn babies at least a pause, and a decent debate.

The Bill has to consider the following:

Conscientious objection (section 9)

Base position:

The current clause 9 should be rejected entirely

CO amendment should be replaced by proposed amendment c2019-043D which was not adopted by the legislative assembly.

Amendment c2019-043D that was rejected covers 'facilitation' as well as performance or assistance and arguably covers things like inserting a line into a patient from which abortion drugs will be run through etc. often allocated to JMO in public hospitals

It is a wide clause that does not require any referral.

The current clause 9 should be rejected entirely

It's requirements for providing information and transferring are unnecessary.

Providing information may involve the doctor having to take active steps to ascertain if a particular doctor will do a particular abortion. This may harm the doctor who believes abortion is the taking of human life.

They become part of the causal chain leading to the abortion.

If the state had a website or brochure you could point to that might be ok, but there should be no prohibition on the doctor being able to recommend other options or counselling or support services designed to support true choice.

Emergency not defined.

- -How will this legislation potentially harm doctors who have conscientious objection and who are forced to compromise seriously held ethics/beliefs?
- Doctors are trained professionals with high standards of conscience, similar to parliamentarians. Just as parliamentarians have a conscience vote on this issue, so should doctors be able to maintain their freedom of conscience.
- -Referral is not required in NSW for ready access to abortion services. Case law already supports abortion. Forcing doctors to participate in the abortion process by effectively referring to another doctor for abortion is unnecessary.

The Bill should have the following provisions added:

- State that parents are to be notified in the case of children seeking an abortion (unless doing so would put them in danger).
- Protect women from abortion coercion.
- Outlaw sex-selective abortions.
- Require data collection for all abortions.
- Protect children born alive after an abortion.

I would also like to see the provisions around informed consent, counselling and late-term abortions strengthened.

I oppose this Kill Bill and Hope that You all in the Upper House do NOT pass this Bill. Thank you $\,$
