Questions from Mr David Shoebridge MLC

4 degrees of warming

1. **Are you aware that the Bureau of Meteorology says Australia is on track for 4 degrees of warming under the current emissions trajectory?**

I am advised this is a matter for the Minister for Energy and Environment.

2. **What would be the impact of this on seniors in NSW?**

I am advised this is a matter for the Minister for Energy and Environment.

3. **Is there a plan in place for adaptation of facilities and teaching to respond to this scenario?**

I am advised this is a matter for the Minister for Energy and Environment.

Homelessness

4. **Older women are the fastest growing demographic in homelessness, what's the plan to address this?**

I am advised this is a matter for the Minister for Families, Communities and Disability Services.

5. **Older women have difficulty accessing housing because they are homeless due to low income, not complex need. When will there be specific programs available to assist older women with homelessness and low income support?**

NSW Aging Strategy

6. **Even though the progress report for the 2 year implementation of the NSW Ageing strategy (2016 – 2020) is on track, there are concerns that the strategy is not ambitious enough to address the needs of our ageing population, when will a more ambitious strategy be implemented?**

I am advised work has commenced on the development of the next NSW Ageing Strategy.

Commissioner

7. **How is the ageing and disability commissioner providing support to vulnerable adults and their families or carers following an investigation?**

I am advised the Ageing and Disability Commissioner will respond directly to the Committee.

8. **What support options will be available?**

I am advised the Ageing and Disability Commissioner will respond directly to the Committee.

9. **What is the budget for this support?**

I am advised that the Ageing and Disability Commissioner will respond directly to the Committee.

Older workers

10. **What is happening to support older people in the workforce? Eg. Physically demanding jobs like construction and nursing transitioning people into coaching or administrative roles?**

I am advised that Working and Retiring is a priority area in the NSW Ageing Strategy 2016-2020 and numerous initiatives are implemented annually for this priority. The Year Four Action Plan and Year Three Progress Report are available on the DCJ website.

Veterans employment program

11. **Has consideration been given to expanding the veterans employment program to the private sector?**

I am advised the Office for Veterans Affairs engages regularly with stakeholders to increase opportunities for veteran employment in NSW.

12. **Will the government support RSLs to divest poker machines, due to the vulnerability to gambling addiction of veterans and the fact that clubs can remain profitable without poker machines?**

I am advised this is a matter for the Minister for Customer Service.

Multiculturalism

13. **What strategies has the NSW government in place to support and increase diversity within the NSW public service?**

I am advised it is the remit of the NSW Public Service Commission (PSC) to implement policies to attract the right people for the right jobs no matter what their gender, race, age, religious beliefs, or personal commitments.

Multicultural NSW sits on the PSC Diversity and Inclusion Advisory Committee to advise on issues and initiatives which promote and enhance diversity within the NSW Public Sector.

14. **What is the number and percentage of people employed in the NSW public service who are culturally and linguistically diverse in 2019-2020.**

I am advised the Public Service Commission's 2019 Workforce Profile Report is publicly available.

15. **Does this represent an increase in such employment, and if so by what percent in relation to 2018-2019?**

I am advised that the Public Service Commission's 2019 Workforce Profile Report is publicly available.

16. **What NSW government agencies provide information in languages other than English?**

I am advised this question should be directed to the Ministers of each Department. All NSW Government agencies are expected to provide high quality services and programs for all people of NSW. The Multicultural Policies and Services Program (MPSP) is the mechanism for agencies to show how they are planning effectively for people of culturally and linguistically diverse backgrounds. The MPSP framework helps agencies to embed multicultural planning within core business operations.

17. **What languages are made available in these departments?**

Please see the response to Supplementary Question 16.

18. **What services are available for people needing translators to assist them with engaging with government services?**

I am advised the NSW Government Multicultural Principles require that all individuals in NSW should have the opportunity to make use of and participate in relevant activities and services administered by the NSW Government.

The provision of interpreting and translation services make NSW Government services more accessible to people with limited English or people who prefer to communicate in a language other than English.

Extensive guidelines for NSW Government agencies and funded services have been developed by the NSW government. These guidelines clearly outline the need to make interpreters and translators available to individuals in NSW who require this support to access government programs.

19. **Have all NSW Government agencies prepared multicultural plans as required by the MPSP Framework and reported publicly on the progress of these plans?**

I am advised Multicultural NSW administers the Multicultural Policies and Services Program (MPSP) where agencies show how they plan effectively for people of culturally and linguistically diverse backgrounds and to report on progress. All agencies must report progress against their multicultural plans under the Annual Reports (Departments) Regulation 2015.

20. **Which agencies have not prepared such plans and or reported on these plans in the period 2019-2020?**

I am advised reports on the 2019-20 plans are expected after 30 June 2020.

Penrith Panthers Western Sydney Community and Sport Facility

21. **Did the Office of Sport do the original assessment before the grant was announced in 2015 for the Penrith Panthers Western Sydney Community and Sport Facility?**

I understand from an article in the Sydney Morning Herald dated the 11th of March 2020 that the NSW Opposition have referred these matters to the Independent Commission Against Corruption.

Given these matters may be under investigation it would be inappropriate to comment.

22. **When was notification of Federal Government approval for a funding agreement for the revised and reassessed Penrith Panthers project, received by the Office for Sport and was this notification received in writing, on which date and from whom?**

I understand from an article in the Sydney Morning Herald dated the 11th of March 2020 that the NSW Opposition have referred these matters to the Independent Commission Against Corruption.

Given these matters may be under investigation it would be inappropriate to comment.

Maximum Financial Delegation

23. **Please provide the instrument which set the maximum financial delegation of the then Chief Executive, Office of Sport, Mr Matt Miller as at 21 February 2019?**

I understand from an article in the Sydney Morning Herald dated the 11th of March 2020 that the NSW Opposition have referred these matters to the Independent Commission Against Corruption.

Given these matters may be under investigation it would be inappropriate to comment.

Sydney Football Stadium

24. **Have any other discussions have taken place either by the Minister, the Office of Sport, Infrastructure NSW or the Sydney Cricket Ground Trust for a commercial partner to fund the inclusion of an LED curtain in the Sydney Football Stadium design?**

I am advised the LED curtain was not included in the design of the stadium.

25. **Are there any provisions in the contract between Infrastructure NSW and John Holland for the inclusion of an LED curtain within the design?**

I am advised the LED curtain was not included in the design of the stadium.

26. **Which elements of the construction would be fast-tracked to meet the July 30th 2022 deadline for handover?**

I am advised the stadium is on schedule to be completed by 30 July 2022 and be operational for the 2022 NRL Grand Final.

27. **On releasing the contract between Infrastructure NSW and John Holland, a number of sections have been redacted. Why has the Contractual Completion Date been redacted from the public release?**

I am advised the NSW Government advised at the time of announcing the contract with John Holland that the stadium would be operational for the 2022 NRL Grand Final.

28. **The Premier stated that by going back to market on the Sydney Football Stadium the Government had “ensured the new stadium will be the highest quality”. What high quality aspects have been added to the construction?**

I am advised the Sydney Football Stadium will be delivered as a Tier 1 stadium consistent with the NSW Government’s Stadia Strategy and the project planning approval.

The redeveloped Sydney Football Stadium will be a modern, world-class venue and will ensure Sydney has a sporting and entertainment precinct of an international standard ensuring that NSW remains the number one choice for sporting and entertainment events.

29. **Have any additional features been added to the Sydney Football Stadium design?**

I am advised the Sydney Football Stadium will be delivered as a Tier 1 stadium consistent with the NSW Government’s Stadia Strategy and the project planning approval.

The redeveloped Sydney Football Stadium will be a modern, world-class venue and will ensure Sydney has a sporting and entertainment precinct of an international standard ensuring that NSW remains the number one choice for sporting and entertainment events.

30. **Were any parts of the \$99 million cost blowout previously identified by Lendlease in their rejected works offer in May 2019?**

I am advised the Sydney Football Stadium will be delivered as a Tier 1 stadium consistent with the NSW Government’s Stadia Strategy and the project planning approval.

31. **What was the amount paid to the Australian Rugby League Commission on top of the blowout to the Sydney Football Stadium, was it \$12 million or \$20 million?**

I am advised discussions were held between the ARLC and the NSW Government to secure the NRL Grand Finals in NSW. Details of these discussions are commercial in confidence.

32. **Were discussions held with the ARLC regarding the potential for the government to provide land to them for a new Headquarters as part of the negotiations to secure the 2021 NRL Grand Final?**

I am advised discussions were held between the ARLC and the NSW Government to secure the NRL Grand Final in NSW. Details of these discussions are commercial in confidence.

33. **Have the NSW Government begun discussions with the Australian Rugby League Commission about a venue for State of Origin in 2022?**

I am advised the NSW Government will continue to work the ARLC and the NRL to secure an appropriate venue within the NSW Stadia Network to host the State of Origin in 2022.

34. **National Rugby League CEO Todd Greenberg described rugby league at the Sydney Cricket Ground as “not the greatest experience”. Is the Sydney Cricket Ground the likely option to be put forward by the NSW Government for a State of Origin game in 2022?**

I am advised the NSW Government will continue to work the ARLC and the NRL to secure an appropriate venue within the NSW Stadia Network to host the State of Origin in 2022.

Sydney Cricket Ground Members Facilities

35. **What is the cost of the new members’ facilities at the SCGT?**

I am advised the project is being priced.

36. **Will the new members’ facilities be included on land currently subject to the development application for the Sydney Football Stadium?**

I am advised yes.

37. **The SCG Trust informed members in November that the new members’ facilities “will form part of the stadium footprint”. Where are these facilities planned to go?**

I am advised the Stadium Club facilities will be in a similar location to those they replace.

38. **The SCG Trust informed members in September that the new ‘Stadium Club’ members’ facilities would “like the old one, (would) be attached to the stadium itself”. Why were the Stadium Club facilities not included in the state two development application for the Sydney Football Stadium?**

I am advised the Stadium Club facilities form part of a planning modification to the Stage Two SSDA for the SFS project.

39. **In this same email communication to members, the Trust informed them the plans were to be “on display for the rest of the membership before the end of the year”. Has this happened? If not, why not?**

I am advised the process is underway.

40. **When will the SCG Trust be submitting the plans for the new members’ facilities as a development application?**

I am advised in line with planning requirements.

41. **When is construction expected to begin on the planned members’ facilities?**

I am advised the construction program is not yet finalised.

42. **When are tenders to be called for to build the planned members’ facilities?**

I am advised a competitive tender process has been followed for the SFS redevelopment.

43. **When are the new members’ facilities expected to be opened?**

I am advised in line with the opening of the new Sydney Football Stadium

NSW Office of Sport

44. **Was there any delay in funding from the NSW Office of Sport to State and Disability Sporting Organisations?**

I am advised funding for 95 State Sporting Organisations and State Sporting Organisations for People with Disability under the 2019/20 Sport Development Program was approved by the A/Minister for Sport. Funding recipients received advice on how to claim their funding before 19 June 2020.

45. **When was the funding for the 2019/20 financial year confirmed?**

Please refer to response to supplementary question 44.

46. **What was the cause of the delay in this crucial funding?**

Please refer to response to supplementary question 44.

47. **Funding to State and Disability Sporting Organisations, which includes our biggest participation sports has not changed from \$60,000 in the nine years you have been in**

government. Why are sports such as gymnastics, netball and hockey being left behind in funding?

I am advised Sporting Organisations and State Sporting Organisations for People with Disability are not being left behind in funding.

48. **In the past twelve months, there has been two permanent and one acting Minister, the CEO of the Office of Sport, Sport NSW and Venues NSW have all resigned from their positions and we've had the heads of the majority of major sports in the state express their concern about the "lack of leadership" for sport in NSW. How can the public have any confidence in the Government to turn this around?**

As Acting Minister for Sport I am committed to the portfolio of Sport in NSW.

49. **What processes were undertaken by the Office of Sport to identify potential conflicts of interest for tenders?**

I am advised the Office of Sport has a Code of Conduct for Procurement and Competitive Processes which is published on the intranet.

50. **What due diligence was undertaken by the Office of Sport when assessing the tender from Barrie Smith Motor Sport Pty Ltd to refurbish the Sydney International Equestrian Centre track?**

(a) **If not, why not?**

(b) **If yes, did this identify any connection between Barrie Smith Motor Sport Pty Ltd and the board of Equestrian NSW?**

I am advised the Office of Sport is undertaking an independent review of the procurement process.

51. **When did the Office of Sport become aware that a subsidiary Barrie Smith Motor Sport Pty Ltd employs the son of the Equestrian NSW President?**

I am advised representation raising concern over the procurement process has been raised with the Office of Sport.

52. **Upon learning this information, what action was undertaken by the Office of Sport?**

I am advised the Office of Sport is undertaking an independent review of the procurement process.

53. **Were any concerns raised to the Office of Sport or any of its employees about potential conflicts of interest in the tender process for the Sydney International Equestrian Centre? If so, what action was taken to identify and limit these conflicts?**

I am advised the Office of Sport is undertaking an independent review of the procurement process.

Regional Sports Infrastructure Fund & Greater Sydney Sports Facility Fund

54. **Not one PCYC received funding under the first round – why did the four PCYC grants miss out on funding?**

I am advised the Regional Sports Infrastructure Fund and the Greater Sydney Sports Facility Fund were competitive, application based grant programs. All eligible projects were assessed against publicly available assessment criteria.

Departmental staff administering the Regional Sports Infrastructure Fund provided the opportunity for applicants to receive feedback on their applications following the conclusion of the assessment process.

55. **Did the former Minister for Sport Stuart Ayres provide any submissions for any grant in his capacity as Minister or as the Member for Penrith?**

I am advised eligible applicants to the Greater Sydney Sport Facility Fund include 33 local government authorities in Greater Sydney; NSW state sporting organisations or the national sporting organisation where the state body is part of a unitary governance model; Incorporated, community-based, not-for-profit sporting organisations and organisations providing sport and recreation programs that benefit the community, Organisations which own and administer public parklands; and Private enterprises.

56. **Was geographic location or geographic spread taken into account at any point in the assessment process for the Greater Sports Facility Fund?**

I am advised yes.

57. **How many projects recommended for funding by the Office of Sport or the assessment panel were not approved?**

I am advised by the agency the process followed was in accordance with the Assessment Methodology and had oversight from an independent probity officer.

58. **When grant applications were deemed successful, who was notified and by whom?**

I am advised for the Greater Sydney Sports Facility Fund, notification to successful applicants was made by the Minister for Sport, to either the applicant's contact person or the senior manager of the organisation.

59. **Were any of the recipients notified by the Minister or a local member of parliament rather than the department?**

I am advised yes.

60. **Did any of the announcements involve candidates in the upcoming NSW election who weren't members of parliament?**

I am advised the Office of Sport does not record this information.

61. **The former Minister said he approved grants "based on recommendations from the Office of Sport". Does this mean the top 15 ranked grant applications were approved?**

I am advised by the agency the process followed was in accordance with the Assessment Methodology and had oversight from an independent probity officer.

Sydney Speedway

62. **The government announced that they *will host a forum on November 15 with motorsport organisations to "discuss the potential masterplan of the new Sydney Motorsport Precinct at Eastern Creek."* Was that date was originally a meeting organised by Mr Gary Holt of Eastern Creek Karting?**

I am advised no.

63. **Was Mr Holt refused to attend the meeting on November the 15th despite the fact it had originally been organised at his instigation?**

I am advised no.

64. **Has Mr Holt been included in any of the meetings regarding the Masterplan for motorsport, particularly given the \$5 million indoor motor cross facility being built on that site?**

I am advised Mr Holt was invited to the Western Sydney Motor Sport Precinct Forum held on 15 November 2019. Mr Holt will be consulted on the broader precinct masterplan.

65. **When was the Minister made aware that Sydney Metro West would resume the Granville Valvoline Speedway site as part of the project?**

On the date of the public announcement of the Sydney Metro West Project by the Minister for Transport and Roads.

66. **When did the Minister contact the Sydney Speedway regarding this decision?**

This is a matter for the Minister for Transport and Roads.

67. **Did the Minister meet with the Valvoline Speedway leaseholders either before the announcement or contact them on the day of the announcement?**

Please see response to supplementary question 65. Ministerial diary disclosures are made publically available.

68. **Was the Minister aware of investments being made by the leaseholders while both Crown Lands and the Sydney Metro West had an interest in the site?**

69. **Was the Minister aware of plans by the leaseholders to develop the site when decisions were made to resume it for the Sydney Metro West project? Has the Minister ever attended the Valvoline Speedway?**

70. **Will the Minister give an iron clad guarantee that a new Sydney Speedway will be constructed and operational for the 2021/22 season?**

Please see response to supplementary question 66.

71. **Operators of the Sydney Speedway have raised concerns that the proposed site at Sydney Motorsport Park is only half the size of the current site. Have these concerns been addressed?**

I am advised yes.

72. **Will the new speedway in western Sydney be 'like for like', including parking capacity and road crew vehicles bays?**

I am advised the design of the new speedway is being finalised with oversight from the Precinct Control Group with Speedway Australia as a member. The new speedway will be a contemporary design to reflect current design standards and requirements as well as current and future demand.

Hunter Sports and Entertainment Precinct

73. **The draft concept plan for the Hunter Sports and Entertainment Precinct was released in July 2017 with community consultation taking place until November 2017, with nothing happening since the release, when will the final plan be released to the community?**

I am advised Venues NSW is currently finalising its community consultation process with over 40 stakeholders, including an established Multiple Agency Steering Committee.

74. **The Venues NSW website says “Feedback from the consultation is now being used to refine the concept plan and to identify any alternate options for the Precinct for further Government consideration”. It has been over 2 years, how much longer will it take for the community consultation to be worked through and a final plan delivered?**

75. **When will the final plan be considered by cabinet?**

I am advised deliberations of Cabinet are Cabinet-in-Confidence.

76. **The draft ‘Vision for the Hunter Sports & Entertainment Precinct’ states that the concept plan currently has no funding attached to it. How will the Hunter Sports and Entertainment Precinct be funded?**

(a) **How much will it cost?**

77. **Are there any plans to sell off parts of the precinct or the Newcastle Showground to fund the redevelopment?**

I am advised no.

78. **In the 2017 draft plan the former Minister for Sport, Stuart Ayres said ‘I look forward to progressing the future of the precinct, a key priority for the NSW Government.’ How much longer will the people of the Hunter have to wait until your government delivers world class sports and entertainment facilities in the region?**

I am advised the NSW Government is committed to delivering world-class sporting and entertainment facilities in the Hunter region.

79. **On 12 January 2019 a Venues NSW spokesperson told the Newcastle Herald “Venues NSW, working with Hunter and Central Coast Development Corporation, are preparing a Strategic Business Case for the Hunter Sports & Entertainment Precinct... This Strategic Business Case is still in the process of being reviewed and once that is completed it will**

be submitted for consideration by the NSW Government.” Has the Strategic Business Case been completed?

I am advised the NSW Government’s total expenditure on the Hunter Sports and Entertainment Precinct is publicly available in the NSW Government’s Budget Papers; and included in respective NSW Government agency Annual Reports, such as Venues NSW, and Hunter Central Coast Development Corporation.

81. Considering the Hunter Sports and Entertainment Precinct is considered the next key site for major sporting and economic development in Greater Newcastle, why has the masterplan process stalled?

82. Will the Newcastle Show remain at the Newcastle Showground as part of the Hunter Sports and Entertainment Precinct masterplan?

I am advised Venues NSW continues to support and work collaboratively with the Newcastle Show.

Hunter Homeless Connect day

83. **Each year the Hunter Homeless Connect day brings together a wide range of government and non-government services at the Newcastle Entertainment Centre to support those who are homeless or at risk of homelessness. Minister, are you aware that Hunter Homeless Connect are charged thousands of dollars by your department to use the Newcastle Entertainment Centre for two days?**

I am advised the Newcastle Entertainment Centre and Showground is proud to partner with Hunter Homeless Connect and currently provides more than a 50 percent discount on its standard rates, including rental fees for the Hunter Homeless Connect Day held at the Newcastle Showground Exhibition Centre.

Venues NSW continues to review these arrangements on a regular basis and are committed to providing additional support of this charity event, where possible.

84. **Considering the important work this not-for-profit organisation does, will you commit to waiving these fees so they can continue to focus on supporting the homeless?**
- (a) **If no, so you will not support a not-for-profit group helping countless vulnerable people?**
- (b) **If yes, will you consider refunding the fees they have been charged in previous years to use the Newcastle Entertainment Centre?**

I am advised the Newcastle Entertainment Centre and Showground is proud to partner with Hunter Homeless Connect and currently provides more than a 50 percent discount on its standard rates, including rental fees for the Hunter Homeless Connect Day held at the Newcastle Showground Exhibition Centre.

Venues NSW continues to review these arrangements on a regular basis and are committed to providing additional support of this charity event, where possible.

Local Sport Defibrillator Grant Program

85. **How many defibrillators have been provided to sport clubs in the Newcastle electorate through the Local Sport Defibrillator Grant Program?**

I am advised to date, there have been 25 applications from within the Newcastle electorate who were all successful in receiving funding under the Local Sport Defibrillator Program to purchase defibrillators.

Newcastle Sports Infrastructure Funding

86. **Are sports clubs in the Newcastle LGA eligible for the Regional Sports Infrastructure Fund?**

I am advised no.

I am advised the urban areas of Sydney, Wollongong and Newcastle Local Government Areas are not eligible to apply for Regional Growth Fund programs with the exception of the Resources for Regions program.

87. **What sports infrastructure funding programs is the Newcastle LGA eligible for?**

I am advised information on successful grants is provided in departmental annual reports.

Canterbury Sporting Facilities

88. **Is the NSW Government aware of any plans to change the current use of Canterbury Golf Course?**

I am advised the use of Canterbury Golf Course is a matter for Canterbury-Bankstown Council.

89. **Will the NSW Government commit to maintaining the Canterbury Golf Course site as public open space?**

I am advised the use of Canterbury Golf Course is a matter for Canterbury-Bankstown Council.

90. **Will the NSW Government commit to maintaining the Canterbury Racecourse site as public open space?**

I am advised the use of Canterbury Racecourse is a matter for the land-owner and the relevant planning authority.

Anti-racism work

91. **What did the Minister for Multiculturalism or Multiculturalism NSW (MNSW) do in response to racist attacks resulting from misinformation on the coronavirus?**

I am advised in February 2020, the CEO of Multicultural NSW issued a statement condemning racism related to COVID-19 and encouraging community to follow factual advice from NSW Health.

The NSW Community Resilience and Response Plan (COMPLAN) Committee has been convened to address the potential impacts of COVID-19 on community harmony and to coordinate NSW Government agency responses. The NSW Police Force and Anti-Discrimination Board of NSW are members of the COMPLAN Committee and shared advice about incidents of racial discrimination, vilification and hate crime related to COVID-19.

Multicultural NSW has been working at the highest levels with relevant NSW Government agencies including NSW Health, Study NSW, the Department of Education, and the Department of Communities and Justice to address the potential impact of COVID-19 on social cohesion and multicultural communities.

Multicultural NSW continues to engage a wide range of community stakeholders to support to strengthen social cohesion during this challenging time.

92. **How many media releases, press interviews, statements tweets or Facebook posts did the Minister and MNSW issue condemning this racism?**
