I am also advised that as TAFE NSW operates in a competitive environment, data is not provided by location or by cohort enrolment and completion numbers. TAFE NSW does provide enrolment data in the Enrolments by Students section of the TAFE NSW Annual Report linked above. TAFE Digital enrolments are included in overall enrolment numbers.

2. Please provide a list of ICT and Student Services jobs that have been cut to date, that were performed by people living regionally.

I am advised that no regional ICT or Student Services jobs were impacted by the 'Changing how we work' organisational change. TAFE NSW complies fully with the NSW Government's commitment to preserving rural and regional employment.

I am advised that the terms of reference for the Review were developed by the Department of Premier and Cabinet in consultation with Mr David Gonski AM and Professor Peter Shergold AM.

6. Is there a plan to reduce the cost of running TAFE to the government?

The NSW Government's priority is ensuring that the people of NSW have access to services and infrastructure that deliver social and economic benefits underpinned by a strong and sustainable economic and financial position. This applies to all NSW Government agencies.

7. Has there been any investigation into further reducing tuition costs for all courses in TAFE

The prices for government subsidised qualifications (Smart and Skilled) are set by Training Services NSW following a methodology established by IPART.

The NSW Government continues to deliver nearly 700,000 fee free courses across VET and TAFE over the next four years.

8. Are there plans to increase the number of courses being run through non -TAFE providers?

I am advised that there are no current plans to increase the number of courses being run through non -TAFE providers.

9. Has there been any modelling on the impact of removing subsidised or fee-free course from TAFE NSW?

I am advised: no.

I am advised that the Government regularly uses the Budget process to review agencies and ensure they are delivering on their objectives. I am advised that the Government engaged McKinsey in July 2019 to assess the One TAFE reforms and enable the public education provider to prioritise resources for teachers and students. I understand a previous analysis was conducted by BCG in 2015.

The Gonski-Shergold review currently underway is assessing the whole VET sector and is not exclusively focusing on TAFE NSW.

I am advised that consultant costs are regularly reported through tenders.nsw.gov.au as per established NSW Government guidelines.

I am advised that the Government engaged McKinsey in July 2019 to assess the One TAFE reforms and enable the public education provider to prioritise resources for teachers and students. I understand a previous analysis was conducted by BCG in 2015.

I am advised that the McKinsey Report is Cabinet-in-confidence and therefore unable to be disclosed. I am also advised that the review conducted by BCG is available on the TAFE website.

13. Is there a plan to further reduce the level of staff in TAFE NSW?

The NSW Government remains committed to increasing the number of teachers at TAFE NSW, including providing \$3.1 million for 525 Training and Assessment Scholarships to provide a pathway for the best and brightest in industry to become a TAFE teacher. This

is on top of a 6.8% increase in the number of full-time equivalent teachers between June 2018 and June 2019.

14. Where there is a CLCs that has opened in a township where a TAFE campus exists, will the original TAFE have its courses reduced or capacity diminished?

I am advised that CLCs complement and add significant value to the current courses offered in the region. Indeed, I understand that there has been an increase in both courses and enrolments in communities where CLCs are now present when compared to before the establishment of the CLC.

The Educational Pathways Pilot Program commenced in 2020 and seeks to overcome barriers to NSW high school students pursuing pathways to a career in VET. The pilot includes an initiative to address the school funding implications of students spending time off campus attending vocational education.

28. How many people are employed by TAFE to work particularly with schools to make the pathway from school to TAFE easier?

I am advised that TAFE NSW's 'Schools Relationship Coordinator' positions have responsibility for leading collaboration with schools. I understand that the role is responsible for developing and managing productive working relationships with schools. Programs managed by coordinators include TVET, Under 17 early school leavers, Get into VET and YES programs.

The Regional Industry Education Partnerships (RIEP) program provides students with stronger links to local employers and industry, an understanding of the skills required to get a job and better post school career opportunities. REIP officers will also assist students wishing to undertake a school based apprenticeship or traineeship connect with local employers.

The Educational Pathways Pilot Program is currently underway in 24 schools across Western Sydney and the NSW North Coast. The Program comprises a range of initiatives that aim to transform the way students and parents think about careers, focusing on improved career advice and increased school-based apprenticeships and traineeships.

New courses at Wollongong TAFE from Semester 1 2020 include the Certificate III in Sport and Recreation, Certificate II in Automotive Vocational Preparation, Certificate III in Painting and Decorating (CPC30611) (for experienced non-apprentices), Certificate IV in Training and Assessment, Certificate III in Design and Fundamentals, and Certificate IV in Travel and Tourism, amongst others.
