Dear Ms Boyd

Thank you for your correspondence concerning the inquiry into the operation of the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016.* 

As you would be aware, the Passenger Service Levy is a \$1 fee per passenger service transaction that authorised taxi and booking service providers are liable to pay. For taxi service providers this means \$1 for every rank or hail journey. For booking service providers (including for booked taxis), it means \$1 for every booking which results in a passenger service.

Revenue NSW receives the levy and manages debt collections on behalf of the administrator, the Point to Point Transport Commissioner.

In accordance with your request, I have attached a spreadsheet showing the breakdown of the amount of the Passenger Service Levy collected through booking service providers and taxi service providers.

I trust that this information is of assistance to you.
