# 1. Which minister approved funding for the project?

Regional Cultural Fund (RCF) has funded the arts and cultural components of the Batemans Bay Regional Aquatic, Arts and Leisure Centre.

All RCF funding decisions are made by the Minister for the Arts in consultation with the Deputy Premier.

### 2. What was the date on which the approval occurred?

This funding was approved on 28 November 2018.

#### 3. From which funding source was it approved?

The Regional Cultural Fund.

### 4. What are the justifications provided for the funding?

Applications to the RCF are assessed by an independent panel, comprised of representatives with regional expertise from across the arts and cultural sector, infrastructure industry, and public servants.

The independent panel provides advice on the merits of each of applications against four program criteria:

- case for change,
- capacity to deliver,
- · value for money and
- engagement and reach.

The arts and cultural components of this project were assessed by the independent panel as eligible and having merit.

#### 5. Was there a benefit cost ratio provided for the project?

The RCF has funded the arts and cultural components of the centre.

Yes, all RCF applications above \$5 million were required to submit a full Business Case with a cost benefit ratio.
