I am advised the NSW Government supports the National Commissioner for Defence and Veterans Suicide Prevention, through the collection and provision of data on veteran suicide.

As the Minister for Veterans I am committed to supporting the health and wellbeing of veterans and their families living in NSW, in collaboration with the Commonwealth Government and Ex Service Organisations.

The NSW Government is developing the first whole of government and community veterans' strategy. The Strategy importantly brings together all services across government and identifies new opportunities based on a comprehensive consultation process. A comprehensive consultation ensured that community involvement and feedback informed the Strategy. The NSW Veterans Strategy will build on the initiatives already in place across the NSW Government to ensure a holistic and coordinated response to issues faced by veterans.

I am advised the NSW Suicide Data Monitoring System enables the collection and reporting of information on recent suspected and confirmed suicides in NSW.

I am advised that the census will add a new question about Australian Defence Force service. This will provide more accurate data about veterans in NSW.

The NSW Government is working to make it easier for veterans who are homeless or at risk of homelessness to access the services they need. The Services we provide help people into safe and stable housing and connect them with a range of support services, helping to prevent former defence personnel ending up on the street. In this respect the NSW Government provides a range of services including our *Link2Home Veterans and Ex-Service* information and referral service and *Rent Choice Veterans*, which offers private rental subsidy for eligible veterans, providing access to affordable housing in the private rental market.

NSW Office of Sport COVID Recovery

26. What is the total cost of the Ernst & Young consultancy report on the impact of COVID-19 on NSW sports?

I am advised consultancy expenses are published in the agency's annual reports.

 - (a) Will the report be made available to NSW State Sporting Organisations?

I am advised this engagement is in the process of being finalised.

28. Did any State Sporting Organisations or a member of the COVID-19 Recovery Committee raise the issue of capitation funding models with the Office of Sport, the Minister or any other Minister?

I am advised the issue of capitation funding models specifically was not raised with the Office of Sport or the Minister for Sport.

- 29. Who was involved in the decision, announced on June 2nd, to allow children's community sport to return on July 4th?
 - (a) Was any consideration given to capitation models for the major participation sports when this decision was made?
 - (b) Why was this consideration seemingly ignored?

I am advised the decision was announced by the Deputy Premier, Minister for Health and Minister for Sport.

30. Was any consultation done with local governments across NSW for assistance with ground hire in 2020?

I am advised the Office of Sport worked with the Office of Local Government (OLG) in relation to this issue. OLG provided guidance to local government in May 2020 which advised that the Government had announced measures that allowed councils to waive or reduce fees under a new COVID-19 category to provide flexibility in waiving fees and charges, including for sporting clubs and organisations. This meant that councils could immediately apply a fee waiver or reduction for this purpose, without following the usual requirements to establish a category, while also bypassing the need to provide 28 days' public notice.

31. What financial assistance is being made available to NSW sporting clubs and associations in 2021 to assist with compliance with COVID Safe Protocols and getting back participants who left in 2020?

I am advised the Office of Sport has secured a supply of hand sanitiser which is being offered free of charge to State Sporting Organisations and other sporting bodies to assist with meeting COVID safe protocols. This is in addition to a range of grant and other programs that can assist with programs and projects aimed at increasing participation.

32. What other work is currently being done to prepare state sporting organisations for the upcoming winter season?

I am advised the Office of Sport continues to provide up to date information to the sport sector in relation to COVID restrictions. There is a dedicated contact point where sporting organisations can direct questions about COVID restrictions as well as on-line tools and resources.

- 33. Is the NSW Office of Sport aware of any competitions which were cancelled or clubs who did not participate in the 2020 Winter or 2020/21 Summer seasons as a result of COVID-19 complications or delays in the return to play?
 - (a) What work is the Office of Sport doing to assist these competitions and clubs to return
 - to play in 2021?

The Office of Sport administered a \$27.3 million Community Sport Recovery Package in 2020 to assist sporting organisations to return to play. The full amount of funding is still being allocated. The Office of Sport continues to provide up to date information to the sport sector in relation to COVID restrictions. There is a dedicated contact point where sporting organisations can direct questions about COVID restrictions as well as on-line tools and resources.

37. The Government released a draft concept plan for a Hunter Sports and Entertainment Precinct (HSEP) in 2017, why has nothing been done to progress this project in the heart of the state's second largest city?

I am advised the NSW Government will complete \$30m worth of projects in the Hunter Sports and Entertainment Precinct this year, including the Newcastle Knights Centre of Excellence and the International Hockey Centre.

38. Will the upgrades to the precinct be completed before the 2023 FIFA Women's World Cup?

I am advised McDonald Jones Stadium is a FIFA-compliant venue with world-class facilities for elite sport. It is part of the NSW Government's bid for the 2023 FIFA Women's World Cup tournament.

39. Why has no money been provided for the business case to progress this precinct?

I am advised the NSW Government will complete \$30m worth of projects in the Hunter Sports and Entertainment Precinct this year, including the Newcastle Knights Centre of Excellence and the International Hockey Centre.

As construction progresses on these multi-million dollar projects, the NSW Government will continue planning for the 11 catalyst areas across Greater Newcastle as per the Greater Newcastle Metropolitan Plan 2036.

The Hunter Sports and Entertainment Precinct sits within one of these catalyst areas and continues to be an important part of this planning.

- 40. How much funding is required to complete the business case for the HSEP?
 - (a) Will the Government commit to funding the business case so this stalled project can progress?

I am advised the NSW Government will complete \$30m worth of projects in the Hunter Sports and Entertainment Precinct this year, including the Newcastle Knights Centre of Excellence and the International Hockey Centre.

As construction progresses on these multi-million dollar projects, the NSW Government will continue planning for the 11 catalyst areas across Greater Newcastle as per the Greater Newcastle Metropolitan Plan 2036.

The Hunter Sports and Entertainment Precinct sits within one of these catalyst areas and continues to be an important part of this planning.

41. How much work has actually been undertaken on this precinct?

I am advised the NSW Government will complete \$30m worth of projects in the Hunter Sports and Entertainment Precinct this year, including the Newcastle Knights Centre of Excellence and the International Hockey Centre.

WIN Stadium

I am advised, no.

48. How much money has been committed to repairing any rust issues with WIN Stadium's grandstands?

I am advised the northern grandstand roof was replaced in 2019.

I am advised all facilities are compliant with Building Code of Australia (BCA) requirements at the time of construction.

I am advised all facilities are compliant with Building Code of Australia (BCA) requirements at the time of construction.

51. In the event of any emergency, how long would it take to empty WIN Stadium of spectators at full capacity?

I am advised all facilities are compliant with Building Code of Australia (BCA) requirements at the time of construction.

52. Have any expert consultants been commissioned to assess safety concerns at WIN Stadium?(a) If so, what has been the cost?

I am advised there are no safety concerns at WIN Stadium. The venue is fit for purpose.

NSW Motorsports Authority

53. When will consultation on the Review of the Motor Sports Act be completed?

I am advised the aim is to complete the consultation on changes to the *Motor Vehicle Sports (Public Safety) Act* this year.

- 54. When was the NSW Office of Sport informed by NSW Police that they would no longer be undertaking inspections for holding of motor vehicle race meetings at prescribed grounds?
 - (a) What has been done as a result of NSW Police informing the NSW Office of Sport about this change?

The Acting Minister for Sport wrote to the Minister for Police and Emergency Services in July 2020 to seek assistance of the NSW Police Force with providing advice on the suitability of motor vehicle racing grounds for an interim period until reforms to the *Motor Vehicle Sports (Public Safety) Act 1985* are implemented. The Office of Sport subsequently met with a range of organisations including the NSW Police Force and Engineers Australia to explore options.
