Answer:

I am advised the \$10 million development of the Leagues Club Park in Gosford provides for a unique and inclusive play space. The park incorporates existing mature trees, including the relocation of 12 mature palm trees, as well as dozens of new mature and less mature trees planted through the upgrade. Trees were selected having regard to the soil profile and salinity, and the risks and costs associated with transplanting mature trees onto site. Where areas were deemed to benefit from additional shading, including the slides and BBQ areas, shade sales and structures have been installed.

80. Given that the Central Coast has now been incorporated into the Greater Sydney Commission, will our region now receive similar funding to the Premier's 'Greening Our City' Program?

Answer:

I am advised the Premier's Priority (12) - Greening Our City is seeking to increase tree canopy and green coverage across Greater Sydney by planting 1 million trees by 2022. While the funding available under this priority is aimed at supporting urban greening across Greater Sydney, the policies and tools being developed to support the priority have broader applicability. The Department of Planning, Industry and Environment will share relevant information with the Greater Sydney Commission to inform the Commission's development of the Central Coast Strategic Plan.

- 83. Has any investigation into changing the land-use at the Long Bay Correctional Complex been undertaken by the NSW Department of Planning, Industry and Environment?

No. I am advised following the release of the South East Sydney Transport Strategy, the Department of Planning, Industry and Environment has started to develop a process for the future investigation of development potential along the Anzac Parade corridor that could include the Long Bay Correctional Complex.

As follow up, an internal meeting was held in August 2020 regarding investigations with Corrective Services NSW of the potential regeneration of the Long Bay Correctional complex as part of a new correctional facility investigation for Greater Sydney.

Hazardous Goods Route (Botany Industrial Park)

- 89. What instrument covers the Hazardous Goods Route?
 - (a) What are defined as 'hazardous goods' under this regime?
 - (b) What effect does the Hazardous Goods Route have on other planning instruments?
 - (c) What development consents in the last 15 years have been conditioned, refused, or modified due to the Botany Hazardous Goods route?
 - (d) When was the last time the Hazardous Goods Route was reviewed?

Answer:

I am advised the Hazardous Goods Routes are regulated under the <u>Dangerous Goods (Road and Rail Transport) Act 2008</u> and the <u>Dangerous Goods (Road and Rail Transport) Regulation 2014</u>. These Acts are administered by the Environment Protection Authority.

- a. Examples of types of hazardous goods can be found in the <u>Australian Dangerous</u> <u>Goods Code</u> (ADG Code) and the <u>United Nations Manual of Tests and Criteria</u> (UN Manual). Examples of hazardous goods include liquid, solid or gaseous chemicals which are flammable, toxic or corrosive.
- b. As outlined, hazardous goods routes are regulated by the <u>Dangerous Goods (Road and Rail Transport) Act 2008</u> and the <u>Dangerous Goods (Road and Rail Transport) Regulation 2014</u>. Under State Environmental Planning Policy No 33 (SEPP 33)—Hazardous and Offensive Development, potential impacts from hazardous goods routes can be assessed in a development application on case-by case basis.
- c. The Department is only aware of one consent which included conditions associated with a hazardous goods route near Botany. This was for the Vopak Bulk Liquids Terminal (Mod 2).
 - Further advice on this question may also need to be obtained from Bayside Council and any other consent authority.
- d. This question should be referred to the Environmental Protection Authority.

Consistency with the adopted LSPS of Council is one of the important considerations that every planning proposal is assessed against at Gateway.

91. Have any Local Government Areas currently been refused Gateway for their Local Strategic Planning Statement?

Answer:

I am advised a Gateway is not required for a Local Strategic Planning Statement.

92. Please list the Local Government Areas who were only granted conditional gateway for their Local Strategic Planning Statement?

Answer:

Refer to answer provided in Question 91.

Draft Design and Place SEPP and Active Transport Infrastructure

93. Has the Department of Planning, Industry and Environment conducted modelling on the impact of the Draft Design and Place SEPP on the development of pedestrian and cycling infrastructure?

Answer:

I am advised the intent of the draft State Environmental Planning Policy (Design and Place SEPP) is to improve the adequacy and connectivity of the walking and cycling infrastructure. Measures for testing adequacy and connectivity are being explored in the next phase of work.

94. Does the Department of Planning, Industry and Environment set goals or targets for the roll-out of pedestrian and cycling infrastructure?

Answer:

I am advised this is addressed through Principle 3 of the draft Design and Place SEPP. Targets include new housing within 5 minutes' walk of local public open space and 20 minutes' walk of local shops, a minimum intersection density and maximum block lengths. Further detail may be provided in the urban design guide, to be developed post-exhibition.

95. If so, what is the total amount of kilometres of new pedestrian infrastructure the Department of Planning, Industry and Environment expects will be built in the next five and ten years if the Draft Design and Place SEPP is adopted?

Answer:

I am advised no estimates are available.

96. If so, what is the total amount of kilometres of new cycling infrastructure the Department of Planning, Industry and Environment expects will be built in the next five and ten years if the Draft Design and Place SEPP is adopted?

Answer:

I am advised no estimates are available.

97. What new powers will the Department of Planning, Industry and Environment have to compel developers to construct infrastructure for pedestrians and cyclists if the Draft Design and Place SEPP is adopted?

Answer:

I am advised that developers of precincts (generally sites over 10ha or 1000 people and subdivisions over 50 lots) will have to demonstrate the precinct contains safe, direct, accessible and comfortable walking and cycle routes, including continuous paths and crossings on key desire lines. This will be a mandatory consideration of the Design and Place SEPP (i.e. consent authorities must consider whether this has been adequately demonstrated before granting consent). All development will also have to demonstrate that it minimises car parking using site specific strategies such as adaptive travel plans.

98. What new powers will local councils have to compel developers to construct infrastructure for pedestrians and cyclists if the Draft Design and Place SEPP is adopted?

Answer:

I am advised as with Question 97 this is a mandatory consideration for all consent authorities.

99. What new powers will the Department of Planning, Industry and Environment have to specifically compel developers to construct end-of-trip facilities for cyclists if the Draft Design and Place SEPP is adopted?

Answer:

I am advised the considerations referenced in Question 97 and 98 also require developers of precincts to identify locations for end-of-trip facilities, and the application requirements requires developers of precincts to propose draft controls for that precinct. The intent of the draft controls is that the consent authority may adopt those clauses in a DCP at the time of making the precinct, so that end-of-trip facilities and other obligations envisaged by the precinct plan are captured in subsequent lot development within that precinct.

Footpaths

100. What role does the Department of Planning, Industry and Environment play in the planning and construction of new footpaths in NSW communities?

I am advised:

- State and Local Government have a range of interlinked roles and responsibilities, when planning and delivering pedestrian infrastructure such as footpaths in NSW.
- Government organisations work together in the use of public footpaths with a focus on improving access, walking space and urban realm attractiveness and activation.
- The relevant Road Authority such as Councils are generally responsible for the design, delivery and maintenance of footpaths and associated street furniture. For State roads this responsibility sits with Transport for NSW.
- The design, construction and operation of footpaths is undertaken in accordance with the NSW Roads Act 1993, the Safe System approach to road safety and Local Government and Austroads Standards and Guidelines.
- A need to balance the road environment for all road users from people, buses and taxis to delivery vehicles, to move around as easily and as safely as possible is important.
- Consideration is given to:
 - O Physical allocation: The physical infrastructure of the kerb to boundary area that includes footpaths based on use, volume of pedestrian traffic and access for delivery and operational activities; and
 - Temporal allocation: The management of the footpath space through access, level of priority by user/use and the need for management of this by time of day, that is different user priority and use by the time of day.
- 101. How does the Department of Planning, Industry and Environment ensure the adequate planning and construction of footpaths as part of the NSW Movement and Place framework?

Answer:

Refer to answer provided in Question 100.

102. How does the Department of Planning, Industry and Environment monitor and evaluate the adequate planning and construction of footpaths as part of the NSW Movement and Place framework?

Answer:

I am advised:

- Responsibility for the design, delivery, operation and maintenance of footpaths rests with the
 relevant Road Authority. This may include Councils for local roads and Transport for NSW for
 state roads.
- The NSW Government has introduced the NSW Movement & Place Program which included a Movement & Place Framework.
- The NSW Government Movement & Place Program and its application are coordinated as a cross-government approach.
- This Framework considers the entire street environment roads, footpaths, kerb-space etc and the places that are connected to these.

The Program includes governance, guidelines, policies and tools for use by practitioners involved in the planning, design, delivery, and operation of our transport networks and the areas around them. This includes both public and private sector decision-makers, planners, engineers, urban designers, and project managers. The framework is managed across government through the Movement & Place Implementation Board and is updated as required based on end-user feedback.

- This NSW Movement and Place Program seeks to provide a common structure for place-based transport and city and town planning across NSW, and to support built environment practitioners by explaining how to apply this approach.
- The design, planning, and management of roads and streets needs to consider potential impacts on the amenity of adjacent places public spaces and land uses.
- Movement and Place distinguishes between movement supporting place (such as public transport connecting places), and movement that is best separated from places (such as longdistance travel).
- By considering the whole street, including footpaths, from property line to property line, and the interfaces with land use, Movement and Place takes into account the needs of all users, including people walking and cycling, making deliveries, and using public transport, as well as the broader community, people spending time in places, going to school, shopping, dining, exercising, or waiting for a bus.

NSW Public Spaces Legacy Program and active transport projects

103. Of the \$250 million in funding announced as part of the NSW Public Spaces Legacy Program in August 2020, what is the total amount of funding allocated to councils that pertains to new cycling or pedestrian infrastructure?

Answer:

I am advised no funding has been allocated as an assessment of councils' project nominations is underway.

104. What specific guidelines or conditions were put in place to encourage applicants to construct new infrastructure for people who ride or walk?

Answer:

I am advised the Guidelines for the Public Space Legacy Program specifically promote projects that are focused on improvements to cycling and walking infrastructure. Specifically:

- 'The program will support the design and delivery of trails and strategic open space linkages'
- 'Councils are encouraged to put forward projects that (...) enable increased community access to public and open space'; and
- Public Spaces Legacy Program information sheet (February 2021) that was issued to all Program
 eligible Councils, clearly articulates the objectives of the Program and how councils could achieve
 the objectives. It is noted that 'Projects can achieve [the Program's] objectives by either creating
 new high-quality public and open spaces through land acquisition or unlocking underutilised land,
 connecting the network through new or improved trails and linkages or significantly enhancing
 the quality of existing public and open spaces'.

Opera House to Parramatta Walk

105. How will the \$500,000 allocated in the 2020-2021 State Budget for the Opera House to Parramatta Pathway be spent?

Answer:

I am advised Transport for NSW is investigating options.

106. As of 9 March 2021, how much of the above funding has been expended?

Answer:

Refer to answer provided in Question 105.

- 107. As of 9 March 2021, what work has the Department of Planning, Industry and Environment conducted to investigate:
 - (a) A foreshore loop in the Blackwattle and Rozelle Bay and repairing and reopening the Glebe Island Bridge to become a key walking and cycling link to Sydney CBD?
 - (b) A 10km foreshore loop around Canada Bay?
 - (c) A new Connecting Canada Bay to the Homebush Bay Circuit?
 - (d) Identifying missing links along the foreshore between Parramatta and Sydney?

Answer:

I am advised the Bays West Place Strategy was released for public comment on 22 March 2021 which identifies a 'world class harbour foreshore walk'. This is separate to the 'Opera House to Parramatta Pathway' initiative.

The Canada Bay loop is a matter for Canada Bay Council.

Principal Bike Network (PBN)

108. What engagement has the Department of Planning, Industry and Environment had with planning for the Principal Bike Network (PBN)?

Answer:

I am advised the Department of Planning, Industry and Environment was engaged on the development of the business case for the Principal Bike Network (PBN). This included discussion on the cycling program, potential funding opportunities, network and costings.

109. Has Transport for NSW formally sought advice or feedback from the Department of Planning, Industry and Environment on plans for the PBN?

Refer to answer provided in Question 108.

110. What advice has the Department of Planning, Industry and Environment provided to Transport for NSW on plans for the PBN?

Answer:

Refer to answer provided in Question 108.

111. What is the total amount of funding spent in 2019-2020 by the Department of Planning, Industry and Environment on projects associated with the PBN?

Answer:

I am advised the Department of Planning, Industry and Environment provided \$11.73 million funding to Transport for NSW in 19/20. This funding was provided for planning and design of two arterial roads which are associated with the PBN. These projects are:

- Richmond Road Stage 3 Upgrade \$6.43 million released in 19/20
- Elizabeth Drive Upgrade \$5.3 million released in 19/20.
- 112. What were the projects and what was the amount spent on each project?

Answer:

Refer to answer provided in Question 111.

113. What is the total amount of funding allocated to the Department of Planning, Industry and Environment for projects associated with the PBN in 2020-2021?

Answer:

I am advised the Department of Planning, Industry and Environment has not allocated any funding to projects associated with the PBN in 2020-21.

114. What are the projects to be funded and what is the amount to be spent on each project?

Answer:

Refer to answer provided in Question 113.

Streets as Shared Spaces

115. What was the total number of applications for the Streets as Shared Spaces grant program?

Answer:

I am advised there were 146 applications.

116. What was the total amount of funding requested for the Streets as Shared Spaces grant program?

I am advised the Streets as Shared Spaces grant program budget is \$15m.

117. How much of the total funding in the Streets as Shared Spaces grant program has been expended as of 9 March 2021?

Answer:

I am advised \$10.2m has been expended as of 9 March 2021. The entire program budget is forecast to be spent in the current financial year.

- 118. Have all the successful projects in Category 1 of the Streets as Shared Spaces grant program been completed?
 - (a) If not, which projects have not yet been completed?

Answer:

I am advised that 22 out of 24 projects have been completed.

- (a) Two projects are yet to be completed including:
 - (1) 'George Street temporary road closure' project from the City of Sydney, and
 - (2) 'Reclaim Hunter Lane' project from Hornsby Shire Council (This project is scheduled to be activated 1 April 2021).
- 119. Have all the successful projects in Category 2 of the Streets as Shared Spaces grant program been completed?
 - (a) If not, which projects have not yet been completed?

Answer:

I am advised No Category 2 projects have been completed to date. Category 2 projects are 12 month projects with completions due from October 2021 onwards.

120. Will the grant program be replicated given the ongoing impacts of COVID-19 on communities?

Answer:

I am advised the Streets as Shared Spaces program is a one-off grant funding program for local councils to test and pilot new and innovative ideas for streets as safe, shared public spaces. The intent of this program was to test and build the case for more permanent changes.

121. How is the success of the Streets as Shared Spaced grant program being evaluated?

Answer:

I am advised the Streets as Shared Spaces projects are evaluated against core success indicators. These are measurable outcomes that correlate with one or more of the program objectives.

Walking Space Guide

122. What initiatives has the Department of Planning, Industry and Environment introduced in 2020-2021 to increase the awareness and utilisation of the Walking Space Guide?

Answer:

I am advised that while the Guide was developed by Transport for NSW, the Department of Planning, Industry and Environment has been working to embed the Guide's principles into multiple policy initiatives.

123. What is the total amount of funding spent in the 2019-2020 financial year on developing, publishing, operating, monitoring or evaluating the Walking Space Guide?

Answer:

I am advised the Guide was developed and funded by Transport for NSW.

124. What is the total amount of funding allocated in the 2020-2021 State Budget on developing, publishing, operating, monitoring or evaluating the Walking Space Guide?

Answer:

Refer to answer provided in Question 123.

125. How is the Department of Planning, Industry and Environment measuring the uptake of the Walking Space assessment tool?

Answer:

Refer to answer provided in Question 123.

Greater Parramatta Olympic Peninsula Place-based Infrastructure Compact

126. The Greater Parramatta Olympic Peninsula Place-based Infrastructure Compact (GPOP Compact) pact was drafted in November 2019. On 23 December 2020, Government released a Response to the Recommendations Report. When will the GPOP Compact be finalised?

Answer:

I am advised the GPOP Place Infrastructure Compact was finalised by the Greater Sydney Commission by making a number of recommendations to Government. The Government has now considered and publicly released its response to these recommendations and will now prepare a GPOP Strategic Plan to embed the recommendations of the GPOP Place Infrastructure Compact into the planning system.

- 127. The Response to the Recommendations Report regarding the Greater Parramatta Olympic Peninsula Place-based Infrastructure Compact, published on 23 December 2020, indicates that Member for Parramatta had a 'Concern around the costs and method used for the PIC, particularly for the Camellia-Rosehill precinct', did the Minister have concerns regarding the costs and methods used?
 - (a) If so:
 - i. Why did the Draft GPOP Compact to proceed to publication?
 - ii. Did the Minister or any member of the Department refute or raise concerns with the costs and methods used?
 - iii. Were any concerns regarding the costs and methods used recording prior to, or after publication?

The Greater Sydney Commission is an independent planning authority. It released its draft Place Infrastructure Compact following consultation, noting two options in relation to Camellia Town Centre. Questions on the process of the preparation of the draft Place Infrastructure Compact and its impetus are best put to the Greater Sydney Commission.

- (b) If not,
 - i. Does the Minister reject the Member for Parramatta's 'Concern[s] around the costs and method used for the PIC, particularly for the Camellia-Rosehill precinct'?
 - ii. If the Minister does not doubt in the costing methodology, why has Camellia-Rosehill been carved out as a separate place based strategies?
 - iii. Does the Minister have faith in Dr Sarah Hill who has a PhD in the Economics of City Planning?

Answer:

I am advised the GPOP Compact methodology highlighted the significant issues that need to be resolved to enable the Camellia-Rosehill precinct to transition to either higher order urban services, or a mixed use precinct. In this respect, the GSC identified two potential options for the Government to consider in Camellia in its recommendations. The Response to the GSC recommendations identified that a Place Strategy be prepared for the whole Camellia-Rosehill precinct commencing in 2021, drawing on the significant body of work that has already been undertaken to identify the economic and environmental opportunities of the precinct.

Camellia Prison

- 128. In December 2020, the *Sydney Morning Herald* reported that Government was planning a 1,000 inmate prison at Camellia. Is the Department of Planning aware of a planned prison in Camellia?
 - (a) If so,
 - i. How advanced is the planning?
 - ii. Has government assessed the remediation costs at a residential level, rather than the lower industrial or commercial remediation standard?
 - iii. Has government consulted with landowners that are seeking to plan a town centre at Camellia?

iv. Has government consulted with the Parramatta City Council or any other council on this matter?

Answer:

I am advised no application has been lodged in relation to a new prison site at Camellia and the Department of Planning, Industry and Environment has not carried out any consultation or assessment in relation to this matter.

129. Is seeking to 'socialise' land at Camellia, to avoid private developers and historic polluters from fitting the cost of remediation?

Answer:

I am advised the Department of Planning, Industry and Environment is not considering an outcome where the Government pays for the cost of remediation on privately owned land. The cost of remediating land is the landowner's responsibility.

Contamination

130. The September 2015, the NSW Department of Planning and Environment commissioned the Camellia Precinct Contamination Remediation Study through Golder Associates Pty Ltd, is this study still being used to inform planning considerations and land acquisitions?

Answer:

I am advised the report, along with a suite of other previous studies on a range of matters, is being considered in the preparation of a place-based strategy for the Camellia precinct. Where a study is out of date, or more contemporary information exists, the draft Place Strategy process will ensure there is an update.

131. Can you confirm that the taxpayer will not be required to fit the bill for remediation on future acquisitions by DPIE?

Answer:

I am advised that the Department of Planning, Industry and Environment has not been asked to acquire land in Camellia.

132. Has government since implemented any procedures that would stop a repeat of the acquisition of 6 Grand Avenue by Transport for NSW, which has left the NSW taxpayer liable for remediation?

Answer:

Refer to answer provided in Question 131.

133. Has the Minister been briefed on any other case where the NSW government has assumed the remediation liability for any other projects?

Answer:

No.

134. What is the financial liability for contaminated land in your portfolio?

Answer:

I am advised as at June 2019, for the Planning Ministerial Corporation, overall estimated financial liability due to legacy contamination within the Corporation's portfolio is \$40,367,400.

North Wilton - Landcom Acquisition

- 135. The Sydney Morning Herald published an article in March 2021 titled: 'Landcom pays \$100m more than seller's evaluation for site near Sydney'. The contracts were exchanged on 16 June 2020 and that the Board of Landcom and the Governments Executive Review Committee jointly approved the transaction. Did you sponsor the submission to the Expenditure Review Committee?
 - (a) When did the Minister become aware that the property was valued at only \$155 million in 2019?
 - (b) When did the Minister become aware that there was no probity plan or probity report accompanying the sale, is this considered normal practice?

Answer:

I did not sponsor the submission to ERC, and am advised Landcom has complied with its internal integrity framework and all policies which guide the probity requirements for such matters.

North Wilton Supporting Infrastructure

136. With regards to the \$950 million in infrastructure committed to supporting North Wilton, what is the logic behind committing close to a billion in infrastructure funding on land that government did not own intended to buy?

Answer:

I am advised the \$950 million investment is required to progress the North Wilton development and fund the delivery of infrastructure to support the development of the wider Wilton Priority Growth Area.

It will be used to provide infrastructure and services including open spaces, parks, community facilities, roads, footpaths, stormwater drainage and to carry out subdivision work.

This funding is a regular part of the major development process and comprises Local Infrastructure Contributions, Special Infrastructure Contributions, and an existing Voluntary Planning agreement with the Minister for Planning for the site. This approach ensures infrastructure and services are in place as the community requires it and, in many circumstances, in advance of major population growth.

137. Did the DPIE model the increased value of the land as a result of the \$950 million infrastructure commitment?

Answer:

- 138. What is the timeframe to implement the \$950 million in infrastructure funding?
 - (a) How much of the \$950 million is road related?

140. Did Mr Brogden make a written or verbal declaration to the Minister regarding his friendship with Mr Brennan?

Answer:

I am advised Mr Brogden has complied with the requirements specified by the Board of Landcom. in relation to this matter.

ePlanning Portal

141. What is the Estimated Total Cost of the ePlanning Portal?

Answer:

I am advised Stage 4 of the Program will spend \$53,228,921 until 30 June 2023.

142. How much money has been incurred to date on the ePlanning Portal?

Answer:

I am advised over the eight financial years from 2013-2014 to 2019-2020 the program cost \$78,767,920.

143. What is the completion date for each stage of the ePlanning Portal?

Answer:

I am advised stages 1, 2 and 3 were assured as completed in December 2020. Stage 4 of the program will finish on 30 June 2023 as per the current business case.

144. How many stages are involved in the ePlanning Portal?

Answer:

I am advised 4.

145. Who developed the Planning Portal, was it developed by department officials or external consultants?

Answer:

I am advised the Department of Planning, Industry and Environment developed the NSW Planning Portal, using a combination of Department officials and external consultants.

- 146. Which company or companies developed the ePlanning Portal?
 - (a) If it was developed externally, was it open to an open tender process?

Answer:

I am advised ePlanning engaged Coforge Australia (Formerly Incessant Technologies), Infosys Australia, ADAPS BTRANSE Pty, XVT, E&Y, Pure Security, Cappemini Australia and Deloitte Australia for specific pieces of work. These engagements were done between January 2015 to December 2020 and complied with the NSW Government procurement rules.

147. How many complaints has the government received about the operation of the Portal?

Answer:

I am advised there are multiple channels for customer feedback:

- 1. The ePlanning Digital Services on the Portal each include a thumbs-up/thumbs-down widget on every screen.
- 2. ServiceNSW hotline, which receives calls from applicants
- 3. The ePlanning Support Team (phone calls and emails),
- 4. Correspondence via the Minister's Office.

The Digital Transformation Office (DTO) collects data on all feedback through multiple channels.

As example, for the week of 15-21 March 2021, the ePlanning Support inboxes received 452 emails. Of these, 412 were enquiries, 27 (6%) were complaints about the operation of the Portal, while the remaining 13 were absent other issues such as the requirement to use the portal for applications.

Since December 2018, the Portal has received in excess of 55,000 development applications. There have been more than 19,000 responses received from the thumbs-up/thumbs-down widget, with the current customer satisfaction thumbs-up score being 87.4%. This is the highest satisfaction score for any NSW Government digital service.

148. How are those complaints being addressed?

Answer:

I am advised the ePlanning Program considers all the feedback it receives in developing ongoing enhancements and improvements to the operation of the NSW Planning Portal.

149. What is the government doing to address the issues raised?

Answer:

I am advised the ePlanning Program logs issues raised by complainants and other users. It uses this information to inform improvements to the operation of the NSW Planning Portal. The ePlanning Program usually releases monthly system updates.

- 150. Has the government considered suspending the operation of the Portal until all these matters are addressed?
 - (a) If not, why not?

I am advised no.

151. When is the project expected to be complete?

Answer:

I am advised the program is operational and will continue to deliver services to users.

- 152. Page 4-8 of the current budget papers indicates "This measure will support the rollout of Stage 4 of ePlanning, which will increase revenue from the sale of goods and services by \$44.0 million over the four years to 2023-24." In the mid-year budget that figure changed to \$92 million over four years, what prompted the change?
 - (a) Is the project to streamline the planning process or to derive revenue?
 - (b) Who is the revenue coming from, is it council or applicants?
 - (c) How much revenue is being generated?
 - (d) Is the revenue entirely captured by the NSW Government or is the private sector developer also generating revenue from each transaction?

Answer:

I am advised:

- a. The NSW Budget 2020-21 Half-Yearly Review does not project \$92 million in revenue for the ePlanning Program. The estimated revenue over the four years to 2023-24 remains at \$44 million.
- b. Applicants.
- c. No revenue has yet been generated.
- d. The revenue will be paid entirely to the NSW Government. The revenue is to fund the operating expenses of the system and depreciation of the asset, so that the revenue will match the expenses of operating the NSW Planning Portal.

I am advised for the same reason as explained in Question 157, it is impossible to quantify the number of native forestry workers affected by the Koala SEPP 2021. At this stage, consent requirements for private native forestry remain current in local environmental plans.

Answer:

I am advised the Koala SEPP 2021 does not restrict or prohibit any type of activity. The SEPP ensures that Koala habitat is properly considered by activities which require development consent from councils. Most day-to-day activities carried out by rural and regional landholders do not require development consent and do not need to consider the SEPP.

November 2020 ICAC report into water management

168. Recommendation 3 of the Independent Commission Against Crime November 2020 'Investigation into complaints of corruption in the management of water in New South Wales and systemic non-compliance with the Water Management Act 2000' refers to the adoption of changes the DPIE has proposed to the Barwon-Darling Water Sharing Plan (BDWSP). These changes were largely proposed as a result of the NRC's review into the BDWSP.
