## Engadine High School - expansion of hall facilities

A Company of the Comp

- Engadine High School currently has a hall/gymnasium in building G which is approx. 790m2. This is above the department's Educational Facilities Standards & Guidelines.
- There are currently no plans to upgrade the hall facilities at Engadine High School.

## Cook School

- demand for places at the school has increased demountable issue standard for future classrooms should be Modular Design Range
- The Cook School is an SSP with 37 enrolments.
- There are seven classrooms in total, comprising three permanent classrooms and four demountable classrooms.
- Current projected enrolments are not increasing and there are currently no planned projects to upgrade the permanent facilities at the school.
- Accommodation needs at SSPs differ from mainstream schools and the school may require additional demountable facilities to meet the needs of its students.
- Modular Design Range classrooms (MDRs) are a form of accommodation used across many schools in NSW. These modular facilities are often preferred because they are seen by schools as more permanent than demountable accommodation.
