3. What purpose do you see for your role as Minister for Regional Youth, given the only Legislative oversight in the portfolio is joint administration of the Advocate for Children and Young People Act 2014 with the Minister for Families, Communities and Disability Services?

The NSW Government has made significant investment in the regions, and critical to realising the ambitions for regional NSW is a skilled, healthy, connected and empowered regional youth. The Office for Regional Youth provides a coordinated and strategic approach to supporting regional youth. The Office for Regional Youth advocates, supports, develops and funds programs that improve the outcomes of regional young people across NSW, focussed on the four pillars of the Regional Youth Framework:

- Work Ready,
- Wellbeing,
- Connectivity, and
- Community.
- 4. What concrete achievements have you made in the role?

All election commitments made in relation to this portfolio have been met. The NSW Government has also delivered support and assistance to regional youth including through the following investments and programs:

- \$61 million for youth projects through the Bushfire Local Economic Recovery package.
- \$54.4 million for youth projects through the Stronger Country Community Fund Round 3.
- \$20.3 million for the Regional Youth Community Coordinators and the Children and Young People Wellbeing Program.
- \$10m of Holiday Break funding through the NSW Economic Recovery Program.

In addition to these achievements, the NSW Government has supported projects, pilots and grants directly aligned to the Regional Youth Framework Pillars, including:

- Regional Gap Year Campaign responding to the impacts of COVID-19 on travel, worker shortages across regional NSW and youth unemployment.
- Maayuma-Li Gem at Lightning Ridge with PCYC, Mining Exploration & Geoscience and Aboriginal Housing Office.
- Birrany and Malungan Program at Dubbo Zoo.
- Physical Activity Program with the Office of Sport in Eurobodalla, Kempsey, and Bathurst.
- Independent Youth Action Meetings (YAMs) facilitator in Coffs Harbour.

Next Women's Strategy

- 65. Consultation processes will be undertaken with the interdepartmental committee and external stakeholders ahead of the development of the Women's Strategy to take effect after 2022.
 - (a) Noting that internal work has commenced on the consultation process, which external stakeholders will be consulted?
 - (b) What form will this consultation take?
 - (c) Noting the intention to invite community feedback on the next Women's Strategy through a "Have your say" public consultation process:
 - i. What form will these consultations take?
 - ii. Will the Government publish any written submissions collected during this consultation process?
 - iii. Will the Government publish quantitative data collected during this consultation process?

ANSWER

- 65. I am advised:
 - (a) In the development of next NSW Women's Strategy, extensive consultation will occur across government with relevant portfolio agencies, including members of the NSW Women's Strategy Interdepartmental Committee (IDC), and non-government stakeholders, in 2022.
 - (d) Consultation will be conducted through workshops with key stakeholders and public consultation via the NSW Government's Have Your Say website. Written submissions will be collected during the consultation process.
 - (e) i. As above and https://www.nsw.gov.au/have-your-say.

(f) ii. & iii. Yes, the data collected through the consultations will be published in a key findings report, which will inform development of the strategy.

Return to Work Program

- 66. The Return to Work Program was announced in the 2020-21 NSW Budget, offering grants of up to \$5000 to assist women in returning to the workplace.
 - (a) Has a review of the effectiveness of this program been undertaken?
 - i. Against what criteria is the effectiveness of the program been measured?
 - ii. How many women have successfully secured employment as a result of this program?
 - (b) How many applications for this program have been made since its commencement?
 - i. How many grants have been delivered to successful applicants?
 - (c) As at 6 April 2021, \$1.8 million in grants had been paid to successful applicants, with an average of \$4,979 approved per successful applicant.
 - i. As of 10 November 2021, how much has been paid out to successful applicants?
 - ii. What is the average dollar amount supplied to successful applicants?
- 67. Noting the further impact of COVID-19 on NSW over second half of 2021 will the Return to Work program be extended?
 - (a) Will the Return to Work program be expanded in terms of funding?

ANSWER

66. I am advised:

- (a) Return to Work Coordinators conducted reviews three and six months after recipients received a Return to Work Grant. The timely approval and payment of grants is also monitored and reviewed regularly.
 - (i) The effectiveness of the Return to Work Program for recipients is being measured against the following criteria:
 - recipients' confidence to gain and maintain employment;
 - recipients' satisfaction regarding the Return to Work Program.
 - (ii) Information on employment outcomes will be collected through the six month survey of Return to Work Grant recipients. Of 830 recipients who completed a

- three months survey: 618 (75%) stated that they are confident they will gain employment; and 812 (98%) found the Return to Work Coordinator process useful.
- (b) As at 15 November 2021, 2,227 women booked appointments with Return to Work Coordinators. 1,588 applications have been received. 1,417 grants have been paid.
 - (i) As at 10 November 2021, \$6.19 million in grants have been paid to 1,417 women.
 - (ii) The average dollar amount paid to successful applicants in \$4,3969.
- 67. I am advised:
 - (a) The NSW Government provided \$10 million as part of the 2020-21 NSW Budget for the Return to Work Program and continues to rollout grants in 2021-22.

Trade Skills Pathways Centre

- 68. The Trades Skills Pathways Centre was funded in order to address trades shortages in NSW in part by encouraging and supporting women to pursue careers in the trades.
 - (a) Has a review of the effectiveness of this program been undertaken?
 - i. Against what criteria is the effectiveness of the program been measured?
 - (b) How many women have been assisted through this program?
 - (c) Does the Government keep track of future career development and experience?
 - i. If so, what information collected?
 - ii. How is this information collected?

ANSWER

68. This is a matter for the Minister for Skills and Tertiary Education.

Reproductive health care

- 69. Reproductive health is considered essential to the empowerment of women by international authorities. The World Health Organisation states that reproductive health includes ensuring that individuals "have the capability to reproduce and the freedom to decide if, when and how often to do so."
 - (a) Noting the closure of clinics providing reproductive health services in Regional NSW, such as the Marie Stopes Clinic in Broadmeadow, what steps is the Minister taking to ensure that all women in NSW have access to adequate reproductive health care?

i. Noting public statements from Marie Stopes that the closure of the clinic was related in part to the regulatory environment in NSW, what steps has the Minister taken to address these concerns?

ANSWER

69. NSW Health does not regulate private abortion clinics in NSW. Affordable and timely access to abortion is a whole of sector response shared by the public health system, private providers, primary care and accredited non-government organisations.

Marie Stopes Australia is a non-profit organisation that provides family planning services throughout Australia. Alternative reproductive services remain available in the Newcastle area after the closure of the Newcastle Marie Stopes clinic in July 2021.

NSW Health has introduced initiatives to improve equitable access to information and services for abortion and contraception. In early 2021, Family Planning NSW was the successful tenderer to trial a new service model to support the delivery of community-based abortion services (medical and surgical) and long acting reversible contraception for marginalised women in regional NSW. This trial commenced in mid-2021 with the first pilot site located in Newcastle.

NSW Health also provides a statewide Helpline to assist women to access services. The NSW Health funded NSW Pregnancy Choices Helpline 1800 008 463 and website provides support with free and confidential information on pregnancy choices in NSW, including details about accessing abortion information, support and services.

Investing in Women Funding Program

- 70. The 2021 Investing in Women Funding Program offered grants between \$5000 and \$100,000 aimed at "innovative programs that support the economic opportunity, advancement and participation of women and girls in NSW". Applications closed on 30 April 2021. Successful applicants are not advertised on the website.
 - (a) What is the status of the grants program?
 - (b) How many applications were received?
 - (c) How many grants were successful?
 - i. Who were the successful recipients?
 - ii. What were the successful projects?
 - iii. How much funding was awarded to each successful applicant?

ANSWER

70. I am advised:

The 2021 Investing in Women Grant Program will be finalised shortly. 177 applications were received.

Broderick review

- 71. The ongoing Broderick review is investigating the culture at Parliament and its management of unacceptable behaviour.
 - (a) How involved has the minister been in ensuring the work of the review can proceed smoothly?
 - i. How and to what extent has the minister been supportive of women employed at Parliament in engaging with the review?
 - (b) What role is the minister intending to take to ensure the review is appropriately considered and its recommendations implemented?

ANSWER

71. This is a matter for the Department of Parliamentary Services.

Women in the NSW public service

- 72. In the 2020 State of the NSW Public Sector Report, 66.4% of government employees were women, with just 41.1% of women in a senior leadership position.
 - (a) What is the progress on the government's goal of reaching 50% female representation in leadership positions in the NSW public service?
 - i. How many of these women have been employed in ongoing or full-time positions?
 - ii. What is the average salary for women in this cohort?
 - iii. Is this salary at parity with their male counterparts?

ANSWER

72. This is a matter for Special Minister of State, Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts.

Community Mental Health support and services

- 73. How much does each LHD spend on community mental health services?
- 74. What planning work have each of the LHD's done to identify additional support models that they need for their local communities?

ANSWER

- 73. In 2021-22, local health districts and specialty health networks have been allocated \$596 million for non-admitted mental health.
- 74. Under the auspices of the Fifth National Mental Health Plan, local health districts and primary health networks have developed joint Regional Mental Health and Suicide Prevention Plans. The plans were developed in partnership with local communities and stakeholders, including health care service providers, sector peak bodies, people with lived experience, carers and family members. Copies of the regional plans are available on the website of each primary health network.

Counselling appointments held via Telehealth

- 75. In relation to online or telehealth services for appointments related to mental health can you please advise how many of these were held in 2020?
- 76. For each of the LHD's, how many online or telehealth appointments for mental health were held in 2020 and to 1 November 2021?
- 77. In rural hospitals' Emergency Departments where they rely on mental health services to be conducted via Telehealth, what is the average wait time for someone presenting suicidal to be connected with a specialised trained health worker?

ANSWER

- 75. In 2020, NSW specialist community mental health services delivered 658,341 community contacts by telephone or videoconference.
- 76. The table below shows the number of community contacts delivered by telephone or videoconference for local health districts and speciality health networks in NSW, excluding Justice Health and Forensic Mental Health Network. Data for 2021 is from 1 January to 31 October 2021 as extracted in mid-November 2021, and will change with future data updates.

Men's Mental Health

- 78. How many people have been supported in the HealthWISE suicide prevention initiative in the Hunter New England Local Health District?
- 79. How many people have been supported in the Next Steps suicide attempt response team in the Illawarra Shoalhaven Local Health District?
- 80. How many people have been supported in the Kumpa Kiira Suicide Prevention Project in the far south-west NSW?

ANSWER

- 78. The HealthWISE Suicide Prevention initiative has supported over 238 people, male and female, who have attempted or are bereaved by suicide in the New England North West region since 2017. The initiative is funded to 2023-24.
- 79. The Next Steps Aftercare program has supported over 537 people, both male and female, in the Illawarra Shoalhaven since 2017. The initiative is funded to 2023-24.
 - The Next Steps Aftercare program is also funded in Southern NSW to 2023-24 and has supported over 52 people, both male and female, since July 2021.
- 80. The Coomealla Health Aboriginal Corporation (Kumpa Kiira) was funded under the Suicide Prevention Fund 2016-20, during which time it supported approximately 300 people per annum, across various events and programs.
