Communication with multicultural communities

Transcript page 3 – 4

The Hon. SHAOQUETT MOSELMANE: Can I just ask the question: What did Multicultural NSW do in communicating with multicultural communities during those three months prior to the lockdown? There was no advertising of public health information for three months. So there was no communication with the multicultural communities from Multicultural NSW for those three months.

The Hon. NATALIE WARD: Mr Moselmane, there a couple of things I would like to clarify so I can help as far as possible. We might have to take on notice the specifics of what you are asking about. I had the privilege of becoming Minister for this portfolio on 27 May this year and shortly thereafter we had the Delta strain of COVID arrive. Mr La Posta and I worked very closely together since that time and one of our first priorities was engagement. We recognised early on the critical role of multicultural media; in fact, we put out very quickly support to multicultural media. **The Hon. SHAOQUETT MOSELMANE**: You recognised later on the critical role of multicultural media.

The Hon. NATALIE WARD: Yes, so much so that—

The Hon. SHAOQUETT MOSELMANE: —but three months before that there was no recognition of the critical role of multicultural media in the middle of a pandemic. I mean, the pandemic did not hit yesterday.

The Hon. NATALIE WARD: No, quite right.

The Hon. SHAOQUETT MOSELMANE: It is now almost two years. So you would have thought that Multicultural NSW would be communicating with multicultural— **The Hon. NATALIE WARD**: I think we are in agreement; the role of multicultural media is critically important and from the time that I started in this role Mr La Posta and I spoke, I think, almost every day.

The Hon. SHAOQUETT MOSELMANE: There was a real failure—

The Hon. NATALIE WARD: Sorry, if you do not mind if I could just finish; it is an important point. When I did start we immediately ensured that we had a series of engagements with the multicultural community through community and religious leaders, non-government organisations and forums, but also specifically with media because we knew we had to get information out in language. If you are talking about prior to that time and the three months prior—

The Hon. SHAOQUETT MOSELMANE: Minister, I hear you and I agree with you, that is the point. I am asking why Multicultural NSW prior to you coming in, Minister, did not communicate with the multicultural community?

The Hon. NATALIE WARD: As I was just saying—

The Hon. SHAOQUETT MOSELMANE: But let me move on. Clearly I am not going to get an answer on that one.

The Hon. NATALIE WARD: No, that is not true, and it is very important I answer that, if I may.

The Hon. SHAOQUETT MOSELMANE: No, I want to move on. I would like to move on.

The Hon. NATALIE WARD: It is very important that I answer that, Mr Moselmane, because I was not the Minister prior to that time, so it is very important that we are clear about my evidence to this Committee. I was not the Minister during the time so I am able to answer what I am responsible for. But I would say that any advertising during that prior time is clearly within the remit of Minister Dominello and Customer Service and I am happy to take that to him.

The Hon. SHAOQUETT MOSELMANE: So Multicultural NSW has nothing to do with it.

The Hon. NATALIE WARD: I am happy to take that to him in relation to what was done prior to my time.

Answer:

I am advised Multicultural NSW has led an intensive multicultural communications and community engagement schedule throughout the COVID-19 pandemic to identify the impacts of COVID-19 on communities and to provide community leaders with the most up-to-date public health advice and messages to communicate to their communities. This work continued through April to June 2021.

During this three-month period, Multicultural NSW convened online community forums alongside senior NSW Health officials to empower community leaders with the latest public health information. Topics covered at these forums included the COVID 19 vaccination roll-out, public health restrictions on places of worship, updates on the Public Health Orders, and the impact of COVID on NSW communities with relatives overseas. Over 400 community and religious leaders participated in these forums during this period.

In this same period, I am advised the Department of Customer Service continued to invest in advertising COVID safe measures through the multicultural media, with \$180,000 spent on multicultural advertising on COVID safety over this time.

In this three-month period, Multicultural NSW continued to promote public health measures across its digital and social media channels, including through the Multicultural NSW EmailLink service.

Communication with multicultural communities

Transcript page 5 – 6

The Hon. SHAOQUETT MOSELMANE: I am interested in those three months. There was a three-month gap of no communication whatsoever with multicultural communities.

The Hon. NATALIE WARD: That is not correct.

The Hon. SHAOQUETT MOSELMANE: It is correct.

The Hon. NATALIE WARD: It is not correct, Mr Moselmane, with respect. **The Hon. TREVOR KHAN**: Point of order: The member is arguing with the Minister as opposed to allowing her to answer. I ask that the member show at least a modicum of courtesy and allow the Minister to complete her answer before asking the next question.

The CHAIR: I uphold the point of order.

The Hon. NATALIE WARD: Mr Moselmane, I might hand to Mr La Posta to give some specifics on the engagement and the advertising because it is important that we should provide that clarity to the Committee.

Mr LA POSTA: Mr Moselmane, I think the first point is our multicultural communities have been extraordinary in terms of how they have tackled COVID since January and February. We had this conversation last year as we watched it spread across through Iran and Italy and then ultimately to Australia in March. We had interpreters at the airport. You know how strong our multicultural communities have been and you know how effective they were, particularly community and religious leaders. In March of this year there was still advertising, and I can give you the specifics on that and take it on notice, but to say that this agency did not engage with multicultural communities between March and June is factually incorrect and I am happy to give you the specifics in terms of any forums that we had because I know personally how invested I was in supporting our sub-continent and South Asian communities as the Delta wave ripped through India. So, to be honest, I do not think it is fair to say that this agency and this Government did not communicate with multicultural communities between March and June.

The Hon. SHAOQUETT MOSELMANE: Thank you.

Mr LA POSTA: And I am happy to give you the specifics of that on notice.

Answer:

Please refer to my answer for transcript pages 3 – 4 above.

Active Kids

Transcript Page 11

Ms ABIGAIL BOYD: Thank you. Are you able to tell me whether the data relating to children who are the subject of these Active Kids vouchers is available within Service NSW for any Service NSW employee to access or are there privacy restrictions in place?

The Hon. NATALIE WARD: Ms Jones might like to speak to that.

Ms JONES: Thank you, Minister. Yes, absolutely there are strict privacy rules around the data that is retained for Active Kids. If you want specifics on that I am happy to take that on notice around what the rules are around access to the data from a privacy perspective.

Ms ABIGAIL BOYD: That would be very useful. If you could let me know approximately how many employees or what class of employees would have access to that data.

The Hon. NATALIE WARD: Can I just add to that, sorry, Ms Boyd, these questions are properly directed to Minister Dominello and Service NSW. We are very happy to facilitate getting the questions to him, but I just point out that he runs Service NSW and his agency is responsible for the conduct of the Service NSW app and the information contained on it. But we would be happy to take those questions to him. Ms ABIGAIL BOYD: Thank you, that would be very useful—in addition to how many employees and what their position description is, or whatever, that gives them access to that data.

Ms JONES: Sure.

The Hon. NATALIE WARD: Sure.

Ms ABIGAIL BOYD: Also whether they have had Working With Children checks, that would be very useful.

The Hon. NATALIE WARD: Sure.

Answer:

This is a matter for the portfolio of the Minister for Customer Service.

National Accreditation Scheme

Transcript Page 12

The CHAIR: Mr D'Adam: Minister, I want to ask you about the status of the national accreditation scheme for sport scientists and strength and conditioning coaches. What is the status of the implementation of that scheme in New South Wales?

Answer:

I am advised the NSW Institute of Sport (NSWIS) is not responsible for the

implementation of the national accreditation scheme for sport scientists and strength

conditioning coached in New South Wales.

Exercise and Sport Science Australia (ESSA) is a peak professional organisation that

establishes accreditation for exercise and sports science practitioners.

The Australian Strength and Conditioning Associations (ASCA) provides strength and

conditioning (S&C) coach accreditation programs for all levels. These programs are

registered with the National Coaching Accreditation Scheme, administered by Sport

Australia.

It is important to note that strength and conditioning coaches are not sports scientists

and best practice accreditation requirements differ.

The Hon. NATALIE WARD: Thank you. That is something I may have to take on notice. I am a big fan of strength and conditioning and do not do enough of it, but I must say that I do not know the current status of that, so I will take that on notice. The Hon. ANTHONY D'ADAM: Ms Jones, are you able to throw some light on that? **Ms JONES:** Yes. I support the Minister's stance in that we would take that on notice. That question, I am more than happy to coordinate a response from our NSW Institute of Sport for you.

The Hon. ANTHONY D'ADAM: Are you able to tell me whether the accreditation scheme applies to the NSW Institute of Sport?

Answer:

I am advised NSW Institute of Sport (NSWIS) strength & conditioning essential

accreditation requirements are aligned with the Australian Institute of Sport minimum

standards as far as degree and Australian Strength and Conditioning Association

(ASCA) Professional Coach Accreditation Scheme Pro requirements. NSWIS further

require ASCA Level 2 Accreditation or international equivalent.

NSWIS sport science essential requirements are aligned with AIS minimum standards

as far as relevant degree and ESSA level 1. NSWIS further require a degree with honors.

It is important to note that strength and conditioning coaches are not sports scientists and best practice accreditation requirements differ.

Ms JONES: That is something I will also take on notice and get an answer to you. **The Hon. ANTHONY D'ADAM:** Are you able to tell me then on notice how many of the sport scientists employed at the NSW Institute of Sport meet the accreditation requirements of the Exercise & Sports Science Australia [ESSA] accreditation scheme?

Answer:

I am advised 100% of NSWIS sport scientist staff meet the accreditation requirements of

the ESSA Level 1 scheme.

The Hon. ANTHONY D'ADAM: Are you also able to take on notice what the compliance arrangements are that apply at the NSW Institute of Sport in ensuring that sports scientists employed there are accredited under the ESSA scheme?

Answer:

I am advised upon offering a position within the NSWIS sport science team (which

includes both sports scientists and strength and conditioning coaches), the NSWIS

People & Culture team request evidence of all relevant qualifications and

accreditations. These requirements are then also followed up annually to ensure they

are not expired.

Employees are contacted prior to accreditation expiration dates and are led through the renewal process by a member of the People and Culture department.

Ms JONES: Absolutely. The Hon. ANTHONY D'ADAM: Thank you.

Grassroots Sport Fund

Transcript Page 13

The Hon. ANTHONY D'ADAM: Thanks. I might move to the Grassroots Sport Fund. How many organisations out of, I think, an estimated 12,500 eligible clubs and associations accessed the 2020 round? Do you have that information at hand?

The Hon. NATALIE WARD: I very much hope all of them, and I hope it has been a quick and easy process for them to access it. But we might have to take the specifics of 2020 on notice, given that was before my time. I would be very interested in that as well.

The Hon. ANTHONY D'ADAM: If you are going to take that on notice, can you take on notice how many applications were made and how many were approved for the 2020?

The Hon. NATALIE WARD: Yes.

The Hon. ANTHONY D'ADAM: Are you able to provide details of the successful applicants regarding sport and location?

The Hon. NATALIE WARD: Sorry, sport and location?

The Hon. ANTHONY D'ADAM: Location.

The Hon. NATALIE WARD: It was before my time, but absolutely. I will have to take that on notice and get that data.

Ms JONES: We can provide that.

Answer:

I am advised the Grassroots Sport Fund, within the 2020 Community Sport Recovery

Package, was administered by State Sporting Organisations and State Sporting

Organisations for People with Disability to their affiliated clubs and organisations.

Details relating to the Fund are available in the Office of Sport's 2019/20 Annual Report.

Information relating to all the clubs' locations is not held in the Office of Sport.

Business grants

Transcript Page 14

The Hon. ANTHONY D'ADAM: Thank you. Can I draw you back to the specific question which is about the business grants. Is it correct to say that that was the mechanism that you were using to provide financial support to local clubs, not the State—

The Hon. NATALIE WARD: Yes.

The Hon. ANTHONY D'ADAM: The primary mechanism for financial support? There is no other package that provided that kind of financial support to local clubs, is there?

The Hon. NATALIE WARD: I will take that on notice, but I would say that there are a range. I am not sure I do agree with it being the only mechanism. I do not think it is fair to—

The Hon. ANTHONY D'ADAM: I did not say "only", I said "primary".

Answer:

I am advised during the period between 26 June and 11 October 2021, the NSW

Government's COVID-19 Support Package was the primary mechanism of providing

financial support to eligible organisations such as sport clubs. This package included a

number of financial assistance programs administered by Service NSW, including the

COVID-19 Business Grants program.

Active Kids

Transcript Page 15

The Hon. ANTHONY D'ADAM: Can you provide on notice the quantum of Active Kids support that was provided on the basis of that arrangement that you just specified in not requiring them to be returned?

Ms JONES: Absolutely.

The Hon. ANTHONY D'ADAM: And can you also provide on notice how many sporting clubs were able to apply for the COVID-19 business grant—how many applied and were successful in relation to—

The Hon. NATALIE WARD: In 2020?

The Hon. ANTHONY D'ADAM: In 2020, yes, that is right—no, this is for the 2021 period prior to the announcement of the latest support package. **Ms JONES:** Yes, sure.

Answer:

I am advised the Office of Sport does not hold information relating to the quantum of assistance provided to Active Kids providers as a result of this arrangement. Providers were not required to return Active Kids vouchers that had been redeemed with them for programs that did not go ahead due to the COVID-19 pandemic.

Service NSW administered the COVID-19 Business Grants on behalf of NSW

Government. The Office of Sport does not hold any data relating to the number of

community sporting clubs that applied for the COVID-19 Business Grant.

COVID-19 check-ins for seniors

Transcript pages 17-18

The Hon. SHAOQUETT MOSELMANE: Questions within the Seniors portfolio. Are you aware that many older people have reported that during COVID-19 they were unable to do their grocery shopping because the critical retail outlets they shop at do not have working scanners to read the QR code issued by Service NSW? **The Hon. NATALIE WARD:** Thank you. I think we may have—

The Hon. SHAOQUETT MOSELMANE: Maybe Ms Smyth might answer it? The Hon. NATALIE WARD: Yes, Ms Smyth is here to assist. I know that with the Senior's Card we have an enormous database which we were able to utilise during that time that you importantly refer to and identify our seniors can get that information out to them. It is part of our engagement and communication with them. I think it was important that we did so. Before I hand over to Ms Smyth I will just say that the Service NSW app and QR codes again falls within Minister Dominello's portfolio. While we do advocate through our Senior's Card and our database, the rollout of those mechanisms at supermarkets does fall within the remit of Service NSW. I would be happy to take the question to Minister Dominello, if that assists. The Hon. SHAOQUETT MOSELMANE: Does Ms Smyth have anything to add? Ms SMYTH: We are aware of the issue and we raised it with Service NSW. There has been a lot of promotion about the card to businesses but there is also the option for businesses to use annual reporting when the card has not scanned correctly or they were not able to scan it. They can just do that manually on an iPad that the business owner holds.

The Hon. SHAOQUETT MOSELMANE: Elderly people had issues not only with the QR code but, anecdotally, some were taking photos of the QR code as opposed to scanning. Is that right?

The Hon. TREVOR KHAN: Not just old people.

Ms SMYTH: Yes, that is right, lots of people at the commencement thought that you took a photo of the QR code rather than understanding that the camera scanned it. **The Hon. SHAOQUETT MOSELMANE:** Has the code card issue been fixed now by Service NSW?

The Hon. NATALIE WARD: We will take that to Minister Dominello, if I may, because the rollout of that certainly would be something with which we would be pleased to assist. But all of this, I would say, is within Mr Dominello's portfolio.

The Hon. SHAOQUETT MOSELMANE: Just on that one, do we know the average waiting time for people to receive the card after they have requested it? Do you know how long it took for the elderly to receive the card when it was requested?

The Hon. NATALIE WARD: Do you mean from the time they applied for the card? The Hon. SHAOQUETT MOSELMANE: They applied for it, yes.

The Hon. NATALIE WARD: I will hand that to Ms Smyth who might be able to assist.

Ms SMYTH: I know that they could be downloaded instantly. Lots of people had family and friends print those out for them, and give those to them, I believe. I will have to take on notice if they were mailed out and how long that took.

The Hon. SHAOQUETT MOSELMANE: Yes, thank you so much.

Answer:

I am advised physical Seniors Cards are delivered via Australia Post and delivery times are dependent upon a range of factors.

Seniors appropriate housing - National Construction Code

The Hon. ANTHONY D'ADAM: I have the details of the grants. I want to understand your role. I assume that the rounds were completed before your appointment as Minister?

The Hon. NATALIE WARD: Correct.

The Hon. ANTHONY D'ADAM: Perhaps Ms Jones could explain to me what role the Minister's office played in the approval of the grants?

Ms JONES: I am happy to take that on notice but typically with legacy programs they are application based. Obviously for legacy programs for a cycling event we are targeting cycling organisations or cycling facilities—

The Hon. TREVOR KHAN: You would hope so—

Ms JONES: You would hope so, particularly since it is cycling legacy that we want to achieve. They are application based. The Hon. ANTHONY D'ADAM: In round one, of the six grants, three were conferred on organisations in the Kiama electorate, two to other areas in the Illawarra and one to the Wollongong electorate. Was there any ministerial involvement in—

The Hon. NATALIE WARD: This is not part of my portfolio at this time. I am very happy to take it on notice. It is prior to my time.

The Hon. ANTHONY D'ADAM: It is not part of your portfolio?

The Hon. NATALIE WARD: Yes.

The Hon. ANTHONY D'ADAM: It is still a matter for the office which you oversee, surely, Minister.

Ms JONES: I will take that on notice as well. I do not have all the briefing notes in front of me in relation to that grant program.

Answer:

The Office of Sport assisted with the administration of this program, including

applications being lodged, assessed and stored using the Office of Sport's grant

administration systems. Approval of projects was made by the Wollongong 2022 Local

The Hon. NATALIE WARD: Sorry, could you repeat the first part of your question? The Hon. SHAOQUETT MOSELMANE: The money that has already been spent will not be taken out of the general funding that would usually go to Multicultural NSW. The Hon. NATALIE WARD: I will have to take that on notice. I am not sure I can comment on future expenditure. It is not the intent, but I would have to take that on notice, given that it is all new funding.

Sorry, Mr Khan, I apologise, but we do have some answers for the Committee. In relation to the NSW Institute of Sport [NSWIS], you asked about the strength and conditioning program. I might get Ms Jones to provide that update, if you do not mind.

Ms JONES: I will go to that one first. Thank you, Minister. I have actually received this advice from the NSW Institute of Sport. It is a requirement for all NSW Institute of Sport strength and conditioning staff to be accredited by the Australian Strength and Conditioning Association. A number of staff do have Exercise & Sports Science Australia accreditation, however, it is not compulsory. This aligns with the requirements of the Australian Institute of Sport.

The Hon. ANTHONY D'ADAM: Can you just clarify, the requirement is only for the strength and conditioning accreditation?

Answer:

I am advised it is important to note that strength and conditioning coaches are not sport scientists and the requirements differ.

All strength and conditioning coaches must have an Australian Strength and Conditioning Associations accreditation. Some also have an Exercise and Sport Science Australia (ESSA) accreditation but this is not essential for strength and conditioning coaches.

An ESSA accreditation is essential for sport scientists.

Ms JONES: Correct.

The Hon. ANTHONY D'ADAM: Why is that?

Ms JONES: If that is a question I will have to take it on notice.

The Hon. NATALIE WARD: I think those staff also have Exercise & Sports Science Australia accreditation, which should cover-off more broadly than just the strength and conditioning. Those guys will make you work hard no matter what you do. Can I just give an answer to—

The Hon. ANTHONY D'ADAM: Before you proceed on to that I just want to clarify again, the sports scientists are not required to have accreditation?

Answer:

I am advised Sport scientists are not required to have an Australian Strength and Conditioning Associations accreditation. They are required to have an Exercise and Sport Science Australia (ESSA) accreditation.

These are different accreditations.

Ms JONES: The only answer I have so far is in relation to the strength and conditioning staff.

The Hon. NATALIE WARD: Which was in response to your question, which we took on notice.

The Hon. ANTHONY D'ADAM: I will ask again: Why are sports scientists not covered, given that the Australian Sports Commission commitment is for a national accreditation scheme to apply to both sports scientists and strength and conditioning?

Answer:

I am advised all NSWIS strength and conditioning coaches and sport scientists have accreditations aligned with the Australian Sports Commission national accreditation scheme.

NSWIS sport science essential requirements are aligned with AIS minimum standards as far as relevant degree and ESSA level 1. NSWIS further requires a degree with honours. NSWIS strength & conditioning essential requirements are aligned with AIS minimum standards as far as degree and ASCA PCAS Pro requirements. NSWIS further requires ASCA Level 2 Accreditation or international equivalent.

Ms JONES: We will follow up on that second part of that question for you. **The Hon. NATALIE WARD:** But I am advised that this does align with the requirements of the Australian Institute of Sport. But we are happy to provide that further information, if you like.

The Hon. ANTHONY D'ADAM: Yes, please. Thank you.
