Question 1:

What was the actual cost of producing an original mix.

Answer:

The cost (excluding GST) of an original mix was:

- Silica Sand: \$13,395
- Otto Arena Tex fabric (mixed with the silica sand): \$12,127
- Estimated cost of mixing: \$8,225
- Total Cost: \$33,747

Note:

The above cost of \$33,747 represents only approximately 5% of the total cost of the project. This is the same cost as the sand / fabric mix moved from Wallaby Hill to SIEC.
