Answer:

428 of the applications were unsuccessful from both rounds of the Regional Sport Facility Fund grant program (2020/21 and 2021/22).

(a) 99 of the applications were unsuccessful as they were late/ineligible for funding under the program guidelines.

329 of the applications were unsuccessful as in competitive grant programs, applications must meet all eligibility criteria and score higher than other applications in merit assessment. Where eligible application funding requests exceed available funding, allocation of funding occurs based upon a project ranking formed through the merit assessment scoring.

- 13. How many applications to the Greater Cities Sport Facility Fund were not successful?
 - a) What are the reasons for why they were not successful? **Answer:**

166 of the applications were unsuccessful from both rounds of the Greater Cities Sport Facility Fund grant program (2020/21 and 2021/22).

(a) 54 of the applications were unsuccessful as they were late/ineligible for funding under the program guidelines.

112 of the applications were unsuccessful as in competitive grant programs, applications must meet all eligibility criteria and score higher than other applications in merit assessment. Where eligible application funding requests exceed available funding, allocation of funding occurs based upon a project ranking formed through the merit assessment scoring.

- 14. How many applications to the 2019/2020 Local Sport Defibrillator Grant Program were not successful?
 - a) What are the reasons for why they were not successful? **Answer:**

Three applications received under the program were unsuccessful. The applications did not meet the eligibility criteria for the program.

Her Sport Her Way

15. In 2018 you announced Her Sport Her Way with ambitions to improve women's participation. Have you met Lucy Small to discuss her concerns about unequal prize money in competitive sport?

Answer:

I am advised the former Minister for Sport met with Ms Small on 9 June 2021. Since being appointed as Minister for Tourism Sport in December 2021, I have responded to correspondence from Ms Small regarding the Equal Pay for Equal Pay for NSW campaign.

First Lap learn to swim vouchers

- 16. How many applications have been received for "First Lap" learn to swim vouchers?
 - a) Can a list be provided of the number of applications by LGA?

Answer:

There have been 181,340 vouchers created as at 17 March 2022.

Answer:

Applications are only declined when the applicant does not meet the eligibility criteria outlined in the program's terms and conditions.

18. What communications have been undertaken in languages other than English to ensure Culturally and Linguistically Diverse communities are able to apply?

Answer:

Translated flyers are available on the Office of Sport website and have been shared with stakeholders in our multicultural and preschool networks. Social media, both paid and organic, have also been undertaken in languages other than English.

National redress scheme and sports scientists/strength and conditioning coaches accreditation

- 19. The Office of Sport requires State Sporting Organisations to sign up to the National Redress Scheme in order to obtain any funding or any recognition. What ongoing measures are in place to ensure compliance with Working With Children Checks for Office of Sport employees and the sporting sector as a whole?
 - a) How many staff in the portfolio have WWCCs?

Answer:

The Office of Sport verifies Working With Children Checks (WWCC) prior to staff commencing employment where it is a requirement for the role. The Office has processes to ensure WWCC are updated prior to expiry and audits its processes.

The Office of the Children's Guardian is the regulator of the WWCC Scheme and responsible for sector compliance activities.

(a) 470 staff (including casuals) at the Office of Sport.

20. Due to the requirements of the Working With Children Check, it is not transferable between states. Given that examples have been reported of coaches working across borders, what mechanisms have the Office of Sport suggested to ensure the WWCC system remains robust and effective?

Answer:

The Office of the Children's Guardian is the regulator of the WWCC Scheme and responsible for sector compliance activities.

21. A national accreditation scheme for sports scientists and strength and conditioning coaches has been in place since 2018. At budget estimates previously the committee was advised NSWIS is 100% compliant. Is this still the case? **Answer:**

NSWIS is compliant with the necessary requirements.

All strength and conditioning coaches must have an Australian Strength and Conditioning Associations accreditation. Some also have an Exercise and Sport Science Australia (ESSA) accreditation, but this is not essential for strength and conditioning coaches.

NSW Institute of Sport (NSWIS) strength and conditioning essential accreditation requirements are aligned with the Australian Institute of Sport minimum standards as far as degree and Australian Strength and conditioning Associations (ASCA) Professional Coach Accreditation Scheme Pro requirements. NSWIS further require ASCA Level 2 Accreditation or international equivalent.

NSWIS sport science essential requirements are aligned with the AIS minimum standards as far as relevant degree and ESSA level 1. NSWIS further require a degree with honours.

It is important to note that strength and conditioning coaches are not sport scientists and best practice accreditation requirements differ.

22. To ensure compliance with the requirement to be accredited, it was intended that an audit be undertaken, however, to date this has not occurred. Does NSW support the Federal Government completing the audit? (a) What conversations will NSW officers have with their counterparts in Canberra about this?

Answer:

The NSW Institute of Sport (NSWIS) is not responsible for the implementation of the national accreditation scheme for sport scientists and strength and conditioning coaches in New South Wales.

Exercise and Sport Science Australia (ESSA) is a peak professional organisational that establishes the accreditation for exercise and sport science practitioners.

The Australian Strength and Conditioning Association (ASCA) provides strength and conditioning coach accreditation programs for all levels. These programs are registered with the National Coaching Accreditation Scheme, administered by Sport Australia.

It is important to note that strength and conditioning coaches are not sports scientists and best practice accreditation requirements differ.

23. As a condition of the Australian Sports Commission's Sport Investment Agreements, national sporting organisations were required to ensure all sport science and strength and conditioning staff have the relevant accreditation with Exercise and Sports Science Australia or Australian Strength and Conditioning Association by the end of 2018. Similarly, NSW requires state sporting organisations to sign up to the National Redress Scheme, has NSW considered a similar requirement to be tied to grants to State Sporting Organisations in relation to accreditation of sports scientists and strength and conditioning coaches?

Answer:

The NSW Government prevents those sporting organisations named in the Royal Commission into Institutional Responses to Child Sexual Abuse or in an application to the National Redress Scheme from receiving grants unless they have joined the National Redress Scheme or been assessed as being legislatively unable to meet the requirements to join the Scheme.

The eligibility criteria for being recognised as a State Sporting Organisation include policies relating to discrimination, bullying, child safety, complaints handling and anti-doping. The criteria is available at the Office of Sport website. The Office is not currently considering additional requirements.

24. Acting Sports Minister Lee previously said "Compensation will also be paid to the waterski club and Morisset Rotary Club, which were impacted by the unexpected closure of the [Myuna Bay sport and recreation] centre". Has compensation been paid?

Answer:

The Office of Sport continues to work with the waterski club on their permanent relocation plans.

25. What facilities will be available at the new Lake Macquarie sport and recreation facility?

Answer:

The scope of the new Lake Macquarie Sport and Recreation Centre will be informed by stakeholder consultation and an analysis of options that will provide for the best value to the sports and the local and regional communities.

There is no review. The Office of Sport has recently completed stakeholder consultation on potential amendments to the Act.

CommBank stadium

40. What work at the stadium is planned to ensure the stadium does need to postpone matches for bad weather in the future?

Answer

I am advised no works are planned.

41. What is the status of the proposal to build Parramatta PCYC on the land immediately to the north of the stadium?

Answer

After completing an Expression of Interest and market soundings Venues NSW will not be building on the site adjacent to CommBank Stadium at this time.

PCYC sold their previous property in Parramatta for a significant sum of money and I would encourage them to consider reinvesting it in Parramatta.

Stadium Australia

42. Did the NSW Government buy back ANZ Stadium for \$220 million in 2016?

Answer

I am advised this is detailed in the final report from the Legislative Council Public Works Committee inquiry into the Sydney stadium strategy.

43. What works are planned to maintain and upgrade the stadium?

Answer

The 2021/22 Budget included \$81.4 million over three years (FY21-23) for critical capital works.

44. Former Sports Minister Graham Annesley previously said "If we didn't invest in the former Olympic stadium by the time it came back to us in 2031, we would have been taking back an asset which was ready for the bulldozer." What was the rationale of the buyback?

Answer

I am advised this is detailed in the final report from the Legislative Council Public Works Committee inquiry into the Sydney stadium strategy.

45. What plans does the Minister have for the future ownership of Stadium Australia?

Answer

Stadium Australia is owned by the NSW Government and is part of the Venues NSW network.

At the Tokyo 2020 Olympic Games, NSWIS athletes made up 33.7% of athletes that represented Australia at the Games across NSWIS supported sports and 21.6% across all sports. At the Paralympic Games 24.6% of athletes that represented Australia were NSWIS.

The target established considers that NSWIS does not support all Olympic and Paralympic disciplines and therefore representative opportunities do not necessarily reflect population size. The target of 25% is determined by factors including historical performance data, the number of categorised athletes considered capable of Australian team selection, etc.

The Institute is part of a national system and every four years, led by the Australian Institute of Sport, the system undertakes a sport investment process. Aligned with the national system, the Institute assesses submissions from sports based on key criteria including AIS categorisation, international sport profile, pathway talent profile, potential impact of NSWIS investment, financial investment required and the available facilities and daily training environments.

In 2022, the Institute commenced new partnerships with archery (including para) and triathlon (including para) and provided investment to combat sports.
