Dear Mr Veitch

I refer to your letter of 30 May 2022 requesting Local Government NSW (LGNSW) provide further information on its position on the Companion Animals (Puppy Farms) Bill 2021.

With regard to the status of LGNSW's submission that was lodged with the Committee as a draft, this is standard practice where due dates do not allow for the LGNSW Board's consideration before submissions are lodged. The submission has now been endorsed by the LGNSW Board without change and can be considered as final.

The LGNSW submission to the Inquiry does not make comment on the Companion Animals (Puppy Farms) Bill specifically. Only one of the Inquiry's terms of reference (TOR 1a) relates to the draft Bill. LGNSW's submission did not specifically address this TOR but instead focuses on other TOR related to deficiencies in current arrangements including financial implications for councils. The submission outlines the issues councils are facing with respect to puppy farms in NSW and calls for stronger controls on mass breeding facilities (both at approval stage and during operation) so as to place NSW on par with its neighbouring States.

The Bill proposes stronger controls on breeding facilities, and therefore LGNSW's letter on the Bill and its submission to the Inquiry are consistent.

LGNSW's letter indicated in-principle support for the Bill and highlighted that it would increase the role and regulatory burden on councils and that this must be adequately resourced. While the Bill makes provision for councils to set a fixed fee for registrations and renewals, it is often difficult to ensure full cost recovery and this may leave councils out of pocket. In addition, to keep costs low our view is that an upgraded Pet Registry would also be essential to enable streamlined business registration and council reporting to occur. LGNSW's letter of November 2021 sought assurances on these matters, once again to prevent councils being burdened with additional tasks without adequate resources.

I trust this clarifies LGNSW's position on the Companion Animals (Puppy Farms) Bill 2021.
