PORTFOLIO COMMITTEE NO. 6 – TRANSPORT – SUPPLEMENTARY QUESTIONS – 26 AUGUST 2022

SQ001

At EIS stage DPI Fisheries said they "were unable to support the proposal". The EPA said the EIS didn't meet SEARs and required a 'Detailed Site Investigation' be done for contamination. However, both agencies concerns were dismissed and instead their concerns appear to be being included in some form via very costly, onerous and complex 'Conditions of Approval'. Have these conditions of approval been included in estimated costs or will we see this figure escalate further?

ANSWER

I am advised that the allocated budget is intended to accommodate the Conditions of Approval.

SQ002

Transport for NSW has stated it will be subsidising the operator of the ferry service which will clearly be another ongoing drain on Government purse. At a previous budget estimates the 'on notice' reply to subsidy costs was "it was too early to speculate". Given this project now has approval, can you supply us with these estimated subsidy costs and modelling data?

ANSWER

I am advised that approval of the Project by the Commonwealth Government under the *Environment Protection and Biodiversity Conservation Act 1999* is still pending. It remains too early to speculate in relation to any service that may operate between the wharves.

SQ003

If the subsidy costs are secret, due to tender negotiations, can you at least confirm whether they form part of the \$49.3million estimated cost or whether they will be additional costs to TfNSW?

ANSWER

I am advised that the current budget allocation is not intended to cover the costs associated with a ferry service that may operate between the wharves.

SQ004

The project is partly funded by the Commonwealth through a joint State/Federal agreement to celebrate the 250th anniversary of Cooks landing in Kurnell. The \$25 million funding has already been granted. However, a further \$4.5 million appears to have been recently allocated from the Commonwealth, outside the agreement for this project. Is the Minister aware of this additional funding and can he explain why it is being allocated?

ANSWER

This question should be directed to the Minister for Environment and Heritage.

The former Prime Minister, Mr Scott Morrison was particularly interested in this project. It sits in his electorate and in his inaugural speech to parliament in 2008 he stated Australia needed to celebrate and give prominence to Kurnell as part of the 250th Anniversary of Cook's landing. The previous \$25 million came from Mr Morrison's office when he was Treasurer. Can the Minister clarify whether this additional \$4.5million was a special allocation from Mr Morrison's office?

ANSWER

This question should be directed to the Minister for Environment and Heritage.

SQ006

The project involves building two marine wharves at La Perouse and Kurnell. Can the Transport Minister confirm the exact (or approximate) final lengths of those two wharves?

ANSWER

I am advised that a description of the proposal is contained within Chapter 5 of the Environmental Impact Statement which is available on the NSW Planning Portal.

SQ007

In the EIS released in July 2021, it stated the La Perouse wharf "will extend 180 metres from the shore". In the Urban Design and Landscape plan released in October 2021 it stated the La Perouse wharf "is proposed to extend about 100 metres from the shore" now in the Determination Assessment report released in August 2022 it states in the Introduction the La Perouse wharf "is proposed to extend approximately 230 metres from the shore." Can you confirm the true dimensions?

ANSWER

I refer to the response provided in Supplementary Question 6.

SQ008

Can you confirm that the amount it "extends from shore", is the same figure as "overall length" of the wharf? (if not, what is the overall length of the La Perouse wharf?)

ANSWER

I refer to the response provided in Supplementary Question 6.

SQ009

Can you explain why the dimensions have grown by over 130% from what was stated in October 2021 in the Urban Design and Landscape plan and what is stated in the August 2022 Determination Assessment Report?

ANSWER

I refer to the response provided in Supplementary Question 6.

SQ010

Would you agree that if a project changes by such a significant amount as 130% at Determination stage then the environmental assessment reports which consider

disturbance of seagrass and sediment would clearly be inaccurate based on the dimensions from the Urban Design and Landscape plan of October 2021?

ANSWER

I refer to the response provided in Supplementary Question 6.

SQ011

Is it the minister and/or departments intention to abolish the Recreational Vessel Advisory group?

ANSWER

I am advised that there is no intention to abolish the Recreational Vessel Advisory Group.

SQ012

When will public consultation occur on the Maritime Inclusion plan?

ANSWER

I am advised that the Maritime Diversity and Inclusion Plan is currently in the early stage of research and development. The timing and extent of public consultation is yet to be determined.

SQ013

Given that Transport for NSW owns/manages the Coffs Harbour launching facility is there a schedule in place for preventative/routine maintenance, especially the removal of marine growth?

ANSWER

I am advised that parts of the Coffs Harbour launching facility are still under construction. The ramp area has recently opened and the Transport for NSW staff managing this construction are regularly inspecting the boat ramp for marine growth. A formal maintenance program will be put in place in early 2023, once all works are complete.

SQ014

If there is a maintenance schedule in place, could the details be provided?

ANSWER

I am advised that maintenance plans have not yet been developed for the facility.

SQ015

How are specific upgrades whether current or future identified?

ANSWER

I am advised that a Maritime Infrastructure Plan has been developed to guide future investment in maritime infrastructure. This is available on the Transport for NSW website.

SQ016

Given that silting is an ongoing problem, and that dredging is necessary to ensure safe navigation for boaters. Who will pay for the cost of ongoing dredging?

I am advised that the cost of the dredging will be met by Transport for NSW.

SQ017

Since its inception, how many applications has Kiama Municipal Council made to the program?

ANSWER

I am advised, one.

SQ018

Of those applications, how many have been successful?

ANSWER

I am advised, one.

SQ019

What were those successful applications for?

ANSWER

I am advised, Kiama Harbour Boat Ramp Car Park and Boat Wash Down Upgrade.

SQ020

Have those successful applications been completed?

ANSWER

I am advised, no. Kiama Municipal Council terminated the Boating Now funding agreement for the Kiama Harbour Boat Ramp Car Park and Boat Wash Down Upgrade as it received funding to deliver the same project through another funding program.

Of the 28 station accessibility upgrades targeted for delivery in Greater Sydney between 2019 and 2023, 15 TAP3 station upgrades have already been delivered, with funding for the delivery of the remaining 13 stations included in the 2022-2023 budget.

I am advised that all recommendations have been implemented.

The Office of Transport Safety Investigations continues to monitor, investigate and seek advice from Transdev Sydney Ferries regarding an ongoing intermittent steering control fault.

The Office of Transport Safety Investigation has conducted multiple follow-up assurance checks and has sought advice from Transdev Sydney Ferries on what operational mitigation strategies have been implemented.

The Office of Transport Safety Investigations is awaiting a formal internal investigation report from Transdev Sydney Ferries regarding the steering defects. The Chief Investigator will decide on any further action after reviewing that report.

SQ159

Noting the significant issues that have been experienced with the ten River Class Ferries, does the Office of Transport Safety Investigation have any investigations underway for this fleet?

ANSWER

I am advised that the Office of Transport Safety Investigation is currently conducting enquiries into one incident involving River Class vessel MV Olive Cotton which occurred on 3 August 2022.

Once information is received, OTSI will determine if any further action is required.

Has there been oil leaks in the engine rooms of the Emerald Class Gen 2 ferries Balmoral, Fairlight and Clontarf?

(b) What are the causes of the oil leaks?

(c) What has been the process of fixing those leaks?

ANSWER

I am advised that oil leaks have been identified in the engine rooms of the Second Generation Emerald Class vessels - Balmoral, Fairlight and Clontarf. The matter was resolved by replacing the centrifuge shaft and staff have been trained to avoid overtightening in the future.

SQ161

Has there been water leaks in the engine rooms of the Emerald Class Gen 2 ferries *Balmoral, Fairlight*?

ANSWER

I am advised that there have been water leaks in the engine rooms of the Balmoral and Fairlight vessels. An interim solution has been put in place while discussions continue between Transdev Sydney Ferries and Birdon, the vessel builder, regarding a permanent solution.

SQ162

How many days have the three Emerald Class Gen 2 ferries Balmoral, Fairlight and Clontarf been taken out of passenger service in 2022 for maintenance reasons, both scheduled and unscheduled?

ANSWER

I am advised that, to date in 2022, the three Second Generation Emerald Class vessels have undergone scheduled and unscheduled maintenance across 114 days.

SQ163

There has been cracking reported on the hulls of the Emerald Class Gen 2 ferries Balmoral, Fairlight and Clontarf. What steps are being taken to repair the cracks in the hulls?

ANSWER

I am advised that the cracking issues on the three vessels will be repaired under warranty. The vessels will have the minor repairs carried out at the first scheduled docking.

SQ164

What is the maximum swell height that the Emerald Class Gen 2 ferries Balmoral, Fairlight and Clontarf can operate to?

ANSWER

I am advised that the maximum swell height for the safe operation of the vessels is 4.5 metres.

SQ165

The Region 9 Bus Network, the Eastern Suburbs, was transferred to a private operator. What is the name of the report that recommended that the Region 9 Bus Network be transferred to a private operator and is it publicly available?

(a) Were there dissenting recommendations regarding the decision to privatise the Region 9 Bus Network, either in an official report or email correspondence, by this Government from Transport NSW?

(b) Were any impact studies done to assess how this would impact public transport for the local community?

i. If so, what were the names of the studies and are they publicly available?

(c) Were there any specific impact studies that assessed bus route cuts, reduced bus frequency and journey times given that services would need to be streamlined to create profit for the private provider?

i. If so, what were the names of the studies and are they publicly available?

(d) Was the privatisation process a competitive bid process?

i. If so, how many private operators submitted bids for the Region 9 Bus Network, who assessed the submissions and are the submissions publicly available?

(e) Were any safeguards written into the contract between the Government and Transdev to mitigate against bus route and bus stops cuts, reduced bus frequency and longer journey times for commuters?

i. If not, why not?

ANSWER

I am advised that in 2019, the Government announced its intention to franchise the remaining three State Transit Authority bus regions.

As Transport for NSW has retained control of assets, routes, timetables and stops, there is no discernible change to commuters. Service changes introduced were designed to provide the best overall integrated public transport network outcomes for Sydney's southeast. Services were not altered for the franchising process. All Greater Sydney bus contracts have provisions that no changes to bus routes, stopping patterns, bus frequency or journey times can be made without approval from Transport for NSW.

The franchising of Region 9 services was a competitive, open market tender process. Details of the tender process remain confidential and the submissions are not publicly available.

SQ166

Multiple bus stops have been removed from the Region 9 Bus Network, were any impact studies conducted prior to the stops being removed?

(a) If so, what were the names of the studies and are they publicly available?

(b) If no impact studies were conducted why and on whose recommendation?

(c) Why did the Government remove these stops?

ANSWER

I refer to the response to Question on Notice 46.

SQ167

The Government pays the private bus operator per kilometre – was there a recommendation to cancel routes in the Region 9 Bus Network as a cost saving mechanism for the Government?

(a) Were there any reports or documents created by Transport NSW, the Government or a third-party contractor that included an assessment of expenditure reduction due to route terminations?

I am advised that bus routes in Sydney's south east were adjusted to support the introduction of Light Rail and provide new connections across multiple modes of transport to improve overall connectivity between different destinations. As with any transport project, costs were monitored to ensure value for money.

SQ168

How many complaints has the Government and Transport NSW received about bus route and bus stops cuts, reduced bus frequency and longer journey times since the Region 9 Bus Network came under private operation?

(a) What is the official complaints resolution process when the Government or Transport NSW receives a complaint about Transdev operation decisions?

ANSWER

I am advised that on 3 April 2022, the Region 9 Bus Network was franchised. There have been less than 50 received by Transport for NSW complaints since that time. (a) I refer to the response to Supplementary Question 165, Transport for NSW has retained control of assets, routes, timetables and stops within Region 9.

SQ169

What mechanisms has the government put in place to ensure staff retention and reduce levels of staff turnover in the Region 9 Bus Network since it came under private operation?

ANSWER

I am advised that the Operator has the responsibility for staff retention and turnover. Transdev John Holland Buses along with most bus Operators currently have a range of strategies to increase attraction to the industry.

Transport for NSW will be soon be holding a workshop with contracted Greater Sydney and Outer Metropolitan Bus Operators discuss staff retention and recruitment.

SQ170

Who is responsible for ensuring buses used by the private operator are compliant with environmental standards, noise levels, pollution and all relevant regulations pertaining to the roadworthiness of the buses?

(a) Who is responsible for independently checking that the buses meet regulation standards for noise level, pollution, and overall roadworthiness of the buses?

ANSWER

I am advised that the Operator is responsible for ensuring all vehicles in operation are designed, manufactured, and maintained within the Original Equipment Manufacturers requirements, and the Australian Design Rules for Heavy Automotive Vehicles. Transport for NSW also undertakes inspections under the Heavy Vehicle Inspection Scheme every six months to ensure vehicles are safe and remain compliant to the relevant standards along with general vehicle safety. Should they fail this inspection they will not be able to operate services.

All new buses must meet Australian Design Rules and all relevant NSW Road Rules to be eligible for registration in NSW.

SQ171

A significant number of bus drivers left Region 9 once the region was privatised. John Holland is now conducting extensive recruitment processes including finders' fees to try and rebuild the workforce

(a) Why do people not want to work for a private provider in region 9?

ANSWER

I refer to the response to Supplementary Question 169.

SQ172

Transdev announced that track maintenance activities will be undertaken on the L2 Randwick and L3 Kingsford lines to improve network safety. What safety issues are being rectified on these light rail lines

ANSWER

I am advised that there are no current specific safety issues that are being addressed as part of the ongoing maintenance. Transdev undertakes regular ongoing maintenance to ensure that the rail infrastructure, including track maintenance, remains to standard.

SQ173

The South-East Sydney light rail has already had over \$1 billion blow out, and has been riddled with problems from day one; why did the NSW government remove 35 bus routes to funnel people onto this mode of transport?

ANSWER

The delivery of the CBD and South East Light Rail has redefined travel through our city and has decongested key routes in the CBD, with every light rail vehicle set able to carry up to 450 people.

The network integrates with other modes, by strengthening existing corridors and connecting major destinations such as Bondi Junction, Randwick and Mascot.

The new network includes buses integrating with rail and light rail to get local commuters as well as visitors to where they want to go and provide much-needed capacity, supporting existing and emerging travel patterns with improved frequency and connectivity across the region.

To help reduce duplication on the network, some bus routes were withdrawn and replaced by new or altered bus routes or frequent light rail services.

SQ174

What is the total amount the South-East Sydney light rail has cost the people of NSW so far?

ANSWER

I am advised that the final cost of the CBD and South East Light Rail project or benefits realisation will not be known until Infrastructure NSW completes a final review in 2023.

I am advised that the staffing budget for the Office of Veterans Affairs for 2022/23 is \$3,986,788

- a) If veterans advised they were unable to attend, one-on-one support was offered with VEP staff or attendance at the next workshop. All venues used are able to cater for equal access.
- b) This is being discussed with the provider. No regional locations have yet been chosen. They will be considered in relation to veteran population data to ensure numbers meet cost benefit of providing. Remote delivery will also be considered.
 - i. Consideration is being given to running a regional workshop in the remainder of this year or first half 2023.
 - ii. If there is demand this will be considered.

SQ183

Karen Douglas Career Coaching and Consulting was chosen as the organisation to deliver theworkshop. Was there a tender process regarding the organisation who would deliver the workshop?

- a) In budget estimates in 26/08/2022, Ms Mackaness said there was a 'piece of work' being conducted on veterans in jail which was 'being led by South Australia but New South Wales is participating in'. Can you explain exactly how NSW has participated in that specific piece of work?
- b) In the past 24 months, when has the commonwealth, state and territory working group met?

ANSWER

I am advised that the Commonwealth, State and Territory Committee (CSTC) is a subordinate committee of the Veterans Ministerial Councils' Roundtable now named the Veterans' Wellbeing Taskforce (VWT). The CSTC acts as the main forum for dialogue between the jurisdictions about veteran initiatives and emerging issues affecting veterans. Collaboration has occurred in numerous areas including sharing of research and program information such as the NSW Veterans Employment Program and Commonwealth funded initiatives such as the Veterans Wellbeing Centres (now 'Veterans and Families Hubs'). One significant initiative was the inclusion of a veteran question in the Australian Census in 2021 that has enabled data on veterans and their families to better inform services and supports.

- a) In late 2021, the VWT requested the establishment of a Veteran Incarceration Policy Working Group to develop possible policy responses and jurisdictional initiatives to better support and understand veterans and their families who are in contact with corrective services systems. The Terms of Reference for this group have been established. Research led by Flinders University in South Australia on the experiences of ex-serving Australian Defence Force personnel in corrective services systems in Australia is also underway, and NSW is participating in this research. This work has been delayed by COVID-19 impacting access to prisons for face-to-face interviews and will not be finalised until the end of March 2023.
- b) CSTC meetings were held in February and August 2022; March, May, June, August, and September 2021; and March, July and November 2020.

SQ185

Can you specifically explain what support/assistance the NSW Government/Office of VeteransAffairs has provided the Royal Commission into Defence and Veteran Suicide?

 a) Can you explain specifically what assistance/support the NSW Government/Office of Veterans Affairs is providing to the Royal Commission into Defence and Veteran Suicidein the next 12 months?

I am advised that the Crown Solicitor's Office has been appointed to represent the State at the Royal Commission into Defence and Veteran Suicide. In 2021 the Office for Veterans Affairs established an Inter-Departmental Committee (IDC) comprised of representatives from across NSW government agencies to monitor hearings and findings and coordinate NSW specific responses and address emerging issues from the Royal Commission. The IDC meets bimonthly. In April 2022, the NSW Government made a preliminary submission to the Royal Commission to provide information about NSW Government services and programs that support veterans.

a) The NSW Government will continue to respond to Royal Commission requests for information.

SQ186

Can you explain what work has occurred on behalf of the NSW Government/Office of Veterans Affairs regarding the National Veterans Cemetery, since May 30 this year?

- a) Can you specifically provide details of what stakeholders you have met with in relation tothis proposal as well as dates and venues where meetings took place?
- b) What work is expected to occur in the remainder of 2022 regarding the National VeteransCemetery proposal

ANSWER

I am advised that since May 30 this year the Office for Veterans Affairs (OVA) has provided information and advice to the NSW Minister for Veterans' office about the National Veterans Cemetery proposal.

- a) The OVA has not met with any stakeholders in relation to this proposal.
- b) No work is planned at this stage, pending further discussions and direction from the NSW Minister for Veterans and his discussions with the Commonwealth Minister responsible for the Department of Veterans' Affairs, which has primary responsibility for this matter through the Office of Australian War Graves.

SQ187

Can you explain specifically what training has occurred for staff members of the Office of Veterans Affairs regarding how to counsel veterans and their loved ones should the scenarioarise?

a) Can you explain what training is scheduled/planned for staff members of the Office ofVeterans Affairs regarding how to counsel veterans and their loved ones should the situation arise?

ANSWER

I am advised that The Office for Veterans Affairs (OVA) staff do not counsel veterans or their families but refer all calls for assistance to appropriate services provided by Commonwealth Department of Veterans' Affairs, other areas of NSW Government or Ex Service Organisations depending on the matter raised, which could relate to access to concessions, housing or health services. Training is supported for all staff in the OVA, across a range of different subjects and courses. Some training has been delayed due to the ongoing effects of the COVID-19 pandemic. While the OVA does not deliver front line services, additional training for relevant staff is currently being sourced.

- c) All staff have access to the Employees' Assistance Program and access to external organisations such as Beyond Blue. Additionally, the Memorial veterans have access to organisations such as Open Arms, RSL Lifecare and Crisis Support.
