# INQUIRY INTO THE APPOINTMENT OF MR. JOHN BARILARO AS SENIOR TRADE AND INVESTMENT COMMISSIONER TO THE AMERICAS

#### **CONTEXT**

I have done my best to answer your questions below, which relate to the appointment of Mr Stephen Cartwright as NSW Agent-General to the United Kingdom.

I ask the Committee to understand that I do not have access to any documentation such as emails, file notes, diaries etc therefore cannot state specific dates. I am able to comment on broader timelines. Having said that, I am presently in Melbourne attending to my dying mother. I am not going to pretend that my recollection in these impaired circumstances is crystal clear.

The date I do remember well is 8 March 2021. I was attending Budget Estimates with then Treasurer Perrottet when I received an email from Ms Amy Brown, enclosing a Brief from Ms Brown to Premier Berejiklian. The Brief requested the transfer of all Global NSW responsibility to Investment NSW in the Department of Premier & Cabinet. This included all components of the strategy, people and budget. The Brief had been approved by the Premier. Whilst I thought the means of communicating the transfer was somewhat unusual (i.e. no prior discussion, no meetings, no phone conversations etc.), I respected the right of the Premier as Head of State to be the designated leader of trade and investment in NSW.

The transfer of Global NSW occurred during March/April of 2021. The only task which remained within my portfolio (and by agreement with Investment NSW and Premier & Cabinet) was for the selection panel to complete the selection process for the Agent-General in the UK & Europe and the Senior Trade Commissioner in North East Asia/Japan. The panel comprised myself, Mr Tim Reardon, Secretary, Premier & Cabinet and Mr Warwick Smith, recognised expert in all matters Trade at an executive level. I recollect that the panel completed the process towards the end of March/early April and the panel decisions were:

- Mr Stephen Cartwright for Agent-General UK & Europe
- Mr Mike Newman for Senior Trade Commissioner North East Asia and Japan

Both of these approvals were then passed to Investment NSW for remuneration negotiation and their appointments. The panel had completed their job and I had no further engagement beyond this point.

# Q1. The selection process which led to the selection of Mr Paul Webster as the preferred candidate for the role of NSW Agent-General to the United Kingdom

I was a member of the selection panel. I am not clear on what this question asks. Preferred by whom, and when? Mr Webster was a strong candidate with deep experience in transactional trade and administration, however the selection panel questioned whether Mr

Webster was ready to step up to the Agent-General role which carried significantly higher levels of executive representation, influencing and stakeholder management.

# Q2. The selection process which led to the replacement of Mr. Paul Webster as the preferred candidate for the role of Agent-General to the United Kingdom with Mr. Stephen Cartwright

The premise of the question is incorrect as there was no "replacement" of Mr Paul Webster with Mr Cartwright as set out in Question 1. Both candidates were put through the selection process.

# Q3. All conversations you had with the Treasurer and/or the Deputy Premier about the above 2 processes

In respect to the Deputy Premier, I can only recollect that he recommended Mr Cartwright into the process. I do not recollect the terms of the specific conversation. However, he was the Trade Minister and had every right to recommend candidates into the selection process provided he had no further involvement in the process and did not seek to influence selection panel members in any way. To the best of my recollection, he had no further engagement beyond recommending Mr Cartwright. Mr Cartwright went through the selection process with each of the other candidates.

In respect to the then Treasurer, I do not recollect that he had any involvement other than that I updated him from time to time on progress as I did with all matters "across my desk". I do not recall any specific conversations.

# Q4. The negotiations had with Mr Stephen Cartwright over his total remuneration package with Investment NSW for the Agent General in London role

I had no role in the negotiations of remuneration with Mr Cartwright as this was the responsibility of Investment NSW.

Greetings. As per our discussions in relation to 'Round 2' of the sourcing, research and interviewing for the Agent-General role we have attached the final Shortlist Recommendations. The key recommendation is that Paul Webster is the strongest candidate. He has a highly relevant background for the role, the right level of experience, a very good mix of commercial and government experience, and strong networks in the UK and Europe.

In coming to this conclusion re Paul Webster we note the following:

- We have completed extensive further sourcing and sourcing.
- We re-approached all potential candidates and virtually sources from Round 1 (including those who were non-responsive).
- · We had a lot of very helpful input.
- We interviewed another five candidates who came well recommended. However they did not measure up to the criteria in the way that Paul does.
- Paul Webster was recommended by multiple sources as a highly relevant candidate.

We have maintained contact with Paul throughout the year to keep him in the candidate pool. He remains keen but will need a decision soon due to the nature of the business cycle and some major pending work in the UK.

Let's know if there is anything else we can do at this stage.

NGS Global was engaged by NSW Treasury to undertake the executive search for the Agent General role.

#### Recruitment process undertaken for the UK Agent General role:

- § External print advertising was placed in the Australian Financial Review on 13

  December 2019 and the Financial Times on 12 December 2019. The advertisement was available on online for both versions of the publications until 27 January 2020.
- § NGS Global provided Treasury with a short list of candidates recommended for interview.

- § A panel was convened to interview seven candidates (one candidate withdrew). The panel was led by Michael Pratt Secretary, Treasury with panel members Tim Reardon Secretary, Department of Premier and Cabinet, Kim Curtain Interim Deputy Secretary, NSW Treasury and the Hon Warwick Smith AO; Chairman, Australian Capital Equity Group Advisory Board, Chairman, ANZ (NSW & ACT), Chairman, Australia-China Council and Chairman, NSW Export and Investment Advisory Panel.
- § The panel conducted capability behavioural based interviews with a focus on the following areas:
  - Extensive experience at a senior executive level in international business or across government and strong commercial acumen
  - Deep understanding of how businesses make investment decisions, trade and investment facilitation and market awareness in the global economic environment
  - Ability to represent an organisation with authority and credibility, including strong communication skills and an ability to engage and negotiate with diverse stakeholders
  - Demonstrated strategic leadership and influencing experience with the ability to lead a culture of collaboration

Thank you Marianne. I appreciate the feedback on the interview so quickly, and the outline of next steps. I am eager to have this process concluded asap.

I look forward to receiving the template from Lynne today and will return the completed version immediately.

The discussion with Jenny is an important one to have soon, and I would welcome your guidance on this matter. I will share with you some important conversations, in the strictest confidence, as these have shaped my expectations around the role, but I am uncertain how much of this has been, or will be, communicated to Jenny.

I would be grateful if you could please keep the content of these discussions between us for the moment.

When the Deputy Premier first asked me to consider the role back in early Feb, he and I had a very open and frank discussion about my circumstances (i.e I have been on a package of over \$800k for some years and have made financial commitments accordingly) and about his view

that the current package on offer was not attracting the right calibre of candidate. Apart from improving the base package (he mentioned low 5's), he indicated (privately of course) that he and the Treasurer had reached an agreement that the cost of suitable family accommodation (including cleaning etc) in an inner suburb of London could be taken care of by the NSW Govt outside of the salary package. He also suggested that, given I have kids in school here, and elderly parents who recently moved to Sydney to be close to us, I should propose how I believed I could make it all work (eg he understood that I cant move the kids until the end of the school year so would need to travel back and forth this year, and I will need to return to Sydney a couple of times each year to check on my elderly parents etc). His parting words were "you come back and tell us how it can be made to work for you."

I have discussed the role in confidence with our High Commissioner to NZ (as Patricia used to work for me, is one of my referees and is close to the Premier) and she indicated that the Federal Government takes care of all of her living expenses in NZ (eg home, cleaner, driver etc) so that her salary package can be used to service her financial commitments back in Australia (ie mortgage etc). When I discussed this approach with Warrick when we caught up for coffee some time ago he suggested that this is the normal way that governments support high level overseas diplomatic / trade posts.

When I met with Mike to discuss the role on 19 Feb, he said that he understood about the kids in school / elderly parents etc and was comfortable that I might spend a fair bit of this year here in Australia but travel to and from the UK as required (eg for the July trip by the Premier etc). I also shared with Mike that I am receiving other offers from the government (eg I have recently been offered the Chairmanship of TAFE NSW by another Minister) and from the private sector, and that I have been stalling them as best I can, but that I would need to lock down a start date sooner rather than later (I think I suggested I would like to commence at the latest by 1 May).

So, in light of all of this, I would welcome your views on the best way to navigate this delicate discussion with Jenny. I don't know how much of the above she knows, and I don't want to directly disclose my discussions with the DP etc, or be accused of being unrealistic or playing hard ball in the negotiations, but my participation in the process to date has been shaped by these expectations and I cant hold off other offers for too much longer so I need a degree of certainty on this role asap.

I am happy to discuss over the phone if you would prefer but I am keen to get your thoughts on the best way to proceed with Jenny.

The chronologies which I will now provide, which I hope will assist the Committee, are based on my best recollections and on records that I hold. In terms of the recruitment process, after I completed my term as the CEO of the NSW Business Chamber in September 2020, I took a sabbatical over the spring/summer months before commencing the search for my next leadership role in February 2021. However, in December 2020, I was approached by New South Wales Minister, the Hon. Dr Geoff Lee, and asked if I would consider taking on the role of Chairman of New South Wales TAFE. The Minister was well aware that I had a keen interest in improving VET outcomes in New South Wales, that I understood the policy settings associated with this challenge and that I had practical experience as well, with the NSW Business Chamber operating a group training company and managing 40,000 apprentices under the largest Federal Government apprenticeship support program in the nation.

The Minister was also aware that I had recently completed my term as the Chairman of the New South Wales Government's International Education Advisory Board. I was very interested in this important TAFE chairmanship role, and discussions concerning my possible appointment continued through January, February and into March. Ultimately, I was unable to accept the TAFE chairmanship role due to my application for the role as the New South Wales agent general to London. On 17 February 2021 I attended a coffee meeting, which had been requested by the then Deputy Premier, John Barilaro. The Deputy Premier had asked me if I could introduce him to a board member from the NSW Business Chamber. After that board member left us, the Deputy Premier asked me if I might be interested in the UK agent general role. I was taken by complete surprise by his question because I had not heard much about the role since it was announced by Premier Berejiklian back in 2019 as part of the Global NSW strategy announcement.

During this conversation, the Deputy Premier asked me what package I had been on at the chamber. I told him that my base was about \$650,000 and that for the past few years, my annual bonuses had been about \$150,000. That is a total of about \$800,000. The Deputy Premier then said that the New South Wales Government would probably be offering a base in the low fives—that is, just above \$500,000—plus the usual support for offshore trade roles, such as the payment of rent and school fees. That is the same as for Austrade and for some of the other States. He said that the Government was keen to attract high-calibre people from the private sector who understood business and trade, who were passionate about New South Wales and who knew how to get business deals done.

I said that the role sounded interesting but that I needed to discuss it with my wife, as it was a very significant decision for our family to move to the other side of the world—especially with children still at school and elderly parents to consider—so I said that I would let him know as quickly as possible. We agreed to meet again the next day. On 18 February 2021 I met with the Deputy Premier in his office in Parliament House and I told him that I was interested in the role. He then made it clear during the meeting that he would immediately let the external recruiter know of my interest, that there was an established independent recruitment process to be followed and that he would not have any further involvement in the process. I was comfortable with this and I never once contacted him, spoke to him or heard from him again during the five-month recruitment process. Indeed, other than my conversations with Minister Lee concerning the chairmanship of TAFE, I did not contact, speak to or hear from any other politician during the five-month recruitment process.

On 19 February 2021 I had a previously postponed coffee catch-up with Treasury Secretary Mike Pratt to seek his advice on my broader career opportunities. I had served under Mr Pratt on the advisory board of Service NSW for four years and held him in very high regard, so I was seeking his advice on career options that I was considering. During this discussion I did ask him about the UK agent general role, as it was a role within Treasury. Mr Pratt gave me some general information about the role and about the Global NSW project and he encouraged me to "throw my hat in the ring" for the UK agent general role, as he thought I would be a "great candidate". I did briefly discuss some of my challenges, such as my children's schooling and my elderly parents, but he indicated that these were matters that could likely be resolved.

On 20 February 2021 I was contacted by Dr Marianne Broadbent from NGS Global, who explained that her firm was recruiting several international roles for Treasury and that she had been given my name by the New South Wales Government as a potential applicant for the UK agent general role. Dr Broadbent sent me an information pack on the role, which pleasingly showed that the role would report directly to Treasury Secretary Mike Pratt, but concerningly showed that the salary package on offer was \$450,000. On the assumption that this base would be complemented with support for rent and school fees, as per my earlier discussion with the Deputy Premier, I sent Dr Broadbent my application letter and my CV on 22 February 2021.

On 25 February 2021 I had an initial Zoom interview with Dr Broadbent to discuss my suitability for the role. I can only assume that the interview went well because I was later advised by Dr Broadbent that I would be progressing to a formal panel interview in March. On 30 March 2021 I attended a panel interview at 52 Martin Place. The panel comprised Mr Mike Pratt, Mr Tim Reardon, Mr Warwick Smith and Ms Jenny West. Later that same day I received a follow-up email from Dr Broadbent saying that the panel interview had gone very well and

**STEPHEN CARTWRIGHT:** The meeting on 19 February was supposed to happen on 12 February, but Mr Pratt had to cancel at the last moment—I suspect because of COVID—and we had to move it a week. It was originally to be 12 February.

**The Hon. DANIEL MOOKHEY:** On 18 February in the meeting with the Deputy Premier, when you said to the Deputy Premier that you would be interested in the role, you're absolutely adamant he said that he would let the external recruiter know?

**STEPHEN CARTWRIGHT:** He said he would let the external recruiter know or put me into the recruitment process. It was something like that.

The Hon. DANIEL MOOKHEY: But he took responsibility for informing others that you have an interest?

**STEPHEN CARTWRIGHT:** Yes. He said, "Now that I know you're interested, I will put you into the process and I will have nothing more to do with it."

**The Hon. DANIEL MOOKHEY:** I want to give you another opportunity just to clarify this point, Mr Cartwright. You are absolutely adamant that you didn't have any conversations with Mike Pratt prior to 19 February about your interest in the role?

**STEPHEN CARTWRIGHT:** Absolutely, because, as I said, when I had coffee with the Deputy Premier, his request as to whether I was interested in the role came out of left field. It wasn't something I had even contemplated.

The Hon. DANIEL MOOKHEY: Mr Cartwright, the problem we have is that your account doesn't accord with the evidence that Dr Broadbent has given us. Dr Broadbent told us that Mike Pratt informed her of your interest at a meeting of the Japan selection panel, which took place on 10 February 2021. We went through this with Dr Broadbent. It's on page 26 of the transcript, which I think has been provided to you as well. She makes it clear that the first time she hears about your interest is in the aftermath of an interview that takes place on 10 February in which Mr Pratt grabs her afterwards and effectively says, "You need to reopen the process to put Stephen Cartwright in." So I'm struggling to understand how either Dr Broadbent is wrong or you are, because it's quite clear from the chronology that has been given to us that you entered the process earlier in February than the date you're giving us, according to the evidence that Dr Broadbent has given. Do you wish to respond?

STEPHEN CARTWRIGHT: My recollection of the transcript was that Dr Broadbent was less than certain about when that conversation with Mr Pratt occurred, but I can't help you in relation to Dr Broadbent's evidence because I know for certain that the first time that I had any idea about the agent general role was 17 February. I went home to my wife after that coffee with the Deputy Premier and said, "You're never going to believe this," because my wife had lived in London for six years when she was younger in an executive capacity, and I went home to her and said, "You are never going to believe what just happened." So I am crystal clear on the first time that I became aware of the agent general role and my interest in being involved in it was 17 February, and, with all due respect to Dr Broadbent, I suspect she is wrong in her dates.

**The Hon. DANIEL MOOKHEY:** I now take you to page 3 of the tender bundle.

STEPHEN CARTWRIGHT: Sure.

**The Hon. DANIEL MOOKHEY:** To be fair to you, Mr Cartwright, this isn't inconsistent with your evidence that you're giving. You can see down the bottom there on the page of the email, on Friday 22 January 2021 you are emailing Mr Pratt's EA in order to establish the meeting, which eventually takes place on 19 February. But you see there in the second paragraph it says:

Secondly, Mike suggested that he and I should grab a coffee soon to discuss my plans for 2021 and beyond ...

I presume that's a reference to some form of a phone conversation or a meeting or text message or some form of communication with Mr Pratt which was taking place around that period of time.

STEPHEN CARTWRIGHT: We had a coffee after I finished with the NSW Business Chamber, so I'm guessing October, November. We were discussing another role that I was interested in at the time. It was a different role, a CEO role, but wasn't in the New South Wales Government. I was just looking for his thoughts on whether he thought that would be a good role for me, whether I'd be a good fit for the role. We agreed, when we had that coffee meeting, that we'd catch up again early in the new year, when I thought I'd then start to get more serious about looking for what I was going to do next, after the Christmas holidays. We'd get together again and I'd pick his brains on any other opportunities that he might or I might know about. So I was just reaching out, saying "Hey. We agreed to do this, and it would be good to catch up."

**The Hon. DANIEL MOOKHEY:** Basically, there was a pattern of conduct and communication that was taking place with the secretary of the Treasury over a period of roughly four months, between October or September 2020 to February 2021. It prompts you to seek the meeting that Mr Pratt flagged. Is it possible that, actually, in the course of one of those communications prior to 10 February, you did actually indicate or Mr Pratt did indicate to you an interest in the agent general's role?

**STEPHEN CARTWRIGHT:** No, it's not possible at all, because 17 February was the first time that I even thought about the role. I'm absolutely emphatic about that, Mr Mookhey, because it came out of left field. Therefore, it had never entered my consciousness that it was even a remote possibility, until it was put to me in that meeting.

**The Hon. JOHN GRAHAM:** Mr Cartwright, when you met with Mr Pratt eventually, two days later, on 19 February—you say in your statement:

During this discussion, I did ask him about the UK Agent General role ...

Was Mr Pratt aware on 19 February of your interest that you'd already conveyed to Minister Barilaro? Or was he unaware when you raised it?

**STEPHEN CARTWRIGHT:** No. I told him what had happened on 17 and 18 February. I told him that it had been raised with me by the Deputy Premier, that I'd gone back to the Deputy Premier the following day and said, "Yes, I am interested" and that he'd said, "Okay. I'll put you into the process", and I told Mr Pratt that on the nineteenth.

**The Hon. JOHN GRAHAM:** You're clear about that in your statement. My question is a different one: Was Mr Pratt aware of that? Or was this the first Mr Pratt was hearing of your interest in the role, on 19 February?

**STEPHEN CARTWRIGHT:** It seemed to me that the first that he had heard that I was interested was when I told him.

**The Hon. PENNY SHARPE:** Can I just follow up with that? Thank you, Mr Cartwright. It might have been the first time that he heard it. Did he give you the impression, though, that there had been discussions in relation to your name being considered for that role? Slightly different.

**STEPHEN CARTWRIGHT:** No, he didn't. No. When I asked him, I said, "I see that it's a role in Treasury. Could you tell me a bit more about it?" He was very forthcoming. He said, "I think you'd be a good candidate. You should throw your hat in the ring." It was as simple as that.

**The Hon. DANIEL MOOKHEY:** Mr Barilaro never told you, at this point in time, that Paul Webster was already the final preferred candidate?

STEPHEN CARTWRIGHT: No.

**The Hon. DANIEL MOOKHEY:** He never mentioned to you that advertisements and applications had closed?

**STEPHEN CARTWRIGHT:** No.

**The Hon. DANIEL MOOKHEY:** He never mentioned to you that his office was seeking to arrange a meeting with Mr Webster, almost contemporaneously to the time they were talking to you about this?

STEPHEN CARTWRIGHT: He couldn't have, because he didn't tell me anything about Mr Webster.

**The Hon. DANIEL MOOKHEY:** I'm giving you the opportunity to be abundantly clear about this, Mr Cartwright, because it is clear to us that, apparently, days before Mr Barilaro is offering you an opportunity to apply for the role, his office is accessing information about who is the preferred candidate—and it's not you. But no mention is ever made of the fact that the selection panel had already met, had agreed that Mr Webster—the recommendations were given, no?

STEPHEN CARTWRIGHT: No, I didn't know anything about Mr Webster until much later on.

**The Hon. DANIEL MOOKHEY:** On 19 February, when Mr Pratt apparently says to you that you would be a great candidate, did Mr Pratt disclose to you that he had already instructed Ms West to make an offer to Mr Webster or at least to proceed with Mr Webster's application?

STEPHEN CARTWRIGHT: No.

**The Hon. DANIEL MOOKHEY:** He never said words to the effect of "Stephen, you're a great candidate but we've already found this person who has been agreed to"?

#### STEPHEN CARTWRIGHT: No.

**The Hon. DANIEL MOOKHEY:** He never said to you, "Gee, the applications have already closed. It's too late. I'm sorry. You would have been great"? No?

**STEPHEN CARTWRIGHT:** If he had said that, Mr Mookhey, I would have said, "Okay, thank you", and moved on with my life.

**The Hon. DANIEL MOOKHEY:** Mr Cartwright, I expect that you may not be in a position to clarify this, but can you understand the questions that are raised here? To distil it to its core, it looks to us like the public service arrives at Mr Webster as the preferred candidate and then, for whatever reason, the Deputy Premier involves himself with apparently some form of a discussion with the Treasurer to unilaterally decide that Mr Webster is not an appropriate candidate and therefore they had to search for someone else and, far from searching for someone else, they basically just offered you the job.

**STEPHEN CARTWRIGHT:** Well, I reject the fact that they offered me a job. They said that I could enter the process. But I'll put to you, Mr Mookhey, that I was a private sector individual who'd been invited to apply for a role. I applied for the role and anything that was going on in the background was absolutely not known to me. So I can't help you in your inquiry in that regard.

**The Hon. DANIEL MOOKHEY:** Mr Cartwright, to be fair to you, if the Deputy Premier suggests to you that you should apply, it's reasonable for you to assume that the applications are—but I just want to be clear here: Neither the Deputy Premier nor Mr Pratt had disclosed to you that Paul Webster was already chosen at this point in time?

#### **STEPHEN CARTWRIGHT:** No.

**The Hon. DANIEL MOOKHEY:** And, specifically, Mr Pratt never disclosed to you that he had already issued instructions to Ms West to proceed with Mr Webster's appointment?

**STEPHEN CARTWRIGHT:** If he'd said that, I would have said, "Well, that means that I can't apply because you've already chosen who's going to have the job". It doesn't make any sense that he would have said that to me and then I went ahead and applied for the role.

The Hon. JOHN GRAHAM: Just referring back to your recollection of those discussions with the Deputy Premier, you indicated in writing your recollection on 31 March that the Deputy Premier and the Treasurer had reached an agreement that the cost of suitable family accommodation could be taken care of by the New South Wales Government outside of the salary package—your recollection at the time. Given you've now told us that the only discussions you had with the Deputy Premier were on those two dates, 17 February and 18 February, if your statement is accurate, that agreement, that private discussion must have occurred before 18 February, before your final discussion with John Barilaro. Would you agree with that?

STEPHEN CARTWRIGHT: That would be a logical conclusion, but can I just clarify one point for you that you've raised in your question. When I say "outside the salary package", what I'm referring to there is that Dr Broadbent had sent me an information pack on the role. And in the information pack on the role, it stipulated a salary package of \$450,000 or \$430,000—something around that. When I say "outside the salary package", I mean these would be components that would supplement or complement. I'm not talking about something that's done on the side. I'm simply saying that, along with a base salary—whatever that base salary may happen to be—there would be other components like rent and school fees, for example, which is very typical for offshore trade roles. This is what Austrade does. This is what the other States do. When I say "outside the salary package", I want to make it clear there's nothing sinister implied in that. This is simply saying outside of the base salary, there would be other components. I just want to make that clear—

The Hon. JOHN GRAHAM: Understood.

**STEPHEN CARTWRIGHT:** —because I fear that that might have been misinterpreted.

**The Hon. PENNY SHARPE:** Mr Cartwright, you are aware, though, that the \$450,000 package is what all of the other senior trade and investment commission roles are working within?

When you draw the comparison between other Austrade roles, they're actually quite different to the way in which these roles are paid within New South Wales. You are aware of that?

**STEPHEN CARTWRIGHT:** Yes.

**The Hon. PENNY SHARPE:** So when you received that information from Ms Broadbent, was it your view that, well, that must be the total package?

**MARIANNE BROADBENT:** I think in early 2021.

The Hon. DANIEL MOOKHEY: Okay, early 2021. We are talking January or February?

MARIANNE BROADBENT: Yes.

The Hon. DANIEL MOOKHEY: In January and February Mr Webster is the preferred candidate?

MARIANNE BROADBENT: Yes.

The Hon. DANIEL MOOKHEY: At what point does Mr Cartwright apply?

MARIANNE BROADBENT: My recollection is that he applies in February.

The Hon. DANIEL MOOKHEY: Can you take us through how that took place?

**MARIANNE BROADBENT:** My understanding is that I received advice that there was to be another candidate considered. I received that advice from the secretary of NSW Treasury at the time, that that candidate was Mr Stephen Cartwright, and we were asked to keep things open so that Mr Cartwright could be considered.

**The Hon. DANIEL MOOKHEY:** Okay. Do you recall—let me unpack that a little bit. You got a phone call in February from the Secretary of NSW Treasury. Is that correct?

**MARIANNE BROADBENT:** No. It was actually at a meeting that we had. I think we were at one of the other panel meetings.

The Hon. DANIEL MOOKHEY: Okay.

**MARIANNE BROADBENT:** And I was advised—again, my recollection—that there was another candidate that we were asked to meet as part of the screening process.

The Hon. DANIEL MOOKHEY: Okay. So there's a meeting of another panel. Is that the Japan panel?

MARIANNE BROADBENT: I expect it was at the time.

**The Hon. DANIEL MOOKHEY:** Yes. So Mike Pratt, who was the Secretary of the NSW Treasury at the time, correct?

MARIANNE BROADBENT: Yes.

The Hon. DANIEL MOOKHEY: He was a member of that panel?

**MARIANNE BROADBENT:** Yes.

**The Hon. DANIEL MOOKHEY:** You and he have a conversation at that meeting. We'll be able to establish, I think, when that meeting took place.

MARIANNE BROADBENT: Yes.

**The Hon. DANIEL MOOKHEY:** I'm sure someone upstairs is doing that. He advised you that there was to be another candidate for the agent general role?

MARIANNE BROADBENT: Yes.

The Hon. DANIEL MOOKHEY: And that candidate was Mr Stephen Cartwright?

MARIANNE BROADBENT: That's right.

The Hon. DANIEL MOOKHEY: And what were you instructed to do?

**MARIANNE BROADBENT:** To treat him as a candidate, which meant that we were asked to meet with him for a screening interview, which we did.

**The Hon. DANIEL MOOKHEY:** Okay. We will get to that part of it. But did Mr Pratt indicate to you that he had had any conversations with Mr Cartwright at the time?

MARIANNE BROADBENT: I don't recall him saying that he had conversations.

**The Hon. DANIEL MOOKHEY:** Okay. Did he give you any explanation as to how he managed to source Mr Cartwright as a candidate for this job?

MARIANNE BROADBENT: Not at the time, no.

The Hon. DANIEL MOOKHEY: At any point?

#### MARIANNE BROADBENT: No.

**The Hon. DANIEL MOOKHEY:** At any point did you ascertain how precisely Stephen Cartwright was identified by Mike Pratt as the person for the agent general role?

**MARIANNE BROADBENT:** I understand that Stephen Cartwright, as has now been released, had a discussion with the then Deputy Premier.

**The Hon. DANIEL MOOKHEY:** Okay. Let me unpack that. You understand that he had a conversation with the Deputy Premier at the time, Mr John Barilaro?

MARIANNE BROADBENT: I understand that Stephen Cartwright did.

The Hon. DANIEL MOOKHEY: How do you have this understanding?

**MARIANNE BROADBENT:** At the time that was a conversation that Mr Cartwright had indicated to a number of people, including me.

**The Hon. DANIEL MOOKHEY:** Okay. So you had a conversation with Mr Cartwright in which Mr Cartwright tells you—

**MARIANNE BROADBENT:** My conversation with Mr Cartwright related to the screening interview and that he was keen to provide service to New South Wales as part of his next contribution to the State.

**The Hon. DANIEL MOOKHEY:** Dr Broadbent, we might need to go a bit slowly over this. When you say a "screening interview"—

MARIANNE BROADBENT: Yes.

**The Hon. DANIEL MOOKHEY:** —are you talking about an interview directly between NGS Global, undertaken by you, and a potential candidate?

MARIANNE BROADBENT: Yes.

**The Hon. DANIEL MOOKHEY:** And this is a precursor to a panel interview, correct?

**MARIANNE BROADBENT:** Correct. It's a process where we are asked, as the search committee, to undertake a screening interview so that—we do that with all candidates who could possibly be short-listed. And then we provide that and we provide our written comments as part of that process.

**The Hon. DANIEL MOOKHEY:** Okay. So you had one of these screening conversations with Stephen Cartwright, as you would with all the other candidates, correct?

MARIANNE BROADBENT: We did, yes.

The Hon. DANIEL MOOKHEY: Do you recall when you had this conversation with Mr Cartwright?

MARIANNE BROADBENT: I believe it was in February.

The Hon. DANIEL MOOKHEY: And this followed after a request from Mr Pratt?

MARIANNE BROADBENT: Yes.

The Hon. JOHN GRAHAM: So how long after would it have been?

MARIANNE BROADBENT: It would've been probably a week after, I expect.

The Hon. DANIEL MOOKHEY: Okay. So we're talking middle—

MARIANNE BROADBENT: We had difficulty scheduling, but we managed to schedule it.

**The Hon. DANIEL MOOKHEY:** Do you think it may have been around 21 February or thereabouts?

MARIANNE BROADBENT: Somewhere thereabouts.

**The Hon. DANIEL MOOKHEY:** Okay, thank you. Is this a phone conversation, a Teams meeting or in-person meeting?

MARIANNE BROADBENT: It was a video. A Teams meeting because of COVID at the time.

The Hon. DANIEL MOOKHEY: And it was you and your staff, I presume?

MARIANNE BROADBENT: Yes, it was.

**The Hon. PENNY SHARPE:** Did Mr Cartwright ever indicate that he had spoken to other members of the Government in relation to this role?

MARIANNE BROADBENT: He didn't indicate that to me in person, no.

The Hon. PENNY SHARPE: Through any other way?

**MARIANNE BROADBENT:** Only in the statement that he did make to me that has come into the public domain.

**The Hon. PENNY SHARPE:** So he did indicate that he had spoken to both the Deputy Premier and the Treasurer at the time?

MARIANNE BROADBENT: That's what he wrote to me, yes.

The Hon. PENNY SHARPE: The Treasurer at the time being Dom Perrottet?

MARIANNE BROADBENT: That's what he wrote to me, yes.

**The Hon. DANIEL MOOKHEY:** Can I take you to that public domain information? I think you might find it in front of you, Dr Broadbent, a printout of an article that was published this morning by the ABC. It might be in one of the documents that's in front of you. We will get to that shortly, if you don't mind. But there's a screening call that takes place. At this point in time the selection panel has already met and decided that Mr Webster was the preferred candidate, correct?

MARIANNE BROADBENT: That's correct.

**The Hon. DANIEL MOOKHEY:** And you had provided advice to NSW Treasury to that effect. That's correct?

MARIANNE BROADBENT: It was Treasury who is—

The Hon. DANIEL MOOKHEY: Your client.

**MARIANNE BROADBENT:** —deciding that he's the preferred candidate.

The Hon. DANIEL MOOKHEY: Yes. So the Treasury had decided that he was the preferred candidate.

MARIANNE BROADBENT: The panel had decided he was the preferred candidate.

The Hon. DANIEL MOOKHEY: Just to be clear, do you recall who the panel members were?

**MARIANNE BROADBENT:** Mr Pratt, Mr Warwick Smith and I'm not sure—I can't remember. The other would be another secretary. It might well have been Mr Reardon.

The Hon. DANIEL MOOKHEY: Was it Mr Tim Reardon?

MARIANNE BROADBENT: I expect it was.

The Hon. JOHN GRAHAM: Yes.

**The Hon. DANIEL MOOKHEY:** I believe we also have documents in front of us that suggest it was Mr Tim Reardon, and that's your recollection as well. So the Secretary of the Treasury, the Secretary of the Department of Premier and Cabinet and Mr Smith have decided that he's the preferred candidate, and that view is then related and endorsed by NSW Treasury for at least some period of time?

MARIANNE BROADBENT: I believe that there were discussions going on to proceed with that appointment.

**The Hon. DANIEL MOOKHEY:** Do you ever recall advising NSW Treasury that Mr Webster was a strong candidate?

**MARIANNE BROADBENT:** Yes.

The Hon. DANIEL MOOKHEY: Did you do that in multiple instances?

**MARIANNE BROADBENT:** It was in our initial report. It was what the selection panel decided as well. But it's the selection panel that decides who the candidate is to be appointed.

**The Hon. DANIEL MOOKHEY:** Okay. So that process—just so I can work out the sequence of events here, Mr Pratt asks you to consider Mr Cartwright some time in February, probably around 15 February or thereabouts?

MARIANNE BROADBENT: About that, yes.

**The Hon. DANIEL MOOKHEY:** At this point in time Mr Pratt, Mr Reardon and Mr Smith had already agreed that Paul Webster was the preferred candidate?

MARIANNE BROADBENT: There was a draft panel report to that effect.

**The Hon. DANIEL MOOKHEY:** And did Mr Pratt indicate to you any reasons why he felt it was necessary to set aside that finding in order to proceed with an additional search?

MARIANNE BROADBENT: No, I'm not aware of that.

**The Hon. DANIEL MOOKHEY:** Okay. And then you have a screening conversation with Mr Cartwright. That's correct?

MARIANNE BROADBENT: Correct.

**The Hon. DANIEL MOOKHEY:** In which he relates to you that Mr Barilaro notified him of this job and suggested that he should apply. Is that fair?

MARIANNE BROADBENT: That's my recollection.

**The Hon. DANIEL MOOKHEY:** Did Mr Cartwright ever say words to the effect, "Mr Barilaro said that I should be the person for this job"?

MARIANNE BROADBENT: I don't recall him saying that.

**The Hon. DANIEL MOOKHEY:** What happens after that, Dr Broadbent?

**MARIANNE BROADBENT:** What happens after that is there is another panel meeting where the panel interviews Mr Cartwright and has a discussion around who they would then put forward as the preferred candidate.

The Hon. DANIEL MOOKHEY: Did that take place on 30 March?

MARIANNE BROADBENT: That would be about right.

**The Hon. DANIEL MOOKHEY:** Did that interview process on 30 March consider any other candidate?

MARIANNE BROADBENT: At that stage, I don't believe it did.

**The Hon. DANIEL MOOKHEY:** So the only reason that panel was reconvened was to consider Mr Cartwright's candidacy?

MARIANNE BROADBENT: I believe that's the case.

The Hon. DANIEL MOOKHEY: And you were asked to assist in that process?

MARIANNE BROADBENT: Yes, I was.

**The Hon. DANIEL MOOKHEY:** And that process led to the decision to make Stephen Cartwright the preferred candidate at that point in time?

MARIANNE BROADBENT: That's correct.

**The Hon. DANIEL MOOKHEY:** At that point, did anybody indicate to you what was wrong with Mr Webster?

MARIANNE BROADBENT: Perhaps that he didn't have recent knowledge of New South Wales. That became a factor in a number of the appointments—that familiarity with New South Wales would be helpful. Mr Webster had been living internationally, in the UK and Europe, for many years. He held a similar role, in fact, to a STIC role for the UK Government. He wanted to do for Australia what he had been doing for the UK Government for quite some time.

**The Hon. JOHN GRAHAM:** Who put that view to you?

**MARIANNE BROADBENT:** It was my understanding that, in the discussion of the panel, that was seen as something which might well be important.

The Hon. DANIEL MOOKHEY: Was it the same panel?

MARIANNE BROADBENT: Yes, I believe it was.

The Hon. DANIEL MOOKHEY: Just to be very clear, this same panel had agreed that Mr Webster had adequate knowledge of New South Wales to become the first agent general to London upon the position's resumption in February, but six weeks later, after Mr Cartwright is suggested by the Deputy Premier as a

The Hon. DANIEL MOOKHEY: In addition to the cost-of-living allowance and in addition to—

**MARIANNE BROADBENT:** Yes, and I think to be fair and understand, these are all things that are normal part of other Commonwealth agency and many State agency and comparable roles.

**The Hon. DANIEL MOOKHEY:** No doubt. Again, no-one can begrudge Mr Cartwright for seeking this. Was Mr Webster, when he was the preferred candidate, making similar requests?

MARIANNE BROADBENT: No, he was not.

**The Hon. DANIEL MOOKHEY:** In respect to any of the other STIC commissioners that have been interviewed or appointed for the Japan role or the ASEAN role, was any such request being made?

**MARIANNE BROADBENT:** There has been a cost-of-living arrangement for the roles. As far as I'm aware, that cost-of-living arrangement includes some of those factors but there was certainly a ceiling on that.

**The Hon. DANIEL MOOKHEY:** But just to be very clear here, Mr Webster, did you ever enter into direct—I guess the term you used, did you ever progress him to the next stage in which these conversations would have commenced?

**MARIANNE BROADBENT:** Those conversations had started. Mr Webster was already living in the UK and was comfortable with the arrangements.

**The Hon. DANIEL MOOKHEY:** So just to be clear here, Mr Webster is established as a preferred candidate late 2020, early 2021—that's fair?

MARIANNE BROADBENT: Yes.

The Hon. DANIEL MOOKHEY: You have progressed to the next stage with him—that's fair?

MARIANNE BROADBENT: That's fair.

The Hon. DANIEL MOOKHEY: In which you start to discuss his remuneration expectations?

MARIANNE BROADBENT: Yes.

The Hon. DANIEL MOOKHEY: And his additional allowances, conditions?

MARIANNE BROADBENT: Yes.

The Hon. DANIEL MOOKHEY: How far down that process did you get?

**MARIANNE BROADBENT:** Really, it was just the articulation of the base salary with super, that was the sum total of discussions. And then that was put on hold and Mr Webster understood that there was some uncertainty going forward.

**The Hon. DANIEL MOOKHEY:** When Mr Pratt then speaks to you circa—I've been advised it may have been around 10 February—

MARIANNE BROADBENT: Yes.

**The Hon. DANIEL MOOKHEY:** —at the Japan panel meeting in which he indicates to you that Mr Cartwright's a candidate or should be considered, do you then call Mr Webster up and say, "Hey, there's a new candidate here"?

**MARIANNE BROADBENT:** I have had ongoing conversations with Mr Webster to say that there is another candidate that's come into the process and I've asked him to be patient while we go through that. He was aware of that.

**The Hon. DANIEL MOOKHEY:** At the time he's told this, though, he's having conversations with you about remuneration because he thinks he's the preferred candidate, yet that all comes to a halt because Mr Cartwright has now been recommended into the process, correct?

**MARIANNE BROADBENT:** Correct. And I continued to have conversations with Mr Webster who was, I believe, very understanding of the situation.

**The Hon. DANIEL MOOKHEY:** He sounds like a saint, Dr Broadbent, in the way in which he's reacting to these turns of events.

MARIANNE BROADBENT: He was—that could be a word, yes.

The Hon. DANIEL MOOKHEY: Or he's saintly in his forbearance.

**The Hon. DANIEL MOOKHEY:** We've ascertained earlier today that a process around the Agent General commences in early 2020, that is then suspended as a result of the COVID pandemic. That accords with your recollection?

WARWICK SMITH: Yes. There was a delay, yes.

**The Hon. DANIEL MOOKHEY:** Then the process resumes sometime in the third quarter of 2020, then the selection panel convenes, settles upon one particular candidate, who then withdraws and then goes towards the other candidate who was capable of appointment. Is that your understanding too?

**WARWICK SMITH:** Yes, I think—the opposite to truncated is elongated. So, it was an elongated process and I think other candidates and other people were put to the committee.

**The Hon. DANIEL MOOKHEY:** We have established that by the end of late 2020, early 2021, the selection panel has interviewed a variety of candidates and chosen Mr Paul Webster as your preferred candidate. Does that accord with your recollections?

**WARWICK SMITH:** Yes. He was good. He was already in the United Kingdom, so of those that were in front of us he was probably a good run-up start, if you know what I mean. There had been no Agent General from New South Wales for 30 years.

**The Hon. DANIEL MOOKHEY:** Indeed. Then we learned as well earlier today that conversations with Mr Webster progressed to the point of details around his salary, as well as his other entitlements. I presume you weren't engaged at that level?

**WARWICK SMITH:** No. I don't go near the process or near the money. I know that sometimes those things are contentious, particularly if you're going to bring people from business into the Government, it's a different atmosphere, a different process. But that's never been part of the remit that I was involved in.

**The Hon. DANIEL MOOKHEY:** We then learn that after the panel has already decided that Mr Webster is your preferred candidate, in the aftermath of a meeting which takes place for, I believe it was the Tokyo position, secretary Pratt informs the recruiter that Mr Stephen Cartwright is a person who is now a candidate for the role. You were on the Japan panel, were you?

WARWICK SMITH: Yes.

**The Hon. DANIEL MOOKHEY:** Do you by any chance recall when that meeting took place?

**WARWICK SMITH:** Look, I am sorry, I don't. I mean, I didn't—I can go back and get the department to give me some dates.

The Hon. DANIEL MOOKHEY: That's okay, I think we can find out elsewhere.

**WARWICK SMITH:** Basically, Japan was a good process and it ended up being a very good candidate and from the marketplace.

**The Hon. DANIEL MOOKHEY:** Indeed. Did you have any conversations in or around that time in which secretary Pratt expressed to you any dissatisfaction with Paul Webster as a candidate for the UK job?

WARWICK SMITH: Not that I recall, no.

**The Hon. DANIEL MOOKHEY:** Were you aware that Mr Pratt had recommended Stephen Cartwright to the recruiter as a person who should enter the process?

WARWICK SMITH: No, I wasn't, no. But Cartwright's quite good. I've seen him in the past, and—

**The Hon. DANIEL MOOKHEY:** We'll get to that. At this point were you given any explanation at all from anybody as to why Mr Webster was not a suitable person to go forward?

**WARWICK SMITH:** Not that I recall, no. I mean, I do recall later conversations where Cartwright was there and how do we attract and keep Webster, because he's particularly strong in Europe, and you would be losing a good person I think, was the view of some of us. And that—

**The Hon. DANIEL MOOKHEY:** The panel reconvenes on 30 March to interview Stephen Cartwright, that's correct?

WARWICK SMITH: I take you on the date, yes, but it did have Cartwright in front of it, yes.

The Hon. DANIEL MOOKHEY: He was the only person on that day who you interviewed, correct?

WARWICK SMITH: I would have to take your word, but I don't recall.

As this includes the details of the preferred candidate and other candidates and it's a confidential process. I have kept the distribution list to a minimum but the others on your original email are aware that I am sending it to you and the wording and broad content, in fact John and Tom created the draft.

#### Background:

For the Global NSW hub office in Tokyo, we are recruiting for the role of Senior Trade and Investment Commissioner (STIC), North Asia. The STIC will be the senior representative for the NSW Government in Japan, and lead in-market trade and investment activities. The Tokyo hub office will have a spoke office in Seoul. An expanded and more senior offshore presence will generate a larger and more targeted pipeline of foreign and better support NSW exporters to reach the Japanese and Korean markets.

All STICs have a structured approval protocol prior to employment. The preferred candidate meets with the Treasurer, Deputy Premier and Premier. If endorsed by all three, a Cabinet appointment form is prepared and added as a Cabinet agenda item. Once endorsed by Cabinet, a contract can be offered to the candidate for negotiation. Following this a brief with finalised employment contract will be sent to Tim Reardon for approval and his signing of the contract.
