Below is a short summary of where things are at with the AG and Tokyo STIC engagement and the advice we've sought or had in this respect from OGC, CSO and HSF/KWM with a whole bunch of relevant correspondence attached so you have the detailed picture if required:

- All current offshore locally engaged employees are GSE exempt and have bespoke contracts specific to the location where they are based;
- Final advice has been that both AG and STICs can also be GSE exempt if that is how we would like to engage them;
- UK contract template had been drafted and finalised by KWM and was in approved stage. It is now with HSF for the AG overlay which will include any additional clauses they deem necessary as well as clauses around relocation, cross jurisdictional tax and pension entitlements, payment across currencies, etc.
- Japan contract was in draft form and HSF advised on final version. 



Why is the Agent General and Senior Trade and Investment Commissioners remunerated at such a high rate?

The roles of the Agent General and Senior Trade and Investment Commissioners require extensive business and trade expertise in diverse and highly complex international markets. These positions are critical to drive opportunities for NSW and better connect our businesses and industries with global trade sectors, buyers and investors.

The Agent General and Senior Trade and Investment Commissioners receive remuneration equivalent to a band three senior executive in accordance with the Statutory and Other Offices Remuneration Act 1975, with salaries set by the Statutory and Other Offices Remuneration Tribunal (SOORT).

These roles are instrumental in helping NSW business scale up and go global to generate jobs and economic growth for the state.

NSW is on track to establish six global Investment NSW "hub" offices across key global regions, as an important part of the government's response to COVID-19 and economic recovery in cities and regional centres.

NSW is committed to expanding our international trade and investment network with more "boots on the ground" in priority offshore markets. This includes up to 55 dedicated staff in 21 cities across 15 countries.

Our Senior Trade and Investment Commissioners form part of the work by Investment NSW, under the Global NSW Strategy, which is about taking the best of NSW to the world and bringing the best of the world to NSW.

The Agent General Employment agreement shows Stephen Cartwright has a total salary and super package of AU\$487,050 per annum (equivalent to salary and super package of GBP 263,070) along with an annual allowance of AU\$112,950 (GBP 60,993) to offset costs such as of housing, schooling and home leave flights.

This is in addition to one-off relocation expenses of up to AU\$60,000 (GBP 32,400), paid as reimbursement against receipts of costs incurred for: flights to London for employee and immediate family (up to four people), temporary accommodation for up to three months, household goods shipment, and incidentals such as home and school search, car hire, tax advice, etc.

That is an annual salary of \$600,000 and including the one-off relocation expense - \$660,000 this year - how is that justified?

(answer with first three paragraphs of question one and the following statement)



Annual allowances and one-off relocation expenses of up to AU\$60,000 are part of standard allowances for candidates who are required to relocate internationally to take up their position.

All roles have been specifically designed for their market and the commercial opportunity for NSW.

Employment contracts are tailored for each jurisdiction to ensure we comply with local laws and incorporate NSW Government Sector Employment Act elements where appropriate and lawful in specific markets to do so.

Investment NSW works with an independent recruitment firm or Austrade to run a transparent and competitive recruitment process, including two stages of interviews and capability assessments.

# What is the recruitment and selection process?

The Agent General and Senior Trade and Investment Commissioners were appointed following a lengthy and competitive global search process, managed by external recruitment firm NGS Global, who identified the preferred and most suitable candidates for each role. The process involved external advertising in national and international newspapers and candidates were subsequently interviewed by a selection panel comprised of senior public servants and independent specialists.

### What is the status of recruitment?

This week we announced our third and fourth STICS, Mr Andrew Parker (ASEAN) and Mr Vishwesh Padmanabhan (India and Middle East) who will lead our engagement in these markets, taking up their posts in early 2022.

Recruitment for the final two Senior Trade and Investment Commissioner positions for the Americas and Greater China is underway and will be finalised in the coming months.

Senior Trade and Investment Commissioner for North Asia Michael Newman started in his role in July this year and Mr Stephen Cartwright commenced his role as NSW Agent General UK, Senior Trade & Investment Commissioner in Europe and Israel soon after.

Our expansion will see representation across 21 locations, rather than postings. Currently NSW is represented in 12 offices in 10 countries: China, Indonesia, India, Japan, Republic of Korea, Singapore, the United Arab Emirates, the United Kingdom, the United States and Vietnam.

Additional new offices planned over the next 12 months include New York, Frankfurt, Paris, Bangalore, Hong Kong, Kuala Lumpur, Toronto and Santiago.

## What has been the delay in the roll-out of the global expansion?

COVID-19 has impacted the world differently and delayed processes such as real estate searches and employment processes. Establishing new offices and legal entities overseas is a complex process we want to get right. This has included ensuring legal, tax and HR structures and processes are appropriate for each jurisdiction and are aligned with our obligations as a Government and employer in NSW.

The following is background information that can be supplied to journalists.

This information is not for direct quoting from a NSW Government or Investment NSW spokesperson but can be used to inform the media article.

The Agent General and five Senior Trade & Investment Commissioners (STICs) are the NSW Government's most senior representatives for each of our new regional hubs:

Mumbai - responsible for India and the Middle East

New York - responsible for the Americas region

Singapore - responsible for the ASEAN region

Shanghai - responsible for Greater China

Tokyo - responsible for North Asia (Japan and the Republic of Korea).

# As of December 2021, NSW is now represented in 12 offices in 10 countries:

China, Indonesia, India, Japan, Republic of Korea, Singapore, the United Arab Emirates, the United Kingdom, the United States and Vietnam.

# Offices soon to open are:

Frankfurt, Paris, New York, Washington, Toronto, Santiago, Bangalore, Kuala Lumpur, Beijing, and Hong Kong.
