The Minister's office is seeking a brief on how we should implement the recent Cabinet decision to appoint the STICs via statutory appointments and is seeking our guidance on whether we would have legislation ready for the 3rd sitting week (not sure when this is). We have not progressed this as I thought we were moving to appointment them directly via a contractual agreement while we awaited feedback from the minister on how we would like to tackle the cabinet decision (if at all).

Amy this seems to be coming via the MO, perhaps second hand, and I wondered if any discussions had been had with the minister especially following his meetings with the candidates last week - or whether this is something he has now just turned his mind to?

I called your mobile but didn't leave a voicemail so if you're wondering who it was, it was me! I just have a request for a brief for the MO to get across what's happening in the STICs space. Bec's handover notes have:

The former DP obtained Cabinet approval to shift the STICs to be statutory appointments. Investment NSW is now working through how best to implement this. The CEO will continue to provide updates through weekly meetings.

However I don't think Amy has brought this up with the Minister, and our PLO has been asked whether we'd like to introduce legislation into Parliament in the 3rd sitting week. The MO have a few questions about whether PCO has drafted legislation, and whether a brief could be prepared regarding the background and status of the STICs, as well as Investment NSW's recommendation on how to best implement the Cabinet decision?
