Further Questions in response to NSW Health responses to Questions on Notice

Having reviewed the answers provided, the committee has requested elucidation on certain answers, in line with the intent of the original questions:

Question 16 - page 27:

The question asks for analyses that were provided to the Minister in consideration of appointments to Local Health District Boards. Please provide a list of current board members and the capability profile of each board. This does not need to include the names of individuals who are being considered for appointments.

Response

Listings for each Local Health District Board are provided as an attachment (TAB A), with information current as at 12 July 2023. These include a list of the appointed member's name with the selection criteria that the member has been appointed to.

For reference, the selection criteria for a Local Health District Board is established by section 26 of the *Health Services Act 1997*, where:

26 Constitution of local health district boards

- A local health district board is to be established for each local health district.
- 2. A local health district board is to consist of 6 to 13 persons appointed by the Minister, selected in accordance with subsections (3) and (4).
- 3. The Minister is to select the membership of a local health district board so that the membership of the board has an appropriate mix of skills and expertise required to oversee and provide guidance to the district, including members who
 - a) have expertise and experience in health management, business management and financial management, and
 - b) have expertise and experience in the provision of clinical and other health services, and
 - c) where appropriate, are representatives of universities, clinical schools or research centres, and
 - d) have knowledge and understanding of the community served by the district, and
 - e) have other backgrounds, skills, expertise, knowledge or experience appropriate for the district.
- 4. A local health district board is to have at least one member (who may also be one of the kinds of members referred to in subsection (3)(a)–(e)) who has expertise, knowledge or experience in relation to Aboriginal health.

The initial response to question 16 provides an overview of the information considered for each candidate as part of the appointment process.

Question 26 – pages 33-34:

The question asks about a change in accounting practice that appeared to be replicated across the local health districts. The answer provided on notice was that it was prompted by a 'management decision'. Please provide information on what prompted this change of policy and whether the change was initiated by NSW Health. Further, please provide a copy of any directive that instituted that change.

Response

Before 2014-15, when the consultancies spend was split into "capital works" and "others", the amounts reported for the "capital works" component were typically very low or nil. For example, in the 2 years before the reporting change, 2012-13 and 2013-14, the total NSW Health figure for "capital works" was nil.

Given that these very low or nil amounts were continuing to be reported, the Ministry of Health reviewed the utility of this spilt into "capital works" and "others", and determined that users of the financial statements would not be disadvantaged by aggregating the two components into a single 'consultancies' item.

The Ministry of Health instituted this change through an amendment to the financial statements pro-forma, completed annually by all reporting Health entities.
